Have you ever wondered about the possibility that a few expeditions in search of the Himalayan abominable snowmen (yetis) might, in fact, be espionage operations aimed at spying on Chinese military and political activities in Tibet? My examination of that question has taken me down many paths new, perhaps, to a cryptozoologist, but certainly the research has been worthy of my time as well as enlightening. Investigators of hidden animals owe it to the field to look behind the casual press releases of yet another new trek in pursuit of some faraway monster. We should begin to ask ourselves, are we being used, in some kind of elaborate cover story, for politically motivated covert operations?

Historical Background

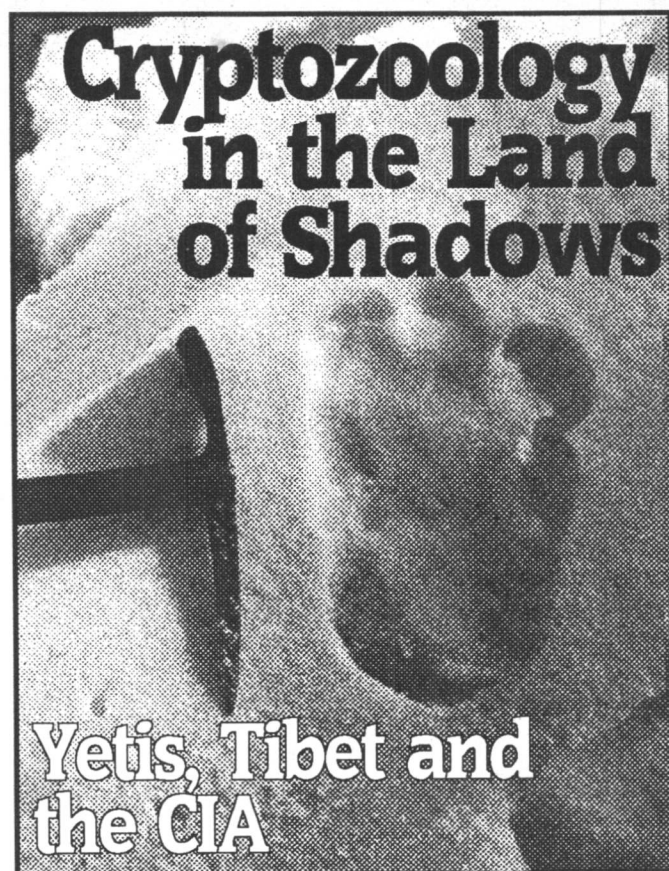
Individuals important to cryptozoological chronicles have been involved with secret intelligence networks for over two hundred years. For example, in 1769, South American reports of the five-foot-tall ape-like creature called the *didi* were collected by the botanist, naturalist and doctor, Edward Bancroft (Heuvelmans, 1959). Bancroft also called himself Jacobus Van Zandt (Sanderson, 1961), and was an espionage agent. As I have written elsewhere:

Edward Bancroft, internationally known as an expert on tropical plants, is an interesting figure in cryptopolitical history...Benjamin Franklin had sponsored Bancroft for membership in the Royal Society of London. When Franklin was at the American Embassy in Paris, Edward Bancroft, Franklin's friend and chief assistant, organized a cell of British spies, beginning in 1772. During his sojourn in Paris, Bancroft left weekly dispatches for the British written in invisible ink between the lines of love letters of a 'Mr. Richardson' and placed in a bottle in a hollow tree at the Tuileries. Franklin, who was involved in occult circles, such as the Lodge of the Nine Sisters in Paris and Sir Francis Dashwood's Hell-fire Club outside of London, is viewed by Richard Deacon in his *A History of British Secret Service* as merely part of the British intelligence network set up by Bancroft and others (Coleman, 1985).

Furthermore, Dr. Bancroft's associate, Sir Francis Dashwood, was thought to have traveled to Calcutta and Bengal (Silver and Lasky, 1977), thus placing him in the sphere of Tibet, the location of our story.

Tibet, Pandas and Spies

Tibet is the focus of this article's investigations. The recent history of this snowy Asian plateau—fenced in by the Himalayas to its south and surrounded by the body of China to its north and east—is central to gaining insights into the interplay between the cryptozoological and cryptopolitical. Before we delve too deeply into the late 1950s and early 1960s web of yeti searches and secret intelligence, let us step back 60 years to the days when the giant panda was still a cryptozoological wonder, quickly becoming a zoological prize. Tibet's lands guarded the secret of the giant panda from the West until the numerous American expeditions of the 1930s began to return with specimens for natural history museums. The first expedition to obtain a dead giant panda for mounting was led by Kermit Roosevelt, Teddy's son. The second expedition to kill pandas was headed by Brooke Dolan of the Philadelphia Academy of Natural Sciences during 1930-1932 (Morris, 1966; Perry, 1969). Interestingly, early giant panda collector Kermit Roosevelt's son, Kermit or "Kim," was later involved in Wild Bill Donovan's Office of Strategic Services (OSS), and the postwar Central Intelligence Agency (CIA). Kim Roosevelt is credited with living an

almost James Bond-like existence and being the one man responsible for the 1953 CIA coup against and overthrow of President Mossadegh and his Iranian government. In 1942, when the United States decided they needed a post in Tibet to assure the Dalai Lama of American friendship, they picked the OSS for the task. Chosen for this specific assignment were the agents Lieutenant Colonel Ilya Tolstoy (emigre grandson of the famous Russian novelist) and, guess who—Captain Brooke Dolan, the accomplished adventurer, Far Eastern explorer, and giant panda hunter. In later years, Tolstoy would become a general manager of Florida's Marineland, a movie producer, and cultivator of Bahamian sponge beds (Smith, 1972).

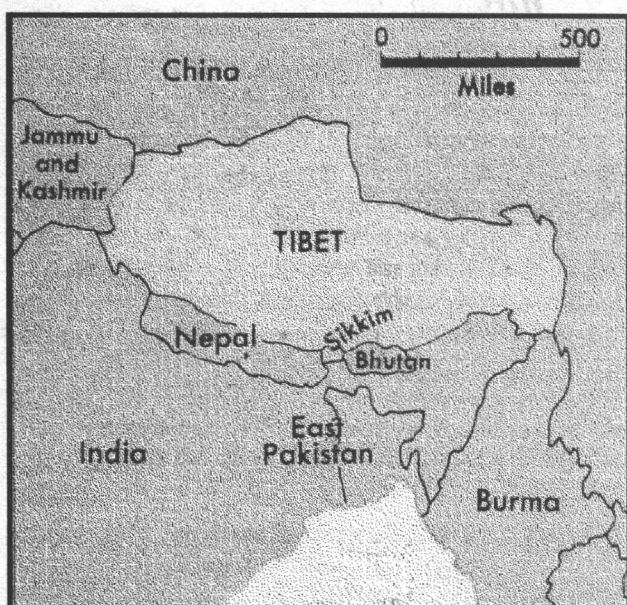
What better "psywar" technique than to search for and promote a variety of positions on strange and bizarre subjects, be they yetis, giant salamanders, or lake monsters?

During the secret mission, Tolstoy and Dolan had first flown into India before traveling through Nepal to the Forbidden City of Lhasa, Tibet. There they exchanged gifts with the Dalai Lama, and thus cemented the American intelligence community's toehold in the region. From Lhasa, their "caravan set out across unexplored Eastern Tibet toward Chungking, studying the potential route for a military road and noting on their map the sites of possible airfields" (Ford, 1970). At

Chungking, Tolstoy and Dolan would have no doubt run into an OSS staff member and jolly amateur chef named Julia McWilliams Child. Today, Julia Child is best known as public television's "French Chef" (Smith, 1972). Upon their return to the States, Tolstoy and Dolan secretly received the Legion of Merit.

Further Examples

OSS veteran Leonard Francis Clark mentioned being in Tibet as the first foreigner since Tolstoy. Clark went on an expedition to Tibet in the late 1940s in an attempt to rally the Chinese Moslems against the Chinese Communists. In his book *The Marching Wind*, he made mention of abominable snowmen and apparently believed in them. Other OSS-connected men have had similarly strange links. Donovan's Colonel Merian Cooper would, in 1942, become Chief of Staff of General Claire Chennault's Flying Tigers in China (Smith, 1972). The Flying Tigers would evolve into the CIA-run Civil Air Transport (CAT), and later the CIA's personal airline, Air America (Leary, 1984). It was Cooper who was the adventurer and the writer/producer/director of the first *King Kong* movie (1933) starring Fay Wray. Peter Tompkins is another well-known former OSS man whose autobiographical book, A

Spy in Rome, was followed years later by his seemingly offbeat bestsellers on obelisks, pyramids and the secret life of plants. [Tompkins' co-author for the latter work was Christopher Bird, thought by some to also have an intelligence agency background (Sanderson, 1970). After his stint with Donovan's special "psychological warriors" division (involved with operation TORCH), Tompkins was to head the entire American World War II intelligence network in Rome. As the war came to a close, Tompkins was sent to Berlin to begin spying on the Soviets (Smith, 1972; Ford, 1970).]

Tom Slick: Beginning Hints

The vortex of intelligence operatives connected with cryptozoology seems to be especially concentrated around the mysterious figure of Tom Slick, forgotten Texas oil millionaire and yeti searcher. Slick's life ended at the young age of forty-six and his early death only intensified the mystery of his life. At about 6 p.m., on October 6, 1962, along

with Dallas pilot Shelly Sudderth, Slick was killed in a midair explosion over the skies of Montana. In my book, *Tom Slick and the Search for the Yeti* (1989), I have detailed the theories surrounding his death. In summary, the questions boil down to this one: was the plane torn apart because of weather, faulty structural design or a bomb? On a list found in Slick's pocket was the word "bombs" written alongside other less sinister notations regarding his alleged hunting trip. Was he transporting bombs, or merely remembering the insect repellent? Slick was a man who avoided publicity. Was he involved in some way with the intelligence network? What hints exist in the record that there may be something to this notion?

Slick had many opportunities to travel to such locales as the Soviet Union, South America, and India, and was in many international networks. From what I was able to reconstruct of Slick's life, his friends included John Foster Dulles, the Secretary of State during the Eisenhower years and brother of Allen Dulles (Director of the Central Intelligence Agency), as well as Jawaharlal Nehru, Henry Cabot Lodge, Jimmy Stewart, Norman Cousins, and other well-known figures. Slick also met many people in his role as a member of the National Advisory Board of the United World Federalists (Coleman, 1989). Founded in 1947, the United World Federalists' first president was the intellectual Cord Meyer. But suddenly in 1950, around the time that China was advancing on Tibet, Meyer left the organization's head post in the hands of liberal Alan Cranston (presently the senior United States Senator from California), and joined the CIA's covert operations division. A close associate was quoted as saying: "It was a great surprise to his friends. He was not the CIA type. He was a world government man" (Smith, 1972). In 1954, Meyer was named Chief of the CIA's Covert Action operations. Hardened by political battles with Joseph McCarthy and by personal tragedies (one of Meyer's sons died in an automobile accident and his wife was killed by an unknown assailant), years later a friend would say that Cord Meyer "got Cold Warized" (Smith, 1972). What level of ongoing contact did Slick have with Meyer? No hints exist in the public record. But was Slick somewhere in the background?

Slick, Saipan and the CIA

Tom Slick's military record is not too detailed in the archives I was able to examine. He served in the Navy, first at the War Production Office in Washington, D.C., then went on to Chile, Hawaii, Saipan, and occupied Japan (Coleman, 1989). In Saipan, Slick wrote in his short resume, he was a commanding officer of an oil tank farm. The Japanese built a naval base at Saipan when it became their territory in 1919 and maintained it until the United States captured the site in July, 1944. What has only recently become known is that the Central Intelligence Agency's "Special Operations Division had 'a home away from home' under Navy cover on the Pacific island of Saipan" (Marchetti and Marks, 1974). In the early 1950s, Koreans and Taiwanese were the recipients of the CIA's advanced training on Saipan, and apparently starting in 1959, Tibetans came too. "The CIA facility used a military designation, Naval Technical Training Unit, for its cover. Recruits were flown in at night by C-47 aircraft like those of Civil Air Transport. New arrivals were blindfolded on the ground en route to the base. But the CIA facility had been built on the highest mountain on the island, with surroundings plainly visible to the trainees" (Prados, 1986). What was the extent of Tom Slick's involvement with the intelligence community's early development of

the Saipan training center? We don't know. But one wonders—was the oil tank farm merely part of a possible cover story?

CAT, CIA and Slick Airways

Incredibly, little discussion has ever been made of the similar evolutionary beginnings of Chennault's and the CIA's Civil Air Transport and Air America, and the origins of Earl and Tom Slick's Slick Airways, Inc. Claire L. Chennault, who was born in Texas in 1890 and trained as a military aviator at San Antonio's world-famous Kelly Field, was destined to embody adventure and derring-do. After years of rebuilding the Chinese Air Force, Chennault took command of the Chinese-based American Volunteer Group (AVG) during the summer of 1941. The AVG (or Flying Tigers as they soon came to be known), was initially created to insure the safety of the land supply route from Burma to China. These were the famed pilots who "flew the Hump over the Himalayas," protecting the transportation of valuable supplies (Leary, 1984).

At the end of World War II, Chennault set about to create a Chinese-based American-owned airline, the Civil Air Transport (CAT). Meanwhile, former members of the AVG in the United States decided to establish two pioneer air freight companies. Robert Prescott, one of Chennault's men, was to head one, Flying Tigers, Inc. The other company was Slick Airways, Inc., which originally started as an idea of Earl Frates Slick, but was something in which Tom Slick quickly became interested. Hiring pilots Earl had once worked with, and buying planes from the military, Slick Airways was the number one air cargo transporter in the 1950s (Davies, 1972; *Business Week*, 1951; Coleman, 1989; Leary, 1984).

In 1950, the CIA secretly purchased Chennault's CAT, and then in 1959, CAT became Air America (Leary, 1984). Other airlines that are connected to the CIA have been mentioned in the public record, such as Air Asia, Southern Air Transport, and Intermountain Aviation, but the CIA had retained the right to delete at least one airline from an expose of their proprietary organizations (Marchetti and Marks, 1974). How deeply involved was Slick Airways in this interwoven network of CIA companies and contracts? We do not have a full answer yet, but intriguing hints exist. One individual who evidences a direct connection between Slick Airways and CAT is Robert Rousselot, who worked for both (Leary, 1989). Rousselot was highly regarded by the Central Intelligence Agency:

Chief Pilot Rousselot was the key link between CAT and the CIA for covert missions...Rousselot took charge of operational planning and selection of crew. The chief pilot looked for capable, responsible individuals, who would complete a mission if at all possible but would abort when necessary...As one former case officer recalled, 'Rousselot always delivered' (Leary, 1984).

Yeti Searching and Covert Operations?

How involved, therefore, was Tom Slick in covert operations? Did the search for the abominable snowmen serve merely as a cover? We know, for example, Slick was in the foothills of the Himalayas many times throughout the mid-1950s. Was he there only for mind science

research and yeti investigations? In the literature about the unknown war between the Chinese and the Tibetans, there is a mysterious episode concerning an apparent CIA agent who comes to a famous Indian border town to discuss setting up an arms supply line with the Tibetans:

It was in the guise of a tourist that an American came to Kalimpong in the spring of 1955...The American who came in 1955 may have been a diplomat but he was most probably a spy. He is not further identified by the man who tells the story, George N. Patterson, a Scottish missionary who had worked in eastern Tibet, spoke the language, wrote several books about the country, and resided in Kalimpong (Prados, 1986).

By 1958-1959, Tom Slick was running the expeditions in pursuit of the abominable snowmen from his home in San Antonio. Peter and Bryan Byrne were Slick's agents in the field. Most of the time, the Byrnes were not in the field. Instead, they would stay in West Bengal, namely in Calcutta, Darjeeling, or other eastern Indian cities. One West Bengal city, Kalimpong, the site of the meeting between the mystery

man and George Patterson, was actually viewed as a "spy center." The *New York Times* of April 4, 1959 detailed Prime Minister Nehru's one-hour news conference held to answer Chinese Communist charges that Kalimpong was being used as the base for Tibetan subversive activities. Nehru said that the city was often described as a "nest of spies of innumerable nationalities," and he had been told by an informed source that there were "more spies in Kalimpong than the rest of the inhabitants." The Prime Minister continued, stating that after the Communists took over in China all kinds of people went to Kalimpong under assumed identities—"some as technical people, some as bird watchers, some as journalists and some as just scenery admirers."

Ornithology and Espionage

It appears that birdwatching and spying were never far apart in the secret world of intelligence operatives. Former CIA director James Schlesinger and covert actions expert Desmond Fitzgerald enjoyed both pastimes. Birdwatching could be a useful cover. Take, for example, a person like S. Dillon Ripley. Ripley, a noted ornithologist and postwar Secretary of the Smithsonian Institution in Washington, was the chief of the OSS counterintelligence branch for southeast Asia.

Film fiction has picked up this thread. In the film, *The Dogs of War*, based on Frederick Forsythe's novel about covert operations in an African nation, the hero, played by Christopher Walken, goes to this country, disguised as a birdwatcher, to do a reconnaissance for a mission. The Walken character is shown reading an African bird field guide on the flight over, to familiarize himself with the names of the local birds.

The most famous (though fictional) agent in modern popular literature is based on this ornithology-espionage connection, and the creator of this character has links to our yeti story. Peter Byrne, thanks to Tom Slick, met with many "former" intelligence individuals in West Bengal, including World War II British Intelligence officer Ian

Fleming. Fleming was to become famous for his series of fictional spy books featuring the British secret agent 007, "James Bond." And, of course, as most people know, the name "James Bond" was actually the real name of the author of the book *The Birds of the West Indies* lifted by Fleming for use in his novels. The original "007," by the way, was the English mathematician, astrologer and occultist Dr. John Dee (1527-1608). Dee served as Queen Elizabeth's personal spy. "007" was, in fact, Dee's code number, and was adopted by Ian Fleming for "James Bond" (Rosenblatt, 1989).

The networks and connections between the 1950s explorers, ornithologists, crypto-zoologists and spies are under-studied, yet revealing. Ian Fleming was the brother of

Peter Fleming, explorer and writer. One of the latter Fleming's most remarkable books is *Brazilian Adventure*, a work in the tradition of Percy Fawcett. Another classic is Fleming's *Bayonets to Lhasa*, an account of the British invasion of Tibet in 1904. Peter Fleming was a school-years buddy of Ralph Izzard, Gerald Russell, and Ivan Sanderson—all individuals deeply involved in the search for the yeti and, to varying degrees, friends with Tom Slick. Izzard led the 1954 *Daily Mail* expedition to the Himalayas in search of yeti, Russell was a member of Izzard's 1954 trek and headed the 1958 Slick-Johnson Snowman expedition to eastern Nepal, and Sanderson was involved in all manner of cryptozoological investigations (including an African expedition with Russell in the 1930s) and writings, authoring the classic *Abominable Snowmen* in 1961. Sanderson was a consultant member of Slick's 1960-1962 search for Bigfoot, the so-called Pacific Northwest Expedition headed by Bob Titmus, then Peter Byrne.

Sanderson and Coon: Spies and Cryptozoologists

Ivan T. Sanderson was a commander in the British Naval Intelligence Service from 1940-1945, assigned to the Caribbean because of his zoological experiences there. The famed crypto-zoologist's wartime connections to spying apparently did not end in 1945. Sanderson gives a hint that some of his information sources remained in the realm of the intelligence network in one passage in his book *Abominable Snowmen*. Therein Sanderson (1961) details two curious encounters with the giant hairy Tok, given to him by "a young American, then in the service of his country, who had been born in the Shan States and brought up there, his parents having been missionaries." Sanderson "was asked not to publish" the man's name.

This individual, it appears, was probably a member of the extraordinary Young family who were responsible for setting up the Burma Baptist Mission. The Sanderson contact was, no doubt, William Young, who was:

...perhaps one of the most effective agents ever, [who] was born in the Burmese Shan States, where his grandfather had been missionary to the hill tribes. Arriving in Burma at the turn of the century, Grandfather Young opened a Baptist mission in Kengtung City and began preaching to the nearby Lahu hill tribes. Although they understood little of his Christian message, a local oracle had once prophesied the coming of a white deity, and the Lahu decided that Reverend Young was God. His son, Harold, later inherited his divinity and used it to organize Lahu intelligence gathering forays into southern China for the CIA during the 1950s. When William was looking for a job in 1958 his father recommended him to the CIA, and he was hired (McCoy, 1972).

In the book *Uninvited Visitors*, Sanderson (1967) discusses how he was called to the Pentagon for a briefing; this is an odd event for someone who supposedly has no official ties to the government. Sanderson appears to have maintained an open line to some members of the espionage community.

Peter Byrne and Tom Slick also had contact with elements of American intelligence. One of Tom Slick's earliest yeti consultants was Carleton Coon, professor of anthropology and former Office of Strategic Services agent. Coon was consulting for the Slick yeti expeditions from the very beginning having been at one of the first meetings attended by Tom Slick's assistant Cathy Maclean, Peter Byrne, and Life's Jim Greenfield in Darjeeling India, on January 16, 1957.

Within espionage circles, Coon's work for the OSS was legendary. One of the first missions of Donovan's spy organization was operation TORCH, the invasion of North Africa, involving, as mentioned above, agents such as Peter Tompkins. Carleton Coon was in charge of TORCH and the affair was such a success that it insured the future of the OSS. OSS's leadership, who were later connected to the Central Intelligence Group, then the Central Intelligence Agency, would never forget Coon for his contributions to the budding American intelligence community.

Gambit, Inc. of Ipswich, Massachusetts (Coon's residence in his late years) published the small book, *A North Africa Story: The Anthropologist as OSS Agent 1941-1943* by Carleton S. Coon, in 1980. It is filled with Coon's 1940s writings of his exploits, with historical background supplied by the editors at Gambit. The book is an interesting insight into the dual life that Coon led. And the mostly code-named characters along the way hint at the overlaps that intrigue us, as well. There's "Levy," for example, a young Frenchman who Coon did not like because of the way he treated the Arabs. Coon noted, nevertheless, that this individual "claims to have been a member of a Himalayan mountain climbing expedition."

A North Africa Story details Coon's thoughts on the kind of legitimate front that worked best for OSS agents during wartime. "The question of cover is one that can only be settled by experience. We have had, however, enough experience to determine a few principles. There are two things good cover should avoid: tying the agent down with cover activities, and making him conspicuous," Coon wrote. He went on to make some further points:

State Department cover is good in that it allows the agent to go places where he could not otherwise get; it does not take up too much of his time. It is bad in that he is conspicuous and constantly under enemy surveillance. They undoubtedly know he is an agent, but don't dare harm him in neutral territory....Special civilian covers are useful only for special jobs of brief duration....To be an archaeologist is silly, even if the agent is really a well-known professional archaeologist in peace time. All archaeologists are inevitably suspected of being agents anyhow even in peace time; and who cares about archaeology in wartime? An archaeologist may be very useful for his knowledge of the country, its people, languages, etc., but he must not pretend that he is still an archaeologist in war" (Coon, 1980).

Coon used the cover of the diplomatic corps during World War II. Carleton Coon tied his public exit from the OSS to the time that the organization was disbanded at the end of the war. Many former OSS agents, of course, were later employed by the operations division of the CIA. Was Coon one of them? Did he change his mind and allow his anthropological career to dovetail with some clandestine activities

after 1945? Coon always seemed to be working right on the fringes of the Communist bloc countries, in Iran, in Afghanistan, and so forth. Or in India and Nepal, near Tibet.

The Dalai Lama, Slick Denials and the CIA

While a great deal of information has surfaced over the years about the Central Intelligence Agency's worldwide covert operations activities, little is known about how deeply the CIA was involved in Tibet in the 1950s and 1960s. "It is impossible at this writing," John Prados noted in his 1986 book, *Presidents' Secret Wars*, "to give a detailed analysis of the Washington decision making for Tibet. The appropriate records remain security classified. If not for the courts, in fact, the entire discussion of Tibet in the Marchetti and Marks book, *The CIA and the Cult of Intelligence*, would have been deleted by Agency censors."

We are forced to read accounts of the conflict in Tibet closely to get some insights into how involved some of the yeti searchers may have been. Let's start with one critical incident, the escape of the Dalai Lama from Tibet. (During 1989, his Holiness the XIVth Dalai Lama was awarded the Nobel Peace Prize.) There are denials, for example, of the rumors circulating that Tom Slick and Peter Byrne were responsible, in some fashion, for the safe passage of the Dalai Lama from Lhasa. (Since the time of Tom Slick's first official yeti reconnaissance of eastern Nepal in 1957, in which he was actually a member of the trek, the rumors of his expeditions' involvement in spying have been rampant. *The New York Times* even saw fit to publish an article reporting on the Russians' promotion of this story in an item entitled "Soviet Sees Espionage in U. S. Snowman Hunt." The April 27, 1957 piece claimed Slick was behind an effort to subvert the Chinese, and free Tibet.)

What can we find in the record about the Dalai Lama's rescue? Who was behind the exit or with the Dalai Lama? Fletcher Prouty, an Air Force colonel who supervised secret air missions for the Office of Special Operations, has written: "This fantastic escape and its major significance have been buried in the lore of the CIA as one of those successes that are not talked about. The Dalai Lama would have never been saved without the CIA" (Prouty, 1973). On March 17, 1959,

in three groups, the Dalai Lama, his immediate family and senior advisors escaped from Lhasa. Tenzin Gyatso [the Dalai Lama] was disguised as a common soldier of the guard....The best information [about the fleeing Dalai Lama] came from the CIA...The CIA was so well informed because it had furnished an American radio operator, who traveled with the Dalai Lama's party....There may have been other CIA agents with the party as well (Prados, 1986).

Who were these individuals? George Patterson might know. Remember, he is the guy who had the mysterious meeting with "an American tourist" during 1955 in which parts of the CIA's war in Tibet were mapped out. Patterson, who used the cover of being a missionary (but drank, smoked and chased women with the best of the guys), was part of a unique foray into Tibet in 1964. Setting out secretly with Adrian Cowell, a British filmmaker, Patterson took off

from Nepal to coordinate and film an attack on a Chinese convoy by Tibetan Khamba commandos. Patterson and Cowell were successful, but upon their return they were briefly jailed in India, and their film was suppressed and not shown for two years. Now here's the interesting part. Who helped them get into Tibet? None other than Peter Byrne, Tom Slick's man in Nepal.

And who has written the most concerning the Patterson incident without saying too much in depth about it? None other than Michael Peissel. In his book, *The Secret War in Tibet* (1973), Peissel mysteriously kept his references to the CIA to only four small mentions in this 258-page book. Peissel discussed a good deal about the secret war in Tibet but strangely never mentioned some amazing points now well-known (due to recent CIA limited releases of information), such as the fact that the small kingdom of Mustang was the CIA-run base of Tibetan guerrilla operations. Peissel revealed that he first went to the area in the spring of 1959 with "a letter of recommendation from Thubtan Norbu, the brother of the Dalai Lama, to the Prime Minister of Bhutan....I was off to meet Jigme Dorji, the Prime Minister of Bhutan, in the small border town of Kalimpong" (Peissel, 1966). We, of course, understand a little bit more about the importance of Kalimpong in the espionage game, as was mentioned above.

Also, we now have some facts about Thubtan Norbu. The eldest brother of the Dalai Lama was connected to the "American Society for a Free Asia," a CIA-funded organization that sponsored a series of visits to and lectures in the United States by Norbu, beginning in 1956 (Prados, 1986). Secretly, the Dalai Lama's family was very involved with the CIA in fighting the Chinese. Gyalo Thondup, the Dalai Lama's second-eldest brother, based in Darjeeling, established an intelligence gathering operation with the CIA in 1951. Six years later, he upgraded it to an advanced CIA-trained guerrilla unit whose members were introduced to commando techniques on Guam, for example, and then

Like a Virgin

Virgin Mary sightings, prophecy, and UFOs

"A sudden flash of light and tremor of excitement in the crowd made me turn and look in the direction of the sun. Almost to my horror, I witnessed what so many have called the 'dance of the sun'—the sun moving back and forth as though on a yo-yo string, its central incandescent white disc surrounded by spinning circles of yellow, green, and red light, for all the world like a Catherine-wheel firework. All around us, people were on their knees praying. To my regret, I felt no such impulse. I had no sense of the numinous, only of the passing strange...I felt that somewhere there must be a rational explanation."

Although unrecognized as such by its author, the preceding description of the recent apparitions of the Virgin Mary at Medjugorje, Yugoslavia, penned by Mary Craig in her book *Spark From Heaven*, reveals a curious connection between religious phenomena and UFO manifestations, as do the phenomena documented at Fatima, Portugal in 1917.

For Those That Believe

Dr. Jean Mundy, studying the apparitions at Fatima and believing since childhood that they were divine

revelations, had fully accepted that three children, Lucia, Jacinta, and Francisco, and approximately 70,000 adults, clearly witnessed the Blessed Mother's apparition. In high school, she states, "[she] would have felt it impertinent to ask the good Nuns for newspaper reports of those strange events or for interviews with eye witnesses." She believed in the motto: "For those that believe, no explanation is necessary. For those that do not believe, no explanation is possible." However, later in life, after receiving a Ph.D. from Catholic University, she viewed the video *The Miracle of Fatima: Documentation* which interviewed, years after the event, three eye witnesses to the miraculous appearances at Fatima: Carolina and Maria Dos Santos, sisters of Lucia, and a brother of Jacinta.

Their memories of the event were still fresh. As the translator described the event, Carolina stated: "it seemed the sun was saying goodbye to the sky and coming down like a saucer singing and working, and coming down, and stopped only when it almost reached the ground...We saw a shadow and it was like lightning." Jacinta's brother stated: "The sun, like a disc in the sky, trembled, and made brusque

movements outside of all cosmic law." The local newspaper reported at the time: "The sun zigzagged for twelve minutes, and then plunged down, almost to the ground, and then it suddenly reversed itself. It was seen by witnesses as far away as 40 kilometers. Certainly beyond all cosmic laws, were the sudden trembling movements of the sun, and dancing as it were, before the astonished multitude who gazed in awe, with spectators crying "Miracle! Miracle!" Other witnesses saw a second sun spinning and giving off fiery fingers of light extending across the sky.

That's No Lady

Estimates of the crowd watching this spectacle vary in the reports from 50,000 to 70,000, but in all the reports it was only Lucia, now Sister Maria das Dolores, who claims she saw a bright light in the form of a woman in white. The "Lady" urged the children to keep her presence a secret and to continue to meet on the 13th of every month until October, when she would reveal her identity. Lucia concluded it was the Blessed Mother.

No one else, including the other two children, saw this apparition. As Lucia herself wrote in her memoirs:

Opening her hands, she [the Blessed Virgin] made them reflect on the sun, and as she ascended, the reflection of her own light continued to be projected on the sun itself...I wanted to call the attention of the crowd to the sun. I was moved to do so under the guidance of an interior impulse.

The Mother of God, writes Dr. Jean Mundy, did not appear to thousands of devout Catholics in 1917 in Portugal. Only little Lucia Dos Santos saw what she claimed was the Blessed Virgin, while thousands of others saw only a fiery disk in the sky moving contrary to all known physical laws.

"Miracle" at Medjugorje

In his book *Extra-terrestrial Friends and Foes* (IllumiNet Press) George Andrews discusses many recent apparitions of the Virgin Mary, like the one in Cameroon, which he claims had numerous indications of UFO involvement. However, he states, the most persistent and well-known of these manifestations have occurred in the little village of Medjugorje in Yugoslavia. There, six youngsters between the ages of 10 and 17 have had ongoing contacts with the Virgin since 1981. One of these six now has a cyst on her brain, and has refused medical treatment stating that the Blessed Mother wants her suffering offered to God.

These recent phenomena at Medjugorje resemble the occurrence at Fatima in 1917. One witness describing the miracle of the sun claims: "It

came down out of the sky. The center of it was like a white host circled with gold and a path led down to us." Although people stared at the sun for 30 minutes, their eyes were not harmed.

The Australian edition of *People* magazine recently featured an article about a Melbourne millionaire who took his video camera to Medjugorje and captured on film "an immense green disc obscuring the sun, then pulsing as it floods the sky with bands of colored light."

Many of the witnesses at Medjugorje describe the sun "dancing in the sky." Also reportedly seen was a "grayish disc" slightly smaller than the circumference of the sun, which appeared to draw near the earth, pulsate, spin, and change colors. George Andrews has an interesting explanation for this phenomenon:

It seems to me that the occupants of that grayish disc must have become overconfident of the gullibility of the spectators they were performing for, and neglected to align the disc correctly between the sun and the spectators. A single sloppy maneuver can destroy the effect of a whole series of impeccable performances, in this case allowing a witness to perceive and describe what had been so long and carefully

camouflaged.

Zone of Strangeness

Dr. Mundy, now a psychologist, has compared descriptions taken from *Secret Prophecy of Fatima Revealed* with suggested stages of the contemporary alien abduction scenario. Analyzed

as such, some interesting parallels emerge. For instance, in the *Captured* stage, the children at Fatima were herding the sheep when suddenly there were two flashes of lightning. They looked up and saw a globe of light, and eventually Lucia sighted the figure of a woman. During this

psychic intrusion they were "frozen with fright," as is reported in alien abduction cases. In this case, capture can also be termed "rapture."

Similarly, in a stage called *Zone of Strangeness*, a "twilight zone" of strange events isolates the witness. During this experience, it seems to the witness that natural law has been suspended and reality is dreamlike. The motif of secrecy runs throughout abductions, as though they are admonished not to tell; even couples abducted together do not discuss the event between themselves. As will be discussed later, to this day there is a secret still held by one of the three children at Fatima.

In the stage best understood as *Time Lapse*, the witness's memory of the abduction blanks out and he or she suffers paralysis or uncharacteristic behavior following the event. In this respect, the introverted boy, Francisco, became an extrovert after the Miracle, Lucia refused to reveal many details of the Lady's requests for ten years, and Jacinta, disobeying her parents, returned quite often to the grotto, neglecting her flock of sheep. This compulsive return to the scene is prevalent in contemporary abduction cases.

In a stage called *Procurement*, a

beam of light strikes the witness, capturing his or her total attention. This drawing force pulls the human into a one on one meeting, procuring or grabbing the human in order to instruct, reassure, pacify and control the abductee. As seen in film footage of the children at Fatima, they were struck so inanimate that onlookers pricked them with pins and otherwise tried to draw them from a strange compelling force without success. They remained looking straight up into the sky, with heads tilted back and necks bent like ostriches, their eyes glazed over with religious "rapture."

While some abductees are subjected to an *Examination* stage, some are not subjected to a medical exam, but instead feel that they have been given a message which they are to reveal to others at a preordained time. The children at Fatima do not report being taken anywhere for an examination, but appear to have skipped this stage in the place of becoming Messengers.

The children at Fatima were instructed on many details, among them to say their rosary every day in order to obtain the end of the war. Typical of the *Conference* stage of abduction, they were told, "In October Our Lord will come, as well as Our Lady of Dolours and Our Lady of Carmel. Saint Joseph will appear with the Child Jesus to bless the world."

Abductions seldom end when the spaceship sails off, and may leave the witness "scarred for life." The lives of all who witnessed the sightings of the Blessed Mother at Fatima, as well as Medjugorje, were permanently altered. Lucia later became Sister Maria das Dolores (Mary of Sorrows) as a direct result of the "visitations." Typical of modern alien contact is the *Return* stage, the continuing visitor experience. In fact, Sister Maria, now living in the convent of the Displaced Carmelites, has continued to experience pre-cognition of deaths and world events and has had visions of Jesus Christ. Also revealed to her was the secret mystery of the Most Holy Trin-

ity, which she is not allowed to share with others.

The Ultimate Scam: Third Prophecy at Fatima

Of the three prophecies Mary of Sorrows was told to reveal, the first two were a plea for people to turn away from sin and save the world from destruction. She was warned: "Many nations will disappear from the face of the Earth." The Third Prophecy at

Fatima was to be opened in 1960, and given by the Bishop of Fatima to the reigning Pope. This event took place behind closed doors, after which, it is reported, the Cardinals filed out of the room with "a look of horror on their faces."

The Catholic Church decided not to reveal the final secret of Fatima [see sidebar, "The Final Prophecy?"] Rumor has it that Pope John Paul I had decided to reveal the final secret of Fatima but, although in perfect health, he died suddenly the night before he

was to reveal it. Requests for an autopsy were denied. What could cause the look of horror on the faces of the Cardinals when they learned the final secret of Fatima? Dr. Jean Mundy believes it was not the threat of war, or even nuclear disaster, stating that humans are "strangely accustomed to large scale dying." She adds: "Death, collectively, is banal. Besides, the first two prophecies were about war and no

one squelched the message or the messenger." The stark horror, she suggests, is a complete disruption of a belief system. It would conceivably constitute the most sacred betrayal to believe that the Roman Catholic Church was established by Jesus Christ, the Son of God, and to learn after a lifetime of devotion that Jesus was an "alien" being. It is the ultimate scam.

If the logical conclusion is that otherworld beings staged an elaborate demonstration involving a Catholic deity, the next progression is to question why they needed such a complex and time-consuming plan to relay secret messages to the Cardinals of the Catholic Church? We must also presume that if the Miracle of Fatima in 1917 was staged, then the revelation in 1960 was meant to give credit to the scam operators, presumably a race of alien beings. Another possibility involves the occult aspect of UFO phenomena. Does the "fallen angel" named Satan have license to fly such a mobile? Some believe that the Lord of the Underworld is involved with this scheme, especially since, as follows, there is abundant proof that appearances of the Virgin are associated with war as a sacrificial blood rite.

Sacrificial Lambs

Mary Craig, writing in her book *Spark From Heaven*, brings to light some religious historical facts which contain a significant clue to the Medjugorje "sightings." George Andrews comments:

Long before Yugoslavia became a nation, a struggle for dominance went on between Croatian Catholics and Orthodox Christian

Serbs in the Balkans. During the early part of the Second World War, the influence of the Catholic Church was aligned with the Fascists. On June 21, 1941, Croatian Fascists took seven monks out of the Orthodox Monastery at Zitomislic along with over seven hundred Orthodox women and children whose menfolk had left to join the Serbian army. Forced into a large pit at the nearby town of Surmanci, they were all buried alive. Forty years after this atrocity, on June 21, 1981, a plaque was erected at the Monastery in commemoration of that day. Just three days later, on June 24, 1981, the first apparition of the Virgin Mary occurred at Medjugorje.

In 1992, eleven years after the original apparition of the weeping Virgin at Medjugorje, in a nightmare reversal it was the Serbs who turned Fascist, while the Croats remained Fascist, both sides perpetrating the most abominable atrocities on each other and on their Moslem neighbors. The sacrificial victims numbered in the hundreds of thousands and perhaps millions, with no end to the killing in sight. In the midst of this religious holocaust, the apparitions of the Virgin continue to occur.

Not surprisingly, the Madonna's roadshows can be easily mapped by instances of human mayhem, and are associated more with suffering and mass death than with universal blessings. Apparently, the Blessed Mother's tears of sorrow for humankind, shed alongside her threats of war and natural calamity, are nothing but "crocodile tears."

Religious Mayhem

As demonstrated by George Andrews in *Extra-terrestrial Friends and Foes*, apparitions of the Blessed Virgin are closely linked to UFO phenomena as well as to religious mayhem. I asked George for his take on all this, and in a recent letter to *Paranoia* he responded:

...Although genuine miracles of healing have also occurred at some of these sites, there is an obvious correlation between these apparitions and large-scale human death. The first of the apparitions was at Guadalupe, Mexico, in 1531, at a time when about three quarters of the indigenous population had just been slaughtered. The apparition at Fatima in 1917 was near the climax of World War I. The apparition in Cameroon was only a few months before the mass deaths near Lake Nios. And look at what has been going on around Medjugorje, what a horrifying blood-bath that whole region has been drenched in, as well as the curious relationship between the beginning of the apparitions at Medjugorje and the massacre of 700 Serb women and children forty years before.

George feels that there are abundant indications that alien technology is involved in the Virgin Mary apparitions. In a discussion of the book *The Keys of the Blood*, George writes that author Malachi Martin, a Vatican insider, devotes considerable space to the manifestation at Fatima. He notes that

Martin never once uses the term 'UFO,' but the way he describes the 'miracle' on the final day could easily be interpreted in terms of UFO phenomena, so easily that Martin must have been aware of this. While deliberately refraining from being too specific, he describes a spaceship without calling it a spaceship, however, he does call it a disc! He also points out the extreme importance attributed by the Pope to the apparition at Fatima. Martin says the present Pope is not concerned about the fact that his positions on a number of key issues are unpopular, further weakening the Church at a time when its membership is already shrinking, because he expects an event of a miraculous nature to occur in the near future that will cause the entire world to convert to Catholicism...

Could such a 'miraculous' event be merely a convenient method for the Grays [i.e. extra-terrestrials] to take complete despotic control of the planet by giving absolute power to a single human being: the Pope?

Catholic Battle Standard

Guadalupe, Mexico in 1531 was not the first theatre of war over which the Virgin presided. Going back to the ninth century, according to Marina Warner in *Alone Of All Her Sex*, the defenders of Chartres against the Norsemen flew "the Virgin's tunic" from the staff which, legend has it, was the trick that defeated the invaders. In Byzantium, at the turn of the seventh century, the "awe inspiring image of the pure Virgin" flew from the ships of the Emperor Heraclius as he sailed into battle. During the siege of Constantinople by the Avars in 626, the patriarch had the Virgin and child painted on the west gates in order to "commend the city into her hands." In 717, during the Arab attack on Constantinople, a relic of the Virgin and child with Cross was carried around the city walls as a "charm against the besiegers."

The Final Prophecy?

The Neues Europa of Stuttgart once published what it claimed was the text of the secret Third Prophecy of Fatima. It read:

A great punishment shall fall on the entire human race in the second half of the twentieth century. The human race has sinned. In no part of the world is life in order. Satan rules in the highest position, laying down how things should be done. He will eventually succeed in seducing the spirits of the great scientists who invent the arms, which in ten minutes could easily wipe out all humanity. He will have under his power the rulers who govern the people and will help them to make an enormous quantity of these arms. For the Church, too, the time of its greatest trial will come. Cardinals will oppose cardinals and bishops bishops. Satan will march in their midst and there will be great changes at Rome. What is rotten will fall, never to rise again. The Church will be darkened and the world will shake with terror...●

In Byzantium, during the crusades, Christians were generally fighting heathens, and in medieval Europe, the armies who invoked the Virgin's favors were fighting fellow Catholics. In the Counter-Reformation's holy wars, horrors were perpetrated by Christian upon Christian in the name of the same God. At the battle of White Mountain near Prague on November 8, 1620, the Catholic army of the Holy Roman Emperor Ferdinand of Austria advanced crying "St. Mary!" and defeated the Calvinists, turning the tide of the Protestant Reformation in Europe and recovering Bohemia (now Czechoslovakia) for Rome. In the years following that victory, Ms. Warner writes, "Austrian armies established Catholic authority over the country, Jesuits assumed control of the

all the while pretending to be his guru-buddie? Leary's legal battles began in the late sixties when G. 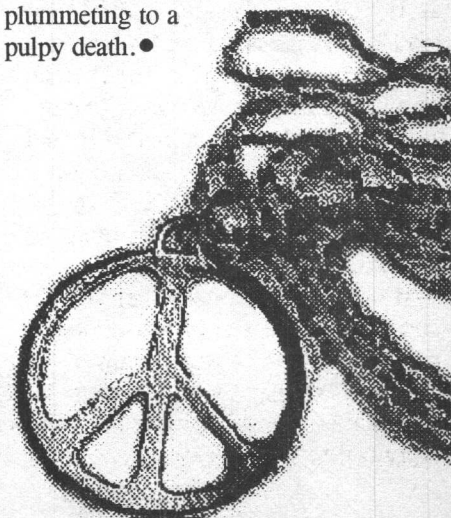

To add insult to injury, the seemingly delicious fruit hanging freely from a nearby tree of knowledge turns out to be oozing with juicy snake venom, killing the cool alien crooner (his name appropriately enough Adam) when he bites into an apple filled with serpent spit, and croaks; an obvious reference to how the writer of this script, Arthur Heineman, viewed the drug-using youth culture of that period.

Upon occasion, the drug-users did, in fact, do dumb things like staring into the sun and blinding their eyes. Or, like Art Linkletter's daughter, thinking they could fly out tenth story windows, thereby splattering their hopped-up heads on the cold concrete of hard reality like so many misguided melons, plummeting to a pulpy death. ●

Blacks used for organs?

- When rich whites need a heart or kidney transplant, they say, "Get us a nigger," according to Nation of Islam leader Minister Louis Farrakhan. Speaking to a mostly black audience at a stop-the-violence rally at the University of Toledo in late April, Farrakhan warned that whites do not want to stop black-on-black violence because, "You've become good for parts." (AP)

The death of Brian

- Two new books claim Rolling Stones co-founder Brian Jones was murdered in his swimming pool in 1969. At the time, the cause of death was ruled a drowning "while under the influence of alcohol and drugs." Both books—*Paint it Black: The Murder of Brian Jones* by Geoffrey Giuliano and *Who Killed Christopher Robin?* by Terry Rawlings—claim the 27-year old guitarist was purposely drowned by London builder Frank Thorogood, who had been hired to renovate Jones' Sussex estate. Rawlings cites a deathbed confession by Thorogood, while Giuliano cites a tape recording of an unidentified witness. Thorogood's daughter maintains that her father was innocent. (Wire reports)

ChemWar in SanFran?

- In late February, San Francisco's Mission District experienced a mysterious "Green Rain." Those with a knowledge of chemical warfare stayed inside, while others reportedly ran around tasting it and smearing themselves with it. No explanation of the "Green Rain" has emerged. (San Francisco Examiner)

Swastika in video game

- Radio Shack/Tandy apologized earlier this year for selling a video game that repeatedly displays the image of a swastika on the screen. The company canceled future orders of the "Pinball Master" game, and offered to reimburse offended customers. A Tandy spokesperson claimed that the symbol, used by the German Nazi Party during Hitler's reign, is a "good luck sign" in the Buddhist religion. Thus, the Asian supplier did not realize the graphic might offend. (Turning the Tide: Newsletter of People Against Racist Terror, PO Box 1990, Burbank, CA 91507. \$10/yr)

Deaths puzzle researchers

- Federal scientists researching a cure for hepatitis B remain puzzled by the 1993 deaths of five patients given an experimental drug. There was no indication of why a deadly poison had built up in the patients' bodies, according to a National Institute of Health researcher. The five patients who died were participating in a trial of an antiviral drug called FIAU. (AP)

Breast cancer cover-up

- A big PR campaign run during National Breast Cancer Awareness Month warns women that the cancer is caused by poor diets, heredity, and hormones. The campaign avoids any mention of the possible role of toxic chemical pollutants, particularly a group called organochlorines. The level of one of these synthetic chemicals—DDE, a metabolized product of the pesticide DDT—has been found to be higher in women with breast cancer than women without breast cancer. So, why the selective warning? Well, the sole financial backer of "Breast Cancer Awareness Month" is Imperial Chemical Industries, which happens to be one of the world's largest manufacturers of products containing organochlorines. (The Providence Phoenix)

Man implicated in MLK assassination

- A man other than James Earl Ray has been implicated in the 1968 assassination of Martin Luther King, Jr. An affidavit by Betty Spates, who once worked at Jim's Grill in Nashville, implicates the owner, Loyd Jowers. In a March affidavit, she was quoted as saying that Jowers "came running through the back door" of the restaurant carrying a rifle moments after King's shooting. (AP)

It's a dang conspiracy!

- Country music star Dolly Parton apologized recently after voicing complaints about what she considers to be Hollywood's anti-Christian bias. After several producers turned down her idea for a show in which a country singer turns to Gospel music and Christian values, Parton reportedly complained about the power of Jews, and lack of powerful Christians, within the Hollywood power structure. (The Spotlight)

Big Brother computer network

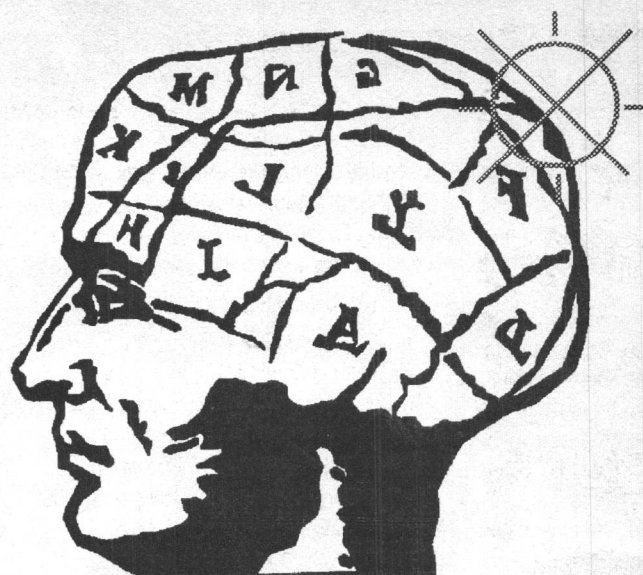
- FINCEN—the Financial Crimes Enforcement Network—is an interactive network of 92 computer databases, connected through a national computer system. It can be accessed by any government agency, either federal or state. Posing as a government official, lawyer Linda Thompson learned of its unprecedented capabilities. With it, someone can find out your PIN (personal identification number), nearest neighbors' names, your spouse's social security number, your VIN (vehicle identification number), your credit history, your travel history, your tax records, and more. In effect, it provides one-stop shopping for government snoops. (Speech by Linda Thompson in October, 1993, reported in Nexus magazine)●

Psychic warfare and nonlethal weapons

On April 22, 1993, both BBC1 and BBC2 showed on their evening news a rather lengthy piece concerning America's latest development in weaponry—the nonlethal weapons concept. David Shukman, BBC Defense Correspondent, interviewed (Retired) US Army Colonel John B. Alexander and Janet Morris, two of the main proponents of the concept.¹ The concept of nonlethal weapons is not new. Nonlethal weapons have been used by the intelligence, police and defense establishments in the past.² Several western governments have used a variety of nonlethal weapons in a more discreet and covert manner. It seems that the US government is about to take the first step towards their open use.

The current interest in the concept of nonlethal weapons began about a decade ago with John Alexander. In December 1980 he published an article in the US Army's journal, *Military Review*, "The New Mental Battlefield," referring to claims that telepathy could be used to interfere with the brain's electrical activity. This caught the attention of senior Army generals who encouraged him to pursue what they termed "soft option kill" technologies. After retiring from the Army in 1988, Alexander joined the Los Alamos National Laboratories and began working with Janet Morris, the Research Director of the US Global Strategy Council (USGSC), chaired by Dr. Ray Cline, former Deputy Director of the CIA.³ I examine the background of Janet Morris and John Alexander in more detail below.

Throughout 1990 the USGSC lobbied the main national laboratories, major defense contractors and industries, retired senior military and intelligence officers. The result was the creation of a Nonlethality Policy Review Group, led by Major General Chris S. Adams, USAF (retired), former Chief of Staff, Strategic Air Command.⁴ They already have the support of Senator Sam Nunn, chair of the Senate Armed Services Committee. According to Janet Morris, the military attaché at the Russian Embassy has contacted USGSC about the possibility of converting military hardware to a nonlethal

capability. In 1991 Janet Morris issued a number of papers giving more detailed information about USGSC's concept of nonlethal weapons.⁵ Shortly after, the US Army Training and Doctrine Command at Fort Monroe, VA, published a detailed draft report on the subject, titled "Operations Concept for Disabling Measures." The report included over twenty projects in which John Alexander is currently involved at the Los Alamos National Laboratories. In a memorandum dated April 10, 1991, titled "Do we need a Nonlethal Defense Initiative?," Paul Wolfowitz, Under Secretary of Defense for Policy, wrote to Defense Secretary Dick Cheney, "A US lead in nonlethal technologies will increase our options and reinforce our position in the post-Cold War world. Our Research and Development efforts must be increased."

How lethal is nonlethal?

To support their nonlethal weapons concept, Janet Morris argues that while "war will always be terrible..., a world power deserving its reputation for humane action should pioneer the principles of nonlethal defense."⁶ In defining a nonlethal strategy, she seeks to establish a doctrine for the use of nonlethal weapons by the US in crisis "at home or abroad in a life serving fashion." She totally disregards the offensive, lethal aspects inherent in some of the weapons

in question, or their misuse, should they become available to 'rogue' nations. Despite her arguments that nonlethal weapons should serve US interests "at home and abroad by projecting power without indiscriminately taking lives or destroying property,"⁷ she admits that "casualties cannot be avoided."⁸ Closer examination of the types of weapons to be used as nonlethal invalidates her assertions about their nonlethality. According to her *White Paper*, the areas where nonlethal weapons could be useful are "regional and low intensity conflict (adventurism, insurgency, ethnic violence, terrorism, narco-trafficking, domestic crime)."⁹ She believes that "by identifying and requiring a new category of nonlethal weapons, tactics and strategic planning" the US can reshape its military capability "to meet the already identifiable threats" that they might face in a multipolar

world "where American interests are globalized and American presence widespread."10

The potential inventory

Janet Morris' *White Paper* recommends two types of "life-conserving technologies": *Anti-materiel* nonlethal technologies—to destroy or impair electronics, or in other ways stop mechanical systems from functioning, and *anti-personnel* nonlethal technologies. Amongst current technologies from which the first category of nonlethal weapons would or could be chosen are:

- Chemical and biological weapons, for their anti-materiel agents "which do not significantly endanger life or the environment, or anti-personnel agents which have no permanent effects."11

- Laser blinding systems to incapacitate the electronic sensors, or optics, i.e., light detection and ranging. Already the Army Infantry School is developing a one-man portable and operated laser weapons system known as the Infantry Self-Defense System. The US Army's Armament Research, Development and Engineering Center (ARDEC) is also engaged in the development of nonlethal weapons under their program called "Low Collateral Damage Munitions" (LCDM). The LCDM is trying to develop technologies leading to weapons capable of dazzling and incapacitating missiles, armored vehicles and personnel.

- Nonlethal electromagnetic technologies.

- Non-nuclear electromagnetic pulse weapons.12 As General Norman Schwarzkopf has told the US Joint Chiefs of Staff, one such weapon stationed in space with a wide-area-pulse capacity has the ability to fry enemy electronics. But what would be the fate of enemy personnel in such a scenario? In a joint project with the Los Alamos National Laboratories and with technical support from the Army's Harry Diamond Laboratories, ARDEC are developing High Power Microwave (HPM) Projectiles. According to ARDEC, the Diamond lab has already "completed a radio frequency effects analysis on a representative target set" for HPM.

- Among the chemical agents, so-called supercaustics—"millions of times more caustic than hydrofluoric acid"13—are prime candidates. An artillery round could deliver jellied super-acids which could destroy the optics of heavily armored vehicles or tanks, vision blocks or glass, and could be used to silently destroy key weapons systems.14 On less lethal aspects, the use of net-like entanglements for SEAL teams, or 'stealthy' metal boats with low or no radar signature, "for night actions, or any seaborne or come-ashore stealthy scenario," are under consideration.15 More colorful concepts are the use of chemical metal embrittlement, often called liquid metal embrittlement, and anti-materiel polymers which would be used in aerosol dispersal systems, spreading

chemical adhesives or lubricants (i.e., Teflon-based lubricants) on enemy equipment from a distance.

Anti-personnel nonlethal technologies include:

- Hand-held lasers which are meant "to dazzle," could also cause the eyeball to explode and to blind the target.

- Isotropic radiators—explosively driven munitions, capable of generating very bright omnidirectional light, with similar effects to laser guns.

- High-power microwaves (HPM). US Special Operations Command already has that capability within their grasp as a portable microwave weapon.16 As Myron L. Wolbarsht, a Duke University ophthalmist and expert in laser weapons, stated: "US Special Forces can quietly cut enemy communications but also can cook internal organs."17

- Another candidate is infrasound-acoustic beams. In conjunction with the Scientific Applications and Research Associates (SARA) of Huntington, California, ARDEC and Los Alamos laboratories are busy "developing high power, very low frequency acoustic beam weapons." They are also looking into methods of projecting non-diffracting (i.e. non-penetrating) high frequency acoustic bullets. ARDEC scientists are also looking into methods of using pulsed chemical lasers. This class of lasers could project "a hot, high pressure plasma in the air in front of a target surface,

creating a blast wave that will result in variable but controlled effects on materiel and personnel."

- Infrasound. Already some governments have used it as a means of crowd control, e.g. France.

- Very low frequency (VLF) sound (20-35 kHz), or low-frequency RF modulations can cause nausea, vomiting and abdominal pains. "Some very low frequency sound generators, in certain frequency ranges, can cause the disruption of human organs and, at high power levels, can crumble masonry.18 The CIA had a similar program in 1978 called Operation Pique, which included bouncing radio or microwave signals off the ionosphere to affect mental functions of people in selected areas, including Eastern European nuclear installations.19

John Alexander

The entire nonlethal weapons concept opens up a new Pandora's Box of unknown consequences. The main personality behind it is retired Colonel John B. Alexander. Born in New York in 1937, he spent part of his career as a Commander of Green Berets Special Forces in Vietnam, led Cambodian mercenaries behind enemy lines, and took part in a number of clandestine programs, including *Phoenix*. He currently holds the post of Director of Nonlethal Programs in the Los Alamos National Laboratories. Alexander obtained a BSc. from the University of Nebraska and an M.A. from Pepperdine University. In 1980 he was awarded a Ph.D.

from Walden University²⁰ for his thesis "To determine whether or not significant changes in spirituality occur in persons who attended a Kubler-Ross life/death transition workshop during the period June through February 1979." His dissertation committee was chaired by Elizabeth Kubler-Ross.

He has long been interested in what used to be regarded as 'fringe' areas. In 1971, while a Captain in the infantry at Schofield Barracks, Honolulu, he was diving in the Bimini Islands looking for the lost continent of Atlantis. He was an official representative for the Silva mind control organization and a lecturer on Precataclysmic Civilizations.²¹ Alexander is also a past President and a board member of the International Association for Near Death Studies; and, with his former wife, Jan Northup, he helped Dr. C. B. Scott Jones perform ESP experiments with dolphins.²²

PSI-TECH

Retired Major General Albert N. Stubblebine (former Director of US Army Intelligence and Security Command) and Alexander are on the board of a 'remote viewing' company called PSI-TECH. The company also employs Major Edward Dames (ex Defense Intelligence Agency), Major David Morehouse (ex 82nd Airborne Division), and Ron Blackburn (former microwave scientist and specialist at Kirkland Air Force Base). PSI-TECH has received several government contracts. For example, during the Gulf War crisis the Department of Defense asked it to use remote viewing to locate Saddam's Scud missiles sites. Last year (1992) the FBI sought PSI-TECH's assistance to locate a kidnapped Exxon executive.²³

With Major Richard Groller and Janet Morris as his co-authors, Alexander published *The Warrior's Edge* in 1990.²⁴ The book describes in detail various unconventional methods which would enable the practitioner to acquire "human excellence and optimum performance" and thereby become an invincible warrior.²⁵ The purpose of the book is "to unlock the door to the extraordinary human potentials inherent in each of us. To do this, we, like governments around the world, must take a fresh look at non-traditional methods of affecting reality. We must raise human consciousness of the potential power of the individual body/mind system—the power to manipulate reality. We must be willing to retake control of our past, present, and ultimately, our future."²⁶

Alexander is a friend of Vice President Al Gore Jr., their relationship dating back to 1983 when Gore was in Alexander's Neuro-Linguistic Programming (NLP) course. NLP "presented to selected general officers and senior executive service members" ²⁷ a set of techniques to modify behavior patterns.²⁸ Among the first generals to take the course was the then Lieutenant General Maxwell Thurman, who later went on to receive his fourth star and become Vice-Chief of Staff of the Army and Commander Southern Command.²⁹ Among other senior participants were Tom Downey and Major General Stubblebine, former Director of the Army Intelligence Security Command.

"In 1983, the Jedi master [from the Star Wars movie—author] provided an image and a name for the Jedi Project."³⁰ Jedi Project's aim was to seek and "construct

teachable models of behavioral/physical excellence using unconventional means."³¹ According to Alexander, the Jedi Project was to be a follow-up to Neuro-Linguistic Programming skills. By using the influence of friends such as Major General Stubblebine, who was then head of the US Army Intelligence and Security Command, he managed to fund Jedi. In reality the concept was old hat, re-christened by Alexander. The original idea, which was to show how "human willpower and human concentration affect performance more than any other single factor"³² using NLP skills, was the brainchild of three independent people; Fritz Erikson, a Gestalt therapist, Virginia Satir, a family therapist, and Erick Erickson, a hypnotist.

Janet Morris, co-author of *The Warrior's Edge*, is best known as a science fiction writer but has been a member of the New York Academy of Sciences since 1980 and is a member of the Association for Electronic Defense. She is also the Research Director of the US Global Strategy Council (USGSC). She was initiated into the Japanese art of bioenergetics, Joh-re, the Indonesian brotherhood of Subud, and graduated from the Silva course in advanced mind control. She has been conducting remote-viewing experiments for fifteen years. She worked on a research project investigating the effects of mind on probability in computer systems. Her husband, Robert Morris, is a former judge and a key member of the American Security Council.³³

In a recent telephone conversation with the author,³⁴ Janet Morris confirmed John Alexander's involvement in mind control and psychotronic projects in the Los Alamos National Laboratories. Alexander and his team have recently been working with Dr. Igor Smirnov, a psychologist from the Moscow Institute of Psychocorrelations. They were invited to the US after Janet Morris' visit to Russia in 1991. There she was shown the technique which was pioneered by the Russian Department of PsychoCorrection at Moscow Medical Academy. The Russians employ a technique to electronically analyze the human mind in order to influence it. They input subliminal command messages, using key words transmitted in 'white noise' or music.³⁵ Using an infrasound very low frequency-type transmission, the acoustic psycho-correction message is transmitted via bone conduction—ear plugs would not restrict the message. To do that would require an entire body protection system. According to the Russians, the subliminal messages bypass the conscious level and are effective almost immediately.

C. B. Scott Jones

Jones is the former assistant to Senator Claiborne Pell (Democrat, Rhode Island). Scott Jones was a member of US Naval Intelligence for 15 years, as well as the Assistant Naval President's Scientific Advisory Committee, and has testified before House and Senate Committees on intelligence matters. After the Navy he "worked in the private sector research and development community involved in the US government-sponsored projects for the Defense Nuclear Agency (DNA), Defense Intelligence Agency (DIA) and US

Army Intelligence and Security Command." He has been head of the Rockefeller Foundation for some time and chairs the American Society for Psychical Research.³⁶

Birds of a feather

Alexander and C. B. Jones are members of the AVIARY, a group of intelligence and Department of Defense officers and scientists with a brief to discredit any serious research in the UFO field. Each member of the Aviary bears a bird's name. Jones is FALCON; John Alexander is PENGUIN. One of their agents, a UFO researcher known as William Moore, who was introduced to John Alexander at a party in 1987 by Scott Jones, confessed in front of an audience at a conference held by the Mutual UFO Network (MUFON) on July 1, 1989 in Las Vegas, how he was promised inside information by the senior members of the AVIARY in return for his obedience and service to them. He participated in the propagation and dissemination of disinformation fed to him by various members of the AVIARY. He also confessed how he was instructed to target one particular individual, an electronics expert, Dr. Paul Bennewitz, who had accumulated some UFO film footage and electronic signals which were taking place in 1980 over the Menzano Weapons Storage areas at Kirkland Air Force Base, New Mexico. As a result of Moore's involvement, coupled with some surreptitious entries and psychological techniques, Bennewitz ended up in a psychiatric hospital. Just before the publication of my first paper unmasking two members of the AVIARY³⁷, I was visited by two of their members (MORNING DOVE and HAWK) who had traveled to the UK with a message from the senior ranks advising me not to go ahead with my expose. I rejected the proposal.

Immediately after the publication of that paper, and with the full knowledge that myself and a handful of colleagues knew the true identities of their members, John B. Alexander confessed that he was indeed a member of the AVIARY, nicknamed PENGUIN. The accuracy of our information was further confirmed to me by yet another member of the AVIARY—Ron Pandolphi, PELICAN. Pandolphi is a Ph.D. in physics and works at the Rocket and Missile section of the Office of the Deputy Director of Science and Technology, CIA. In his book, *Out There*³⁸, the *New York Times* journalist Howard Blum refers to "a UFO Working Group" within the Defense Intelligence Agency. Despite DIA's repeated denials,³⁹ the existence of this working group has been confirmed to me by more than one member of the group itself, including an independent source in the Office of Naval Intelligence. The majority of the group's members are senior members of the AVIARY: Dr. Christopher Green (BLUEJAY) from the CIA⁴⁰, Harold Puthoff (OWL), ex-NSA; Dr. Jack Verona (RAVEN), Department of Defense, one of the initiators of the DIA's Sleeping Beauty project which aimed to achieve battlefield superiority using mind-altering electromagnetic weaponry; John Alexander (PENGUIN); and Ron Pandolphi (PELICAN). The mysterious "Col. Harold E. Phillips" who appears in Blum's *Out There*, is none other than John Alexander.

John Alexander's position as the Program Manager for Contingency Missions of Conventional Defense Technology,

Los Alamos National Laboratories, enabled him to exploit the Department of Defense's Project Reliance "which encourages a search for all possible sources of existing and incipient technologies before developing new technology in-house"⁴¹ to tap into a wide range of exotic topics, 'sometimes using defense contractors, e.g., McDonnell Douglas Aerospace. I have several reports, some of which were compiled before his departure to the Los Alamos National Laboratories when he was with Army Intelligence, which show Alexander's keen interest in any and every exotic subject—UFOs, ESP, psychotronics, antigravity devices, near-death experiments, psychology warfare and nonlethal weaponry. John Alexander utilizes the bank of information he has accumulated to try to develop psychotronic, psychological and mind weaponry. He began thinking about nonlethal weapons a decade ago in his paper, "The New Mental Battlefield." He seems to want to become a 'Master.' If they ever succeed in this ambition, the rest of us ordinary mortals had better watch out. ●

More on KAL

There is another view of KAL 007 [Paranoia Issue 4] that might interest your readers. It can be found in Fletcher Prouty's 1992 book, **JFK: The CIA, Vietnam and the Plot to Assassinate John F. Kennedy**. Prouty maintains that the story of KAL 007 landing safely at Sakhalin island was planted by the CIA to get the Japanese to recall their Air-Sea Rescue fleet. "With that essential diversion safely accomplished, the government could announce any scenario it wanted," he says. He does not offer a real reason for the shootdown, but others have suggested that the plane was deliberately flown into Soviet airspace so that the space shuttle Challenger, in orbit above the precise location, could monitor Soviet defenses. If the plane did land safely and Larry McDonald lives, the Russians are welcome to keep him in my book. But if KAL 007 sacrificed 269 lives for the sake of collecting some defense data, then we all have cause to be paranoid.

Persistent reports of UFO activity emanating from the small town of Fyffe, Alabama in 1989 prompted that state's senate to declare Fyffe "The UFO Capital of Alabama." The good folks of Fyffe and other small burgs tucked away in the northeast corner of this state accepted their newfound celebrity with aplomb, considering the whole affair quite harmless.

The perception of harmlessness changed quite rapidly with the discovery of the first mutilated cow in 1992. There have been at least twenty-five similar incidents since then. These cattle mutilations fit the same *modus operandi* as thousands of others that ufologists and police departments have investigated since reports began in 1967. Certain features and details of the mutilation scene remain constant. There are never any signs of struggle or predatory animals surrounding the *corpus bovine*. Internal organs, patches of skin, even teeth are taken with surgical precision.

Typical is the case of Margret Pope from the nearby town of Geraldine. Close inspection of her dead calf revealed that something or someone had sliced off its udder. It also had a four inch circular incision in its side with a matching circular cut on the left jaw. Pope was quoted as saying, "There was no sign of a struggle. No blood, nothing. Just laying there, with its parts cut out. I think it's UFOs, because of lots of lights in the sky, no disturbance on the ground. And the cuts were too precise. But you just watch who you say aliens and UFOs to. I don't want to be made fun of. We're not weird. And this isn't fun."

Many claim that the lights that Pope refers to actually belong to mysterious helicopters, which have been seen landing out on the pastures at night. This has led some to speculate that these mutilations are the handiwork of government agents performing some sort of grisly field experiments. It should be noted that the appearance of helicopters in this case does not necessarily preclude the UFO theory. In fact, many documented UFO sightings have also involved the enigmatic presence of unmarked helicopters, often acting as escorts for the flying disks. Eyewitness accounts often note the presence of well dressed men aboard these copters. In past UFO encounters, some witnesses and contactees have reported visitations from

"Men In Black" who attempt to threaten or cajole them into silence. These MIB's are usually reported to have a "pasty" appearance to their faces, as though they are wearing heavy stage make-up. 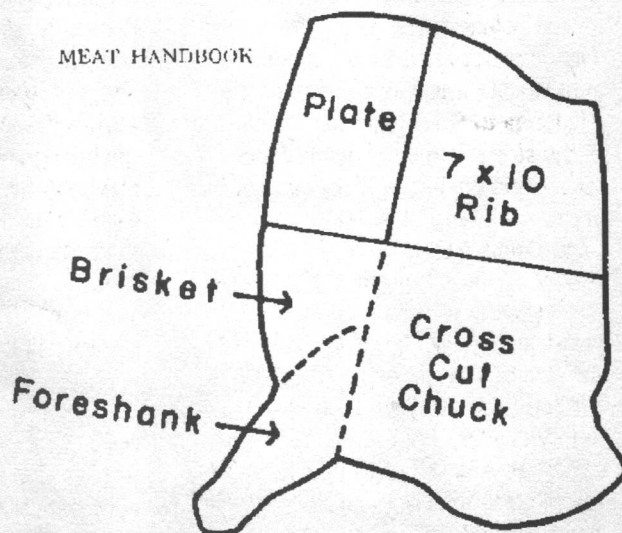


FIG. 13.1. BEEF FOREQUARTER—PRIMAL CUTS CHICAGO-STYLE

universities, thousands of Protestants were banished, and those that remained were deprived of their civil rights."

The use of religious ritual as a battle standard was combined in the Church's fostering of devotion to the rosary, a necklace of beads on which the Hail Mary is recited over and over. The exact point of entry of the rosary into western Christendom is not known, but is generally attributed to the crusaders. By the end of the twelfth century, Marina Warner writes, "the Franciscans and Dominicans had spread the use of the rosary among the laity and encouraged its use among the illiterate to obtain the Virgin's mercy and protection." By the fifteenth century the practice had spread zealously throughout Europe.

The notorious witch-hunter Jacob Sprenger, formed the first lay confraternity devoted to the rosary in Germany in 1475. After Pope Alexander VI, the first pope to mention the rosary, gave his official approval in 1495, the practice spread like wildfire. In 1573, Pope Pius V instituted a feast of Our Lady of Victory to commemorate the defeat of the Turks at the battle of Lepanto, a victory that "destroyed the power of the heathen Turks in the Mediterranean." The pope believed that by the rosaries offered by the confraternities of Rome, the Virgin's intercession had given the battle to "God's side."

This proclamation affirmed the sacred power of the rosary for all time. The evidence cited by the pope to authenticate this was a vision of the Madonna to Saint Dominic. According to the story, while conducting the inquisition against Albigensian heretics at the beginning of the thirteenth century, Dominic had been given the rosary by the Virgin herself.

Her claim to the divine through the physical "immaculate conception" of the Son of God gave the Blessed Mother powers of intervention, or, the ability to work both sides. The Son could not refuse the Mother's imploring pleas to intervene on behalf of her favorite children, so long as they utilized the power of the magic beads.

Thus, the direct intervention of the Virgin in human affairs gave the rosary a claim to divine ordinance. Nineteenth and twentieth century visions of the Virgin Mary have since confirmed her special love for the rosary. At both the visions in Lourdes and at Fatima, the apparition urged the recitation of the rosary and pilgrimages are now committed to the recital of the Hail Mary.

Communism and the Anti-Christ

The Virgin and the rosary have over time become associated with the Catholic struggle against its arch-enemies. In 1717, the feast of the Rosary was extended to the entire Church after the defeat of the Turks at Petrovaradin (now in Yugoslavia). Exactly two hundred years later, during the visions at Fatima, Our Lady of the Rosary spoke of an Anti-Christ. Lucia dos Santos revealed in 1927 that the Virgin had warned:

I shall come to ask for the consecration of Russia to my Immaculate Heart...If my requests are heard, Russia will be converted and there will be peace. If not, she will spread her errors throughout the entire world, provoking wars and persecution of the Church...But in the end, my Immaculate Heart will triumph.

In the propaganda that followed the visions, this Anti-Christ was identified with Communism and used to spread fanatical anti-Communist paranoia. Many Catholics believed that the Fatima vision prophesied the Second World War and, further, that it influenced the pope's attitude toward Russia. In 1942, Pope Pius XII dedicated the world to the Immaculate Heart of Mary, and soon afterwards instituted a new feast of that name, celebrated on August 22. According to Marina Warner, the horror with which the Vatican viewed Russia contributed to its alignment with Nazi Germany, Russia's enemy. As one Catholic author stated: "Against Satan in his red threats, we have Mary."

When Statues Cry

Now we arrive at the ultimate question: Do the apparitions "cause" war, as George Andrews and others have suggested, or does war "cause" the apparitions? The psychoanalytic aspect of these phenomena is studied

by Michael Carroll in *The Cult of the Virgin Mary*. He suggests that, when populations are faced with danger and destruction, it is understandable that an attempt to reduce anxiety might occur. Religion is the oldest remedial standby for the lack of control people feel at certain times. For instance, the arrival of French troops into Italy under Napoleon in 1796 instigated a rash of "miraculous events," mostly associated with the Virgin Mary. Statues and images of Mary began to do strange things: she cried, she turned luminescent, her eyes opened and closed, and fiery sparks flew from her eye sockets. The Blessed Virgin "coming to life" would reassure people on the verge of calamity that "the forces of the supernatural world are on their side."

Likewise, an apparition appearing in the sky to several children in Pontmain, France on January 17, 1871 occurred in the final stages of the Franco-Prussian War, after France had suffered a series of defeats. As Michael Carroll explains, "Paris had been under siege since September and under bombardment since December...the city's population was starving and on the verge of surrender..." In addition, thirty-five males from the small town had gone off to fight the Prussians, who were expected to enter Pontmain in a day or two. This anxiety-ridden community would be especially receptive to believing that clouds in the shape of the Virgin Mary, and messages written underneath, meant that their boys would come home safe and all would be well. Also, it is important to note the attention and control that children command from adults in these "can't you see it?" scenarios.

Giving George Andrews the last word, he suggests that we should "not refrain from asking any questions that come to mind when presented with paranormal phenomena of a religious nature, nor go to the opposite extreme of systematically debunking religious manifestations." We should, then, approach these phenomena with an open mind, rather than through a screen of conventional preconceptions. ●

The Cosmic Pulse of Trevor James Constable

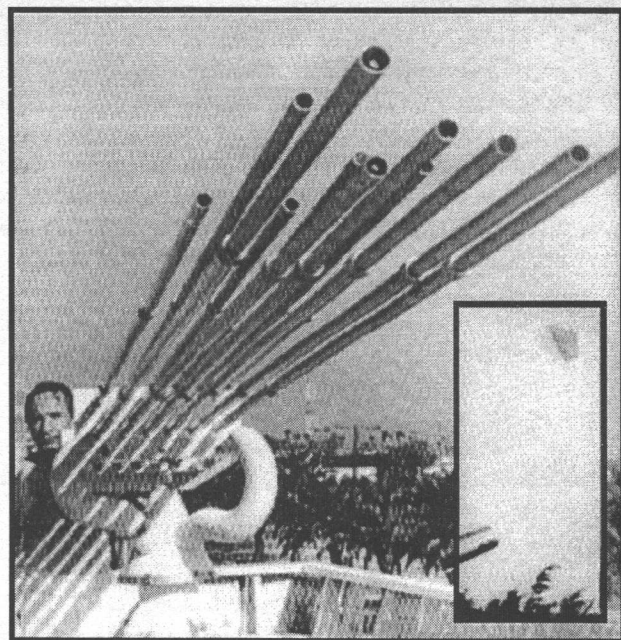

Plasmoids That Live in the Sky might be the title of a campy fifties sci-fi movie, but in this case it's the subject of the life work of Trevor James Constable, and the result of years of scientific research gathered and corroborated worldwide and presented in his book *Cosmic Pulse of Life*. When he is not documenting the existence of macrobacteria on infrared film, Trevor is doing some serious "cloudbusting" experiments, explained in his video *Etheric Weather Engineering on the High Seas* and in a forthcoming book. Here, Trevor talks about fringe science, the invisible realm, and the flummoxing of earthling power elites by evil entities having no business doing business in this dimension.

Mr. Constable, I read that your book, *Cosmic Pulse of Life*, first published by Merlin Press in 1976, "shocked the publishing industry" because of its criticism of official science, a "science" which has been unable to make a significant finding in the area of UFO phenomena in over forty years.

Well, first of all, the shock which is alleged to have occurred in the publishing world is, I think, exaggerated. [However,] I think it had a serious impact on the UFO world, because people suddenly found that a large mass of evidence had been gathered, and it was original evidence. It hadn't been put through any kind of government or scientific strainer where the life could be knocked out of it. This indicated that the UFO thing was something immeasurably more complex than just a bunch of entities climbing into spaceships over on Venus or Mars or somewhere else in the universe and traveling over here to take part in the life of the Earth in some incomprehensible fashion. It showed that there was a biological dimension to the whole thing, and this in turn is the key to the general sequestration of the whole approach [of] *Cosmic Pulse of Life*. It is true that, since the days of Kenneth Arnold, when UFOs first entered the public domain, there has been no single significant finding in the area of UFO phenomena.

Yet, answers seem to be closer when working with the theories of Wilhelm Reich and others considered to be in the realm of "fringe" science.

That is a fact. It is true that answers are closer when you work with the theories of Wilhelm Reich. Because you must remember that Reich's work is rooted in practical matters. And his discovery of this biological entity, a specific biological energy that he called orgone, set the entire question of vital force on a completely new basis. Up until then, it had been sort of a philosophical will-o'-the-wisp. Reich changed all that, and by using modern instrumentation and modern methods he presented evidence of the existence of this biological

power, the thing that makes every heart beat and which nobody, but nobody, in the entire reaches of official science has yet seen fit to address.

Why do the High Priests of Science need to protect the materialist worldview at all costs?

[Imagine being] raised from infancy with chains of interlocking and interlacing views

laid upon you and made a part of your method of functioning and viewing creation, and all this excludes the idea of a biological energy; there isn't any pulsation, it's just chemicals. Then all of a sudden someone comes along and says "Hey, wait a minute, there is a bio-force!" And it's physical, it's accessible. You can demonstrate it! Well, what happens is everything that you know, everything that you have

been taught, everything that makes up the cement of your whole world view is subject to a very serious disillusionary attack. That is the reason why they clamp down in official scientific circles at the very suggestion of specific biological energy, orgone, or as we refer to it in my phase of weather engineering, chemical ether.

Explain your theory that some UFOs are "plasmoidal living organisms" which are native, albeit invisible, to our atmosphere and how you came to realize that these biological entities could be photographed using infrared film.

As explained in my book, when Dr. Woods and myself started this work back in 1957, we went after spaceships like everybody else. We had no consciousness whatever of there being anything else. And when we used infrared film for the purpose of pursuing objects that were repeatedly seen and reported worldwide as having come from and often returned to an invisible state, we recorded not so much spaceships as these strange plasmoidal living organisms. And there were too many of them to be ignored, or blown away as aberrations or the results of faulty processing: the normal excuses that are made for these things.

And, we were not at all happy at the time that we obtained the first evidence of the plasmoids; not at all, because we wanted spaceships. We were in that same hard, mechanical idea about these things, that someone had built these things over in Venus or Mars or elsewhere, and they jumped in them and flew over here; and they were cheek by jowl with us on Planet Earth. At least that's what we wanted to be able to prove.

In actual fact, using infrared film, which extends the range of the human eye far beyond what the eye itself will register, we got something else. We got these living organisms, and we got lots of them. And since that time lots of other people all over the world have got them. I just got a letter from a gentleman who photographed shoals of these things over the Western Australia desert. So, they are there and they have always been there. They are not from anywhere else, they are what we might call the upper dimension of our physical world. They have been referred to as macrobacteria: the counterpart at the upper border of physical nature of the microbes that infest the sub-sensible realms of physical nature of which we were earlier not aware. We are aware of them now, because centuries ago the microscope was discovered and an optical limitation was removed. Infrared film does the same thing at the upper border of physical nature, but the things that are found, instead of being extremely small, they are very vast, sometimes forty or fifty feet across.

So everything fits from a polarity point of view, and finding out that these things could be recorded with infrared film was simply accidental. It was not something that was planned, programmed or intended. But we didn't shrink from what we found, we pursued it through the years and we never found any reason to revise it. The work that was done subsequently in Italy twenty or thirty years later served only to verify it, as has the work done by other people in Romania, Australia and elsewhere. All through the years, all of this has been mercilessly crushed by the people in the UFO field who feel that they are somehow serving the truth by killing something that's alive.

How does orgone energy ("the ether") relate to your exobiology theory and your work in Reichian cloudbusting?

I would need a three or four hundred page book to describe my work in Reichian cloudbusting. In fact, a fairly comprehensive volume on this is being prepared now and is going to be published by Borderland Sciences Research Foundation sometime this year. So it is

futile to attempt an interview at this time to describe my work. I haven't done Reichian cloudbusting in a while; I do things in a completely different way, I use geometric forms. I do not use the old time Reichian cloudbuster anymore, although I made good use of it for many years.

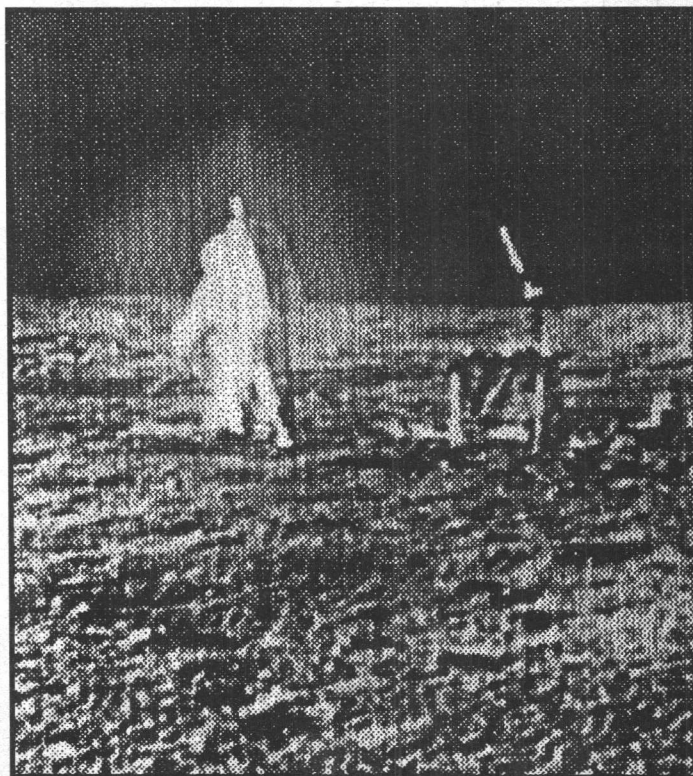
I can only say it is impossible to assemble any kind of valid exobiology theory if you do not first understand why it is that everything living on this Earth, from the microbe to the mastodon, pulsates! That's the thing that you have to elucidate first.

If Reich had lived beyond the mindset of the fifties, do you think he would have changed his view of UFOs as "machines from another planet?"

Sure, I think that he would have readily expanded his initial conception of UFOs as machines from another planet. However, I want to point out something significant here, and I never tire of re-emphasizing this, because it never seems to sink in, that it's not a question of having spaceships or plasmoidal organisms: you have both! There are at least two dimensions to the UFO phenomenon. One is the spaceships idea and the other is the living organisms. And because in the mode of their manifestation these two aspects of the UFO phenomenon are mutually confused, nobody seems to have been able to straighten it out, except me.

People believe that you've got ships from other planets and you can't have anything else. If you're going to have biological critters in the upper atmosphere, well then you can't have the other. You've got to have both. And what this does is expand your consciousness. And that is one of the good things about this whole phenomenon in all its diversity. You've got to get your consciousness expanded and operating

along new lines. The old ways are dead and gone, like this civilization of ours. I certainly believe that Reich, had he lived, would have expanded his understanding of these things, because he had the mentality and the observational power to do so. But, you can't expect very much of a man at a critical time of his life when he was being harassed and hounded by the medical profession, the psychiatric profession, the FDA, and the courts. You can't expect much from a man who is under that kind of pressure.

What was your theory of space and flying saucer propulsion in 1958, when you wrote your classic book *They Live in the Sky*, and how have your theories changed since then? Were you influenced by Wilhelm Reich's work (described in his book *Contact With Space*) and were you pursuing a similar path in your research?

My theories in 1958 I cannot recall for you in detail or compare them to the views that I hold now. But basically there wasn't a great deal of difference, it's just that in the meantime more and more evidence has accumulated. The basic idea that the source of all these things is the invisible has continued to gain momentum and continued to gain status because of the derelictions and inadequacies of the formal theories. Of course I was influenced by Wilhelm Reich, but not until after I had made my original contribution with *They Live in the Sky*. I did not know Reich existed or I might have written that book differently. That influence came along later and is part of subsequent development worked out in *Cosmic Pulse of Life*, which correlates with work from Romania and Italy.

Does the appearance of UFOs in the skies have anything to do with the "destruction of the industrial, financial, moral and spiritual fabric of the USA?" Is the American decline an engineering job on the part of an otherworld intelligence which somehow rules the planet Earth through its top power elite?

Everything that has happened and everything that we are seeing now that shows this ongoing downtrend in American life, the industrial, financial, moral, spiritual and political fabric of the USA disintegrating, this is all being brought about by people who are in the body with us. There is no question about that. This is a function of conspiratorial activity. It is the inspiration of it that comes from other planes; the guidance of it. And very often these people have no conception whatever that they are under psychic control and are being directed from other planes to do these things by entities who cannot manifest here themselves. That, in my opinion, is the reality of any infiltration of the top power elite which is, by the way, not something visible to the ordinary citizen. It is hidden also, as most people know, down at the level of the Presidency. Somebody like George Bush, for example,

would be probably at about the fourth layer down in the power structure. The entire world is run from the shadows and it is well to keep that in mind.

In your book you state that scores of people believe there is some undetermined energy principle behind the UFO phenomena, yet the billion dollar NASA budget does not contain a dime for UFO investigation. Why does the government bury its head and continue to pretend there is nothing out of the ordinary happening in the Earth skies?

Of course it is true that there is an undetermined energy principal behind the UFO phenomena, and NASA has no hesitation in squashing billions which it doesn't have to earn, and spending nothing to investigate UFOs or even have a small project on them. Nothing. The reason for it is very complex and relates to the energy question. We know from Reich's work that this energy will run motors, and if you can run motors out of the atmosphere without having to hook into the power grid, that is a disaster for the world's power structure. The control of energy is the control of people. It is the control of economies. So the breaking of the fuel monopoly is reason enough for governments who are run from the shadows and steeped in corruption to do nothing to elucidate the principles of energy that are behind UFOs.

Discuss your statement that "unseen extraphysical entities have expanded their manipulations and destructive capabilities on the physical plane via humans they can control." Do you see this as an occult influence in top levels of world secret government?

Extraphysical entities with an interest in the earth plane can only manifest here through correspondences. They do not come down and land on the White House lawn, because they do not belong to the Earth plane. So what they have to do is find correspondences within those in authority and control what they can access and, by those means, infuse their malevolent ideas and purposes into the civilization.

On the simplest and broadest basis you may ask yourself why it is that the US, despite having had the most successful and largest expansion of production in the history of the world in World War II, grew by 1950 to become a phenomenally prosperous country, and since that time has been run down mercilessly to a shadow of its former self, incapable of carrying out even many of its own defense processes, can't forge its own aircraft carrier anchor chains, stuff like this. Straight down from a high point. Despite the prodigious proliferation of computers and other things that are supposed to improve productivity and increase the standard of living, our standard of living goes down. The chief agency and the chief link between the ruling authorities, the real rulers here, and those in the extraphysical realm who are utilizing them, is the dishonesty of the men on the physical plane. That's what opens them to access from the unseen.

In your book you talk about Hitler and the occult influence in

the machinations of World War II. Most people do not believe in "magic," but is it more simply understood as a series of deals made with other-dimensional entities who shouldn't be trusted?

I referred to Hitler merely in passing and pointed out that he was essentially the vehicle of Lucifer and it was a Luciferic activity that he headed in Germany. Anyone who does not understand the difference between Lucifer, Ahriman [the evil deity in the Zoroastrian religion] and Christ will never know anything about this world. We in the USA are fully in the clutches not of Lucifer but of his opposite, Ahriman, and the Ahrimanic powers in general. This is what you are dealing with in the so-called phenomenon of the Greys, all of which is taking place in the darkness. It's a significant point, it's a signature. Twelve linked to Watergate died in mystery crash

What really happened during the infamous "Watergate plane crash" at Chicago's airport on December 8, 1972?

[Mentioned in Joffre Stewart's piece in the Spring 1994 Paranoia -Ed.] United Airlines flight 553 out of Washington, D.C. exploded while landing in Chicago. Aboard were 12 people who were connected in some way to the burgeoning Watergate scandal. Among the victims was Dorothy Hunt, wife of former CIA man (and Watergate burglar) E. Howard Hunt. Evidence indicated the plane was sabotaged, but independent investigator Sherman Skolnick made headlines when he charged that the sabotage had been covered up by the government.

Skolnick discussed his findings when he was the guest on the December 23, 1993 broadcast of *The Spotlight's* nightly radio call-in talk forum, Radio Free America, with host Tom Valentine. At the time of the crash, Valentine was a journalist working in Chicago and became acquainted with Skolnick during the furor over the loss of flight 553. According to Valentine, "It was the flight 553 affair that really convinced me this government was corrupt. I was a meathead and believed in our government. I knew the medical Establishment was corrupt, but this really convinced me the government was corrupt." Skolnick, who has been a regular guest on Radio Free America, and who is an adviser to Liberty Lobby's Populist Action Committee, has a recorded five-minute commentary (changed several times a week) that people may call 24 hours a day at regular long-distance rates. The number is (312) 731-1100. Skolnick's recorded message brings periodic updates on matters the investigator and his research team are working on. An edited transcript of Valentine's interview with Skolnick follows.

The Watergate plane crash is the first investigation you and I worked on together.

This subject is one of the great forbidden subjects of this country. You are not supposed to talk publicly about airplanes that have been sabotaged. If sabotage is ever brought up, it's always in some foreign country where a bomb blows up the airplane.

Then the loss of the United Airlines flight 563 was not just fog or pilot error or something like that.

In the history of aviation there have been a number of situations where there was actual sabotage—not necessarily a bomb—and that sabotage put the plane down and killed people for political reasons. I started writing a book about airplane sabotage right after the plane crash. I called it *The Watergate Plane Crash*. The reason why was because on this one plane were 12 people connected to the Watergate affair.

The disaster happened exactly one month after Richard Nixon had been re-elected. The Watergate affair had started, but it was not widely known at the time. Former CIA man (and Watergate burglar) E. Howard Hunt, part of the so-called White House Plumbers, was under arrest. It later came out that Hunt was threatening to blow the lid off the White House if Nixon didn't take care of him. Hunt wanted \$2 million. What Hunt reportedly had was information tending to show that Nixon, who was in Dallas at the time John F. Kennedy was murdered, was complicit in the assassination. Hunt's wife Dorothy was carrying around "hush" money to various witnesses in an effort to silence them about the Watergate affair. She was on flight 553, and this time she was traveling under her own name. She was so concerned about the baggage (which contained \$2 million worth of cashier's checks and money orders, which some astute people could have traced back to the Nixon White House) that she bought an extra first class seat for her baggage (and the valuables therein). The press later said there was only \$10,000 in her possession, but that was false.

We know about this because of records of the National

Transportation Safety Board which had the manifest of the airplane. A year after the crash, an air baggage robbery gang was prosecuted in the case of U.S. vs. Joseph Cirelli. I was the only journalist who covered the hearing. There an FBI document came out showing that this criminal mob, a Mafia family, had somehow penetrated the crash zone, stolen Mrs. Hunt's luggage, and were fencing \$2 million worth of valuables for \$5 million. Why? How? Because these money orders could be traced back to the Nixon White House and as a consequence were worth more as blackmail information.

The plane was steered into the ground. It's not technically accurate to call it a "crash." The plane was pancaked and then caught on fire. Now bear in mind that every airport has what they call the "outer marker" which enables the pilot to know his altitude. The outer marker was working for the plane ahead of flight 553 and for the plane behind flight 553, but as 553 approached the marker, it mysteriously went out. Now here's the mystery. There were 150 FBI agents waiting on the ground. The government's own documents show that the fire department responded within a minute and a half. The FBI headquarters in Chicago is downtown, 12 miles away. If they got on a helicopter off their headquarters roof they couldn't have made the 12 miles faster than the fire department. However, when the fire department came near the crash zone, the FBI had cordoned off the zone and kept the firefighters from approaching the plane. A number of police officers were also held back and kept in a nearby park and not allowed to approach the plane. The only ones who were able to approach the plane were the FBI.

I found out about this later, and for several months thereafter some of the press called me a liar, but finally a letter came from the acting director of the FBI, confirming that I was correct, and that there were a large number of FBI people there. He cryptically put in his letter that it was justified because they were investigating "airline piracy." Which means, in other words, was somebody trying to steal luggage on that plane, en route, and therefore the FBI was waiting? We believe the FBI was waiting there to arrest Mrs. Hunt because of the blackmail scheme. I went to the National Transportation Safety Board [NTSB, which investigates crashes], and they set up shop in Chicago and held a hearing in the spring of 1973. They concluded there was ice on the plane's tail. I interviewed a number of their witnesses and found the NTSB did not bring out the correct facts. I brought a lawsuit against the NTSB, and, unknown to United Airlines, my friends liberated the entire government file of 1,300 documents and pictures, and we knew it was sabotage from the government's own records. I got on a lot of radio talk shows at the time, but I didn't tell them that we had the entire file. United Airlines got upset about me being on radio saying

these things, and they demanded that the NTSB reopen the hearings to prove that I was a liar. At the two days of hearings in June, 1973, at which time they expected to prove me a liar, some 250 reporters showed up from all over the world. CBS had closed-circuit video coverage for their higher-ups since one of their reporters, Michelle Clark, had been sitting next to Mrs. Hunt.

Now remember, United Airlines didn't know that my friends had swiped the NTSB files on the crash. So when they turned on all the lights for the videotaping process (for the CBS executives), at that moment I opened up my suitcase at the hearing and spread all of the documents out on a great table before me. There was a panel of five NTSB members there. I said, "Now here's your entire file. I admit that I swiped it. If you want to arrest me, do it right now in front of all of these reporters." For two entire days I showed from their own records that they knew it was sabotage. The *Chicago Tribune* took a picture of me at the table, but they chopped off the portion of me pointing at the documents, and they ran a headline saying "No proof whatsoever of sabotage."

The Associated Press's national wire ran an objective story, to their credit, saying that I presented a "heavily documented case of sabotage regarding a flight where Watergate figures died." Only one newspaper in this country, however, ran that AP story. It was a newspaper in Seattle. All of the other newspapers disregarded that major story carried on the AP's national wire (known as the "A" wire, which carries all the major stories). The reason for this is simple: United Airlines was the largest airline in North America, and were this to have been publicized they could have lost their certificate to fly. Edward Carlson, United Airlines board chairman, was very close to Nixon. Now as I mentioned, CBS News reporter Michelle Clark was on the plane beside Mrs. Hunt. She was also a friend of Rep. George Colins (D-Ill.) who also died on that crash. At the later hearings, we had the chief assistant of Congressman Collins. Apparently Collins had somehow found out about the Watergate affair before the break-in and had told Michelle Clark about it, and she knew about it. What happened was that certain people decided to sit on matters for their own financial gain.

Here's briefly what happened. I had a mutual friend who knew Miss Clark's family. They said

that since Michelle had died in the crash, they were going to blow the lid off United Airlines, which is owned largely by the Rockefeller family's Chase Manhattan Bank. They were also going to use this information against CBS (Michelle's employer) which was part of the cover-up. Using my material they got what was said to be as much as a \$5 million settlement from CBS by remaining silent about what the family found out. Cardiss Collins, the widow of Congressman Collins, took his place, and from my information she was in favor of squelching the whole affair.

Reports showed that [Watergate burglar E. Howard Hunt's wife] Dorothy Hunt and the other Watergate people on board the flight had very high cyanide levels in their bodies

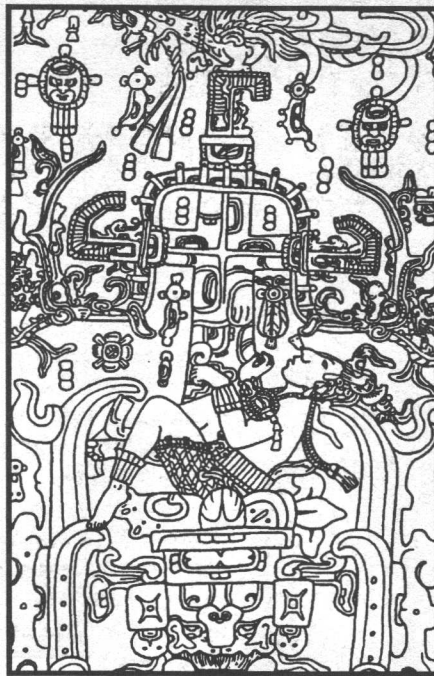

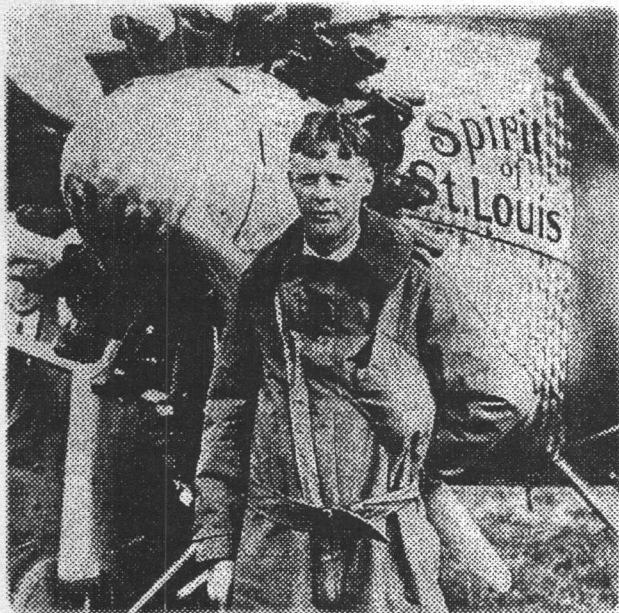
Baktun-12

THE LINDBERGH KIDNAPPING HOAX



Book Review: **Crime of the Century: The Lindbergh Kidnapping Hoax.**
Gregory Ahlgren and Stephen Monier. Branden Publishing, 1993
21.95

Before Polly Klaas, there was Charles Augustus. The twenty month old son of aviator hero Charles Lindbergh and his wife Anne was abducted March 1, 1932. Seventy-two days later, the baby's body was found in the woods a short distance from the Lindbergh's house near Hopewell, New Jersey. The crime and subsequent trial were a media circus, the forerunner of today's tabloid TV. Newspapers hyped it as the "Crime of the Century." Lindbergh was assisted in his investigation of the crime by the colorful "Wild Bill" Donovan, who would go on to lead the Office of Strategic Services, precursor to the CIA. Even imprisoned gangster Al Capone offered his assistance in solving the case (the offer was rejected,) and some couples actually wrote to the Lindberghs offering their own children as substitutes. As the authors note, "Everybody was getting in on the act."

A 2½ year NJ State Police Investigation led by Col. Norman Schwartzkopf (father of the Desert Storm General) led to the

conviction of Bruno Richard Hauptmann. As the authors demonstrate, the evidence against Hauptmann was at best circumstantial. In fact, it's now clear that there was a conspiracy to railroad the immigrant German carpenter. But Ahlgren and Monier take the conspiracy scenario further: They argue that the entire kidnapping was a hoax, orchestrated by Lindbergh to cover up his negligent murder of his son. Like the evidence against Hauptmann, the evidence against (Un-) Lucky Lindy is circumstantial, though surprisingly persuasive. For

example:

- Lindbergh ordered his son cremated without an autopsy.
- The evening of the abduction, Lindbergh had been scheduled to make a New York appearance. The fanatically punctual flyer never showed up, even though the event took place hours before the kidnapping was discovered. He never explained where he was during that time.
- That night, the meticulous Lindbergh appeared in the Hopewell home driveway 45 minutes later than normal, honking his car horn as if to make sure his apparent arrival would be noticed.
- It was Lindbergh who "discovered" the alleged ransom note the night of the kidnapping, on a nursery window sill. His wife and household staff, however, had seen nothing there when the abduction was first discovered.
- The kidnapper not only knew which room Charles, Jr. was kept in; they also knew which single window of all the room's latched windows had a defective shutter that allowed it alone to be opened from the outside. And they somehow knew that the family would be at the Hopewell home that night, a change from their established routine of spending weekdays at their second home.
- When nursemaid Betty Gow and wife Anne discovered the empty crib, their immediate

thought was that Col. Lindbergh himself had done it, because he had staged a "kidnapping" of the child two months earlier. (After throwing the household into a panic, a laughing Lindbergh had finally admitted it was a hoax.)

After establishing the Colonel's penchant for such disturbing and cruel "practical jokes" (a habit he happened to lose after the alleged kidnapping,) defense lawyer Ahlgren and police official Monier present their scenario, summarized here:

Lindbergh arrives home as usual, at approximately 7:45. He parks out of sight of the isolated home. Planning to carry out another kidnapping "joke," he uses a makeshift ladder to enter the nursery and take his baby. But on this windy and rainy night, the top

rung breaks and the adjoining side rail of the ladder splits. (This is how the ladder was found.) He drops the baby, crushing his skull. (During each of several police reenactments, an officer starting down the ladder slipped and dropped the bundle representing the baby.) He takes the body a few miles south and leaves it in the woods. (Interestingly, suspect Hauptmann lived north of the Hopewell home; so why would he have risked traveling out of his way and then doubling back, prolonging his

time at the crime scene?) He then drives up to the front of the house at 8:25, honking his horn as if to ensure that his "arrival" be noted. At approximately 9:15, he claims to hear a suspicious noise outside, although wife Anne at his side hears nothing, and their high-strung terrier Wahgoosh never barks. Lindbergh plants the "ransom note" soon after the disappearance is discovered. The ransom note reads in part:

Dear Sir! Have 50.000\$ redy 25.000\$ in 20\$ bills 15.000 in 10\$bills and 10.000\$ in 5\$ bills. After 24 days we will inform you were to deliver the money. We warn you for making anyding public or for notify the Police The child is in gut care.

By using some simple German ("gut" for "good") and spelling some words as he believed a German immigrant would pronounce them ("anyding" for "anything"), Lindbergh attempted to draw suspicion away from himself and onto South Jersey's large immigrant population. As the authors astutely point out, "A German struggling with the English language often says 'd' instead of 'th' as the 'th'"

sound does not exist in German...(but) a German would not spell a word with a "d" instead of a "th"; it is not that he thinks the word is spelled with a "d"; rather, he knows (how) it is spelled but he simply cannot pronounce the "th." The note, then, is an attempt of someone to imitate a German immigrant's speech.

The authors do a thorough job of cataloging



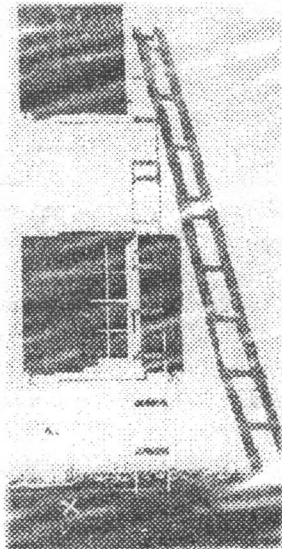
The baby celebrates his first (and only) birthday

the many disturbing issues surrounding the trial of Bruno Richard Hauptmann. For example,

- The ransom note and subsequent letters referred to "we," but Hauptmann was the only person charged.

- Hauptmann was a carpenter by trade. Yet the kidnap ladder was of an unusually sloppy and amateurish construction.

- Equally sloppy was the way Hauptmann was "identified" in a police lineup consisting of the tall Hauptmann and two short and stocky policemen of Irish descent, one still in uniform.

- Hauptmann, who spoke only broken English, was not afforded a translator during the trial. The authors present a clear-headed and reasonable analysis. They are not conspiracy-mongers. For example, they report that the corpse found in the woods was 33½ inches long, while Charles, Jr. had been measured by a doctor just two weeks before the kidnapping at 29 inches. Was the body of another baby placed in the woods? Digging a bit deeper, they learned that the original doctor records

actually indicated a height of 2'9", or 33 inches. The foot abbreviation (') had simply been lost in subsequent reports. In addition, they take the suicides of two suspects during the investigation at face value, and resist making dark but unsubstantiated speculations.

However, the authors cannot, and to their credit do not attempt to, use the substantial evidence that Hauptmann was framed to bolster their claim that Lindbergh was the real kidnapper. In this sense, the large part of the book dealing with Hauptmann really does nothing to advance their theory. Also, they fail to adequately explore the possibility that the kidnapping was an inside job, carried out in part by a household staff member.

In addition, the narrative drags in spots, as when the authors provide too much detail in their critique of the testimony of "wood expert" Arthur Koehler. (Sample: "He had arrived at the rate of 232.5 feet per minute by assuming that all top cutting heads revolved at 3,000 revolutions per minute... A speed of 232.5 feet per minute would in fact result in a spacing of ninety-three hundredths of an inch each revolution..." Well, you get the idea.) Lost in all this sawmill esoterica is the stark fact that the ladder rail that police said matched a floor

Wild Theory?

The theory advanced in *Crime of the Century* isn't as far-fetched as it first sounds. Consider the fact that roughly 70% of all homicides of children aged 2-9 are committed by one or both parent. Also consider these three cases:

- In November of 1984, a Pawtucket, Rhode Island couple alleged that someone had kidnapped their infant son from a second story window. Two days later, the child's body was found nearby. The police soon determined that the child had died as a result of parental abuse, and that the kidnapping had been fabricated.

- On February 2, 1990 an upstate New York mother reported her twenty-three month old daughter as kidnapped. Eventually, she led police to the body and was convicted of manslaughter.

- In April of 1993, a Canadian couple reported their infant daughter kidnapped in New York's Central Park. Soon after, they admitted they had found their daughter dead, and staged the kidnapping hoax to avoid being blamed for the death.

board in Hauptmann's attic was in fact thicker than the board it was supposedly cut from.

Which is just one more fact that suggests that Hauptmann's state execution, rather than the kidnapping itself, was the true Crime of the Century. ●

The title for this review is taken from a statement made by Attorney General Janet Reno regarding the reason behind the government's infamous 1993 raid on the Branch Davidian church at Mount Carmel (near Waco, Texas.) In this instance, it appears that the federal government decided to show "concern" for the children by murdering them. If the reader feels that the word "murder" is too strong, then a viewing of **Waco II: The Big Lie Continues** is in order. This latest video by Linda Thompson goes far in revealing not only the major players involved in this atrocity, but also names those who are quite willing to further their own political careers by assisting in the coverup. Among the latter are the major media outlets. Most of the footage seen in this video was retrieved

from satellite feeds provided by the major networks. These supposed guardians of democracy have seen these images but they have not shown them to us.

For instance, the official version of the story states that the initial raid on Mount Carmel failed when federal agents came under the superior fire power of a Davidian ambush. However, the video footage of the event shows BATF (Bureau of Alcohol, Tobacco and Firearms) agents firing wildly into the front of the house. There is no return fire on the part of the Davidians. The video then goes on to show the BATF agents carrying the lifeless body of 8 year old Cyrus Koresh. It was his misfortune to be playing in his own front yard on that fateful day. Only after David Koresh was fired upon while appealing for calm did the Davidians take up arms to protect themselves. During this initial assault, Koresh tried to reason with the authorities by dialing 911.

Technically, the Davidians had a legal right to defend themselves against the BATF. According to Texas penal code Subchapter C, Article 9.31-Self Defense:

"Use of force to resist arrest or search is justified if an officer uses greater force than necessary to make the arrest or search" or "when the actor reasonably believes the force is immediately necessary."

Unfortunately for the Davidians, right and reason did not apply in

this case. It did not even matter to the authorities that the action taking place was being perpetrated under a misdated warrant. With the help of the military's Psychological Operations Department, the Davidians had been sufficiently pre-demonized. This was accomplished by having the local Waco **Tribune-Herald** run a collection of ad hominem against Koresh entitled "Sinful Messiah." This Psy/Ops work was conducted throughout the ensuing standoff by the implementation of "non-lethal" weaponry. [See related article "Psychic Warfare and Non-Lethal Weapons" on page 13.]

These mind control techniques were documented in Thompson's **Waco the Big Lie** and are studied in more depth in **Waco the Big Lie Continues**, along with evidence of the direct involvement of Janet Reno in these programs. Adding insult to injury, shortly after the FBI incinerated the Branch Davidians for having the nerve to embarrass the Bureau, one of the major networks produced an official movie of the week version of what happened. This is standard operating procedure for the military propagandists, according to Psy/Ops Manual, Army FM 33-1; P10-4: Motion Pictures: "Most children and a high percentage of adults accept without question presumably factual information presented in films..."

In the words of Linda Thompson, the "free press consists of those handpicked to tell you lies." All those not handpicked are threatened and beaten by military troops, as this video chillingly shows. What else can be expected when the media is kept at a distance of two miles and spoon-fed the government line by mouthpieces like Bob Ricks. Considering that much of the footage in **Waco Continues** was shot from two miles away, the clarity of the images is surprising. Because of this fact, one might imagine that the next Waco incident will not be filmed at all...for national security reasons, of course!

Anyone who saw Thompson's first video, **Waco: the Big Lie** will never forget the so-called "roof scene," in which four BATF agents are shown climbing a ladder onto a second story roof to enter a window. After tossing a grenade through the window, three of the agents enter the same window. The next scene shows the fourth agent firing through the window that the other three had just entered. He is then forced off the roof by a barrage of bullets fired back at him through the wall.

All three agents who had entered through that window were later found dead from gunshot wounds. **Waco Continues** goes into greater depth regarding this incident. Through testimony provided by other agents, new evidence reveals that while these three agents were entering the building from the west side, three others were entering an east window. Slow motion photography and computer graphics also demonstrate that some of the bullets entering the room came from helicopters hovering above.

One can easily imagine the scene inside the building. Pitch black with smoke from the grenade explosions, east meets west in a heightened state of anxiety. Shots are fired in panic, choppers are called in for backup fire support, and the Davidians are blamed for the "friendly fire" deaths. The victims of this fiasco never saw a hospital. Instead, they were treated at the scene by a private (i.e. government) physician. Interestingly, three of the four agents who died in this raid bore the same "execution style" wound entering just above the left temple and exiting at the back of the skull. One had a hole in his throat that the coroner described as a "field tracheotomy." He later recanted this statement during court testimony, calling it a bullet wound (shades of JFK?)

Even more strange (coincidental?) is the fact that the three agents who were killed after entering the west window, Conway C. LaBleu, Todd W. McKeenan, and Robert J. Williams had all been assigned as bodyguards to Bill Clinton during the presidential campaign. The suspicious nature of this incident has led Linda Thompson to speculate that "someone in the government wanted these men to be real dead." Of all the dead and wounded among the ranks of the BATF, not one was proven to be the result of aggression by the Branch Davidians. In fact, most wounds were inflicted by grenades, "friendly fire" in other words.

Although the BATF sustained many casualties during this initial raid, the Agency's collective suffering pales in comparison to the horrors visited upon the families living at Mount Carmel. The descriptions of the ways in which the children died is especially poignant. Doctor Rodney Crowe, a coroner at the scene, appeared on the **Maurey Povich Show** to tell America that of the children's bodies found in the underground bunker, "three of them died from the concrete in the bunker that fell on them, 21 died from gunshot wounds and the rest died of smoke inhalation and, of course, suffocation due to being buried in the debris when the bunker collapsed."

The reason for the collapse of the bunker is well documented in **Waco Continues**. This bunker was constructed of concrete and buried in the backyard. It had an entrance from the house via a tunnel. It had another entrance outside in the yard. The bunker should have been a very safe place to be if something happened to the main house. The video shows a tank parked adjacent to the bunker's outside entrance. FBI agents are shown exiting the tank, presumably to enter the bunker through the outer door. At this point, the tank can be seen knocking down a corner of the house, effectively cutting off the tunnel leading to the bunker. Smoke then can be seen rising from the outer entrance to the bunker. All this occurred hours prior to the fire in the main house. The major networks filmed all of this yet never raised any questions. The weight of this visual evidence suggests that the FBI deliberately killed the children first. Outlandish as this may seem, one must acknowledge what one sees with one's own eyes.

Who could be so bloodthirsty? The callousness of some of the federal agents is underscored by a statement made by one of their own on that fateful day. Staring into a video camera being held by a fellow FBI man he boasts, "Honed to a fine edge, honed to kill!" More killing is displayed later on that infamous morning when two specially retrofitted combat engineer vehicles (CEV's) move in. These two Vietnam era tanks were modified at Fort Hood Texas to carry flame-throwers. [See **Paranoia Issue 4**]. Despite the fact that authorities tried their best to hide this fact, the damning evidence was clearly visible. These CEV's, along with other tanks and helicopters, were supplied by the military at Fort Hood in defiance of the Posse Comitatus Act. This law specifically prohibits

the military from using any equipment or personnel against American citizens.

In one especially harrowing scene, one of the CEV's is shown tearing through a second story wall. As the CEV backs out of the building, a man can be seen clinging to its gun barrel. Unable to scrape this hapless victim off the barrel by ramming the wall again, the operator of the CEV torches the man with its flame-thrower. The victim and debris then fall to the ground in a flaming heap. Not surprisingly, R.J. Craig, the FBI agent who was driving the vehicle, was the agent who testified that he saw Davidians starting the fire. His statements were corroborated by Paul Gray, Chief Fire Investigator for Waco. Though ostensibly an independent authority, Gray in reality had numerous ties to the BATF, specifically that his office was in the BATF building for ten years, his wife works for BATF, and he carried a card identifying himself as a BATF Fire Investigator.

While claiming that allegations of child abuse were behind the siege, the government ignored the testimony of qualified psychological

counselors and theologians and opted instead for the advice of two groups whose credentials are spurious at best. One of these, the Anti-Defamation League, used to be known as the Jewish Anti-Defamation League. What their motive could be for getting involved is open to conjecture. The second group is known as the Cult Awareness Network. The head of this group, a convicted jewel thief named

Rick Ross, bills himself as a self-styled deprogrammer. This unholy alliance of ADL-CAN has a long history of raising the same unproven charges of "perverted sex, child abuse and brainwashing" against its victims. Such damaging allegations seldom need to be proven; merely making them is sufficient.

There were other charges made against Koresh by private parties and, though some may have felt that they were truly wronged by Koresh, the video demonstrates that others were motivated by greed. Such was the case of Marc Breault. Breault's testimony that he saw young girls leaving the bedroom of David Koresh was instrumental in the formulation of abuse charges raised by ADL-CAN. The fact that Breault is legally blind makes him a strange eye witness indeed!

The government even had the audacity to admit one of its lies regarding these charges against Koresh.

When asked to provide video documentation that the

children still inside the house were unharmed, Koresh gladly complied. Page eleven of the negotiator's log states that when the video tape was reviewed there was "concern that if the tapes were released to the media, Koresh would gain much sympathy." Janet Reno then lied to the media by claiming that the Davidians had refused persistent requests with the negotiators to send out a video of the children. Koresh could not counter these lies because the FBI had (illegally) cut off communications between Mount Carmel and the outside world.

These videos were only recently shown on one of the national info-tainment programs, presented by Diane Sawyer, member of the



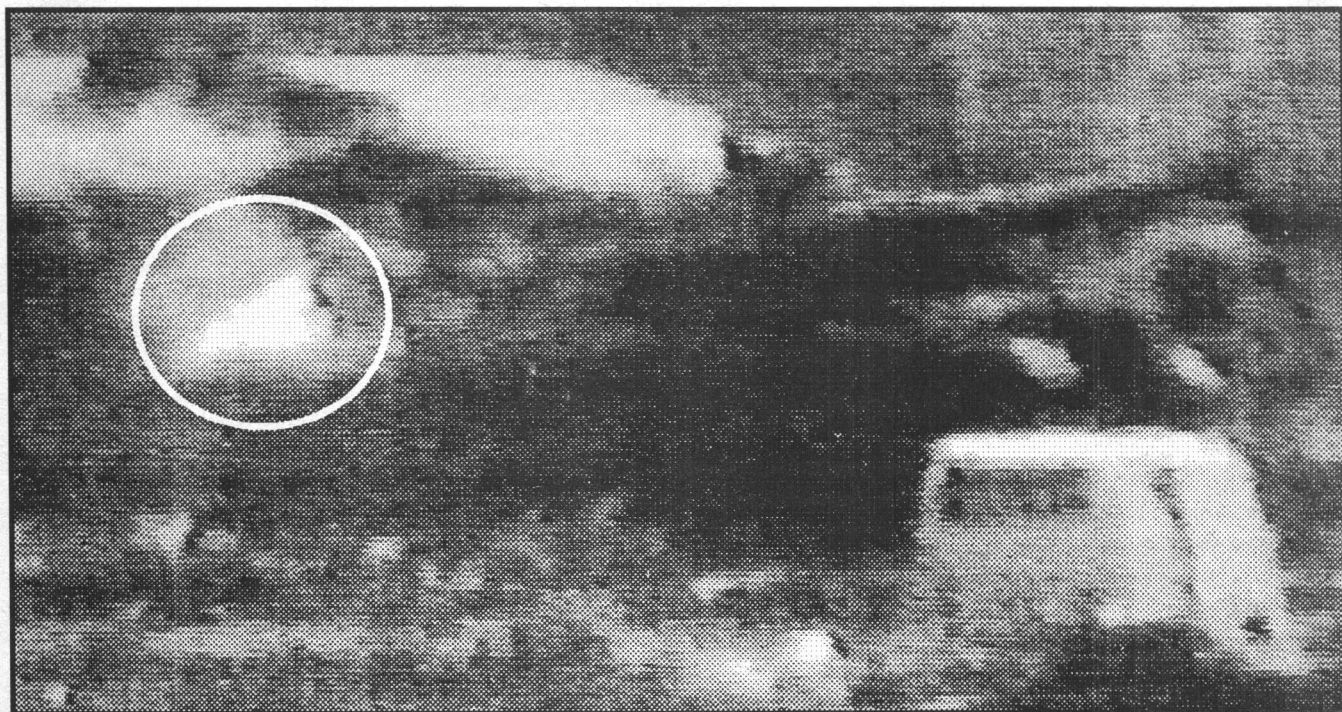
Killed at Waco: Cyrus Koresh

Council on Foreign Relations. The only reason they were shown at all is because the few surviving Branch Davidians had recently been found innocent of the charges brought against them. This Spectacle was definitely an attempt at damage control on the part of the shadow government. Her slant, of course, was that the evil Koresh was responsible for the dreadful loss of these young souls.

Looking back on all the events which led up to the tragedy at Waco, you would have to start the trail at the doorstep of people like Marc Breault. It was he and his cohorts who got ADL-CAN involved; it was

Willie L. Williams (presently L.A. Chief of Police). All three of these "independent investigators" had direct

Satanic child abuse coverup!

In the early 1980s, allegations began to circulate that children in day-care centers and schools were being sexually molested and forced to participate in Satanic rituals. Some religious leaders and law enforcement officials went so far as to suggest that there is a nationwide Satanic cult at work, forcing children to engage in sexual acts, drink blood, eat excrement, and watch horrible human and animal sacrifices. And they warned that this and other "Satanic crime" is on the increase.

Is there any basis for these fantastic charges? First of all, it is undisputed that individual vandalisms, mutilations, and murders have been committed by self-proclaimed Satanists (perhaps the most infamous being California's "Night Stalker," serial killer Richard Ramirez.) And the pedophile population undoubtedly contains its share of Satanists (as well as members of other, more conventional groups.) It is also reasonable to assume that the public *perception*—considered an unfair generalization by many in the Satanist community—that Satanists are devoted to evil and violence would attract people of such inclination to "devil-worship."

And consider that Richard Ramirez isn't the only

Satanic serial killer. At least two other serial killers (Henry Lee Lucas and "Son of Sam" David Berkowitz) have stated that they killed as part of two (unrelated) Satanic cults. However, as Arthur Lyons suggests in his sympathetic history of Satanism *Satan Wants You*, "Even when an individual or group claiming to worship the Devil is involved in crimes, motivations are often not easy to sort out." He suggests that, if a conspiracy exists, it is among the anti-Satanist conspiracy-mongers who have gained financial benefit from various books, seminars, and talk show appearances.

Baby stealers

As Lyons points out, the idea of an underground secret society dedicated to evil and the destruction of civilization has

The McMartin Scandal

The McMartin Preschool was established in Manhattan Beach, California in 1966 [declared the first year of the Satanic Age by Church of Satan founder Anton LaVey-ed.] by Virginia McMartin. Among the employees were her daughter Peggy McMartin Buckey and her grandchildren (Mrs. Buckey's children) Raymond Buckey and Peggy Ann Buckey. The first inkling something was wrong at the school came in August of 1983, when Mrs. Judy Johnson reported to the Manhattan Beach Police Department that she believed her son had been molested by Raymond Buckey. Although Buckey was initially arrested, he was later released. However, the

police continued the investigation and alerted the families of McMartin school students that an investigation was under way. Over several months in the winter of 1983 and 1984, some 400 children were interviewed extensively. Evidence indicated many of the children's stories about molestation they had experienced coincided.

Satanic Rituals

Many of the children described what appeared to have been Satanic rituals, including the sacrifice of animals, which accompanied the sexual molestation. The children also described having been secretly taken away from the preschool building to the outside through "tunnels." According to the children, acts of molestation also took place in these tunnels. Investigators determined that, in their judgment, at least 41 of the

children interviewed had been victimized. This led to the formal convening of a grand jury by then-Los Angeles District Attorney Robert Philobosian. It was in March of 1984 that the McMartin family members were indicted, along with three other preschool employees, Mary Ann Jackson, Babette Spitler and Betty Rador, on charges of child molestation.

Death Threats

They were charged with having sexually abused at least 18 children over a 10-year period, and it was charged they had used death threats to keep the children from talking about their experiences. The preliminary hearings in the case took an entire 18-month period—the longest preliminary hearing in California history. By January of 1986, newly elected Los Angeles District Attorney Ira Reiner announced the evidence was insufficient to warrant a trial for five of

been around at least since the second century. Interestingly, these groups have often been thought to engage in incest and cannibalism, perhaps society's two biggest taboos. As Lyons reports, it is ironic that "Christians were the first to be accused, by the Romans. But as Christianity gained power, Jews took their place...being portrayed as baby-stealing monsters." Indeed, as historian Norman Cohen has found, well into the twentieth century it was a widespread belief in Eastern Europe that Jews used the blood of Christian babies to make Passover bread. Even today, according to Lyons, "We still need the bogeyman to articulate those dark, irrational forces that threaten to overwhelm us."

Secret tunnels

Allegations of ritualistic, Satanic child abuse were behind the longest and costliest criminal trial in American history, the McMartin Preschool case. Because the case resulted in no convictions, and the mother who initiated the investigation was said to have a history of mental problems—she later died of an apparent suicide—many have dismissed the entire possibility of Satanic ritual abuse.

The 1992 trial of Frances and Daniel Keller, however, was a challenge to skeptics. For the first time, clear allegations of Satanic ritualistic abuse emerged. And it was the first such multiple victim/multiple perpetrator case to result in convictions (of sexual assault.) The Kellers were accused of forcing children to witness a baby sacrifice and drink the blood of a sacrificed dog. They were said to have buried children alive, and forced them to watch as they dug

up bodies in a cemetery one mile from the Keller's day care center. During the trial, news cameras captured Daniel Keller twice making an odd hand gesture. Some believe that it was a Satanic hand signal meant to intimidate the child witnesses, but defense attorneys mock the charge as ludicrous.

Despite the Keller convictions, the McMartin Preschool case continues to define (and weaken) the case for ritual Satanic abuse in the public mind. (See sidebar, "The McMartin Scandal.") Nearly 400 children were interviewed during the initial investigation, and investigators believed that at least 41 of them had in fact been molested. The children stated that they had been forced to participate in Satanic rituals, including animal sacrifices, in secret tunnels beneath the school. Some also spoke of being taken through the tunnels to be molested at

other locations off school grounds.

Now, despite the denials of Charles Buckey, husband and father of two of the McMartin defendants, it has been revealed that the secret tunnels did in fact exist. The existence of the tunnels, exposed by private investigator and 28-year FBI veteran Ted Gunderson, may have led to the conviction of defendant Raymond Buckey. However, the Los Angeles District Attorney failed to introduce this new evidence.

Suspicion should have been aroused when two of the McMartin parents independently told the D.A. that they had observed Charles Buckey and others mixing and pouring cement outside the school. Furthermore, the parents had

the seven defendants, and charges were dropped. As a consequence, only Peggy McMartin Buckey and her son Raymond Buckey were turned over for trial. The trial did not formally begin until mid-1987 and then, finally, came to a close on November 2, 1989—the longest criminal hearing in U.S. history. After 21 months of jury deliberations, the jury reached a verdict on January 18, 1990 and acquitted Mrs. Buckey on all counts. However, the jury deadlocked on 13 counts involving Raymond Buckey, and the judge declared a mistrial on the Raymond Buckey case. At this point, Reiner announced Buckey would be retried on eight counts.

Political Controversy

On May 7, Buckey's second trial began. Within a week, a political controversy arose when it was revealed Reiner had offered a tentative plea bargain for Buckey, although

Reiner initially denied a deal had been offered. Reiner, a candidate for California state attorney general, was defeated in the June 5 primary, in part because of the controversy over the Buckey case. It was during this period that private investigator Ted Gunderson and archeologist Dr. Gary Stickel, uncovered proof the secret tunnels, described by the victimized children, did indeed exist. However, as noted in the accompanying story, the district attorney's office refused to use the evidence during the Buckey trial—much to the disgust and dismay of the parents of the children. By July 9, 1990 the case was ready for presentation to the jury, and after 15 stormy days of deliberations, including a re-vote on two of the counts, the jurors reached a deadlock. On July 27 the jurors announced they were deadlocked on all eight counts. At this point

the judge declared a mistrial, and Buckey was free. According to private investigator Ted Gunderson, if the evidence relating to the secret tunnels underneath the school had been introduced at the Buckey trial, the verdict might have been different. ●

discovered *new* cement in a side lot alongside the school building, although the school had been closed for nearly six years since the scandal first broke.

Celebrity molesters?

Working with Gunderson, the parents obtained permission from the new owners to excavate the area beneath the cement, beginning in April of 1990. According to Gunderson, "We found a 35-foot tunnel. We found a seven-foot tunnel. We found the bones of over 200 animals in these tunnels." Gary Stickel, a professor of archaeology at UCLA and an associate of Gunderson, adds that, "The tunnels were exactly where the children said they were. In fact...one of the children took one of my assistants around to show where she had entered the tunnel, and where it ran beneath two rooms, classrooms three and four, and that's exactly where the tunnels turned out to be."

If such evidence has been ignored or covered-up, it may be because, as Gunderson believes, "Among the people [the children say molested them outside the school grounds] were household names: actors, sports figures, politicians." One child, in fact, identified one of the city attorneys as well as action film star Chuck Norris as two of their molesters (though no substantiation of the charges ever emerged.) Given the recent allegations made against pop star Michael Jackson, is this really as impossible as it first sounds?

D.C. call-boys

Allegations made by conspiracy researcher Antony Sutton in his *Phoenix Letter* newsletter, and also investigated by Ted Gunderson, make the McMartin allegations seem rather modest. Sutton has written about a Satanic ritual abuse scandal involving powerful Nebraska elites, a scandal that stretched all the way to the Bush White House.

The mainstream American media has only reported a small part of the scandal (though international media have been more forthcoming.) The part that was reported was the convenient suicide of Craig Spence, who ran a Washington, D.C. "call-boy" prostitution ring that reportedly catered to White House staffers and other D.C. insiders. The *Washington Times* reported that call-boys "took midnight tours of the White House," but this is as far as the official story went.

Spence's Washington partner was Larry King, Jr. (no relation to the talk show host,) a powerful Nebraska Republican and George Bush acquaintance, who attended both the 1984 and 1988 Republican National Conventions.

Sutton claims that King was widely known for his pedophilic practices, and organized lavish parties involving pedophiles, drugs, and Satanic practices. According to Sutton, prominent Nebraska corporate and political figures participated in these parties. Children abused at King parties were drawn from Father Flanagans Boys Club and North Omaha Girls Club, the latter founded by King.

Investigator killed

The Nebraska legislature had first begun a probe of King's shady financial dealings (they found almost \$40 million unaccounted for at the King-managed Franklin Credit Union.) After the initial session, Nebraska state Senator Chambers extended the probe to include charges of physical and sexual abuse of children. On December 19, 1988, Dennis Carlson and others from the Nebraska Foster Care Review Board stunned Chambers' Franklin Committee with the statement that, "The nature of these allegations are something that is going to shock the Committee. They deal with cult activities, they deal with sacrifices of small children, they deal with sexual abuse." Foster Care Review Board personnel went on to detail these fantastic charges based on information in FCRB files. According to Sutton, "Larry King was charged as the 'organizer' of an extensive child abuse-pedophilic prostitution ring extending into the highest political circles."

Ominously, while State officials stone-walled the Committee, Committee investigator Gary Caradori was killed when his private plane exploded in mid air on a flight to Chicago. Soon, Committee members had resigned, and the Nebraska Legislature refused to continue its existence. Meanwhile, King was indicted on financial charges only and sent to a Federal psychiatric facility in Springfield, Missouri, and then on to jail. Amazingly, the child abuse victims who refused to recant their testimony were accused of perjury and also sent to jail.

60 left shoes

Like most conspiracy theories, those involving Satanic crime and ritualized child abuse incorporate more facts than skeptics would admit. On the other hand, speculations often extend beyond what even open-minded observers are willing to accept. In the end, we are left with facts like the following, and whatever speculation we care to make:

In 1985, Lucas County Ohio Sheriff James Telb made headlines when he speculated that some eighty victims had been sacrificed by a local Satanic cult in a wooded area near Toledo. A two-day dig uncovered no bodies, but several disturbing items including: a headless doll with nails driven through its feet, a nine-foot wooden cross with ligatures

Another one that I think shook down the Federal Aviation Administration [FAA] and the Nixon administration for a large amount of money was William F. Buckley Jr. Buckley had not only served in Mexico City under E. Howard Hunt in the CIA (years before), but since Hunt was a convicted felon (as a consequence of the Watergate affair), Hunt could not be the executor of his wife's estate. Buckley, as the godfather of Hunt's children, brought a lawsuit in the federal courts in Chicago against the FAA and in cryptic language said that the FAA allowed this crash to happen. The lawsuit didn't quite allege sabotage but in a way referred to what we had uncovered, and [they] were using it for their own financial gain. In other words, they strong-armed the FAA and the Nixon White House to get money out of them. The press didn't cover the fact that Buckley had brought such a lawsuit.

Now in the NTSB reports that we had uncovered, we reviewed the toxicological reports. These reports showed that Dorothy Hunt and the other Watergate people on board the flight had a very high cyanide level in their body—higher than they could have breathed into their body in a fire. In other words, it had to have been injected. We went to the leading toxicologist in the country, and he said that the cyanide had to have been injected. In any case, after two days of hearings, I told a joke that was used against me. I said, "I am here to admit that I have absolutely no proof whatever that Richard Nixon himself or Edward Carlson, the chairman of United Airlines, was on the plane with a .38 and shot Dorothy Hunt." Do you know that the Chicago paper had a banner headline saying that "Skolnick admits no proof whatsoever." They left out the part of the sentence that was a joke.

Now there was a very interesting man on that plane who survived the crash. He was sitting right near the tail near the door. His name was Harold Metcalfe, one of the top narcotics agents in the United States working directly for the Nixon White House. When the plane crashed, he opened the door and got off at the tail. He was in a jumpsuit like he was going to parachute or something. What happened was that he was supposed to testify before a grand jury in Indiana. An associate of mine found him and confronted him and said, "You survived the crash and came out of a plane in a strange jumpsuit. You knew that plane was supposed to crash." Metcalfe turned purple and started blurting out, "It wasn't supposed to happen that way."

We brought that up at the special hearing. Finally, after two days of hearings a reporter for the Hearst newspapers came up to me, and I'll never forget what he said. He said, "All of your documents are worthless. You didn't prove that the plane was blown up with a bomb." I said, "We're living in a modern world. Of those planes that have been sabotaged, not all have been blown up that way." He said, "Without a bomb, you have no case." That was the opinion of the top reporter of the Hearst newspapers. I confronted the members of the NTSB panel with conflict of interest charges in that most of them were stockholders in the airline industry, but they refused to disqualify themselves.

The panel came out with a revised verdict that the prophetically named Capt. Whitehouse (on the ill-fated plane) had committed pilot error, and that's why the plane crashed. In so doing they came out with a new set of documents. But I had their file, and I was able to show that their new documents were falsified and not the original records of what had happened. Whitehouse had been one of the best pilots in North America and had been a stunt pilot. If there was anybody under heaven who could have landed that plane, he could have.

The plane's electrical system had been sabotaged, too. But to protect United Airlines, they covered up what really happened. My book on the affair [which Tom Valentine was scheduled to co-author—Ed.] was supposed to be published by Pinnacle Press, but the lawyer for Chase Manhattan Bank (which, as we said, owns part of United Airlines) said that the book was "not documented," even though we had all of the documents from the NTSB.

After that my magazine *Newsreal* was going to publish your story, but our distributor, Fawcett, was purchased by CBS, and that was the end of that.

There have been a lot of mysterious plane crashes over the years. One of them was the disappearance of the plane (in Alaska) carrying Rep. Hale Boggs (D-La.), just a month before Nixon was re-elected. I talked to a lot of people who investigated it, and there is reason to believe the plane was found. Boggs had begun making statements that FBI Director J. Edgar Hoover was wiretapping members of Congress. Boggs had also been a member of the Warren Commission that said Lee Harvey Oswald was the lone gunman in the JFK assassination. Now his daughter, Cokie Roberts, who is a top reporter for ABC, recently said that she agreed with her father that "Oswald acted alone." The fact is that her father had begun to have misgivings in 1972 about the Warren Commission, and it was at that point his airplane disappeared. ●

parachuted back into Tibet (Avedon, 1984). What was Peissel's connection to the CIA? It's difficult to say.

Peissel was apparently able to obtain much "Tibet file" (as he called it) information from American and British intelligence contacts. He even reveals names that sound familiar—such as "Nyma Tsering," said to be one of the most trusted officers among the Tibetan guerrillas. Tibetan names in English are merely rough transliterations, often in different spellings. So we are not surprised to find the Sherpa "Nima Tenzing" on Slick's 1957 and 1958 expeditions, and the same individual "Nima Tshering" on Hillary's 1960 expedition. Was this person also the aforementioned "Nyma Tsering"? Were Peissel's connections woven into the espionage network?

This is the same Michael Peissel who wrote a yeti-debunking article for *Argosy* magazine in 1960 entitled "The Abominable Snow Job." Peissel mentioned that the subject of his 1966 book, Boris Lissanevitch, had been given a tranquilizer gun by the Tom Slick expedition. Peissel half jokingly wrote that "The Indians thought Boris a Russian agent, the Russians thought him an American agent, and the Americans, a Russian agent" (Peissel, 1966). It is interesting that Peissel would show up in the Tibetan area to investigate the abominable snowman, during the critical time of the Dalai Lama's escape. Slowly, over the years, he revealed his deeper covert operations links.

Adrian Cowell, for his part, turned up in Burma in the mid-1960s filming guerrilla opium armies (McCoy, 1972) and recently has been involved in Brazilian projects. But Cowell's official biography in *Contemporary Authors* neglected to mention his Tibetan adventures with Patterson.

Something strange is going on here.

"Atomic Testing" In Colorado Anyone?

In 1959, after the Dalai Lama had been helped out of Tibet by the CIA, this same agency started sending Tibetans to America for covert instructions. The secret CIA training site for the Tibetans was Camp Hale, near Leadville, Colorado. (Coincidentally, Tom Slick's mother's family was from Leadville.) The Tibetans were silently flown out of Asia, had only one refueling stopover in Hawaii and, upon their arrival, did not even realize they were in the United States. The intrigue surrounding this covert army is worthy of study by researchers who are looking for the techniques used in governmental coverups. Indeed, on July 16, 1959 (Prados, 1986) the CIA had

planted a front page story in the *Denver Post* reporting that atomic testing—though not bomb detonation—was to be conducted at Camp Hale. The vast area of 14,000-foot peaks and valleys covered by the camp was henceforth strictly off bounds to the civilian population. People who were near Peterson Air Force Base, outside of Colorado Springs, when a subsequent group of Tibetans was flown out, found themselves detained. Up to forty-seven at a time were held at gun point behind army roadblocks until mysterious buses, their windows painted black, had passed by. When news of unidentified Orientals in Colorado reached the *New York Times*, Secretary of Defense Robert McNamara personally had

the story suppressed. As a final resort, soldiers guarding the most sensitive areas of the base—as well as the Tibetans themselves—were given explicit instructions to shoot to kill anyone found within the perimeters" (Avedon, 1984).

Names of men involved in the training at Camp Hale are difficult to locate, but it is interesting to note the connection of the one person I was able to identify, to other parts of our examination. McCoy, writing in 1972 on the secret war in Laos, discussed only a handful of highly committed CIA men there. One was Anthony Poe. Agent Poe, before his Laos work, recruited Khamba tribesmen in northeastern India, escorted them to Camp Hale in Colorado for training, and accompanied them into Tibet on long-range sabotage missions." And which hardworking CIA agent had Poe replaced in Laos? William Young, that's who, the gentleman we met earlier because of his probable link to Ivan Sanderson and the Burmese Tok stories. (McCoy, 1972).

While Air America, Air Asia, and even a special Nepalese airline were all involved in the transport of the Tibetans to Camp Hale, was Slick Airways part of the picture? Henry Belk (1989) told me that he

believes Slick Airways was responsible for taking agents to war theaters in Southeast Asia. Were Slick Airways' activities part of the deleted Tibetan material never released by the CIA?

Disinformation Chief Involved?

And what role might have Desmond Fitzgerald played in all of this? A

veteran of conflicts in Burma, FitzGerald was very much the Asian expert in the CIA. Assistant to the head of the Far Eastern Division of the CIA's "Directorate for Plans" in 1952, FitzGerald was described as "bright, affluent, cultured, charming, and an avid bird watcher" who "undertook the deadly business of covert operations with a light-hearted, romantic activism...during the 1950s" (Leary, 1984). We now know that by the early 1960s, FitzGerald was named head of the Special Affairs staff and was responsible for at least one disinformation incident against the Chinese using UFO reports (Good, 1988). Shortly after that, on November 22, 1963, FitzGerald, posing as a senior United States senator in Europe, handed Rolando Cubela a weapon disguised as a fountain pen for use in an assassination attempt against Fidel Castro (Summers, 1980). Deadly serious about his work, FitzGerald was a member of the CIA's so-called "Knights Templar," a group of original CIA officers and followers of Wild Bill Donovan. They seemed to have envisioned themselves like the ancient Catholic military order founded during the Crusades as a "mysterious and tightly knit group dedicated to a sacred cause" (Hougan, 1984.) FitzGerald was very involved in the Tibet situation:

Despite the refusal [of President Eisenhower and the United States government] to associate with the Tibetans openly, secret plans continued. Before his NSC [National Security Council] meeting of February 4, 1960, the President met with a group including [former Psychological Strategy Board Staff Director and at that time special assistant to the President for national security affairs] Gordon Gray, [(Secretary of State) Christian Herter, [CIA Director] Allen Dulles, [CIA Deputy Director Charles] Cabell, and Desmond FitzGerald to discuss Tibet (Prados, 1986).

What kinds of disinformation was FitzGerald creating for the Tibetan operations? Did any of it refer to the yeti expeditions searching the border of Tibet for traces of the creatures?

Yeti Expeditions: Spy Missions? Truth Stranger than Fiction?

Late in 1960, Sir Edmund Hillary, sponsored by the World Book encyclopedia company of Chicago, left on his famous expedition to Nepal in pursuit of the "Abominable Snowman." While Tom Slick's 1957-1959 expeditions may have been rumored to be espionage missions, what part did spying play in Hillary's trek? Driven by publicity and the media, most accounts of the yeti debunking affair mention only the high altitude medical testing as a subgoal of the fiasco. A few English and Italian press accounts exist confirming that one objective of the group was to spy on the Chinese in Tibet. Two rocket experts, Tom Nevison of the United States Air Force and Peter Mulgrew of the Royal New Zealand Navy, were closely watching and gathering data on the Chinese firing missiles from Tibet. Journalist Desmond Doig, Nevison and Mulgrew were camped together at Tolum Bau glacier when they all witnessed just such a launching. Meanwhile, the Chinese were jamming the camp's radio (Coleman, 1989; Sanderson, 1961; Doig, 1960). All of the official chronicles of the Hillary-World Book expedition not too surprisingly fail to detail this aspect of the party's activities.

Strangely, in 1970 and 1971, two fictional accounts surfaced linking espionage activities with the abominable snowmen. The 1970 Billy Wilder movie, *The Private Life of Sherlock Holmes* is a story including large components of covert activities and the Loch Ness Monster. Interestingly, it also contains a segment set in the exclusive Diogenes Club where Holmes comments on the members' uncanny ability to turn up "here, there and everywhere." Then he later adds, "When there's trouble along the Indian frontier, some of your fellow members pop up in the Himalayas allegedly looking for the Abominable Snowman" (Haddon, 1987). *The Private Life of Sherlock Holmes* is not in distribution and difficult to locate today, aside from occasional television appearances.

Ronald Rosenblatt (1989) has informed me of another presently rare fictional work that connects intelligence agents and a search for a Tibetan mystery animal. In 1971, Jack Benton Scott's *Spargo: A Novel of Espionage* was published. The book details the activities of a renegade CIA agent who goes on a mission to Tibet and India, using a search for the so-called "Sun Bear," a supposedly extinct animal, as his cover.

Is truth stranger than fiction? During the hottest days of the secret war in Tibet in 1959 and 1960, eleven separate expeditions, including one led by the Chinese, were sent to the area on the track of the abominable snowmen of the Himalayas (Coleman, 1989; Sanderson, 1961; Dong, 1984). Were all of these merely cryptozoological investigations, or was something more covert taking place? Has the yeti been a cover story for spy missions? Until some future Freedom of Information request produces a document or an expedition member talks openly, thus giving us some hard evidence, for now we are left with only a few linkages and some intellectual possibilities. Still, something seems to be afoot!

Coverup vs. Cover?

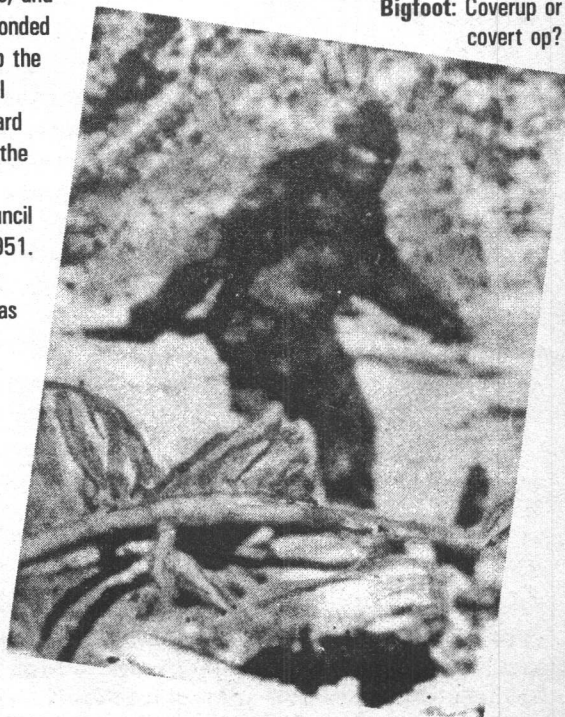
For the last few years, a great debate has raged in ufology regarding the role of the CIA and other similar organizations in the

UFO field. For example, Timothy Good's *Above Top Secret*, a 1988 book, has already taken on near classic status. Its stance, taken in the first paragraph, can be summarized as indicating that a "wide-scale coverup" of the involvement of the intelligence community in the study of UFOs is occurring. Good and others feel the government is hiding proof of the existence of UFOs.

In our cryptozoology-espionage examination, however, the reasons behind the alleged cover-ups seem to have more to do with hiding covers than burying evidence and special knowledge of the reality of the arcane subjects which occupy our interests. Over and over again, as we delved deeper into the subject of the Tibetan yeti expeditions and the Himalayan spy missions, the characters involved revealed a pattern of covert psychological warfare operations in their back-grounds. While in North Africa, Carleton Coon, for example, invented a mine disguised as donkey dung in order to kill Nazis. Meanwhile, in Algiers, Peter Tompkins was a member of the Psychological Warfare Branch of General Eisenhower's headquarters, conducting all manner of propaganda and direct actions, and possibly assassinations.

Desmond FitzGerald used false UFO sightings, and perhaps yeti ones also, to disrupt the Chinese. In a meeting to discuss secret activities in Tibet, FitzGerald discussed plans with Gordon Gray, among others. And if we are to believe the truth behind the claims of ufologists, Gray was a member of the ultrasecret MJ-12 group, designated to deal with UFOs. But Gordon Gray's connections and history are amazing even without this as yet unproven linkage, for Gray was the first staff Director of the Psychological Strategy Board. And the background to the Psychological Strategy Board is illuminating. In February 1949, President Truman created a State Department psychological warfare office. In March 1950 Truman adopted special order NSC-59 for more foreign information gathering and psychological warfare, and then NSC-74 for "A Plan for National Psychological Warfare." The President then moved quickly to get Rear Admiral Sidney W. Souers for consultations. Souers supported a recommendation to create an interagency group for nonmilitary cold war activities, and Truman responded by setting up the Psychological Strategy Board (PSB) under the National Security Council in Spring, 1951. Gordon Gray was picked as first staff Director of PSB. Gray knew Frank Wisner, Directorate of Plans, and CIA deputy director William

H. Jackson and the PSB assistant Gray hired Tracy Barnes, because they all worked for the same Wall Street law firm, Carter, Ledyard and Milburn, before WW II. At the time, the Director of Central Intelligence was Walter Bedell Smith; Gray was asked to head PSB by W. B. Smith and William Jackson. Earlier Gray had been involved in the whole setup of the Army staff's adoption of "psywar," i.e. psychological warfare, in January 1948. Although the prime mover in that area was General Robert McClure, Gray as Assistant Secretary of the Army encouraged the effort. The Army's interest in "psywar" eventually evolved into the Army's "Special Forces." PSB disbanded in 1954 for political reasons, and Gray was exiled to the review board that sat in judgment of nuclear physicist J. Robert Oppenheimer. But Gray would be back. He served in the intelligence community for forty years (Prados, 1986). Those aware of the supposed MJ-12 affair realize that Gray, Smith and Souers are noted as 1952 members. The overlap between PSB and MJ-12 seems more than a coincidence in time, in membership, and in motives. But perhaps the key is psychological warfare, not physical facts.

What if the whole thrust of the intelligence community's interest in cryptozoology, ufology, and fortean subjects in general has more to do with covers and fronts than with a cover-up of data? Diplomatic, ornithological, and archaeological covers have been used. Why not present an agent as some half-crazed cryptozoologist searching for such and such a creature in some sensitive section of a foreign country? What better "psywar" technique than to search for and then promote a variety of positions on strange and bizarre subjects, be they yetis, giant salamanders, or lake monsters?

Intriguingly, if we accept for a moment the reality and membership of MJ-12, two of the individuals in the group, Dr. Donald Menzel (Director of the Harvard College Observatory) and Vice Admiral Roscoe Hillenkoetter (first Director of the CIA) were very publicly on two sides of the fence regarding UFOs. Menzel, through his book *Flying Saucers* and other writings, was the foremost and most widely read UFO debunker of his day. Hillenkoetter, concurrently, was the first intelligence czar to say that UFOs were real, and to join the Board of Directors of the UFO organization, NICAP (Good, 1988).

The division in approach between the possible covert operation-linked yeti expeditions mirrors that established in ufology. On one side, the believers with some covert backgrounds lined up—Leonard Clark, Tom Slick, the Byrnes, George Patterson, Nyrna Tsering, Carleton Coon, and Ivan Sanderson. Then, after 1960, on the other, we have Hillary, Perkins, and Peissel. Behind the scene-setting among the yetis of Nepal and Tibet, the psywar techniques of FitzGerald and Gray seem vaguely apparent. The freeing of the Dalai Lama in 1959 (and hopefully of Tibet) was probably the primary motive behind the deception: the use of what Tom Slick liked to call "the ultimate quest," the search for the abominable snowmen of the Himalayas, as one of the cleverest covers in espionage's history.

In the end, we may discover that the covers are the secret, and not some disinformation coverups of alien bodies in Ohio's Wright-Patterson Air Force base or of yeti corpses at San Antonio's Southwest Research Institute. ●

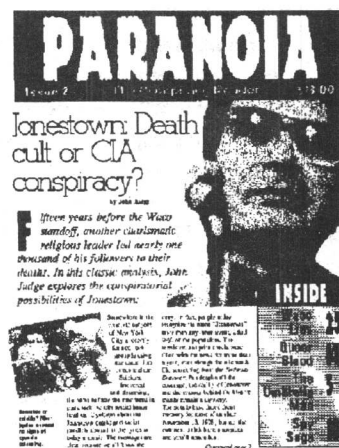

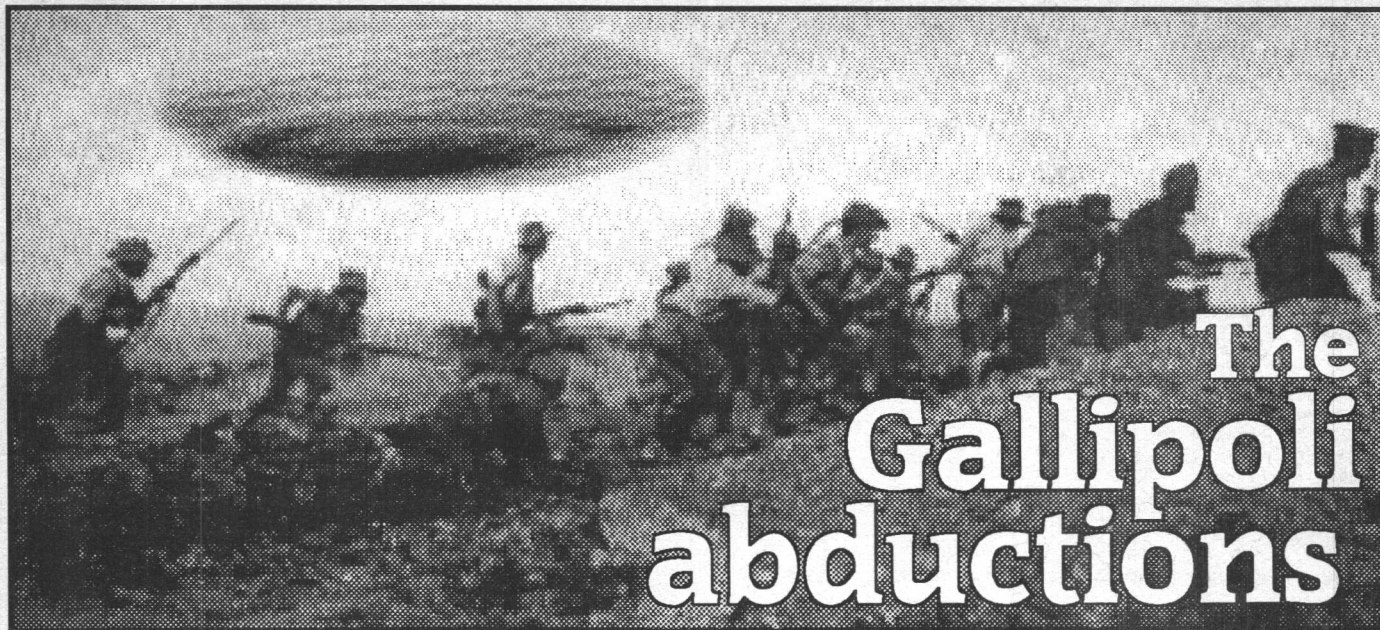

Excerpted from *Passport to Magonia*,

The mass abduction of an entire British Regiment by a huge "cloud" UFO allegedly occurred on August 28, 1915 in Gallipoli during World War I. Here is the original account:

The following is an account of a strange incident that happened...in the morning, during the severest and final days of the fighting, which took place at "Hill 60," Suvla Bay, [Africa] ANZAC (Australian and New Zealand Army Corp). The day broke clear without a cloud in sight as any beautiful Mediterranean day...the exception, however, was a number of perhaps six or eight "loaf of bread"-shaped clouds—all shaped exactly alike—which were hovering over "Hill 60." It was noticed that, in spite of a four or five mile an hour breeze from the south, these clouds did not alter their position in any shape or form, nor did they drift away under the influence of the breeze. They were hovering at an elevation of about 60 degrees as seen from our observation point 500 feet up. Also stationary and resting on the ground right underneath this group of clouds was a similar cloud in shape measuring about 800 feet in length, 200 feet in height and 200 feet in width. This cloud was absolutely dense, almost solid looking in structure, and positioned about fourteen to eighteen chains from the fighting in British held territory.

All this was observed by twenty-two men

of No. 3 Section of No. 1 Field Company, N.Z.E. from our trenches...approximately 2500 yards southwest of the cloud on the ground...overlooking "Hill 60" by about 300 feet...we had a perfect view of the cloud's sides and ends as it rested on the ground. It's color was a light grey as was the color of the other clouds. A British Regiment, the First Fourth Norfolk, of several hundred men, was then noticed marching up this sunken road or creek towards "Hill 60." It appeared as though they were going to reinforce the troops at Hill 60. However, when they arrived at this cloud, they marched straight into it, with no hesitation, but no one ever came out to deploy and fight at "Hill 60." About an hour later, after the last of the file had disappeared into it, this cloud very unobtrusively lifted off the ground and, like any fog or cloud, rose slowly until it joined the other clouds...[which] all looked alike, as peas in a pod. All this time, the group of clouds had been hovering in the same place, but as soon as the singular "ground" cloud had risen to their level, they all moved away northward, toward Thrace (Bulgaria). In a matter of about three quarters of an hour, they had all disappeared from view.

The Regiment mentioned is posted as "missing" or "wiped out" and, upon Turkey surrendering in 1918, the first thing Britain demanded was the return of this Regiment. Turkey replied that she had neither captured this Regiment, nor made contact with it, and did not know that it existed. (A British Regiment in 1914-18 consisted of any

number between 800 and 4000 men.) Those who observed this incident vouch for the fact that Turkey never captured that Regiment nor made contact with it.

We, the undersigned, although late in time, on the fiftieth Jubilee of the ANZAC landing [1965], declare that the above-described incident is true in every word.

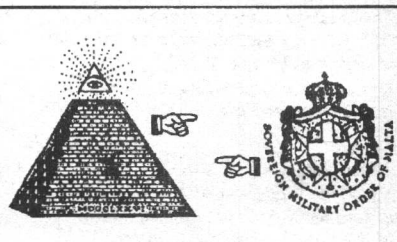

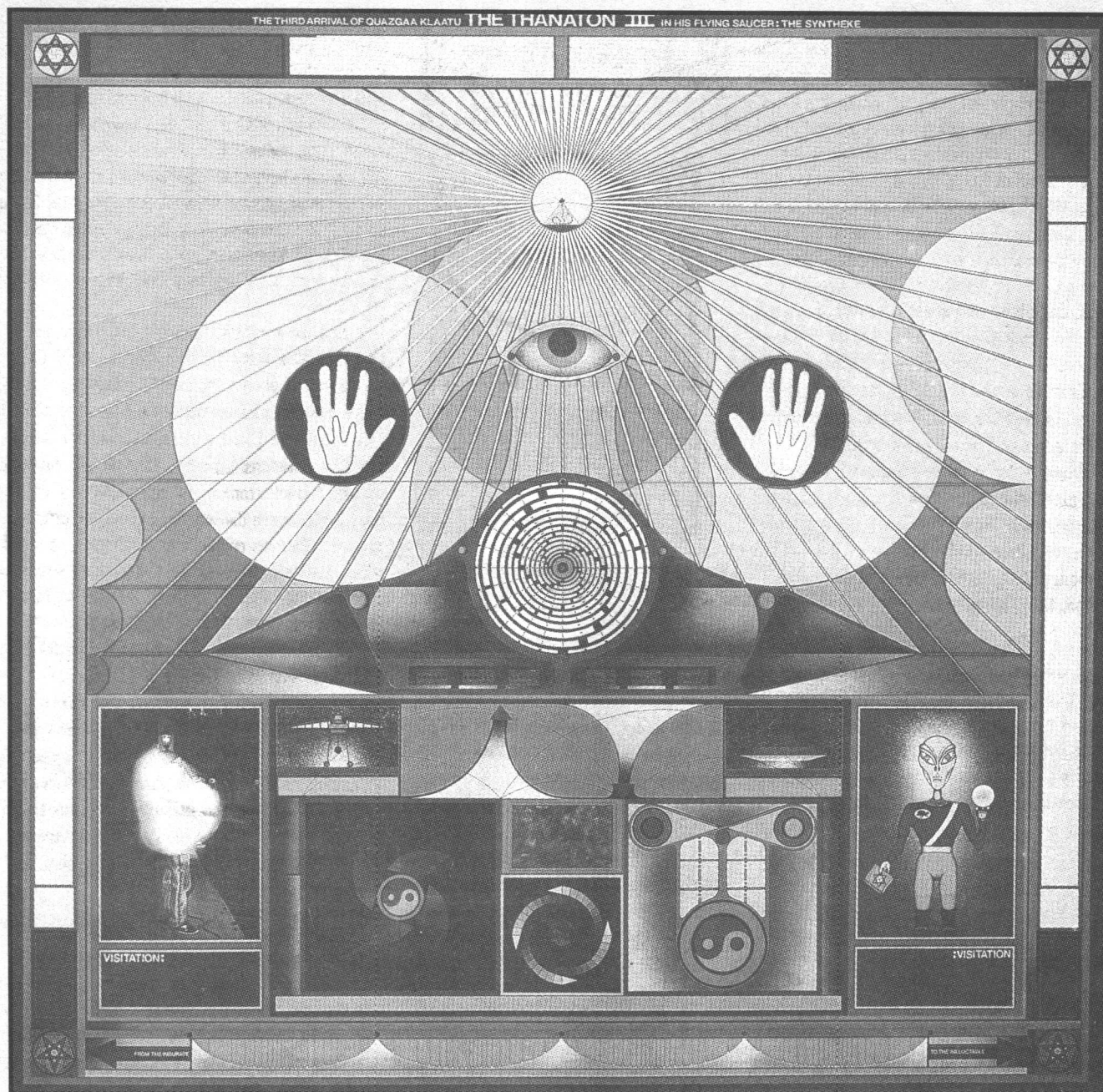

On Lucid Dreaming...

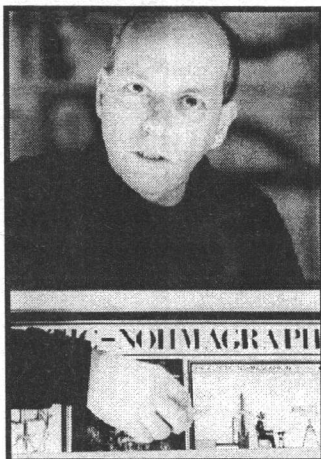
Paul is talking about his painting "Marquette for a Thought Form," which was part of his winter 94 show entitled "Art and Lucid Dreaming" at the Federal Reserve Bank Building in Boston.

Lucid dreaming is the ability to become aware, during a dream, that you are dreaming and to do two things: one, take control of the dream, and two, take back a message.

In 1903, D. W. Ledbetter put forth the idea that you could see thought forms in people's auras. The word "thought" didn't really mean they were seeing sets of words, like cartoon balloons, it was simply that those were forms that had emotional translation. My piece, "Marquette for a Thought Form" contains one star, which is tantric in terms of sexual penetration. You could see other shapes and colorations. You'd wonder what this outflow was, maybe it was a light brilliance? It looked like something you'd bring to the beach.

In lucid dreaming you are creating a condition where you can turn up the heat or cold to whatever degree you want and it will actually be connected to the object you are dreaming about. You also have to train yourself so that you can go into lucid dreaming without any interface between a normal blackout and waking up into a regular dream, which is dealing with the past. When you dream, you are dealing with the subconscious past and you have a lot of baggage, which tends to negate any kind of energy or control which you have over this process.

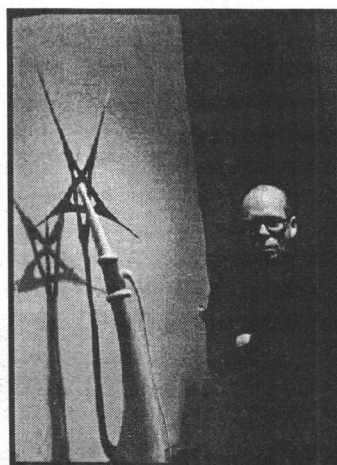

When you go directly from the waking state to the lucid dream state you overcome the subconscious so that you are not using archetypes, or any of the baggage that psychology has lain on us. This is like using the energy directly as you would during the waking state, only you have access to systems and instrumentality that is limitless. It's only limited by what we can think of in the same way that our existence as humans has only been limited by what we can think of. It's totally dependent on our own creativity.

I want to use lucid dreaming in a methodical way, almost a scientific way. People use it to decode astral projection; to go on journeys. I think it has much more interesting consequences if seen as an instrument, and it thus produces a whole new genre of inventions which go beyond the traditional notion of psychotronics, which are defined as mind-matter interactive devices. But how consciousness and mass become continuous was never explained; it has just been assumed that there isn't any interface situation. There is no use of different aspects of this along the spectrum; its either on or off.

But if we find that the process is literally true that mass and consciousness are continuous, then you can tap it at different points and achieve different results. So here is where you have consciousness and mass, with lucid dreaming seen as the mid-point. So it has the ability of consciousness to use the will, but also makes consciousness have mechanical aspects as well. You have invariants. You can engineer your next step and achieve a particular result.

The Klein Bottle...

The Klein bottle is extremely tectonic. Many people, including myself, consider that the shape of the physical universe in terms of its boundedness has got to be much like the klein bottle, in which one form will penetrate the other without rupturing either surface. You're dealing with a higher situation, you're given a clue as to how to connect the physical to the metaphysical.

You can take two mobius strips, a right and left handed, and converge to make a Klein bottle. Then you can take a left and right sided Klein bottle and make a hyper-Klein bottle. It becomes another form we don't have nomenclature for yet...but it's a way of recognizing that while there is a finitude to each dimension, there is also a way out; there is a connection to another dimension.

The Soliton Wave...

It is postulated that soliton waves are responsible for the slight voltage in our bodies' electrical system. It has got to be the soliton waves that are actually the pulses that are going through our bodies. There are millions of miles of dendrites that this electricity has to go through in order to complete the natural contraction of muscle tissue.

And Perpetual Motion...

In that sense, when you look at life it seems like perpetual motion. Look at the gyroscopic motions of the atoms—these are also types of perpetual motion. A perpetual motion device has to have some discreteness, some disconnectedness from ourselves, and the ability to use a source of energy. A perpetual motion machine as a device that does not use energy simply can not be, like the overbalanced wheel. Thomas Cox, in 1729, invented a perpetual motion clock based on changes in barometric pressure and the thing is still in operation. So there's perpetual motion... the moon is perpetually going around the Earth—if you have a source of energy and an environment that does not alter, and you can utilize it, then you've got perpetual motion.

Mix Phenomena Well...

So, what I'm planning here is that through the use of two interlocking mobius strips connected with mercury in evacuated tubes, combined with the use of lucid dreaming, I can generate a soliton wave. One of the things I found out about lucid dreaming is that we can process information which, of course, equals energy. You can see why we can learn new things, why there is an advancement in knowledge from one moment to another is the fact that we then process energy as information. Pure Einstein! So, therefore, in the same way that in the waking state you can introduce energy into a situation, you can do this in lucid dreaming. You would have to have a hermetically sealed system—sealed by Hermes—sealed by Revelation, so that you cannot get in or out except in a certain way.

Different Geometries...

The mobius strip and klein bottle are considered unusual forms in having no application. The forms of, say, dynamic geometry always conform to simple things like platonic solids or spheres. These imply inertia in their structure. They imply an interaction with mass, where mass predominates, where the sense of invariance predominates, whereas the mobius strip and the klein bottle do not. Flying saucers make right angle turns, but they're really making mobius strip turns which look like right angles when you look at only one part of it.

We've always been able to understand the lucid dream state; we've just never been able to use it. My claim is that lucid dreaming once utilized, won't merely be the next LSD trip, because you can slow it down to any speed of knowledge acquisition that you want. The reason why LSD didn't work is that its velocity was normally greater than the absorption power of the average mind. You are absorbing information, but you cannot use it. It's like twirling your head around... you're seeing all this stuff, but how can you use it? In the lucid dream

state, you are able to control the velocity of the information entering from another dimension. This is extremely useful.

Physically Alive Architecture...

All vegetation in the world should be grafted together to create a single pollen. This can actually be done in our time. The earth could be made into a single vegetable, with the ley lines of the earth covered in vegetation. You can grow this vegetable sphere at, say, 12 miles above the earth. At 12 miles you are about half way into the atmosphere. This is where most of the pollutants and airborne minerals are. You can actually construct that, and then through vegetation which has been genetically programmed to withstand

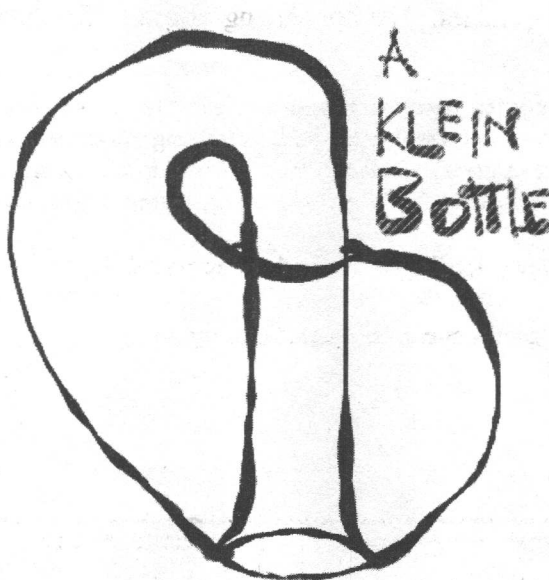
compressive strengths, we can make this sphere around the earth physically alive. We can then connect all the vegetation together so that we are literally creating the good greenhouse effect. This would take all the oxygen making apparatus and enhance it. We would immediately be absorbing all the pollutants that we put into the air, and returning the stuff back to the earth where it belongs. We should never have taken that stuff out of the earth in the first place. Over the centuries, you could eventually connect the whole thing. What would remain would be a purely vegetative environment. You could make your houses out of this. There would be places where it would all connect. I have plans on how to do this on an individual basis. It's like a

little sync of synergy where you make one and you're draining out of the other systems around it. So the most logical thing is that you have the entire earth done in this way.

I like orchids. I want to live in an orchid. An orchid can literally be made larger than its form. In Darcy Thompson's famous book, **Growth and Form**, he was the first bio-engineer to state that the reason why things are the way they are is because of their structural limits.

A mouse is different than an elephant because it starts out programmed in a different way. A mouse form could not simply be enlarged to the size of an elephant. The mouse would have to change into an elephant. The interesting thing is that the orchid, of all the flowers, is over-structured, it's overdesigned. You could enlarge it a couple of times, probably ten or fifteen times its size and still have its form remain. You could make it so large that you could live in it. There are a lot of interesting spaces in an orchid. The surface and the structure are the same thing. Orchids are wombs on the end of a stick. A flower is the sex organ of a vegetable. That's an amazing concoction!

A pollen is already conforming to the ley lines of the earth, a dynamic bio-geometry. We would still have mountains, for instance, they would be vegetable mountains rather than earth mountains. We would have different kinds of water rather than the uniform salt or non-salt water. Instead of a landscape like a renaissance painting, with ground plane, verticals and sky, you would find dirt doing other things. ●

Don't say we didn't warn you...

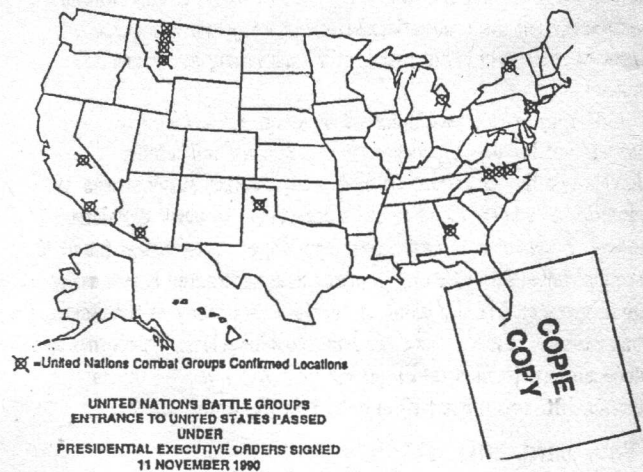

Black helicopters and foreign troops have been reported in various parts of the United States, according to a new book that arrived as we were going to press. The book, *The United Nations Concentration Camps Program in America*, by Serge Monast, warns that these troops and helicopters are part of an effort to trash democracy and the Constitution of the United States, and establish a New World Order (NWO) under UN control. In fact, some of these UN forces have already arrived (see map at right.) Are they simply in training, or is something more sinister going on? We hope to explore the issues and questions surrounding the NWO in more depth in future issues of *Paranoia*. For now, let this serve as an introduction. And a warning...

In Monast's view, the recent expansion of UN military activities (in Somalia and Yugoslavia, to name just two locales,) and the concurrent "downsizing" of the US military are intimately related: they are part of a decades-old plan to put the New World Order in action. Unlike many who warn of the NWO, Monast provides a copy of what appears to be a legitimate US government document to back up his claims. The document, United States Arms Control and Disarmament Agency Publication 14, appears to date from the 1950s and contains a diagram that shows how the US military, as we've come to know it, will be "downsized" almost to the point of extinction. Meanwhile, we'll have to trust a growing UN military force to serve as the globe's super-army.

The super-army will, as happened in Somalia, contain US personnel who will have to obey UN commanders (not the President, as our Constitution requires.) Technically, the US will be just one voice of many at the UN table, and thus the American people will have virtually no control of how its military is used. And, as a member nation, the United States may even find itself invaded by UN forces, should conditions here grow "unstable" in the eyes of the UN bureaucrats. Equally ominous, as the diagram suggests, is the fact that the US military will have an interesting new role: "Internal Security Forces."

And what kind of "Internal Security" will the New World Order require? The answer, of course, depends on the degree to which our rulers feel threatened. If a "national emergency" occurs (however those in power choose to define this vague term,) things would simply be nightmarish. In fact, it is



undisputed that certain Presidential Executive Orders (EOs) already exist that would, in "national emergency," revoke the Constitution and replace it with what can only be described as a military dictatorship. (Because the term "martial law" has such nasty connotations, government bureaucrats have apparently employed the friendlier term "martial rule.")

Quoting a former US Army Intelligence Analyst, Monast describes how a little-known group called the MJTF (Multi-Jurisdictional Task Force) might be deployed during a "national emergency." The MJTF's primary mission is "house-to-house search and seizure" (of weapons) and

"separation and categorization of men, women, and children" in large numbers to transfer to detention facilities and the use of those facilities for interrogation purposes. According to Monast, mass detention facilities—also called

concentration camps—have been set up at several US military installations on the secret orders of ex-President Reagan. (Could this be the real reason behind the recent so-called "base closings"?)

Basically, anyone the government deems to be "dangerous" will be rounded up, just as Japanese-Americans were during World War II. And who might be rounded up? This is where the warning of the headline comes in, because Monast reports that it could be you:

It will be swift and legal. The law is already on the books. (Detainees will) represent every shade of political and social opinion, from Right to Left and (include) a big span of middle-of-the-road citizens who have never committed an offense more heinous than having subscribed to an unapproved periodical.

So don't say we didn't warn you... ●

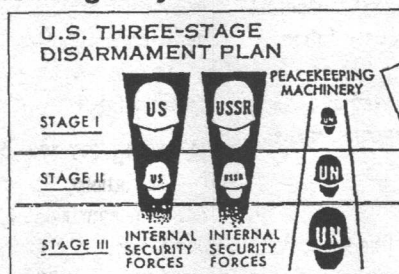
Please read across from Left to Right.

Attack of the Superbugs!

Many of the antibiotics that we take for granted were developed in the early part of this century. Back in those "good old days," sick people stayed close to home, thereby confining illness to their immediate surroundings. Nowadays, with the help of rapid transportation, you could find yourself on the far side of the globe before you even felt the first symptoms of disease. This situation is responsible for the international blending of germs into mutant super bacteria which are resistant to everything in our medical arsenal.

Speaking at this year's annual meeting of the American Association for the Advancement of Sciences, Rockefeller University's Dr. Alexander Tomasz said, "Already some strains of bacteria have been found to carry resistance to every antibiotic known to medicine." In fact, one such super bacteria was found to be responsible for 58% of the pneumonia contracted in one major urban hospital. Tomasz went on to warn that many of the diseases that we now consider curable, such as tuberculosis, pneumonia and blood poisoning could return as the incurable killers of the next decade. "Your card, citizen?"

One of the main features of the Clinton health care agenda is a "Health Security Card," which would be issued to all citizens. Looking like an ordinary bank card, this piece of plastic will contain all of your medical records. While the government's stated purpose is to improve the health care system, privacy advocates worry about this card's potential for abuse. For unlike a standard credit card, this one utilizes new technology that allows for volumes of retrievable records on the card holder. Pushing such cards in the interest of national "health" has been the preferred method of introducing national ID cards into countries whose citizens would normally balk at the idea. Officials at Schipol Airport in Amsterdam have no such qualms. They have provided a test group with international ID cards. Promoted as a way to get through customs more easily, the card holds all the pertinent information on the holder that the government deems necessary, along with a digitized map of the owners hand print. As a preview of what the future may hold, these selected passengers insert their card into an electronic "palm reading" device while placing their hand over the device's scanner. The bureaucrats at the Centers for Disease Control and Prevention are at it again. It seems that the latest figures are in on alcohol-related traffic deaths, and our public servants are patting themselves on the back because the number has dropped 10% between 1982 and 1992. But there's a fly in the ointment that greases the number crunching machine. While the 10% reduction represents people behind the wheel, the number of drunk pedestrians killed by automobiles has only gone down by 3%. Deeming this situation as unacceptable, the CDC's National Center for Injury Prevention and Control has instituted a study on ways to adapt present drunk driving regulations to fit the drunk walking scenario. So watch your step. (AP)

The bill for Bill's bill

What will \$200 billion buy these days? How about a police state? \$200 billion is what's being allocated for Clinton's crime bill. Big Brother's shopping list reads as follows: \$3 billion for the construction of ten high security regional prisons. \$3 billion for the construction of military style boot camps and local correctional centers. (This would free up space in state prisons for hard-core criminal types.) \$500 million for juvenile rehabilitation centers. Sixty thousand juveniles are expected to occupy these camps. Other funds will go towards such goodies as metal detectors for schools and DNA research. The bill also expands the list of capital crimes. You can now get the death penalty for killing a federal officer in the performance of his duty. This includes chicken inspectors. The government has also increased the penalty for "hate crimes" by one third. Hate crime is described as a criminal attack on person or property on the basis of the victim's race, color, religion, national origin, ethnicity, sex or sexual orientation. In other words, some criminal attacks are deemed more serious than other—equivalent—acts, based solely on the attacker's alleged beliefs. (New York Times, Leading Edge)

Working for the clampdown...

The National Guard of Puerto Rico has embarked on an anticrime campaign which some fear is a dress rehearsal for an authoritarian clampdown here in the United States. Using the "war on drugs" as an excuse to forego civil rights, the National Guard first surrounds a government housing project with a chain link fence, then conducts a door to door search. Thus far, 24 of the 332 government projects have been occupied by machine gun toting troops. National Public Radio recently broadcast a report on this campaign which, while touching on libertarian issues, seemed mostly to concentrate on praise for the troops by inhabitants of the projects. It would seem that, as in the U.S., the restrictions on recreational drug use have made life in the projects a dangerous affair. So once again the citizenry is anxious to sell rights for safety. The end result of this police state tactic is that the drug dealers have quit the projects and moved into the suburbs. (The Spotlight, Leading Edge, National Public Radio)●

Rosa and Ella are jelous of each other it brings a warm feeling to me. Both are at my place for the first time. Ella and

Pavil both give ash-trays (I don't smoke) we have a laugh.

Nov. Finds the approach of winter now. A growing lonliness overtakes me in spite of my conquest of Ennatachina a girl from Riga, studying at the

music conservorie in Minsk. and short After an affair which last a few weeks we part.

Nov 15 in Nov. I make the acquaintaces of four girls rooming at the For. lan. dormitory in room 212. Nell is very interesting, so is Tomka, Tomis and Alla. I usually go to the institute domatory with a friend of mine who speaks english very well. Eraich Titov is in the forth year at the medical institute. Very bright fellow At the domatory we 6 sit and talk for hours in Russian- english

Dec 1 I am having a light affair with Nell Korobka.

Jan 1 New Years I spend at home of Ella Germain. I think I'm in love with her. She has refused my mor dishonourable advanis, we drink and eat in the presenec of her family in a very hospitable atmosfere. Later I go home drunk and happy. Passing the river homeward, I decide to propose to Ella. ●

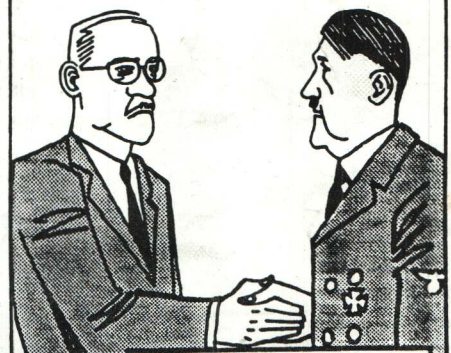
