





# I Baird's

Introduction by Joan D'Arc

he tries to walk that moral dotted line—When does life begin?—Bill Baird has to be careful crossing the street. Looking to the Right, he sees the Multi-Million Dollar Patriarchal Christian Corporations and their take-over agenda, and abortion foes praying daily for his death; to the Left, he sees a Women's Movement that for thirty years has slandered and rejected him as a "CIA agent" and "an embarrassment."

Baird has been called the "Father of the Abortion Movement" but he should more accurately be championed as the "Father of Reproductive Rights." No matter your age and sex, chances are your birth control rights would not exist if it were not for Bill Baird's three historic Supreme Court victories.

However, since the early sixties, the

women's movement has largely shunned Bill Baird. It may surprise today's Right-wing critics of so-called "extreme feminists" to learn why. In brief, they disagreed with his in-your-face tactics. Planned Parenthood actually thought there was "nothing to be gained" by his court-

room antics. Instead, they recommended pokey, polite measures. "Reform not repeal" was their mantra.

Bill was a "hard-core" militant. He rocked the boat. He purposely got himself arrested many times so he could appeal his arrest to the Supreme Court. Amazingly, he was heard and won three times. Does it matter how he did it,

so long as it was done? Is the women's movement so embarrassed that a man championed for their reproductive rights?

Bill Baird did time for the reproductive rights of all Americans. And the women's movement has tossed this wounded warrior aside, claiming he did it all to get laid. Do you hear anyone saying Gloria Steinem joined the women's movement to get laid by strange bedfellows Morton Zuckerman and Henry Kissinger? They wouldn't dare. Steinem had only to whine she was "tired" from her years on the road, and needed to be cuddled by big daddy, and her book became a bestseller.

Bill Baird busted like a steamroller through their bullshit, and the corporate hands they were busy shaking. Some in the women's movement called him a CIA agent, but feminism has its own undercover skeletons in its closet [see PARANOIA issue 3]. Perhaps they were tweaked that our reproductive rights were brought to us by...an unrepressed white man! Rather than insisting he was just driving his own ship, why don't we thank him for where his ship has taken us?

n October 17, 1967, exactly 27 years ago today, I stood before a judge in a crowded courtroom while literally hundreds of young people outside waited for the verdict with me. And the word came down. The judge ruled and said "Bill Baird, you're a menace to this nation, and you should be punished." I was convicted as a felon. If you've studied law, this means you are basically treated as a second class citizen. I was given a three month prison term.


Think about this. If you were asked to go to another state to contest the constitutionality of a law which, if it were changed, all the people of that state would benefit, but if you lose, then you, and you alone, would go to prison. How many of you would do it? That's what happened to me. I got a letter from Ray Mungo, editor of the Boston University News, asking me to come to Massachusetts to fight the constitutionality of the "Crimes Against Chastity" statute in Massachusetts. This law stated that anyone who printed, published, or caused to be written any information on birth control or abortion would be convicted of a felony and would do time in prison. I said "That law sounds insane," but I didn't really want to go and challenge it and do time in Massachusetts!

Years before, I worked for a company called EMKO, a birth control company. I witnessed the death of a woman in Harlem Hospital. I was doing research and I heard a woman screaming, screams I've never forgotten to this day. I ran into the hallway and I saw this naked woman literally covered in blood, from the waist down, as if somebody threw a can of red paint on her. I noticed she had about eight inches of wire coat hanger sticking out of her uterus. She collapsed in the corridor. She died. The stupidity of New York law was that not only did she not have the legal right to an abortion, but she did not have the right to birth control. I went to the Board of Health, the people whom you think would give out birth control. I picketed the Board of Health for refusing to give birth control to single people; abortions at that time you could forget about.

I went to Planned Parenthood. Did you know that Planned Parenthood was in the beginning totally opposed to abortion? This is part of the conspiracy I want to tell you about. Look at the handouts I gave to you. There is a 1967 statement by Planned Parenthood which states: "Abortion takes the life of an unborn child." In a sit-in, I took over their NY headquarters in 1967 to force them to come out and support abortion, which they finally did in 1969.

I bought an old United Parcel truck and fixed it up. I built inside a living room and a fireplace, so it would look like the home of a friend. And I drove it into poor neighborhoods and invited women in to talk about birth control, abortion and health issues. In Long Island, where I live, I went to talk to some women about birth control and out of nowhere two police officers showed up and said Baird, you're under arrest for "indecent exposure." I was handcuffed and arrested for showing a diaphragm in public. I faced one year in jail for that one. This was not Mississippi, not Alabama; this was New York, in May of 1965!

In a little town Freehold in New Jersey, police were

threatening to jail unwed mothers on the charge of fornication. As you probably know, fornication is against the law in many states, often with a six month jail term. I challenged, how can you do that? The reasoning was that jailing unwed mothers would lower welfare costs. If they were in jail, not fornicating, they couldn't get pregnant!

Shortly after, 800 B.U. students signed a petition asking me to come to Massachusetts. I refused, at first. I was pretty well bloodied after the horror being jailed in NY and NJ. But then I thought about that woman who died. She was the impetus for a lot of things I did over the years. In the interim, I had set up the first birth control/abortion clinic in 1964 in her memory.

In the July, 1967 issue of **Sepia** magazine was a story about me and my struggle against self-abortion. What does 1967 mean to you? **Sepia** was telling women, if you're in an unwanted pregnancy come to Bill Baird and he will help you. But to the police, it was still a jail term. To aid and abet an abortion in 1967 was a ten year prison term... Women came to me from all over the country, women who were desperate enough to try anything. If I may be so bold as to show you this chart.

This chart contains the items I showed before the Supreme Court explaining how self-abortions were performed. Let me explain those methods to you. Before legal abortion, women burdened with unwanted pregnancies would take a douching bag and fill it with Lysol, with bleach, or even with turpentine. This is a young police officer standing here behind me as I speak, but older police officers will tell you how they used to go into motels and find the bodies of women who died from these self- abortions. They would take one of these big turkey basters and force salt water into the uterus to cause an abortion and die from hyper-oxygenation. Residual air would get trapped in the blood vessels. If you force air into a major blood vessel, you die right there of an embolism.

There's a brown laundry soap called Kirkman that poor black women often used for abortions; they would chop it up and mix it with warm water, making an emulsion. They would put it into a douche bag and put it into the uterus. Death would often occur within ten minutes. What would kill a woman so quickly? Soap is made from fat. Your body can absorb the fat from the soap, and the women would die of a fat embolism.

I've seen patients who had taken a coat hanger with the end wrapped in adhesive tape. They would try to perform an abortion by inserting it slowly into the uterus and scratching the uterine wall to induce bleeding. Then they'd rush to a sympathetic hospital like Harlem Hospital. If she could prove she was bleeding, an abortion would be done to save her life. In the case of

the woman whose death I had witnessed, she had pushed the coat hanger through the uterine wall and punctured her bowel. She hemorrhaged to death.

Abortions were often done in motel rooms. Think! If you knew the police were nearby, how could you possibly perform an abortion in a motel room? You can't bring in an examining table; it's too heavy to carry for a fast getaway. You can't do an abortion on the floor, even the bed is too low. How do you think they were done? The abortionist would take out the dresser drawers and slide them in between the mattress and box spring so that whoever performing the abortion was at eye-level to the vagina. The woman was fully conscious and received no drugs for the pain; her purse was never allowed nearby in case she had a tape recorder. What you would do is go into the uterus and scrape the wall with a curette, the term is called Dilation and Curettage (D&C). It takes about five to seven minutes. A lot of patients I spoke with claim they were in fact given drugs,

ostensibly to relax them. They would wake up in the middle of the procedure with two or three men abusing them sexually. Now they couldn't go to the police and say "Hey man, I was just ripped off" because if you came out and said you were looking for an abortion, you could be under arrest.

I went to the Planned Parenthood people, I went to the NOW people. They all wanted to do things too slowly. While many in the feminist movement were calling for reform, I was calling for repeal of the laws. I felt somebody had to be more direct. There's some people who love me for this, and lots of people who hate me for it. But I'm a great believer that you don't beg for your freedom. Rather, you say, with dignity and strength, I will fight nonviolently for these rights. So on April 6, 1967, I stood before 2,000 Boston University students. I had never written a speech in my life but I knew what I

wanted to say.

It was then that I decided to challenge the "Crimes Against Chastity" law denying single women access to birth control. How in the world do you challenge it? There were no books written. I had no legal advice. The so-called legal people (the Mass. ACLU) turned out to be my bitter enemies. So I decided to hold up this very thing I'm showing you, a birth control device, which I held up to 2,000 students on April 6, 1967, the day of my arrest at Boston University. Can you see that this is a photograph of the Pill? On the bottom, it's called Saint Joseph's Baby Aspirin. It looks like the pill. On the top was a real birth control pill. So I said to the police, will you arrest me for showing the real pill. what looks like the pill, or the photograph of the pill? They didn't make the arrest. So what do you do next? Remember the law that said you could not print, publish, exhibit or give any information about birth control.

Prior to my getting to the B.U. lecture, I bought one condom and one package of foam and arranged to give it to a nineteen year old student; in other words, I deliberately gave birth control to a minor. I attached the sales receipt from Zayres department store, which said \$3, and 9 cents sales tax. Think about it. If you go to jail for giving out a condom. why not arrest the attorney general for allowing the illegal sales tax on an illegal sale? I thought I was very clever, but this challenge taught me a painful lesson; the students who had promised to back me only backed me until they graduated! Planned Parenthood wasn't about to back me. If you look right here at their literature from that time, they stated there was "nothing to be gained by court action of this kind." They even tried to sabotage my court challenge. Do you see that conspiracy? They were already a multi-million dollar organization. They tried to undercut the challenge of my goal, which was to be heard by the U.S. Supreme Court.

I have the anti-abortion people writing to me every day saying that they pray for my death, and I have the women's movement saying, "We don't know you."

Planned Parenthood further stated: "Bill Baird is an embarrassment to us." I was an embarrassment because I challenged the law, without their money or support! Their 1967 literature states: "An abortion kills the life of a baby after it has begun." So they've rewritten history to fool the public that they were always pro-choice. That's a falsehood.

In spite of all that, I appeared before Judge Macauly, who said, "You're a menace to society." He admitted that letters had come to him from across the U.S. and the world, asking for leniency such as a \$100 fine. He sentenced me to three months. You have no idea of the price I paid. I was stripped naked in that prison, the Charles Street Jail in Boston. Every night I had to worry about rape. And the System kept offering me the "good cop, bad cop" deal, saying, go back to New York and we'll give you a pardon. Despite news reports to the contrary, they had no intention of giving me a pardon.

In order for my challenge of the law to be effective, it had to be heard by the U.S. Supreme Court. Do you know that 98% of cases appealed to the Supreme Court are rejected? That's a 2% chance of being heard! When I was in prison,

the United States Supreme Court said this case has no value, they rejected it. Except for one man, Justice William Douglas. He said, "The teachings of Bill Baird and Galileo may be of a different order, but the suppression of either is equally repugnant." After my imprisonment, the U.S. Supreme Court decided to hear the case. On March 22, 1972, the court said this to the people: "If the right of privacy means anything, it is the right of the individual to be free to decide to bear or beget a child." It was a tremendous victory.

That case, called **Baird vs. Eisenstadt**, not only legalized birth control in America, but it set a precedent for the infamous abortion rights case, **Roe vs. Wade**. That decision, rendered the following year, quoted **Baird vs. Eisenstadt** six times.

Shortly after that, the rights of teenagers concerning abortion and birth control came under attack. What we do as older people to young people boggles my brain! The law at that time said: If you are a minor, you need the written permission of your mother and father or a judge of the Superior Court to get an abortion. I went to court in a case entitled Baird vs. Bellotti (the attorney general of Massachusetts) and I said through my lawyers, quite simply, if you're a teenager do you need your parent's permission to have a baby? If you are a teenager and you are a drug addict, do you need your parent's permission to be treated? How about if you have venereal disease? The answer to all of these questions is no! The court agreed with me that the abortion law regarding minors was unconstitutional. They stated the

Bill of Rights is not "for adults only." Now a new law says that if you are a mature minor, you can get the abortion. The judge rules the maturity. I dare one of you in this room tonight to tell me what is a mature adult? What is a mature minor? Listen to the power of what we do to young people. If you are a mature minor, you can get the abortion. But an immature minor can't get an abortion, so she gets to be a parent! Here's the kicker. Once you have that child, you are an "emancipated minor." That means you no longer need permission to get an abortion.

We Americans often will not allow ourselves to respond honestly as sexual beings. In Europe, they laugh at us. I can show you pictures of people blown apart in war, but I can't show you a picture of a couple having intercourse. On television you can advertise Preparation H for your rectum, underarm deodorant and vaginal douches. When was the last time you saw a television ad for the diaphragm or the Pill, or any birth control? Why is birth control a dirty word? William Shatner, Star Trek's Captain Kirk, was on the Mike Douglas Show with me in 1969


where I held up my birth control board. Ed Joyce, President of CBS at the time, kicked me off the air. He said it was disgusting. Yet, on the 6:00 PM news, you could watch people get blown up in Vietnam. He replaced me with Leave it to Beaver.

Last August, I debated
Rev. Paul Hill [now on Death
Row in Florida for the murder
of an abortion doctor and his
bodyguard] for 2 hours on
Boston's religious radio station WEZE. He stated that
killing Bill Baird was "justifiable
homicide." I've also debated
Randy Terry [founder of

(photo: Joe Donohue) Randy Terry [founder of Operation Rescue] on California radio station KKLA. Randy said that any woman who uses an IUD should be charged with murder! Father David Trosh stated on ABC on October 6, 1994, that any woman who gets an IUD, or the birth control pill, or walks into an abortion clinic with her husband or boyfriend, both of them should be executed. This is not a game. It's a Holy War.

When I debated Randy Terry on KKLA, he said "Bill Baird, not only you, but any doctor or anybody who helps a woman with an IUD, birth control pill, or an abortion, should be put to death." And nobody takes this seriously. Now we've had two murders in fifteen months. [Note: This lecture occurred before the Brookline, MA abortion clinic shootings of December 31, 1994.]

It's not safe for me to speak anywhere. Look at the situation tonight. Twenty-five or so years ago, the police were around to arrest me. Tonight the Providence Police have come to protect me, two officers inside and three police cars

outside. What does that say about what I've done to change things in the last thirty years? But I have to worry, will I get shot tonight? And what have I done? What have I done for the last 31 years, other than stand my ground and say that every woman has an absolute right to birth control and an abortion if she so desires to terminate an unwanted pregnancy.

How dare any religious tyranny say that a fertilized egg is a person! Their belief is that a soul enters at conception. Let's discuss that rhetoric. In the concept of twinning, the egg divides in half ten days after conception. So does each egg then get half a soul? Or maybe one gets a whole soul and the other gets none. Roman Catholics, let me ask you: Has the church always been anti-abortion, despite their lies? From 1249 to 1869, the church allowed the "40/80" method, according to the beliefs of Saint Thomas Aquinas, who believed that after 40 days a male gets a soul and after 80 days a female gets a soul. So since nobody could really tell if it was a male or female, all abortions were allowed up to the 80th day. In 1869, Pope Pius stated that we had it all

wrong: the soul enters at conception.

If a fetus is a person at conception, then the census should count every pregnant woman as two people. There is no state in this country that issues a conception certificate instead of a birth certificate. The 14th Amendment states that a citizen is born in the United States, not conceived in the United States. Did you also realize that about one-third of all pregnant women miscarry? I love it when priests say, "It was God's will." If that is so, then God is the biggest abortionist of all mankind. If you're going to quote the bible, I'll give it back to you, right down your throat. With its raw sexism, the bible states that a woman pregnant with a manchild is "unclean" for seven days. If you're pregnant with a womanchild, do you know how dirty you are? Fourteen days: twice as dirty! Why?

The population of the world is six billion and gaining at the rate of 94 million a year. Does it make any sense for a woman to bring into the world a baby that's going to starve to death? That is cruel, vicious and evil! Yet the Pope denies birth control to millions of Catholic women and others, be-

# The Clinic Shooter: Another 'Lone Nut'?



The anti-abortion movement denies any ties with John Salvi, accused of the deadly shootings at two Brookline, MA abortion clinics on December 31, 1994. However, the evidence seems to indicate otherwise.

He drove more than 500 miles, bypassing 180 abortion clinics, before zeroing in on one of the few open on New Year's Eve—a clinic long the target of radical anti-abortion activists. He was marginally employed and failed even to pick up his last paycheck. Yet when he was arrested, police found more than \$1,000 in cash on him.

He is described as a disturbed loner, an outsider to the anti-abortion movement. Yet police reportedly found a receipt from a Massachusetts anti-abortion group and the name and number of a Virginia activist who has advocated the killing of abortion doctors.

While anti-abortion groups deny any connection to John Salvi III, the investigation has raised suspicions of a conspiracy. "Why he went to Norfolk is a key aspect of the investigation," a senior federal official in Washington said on condition of anonymity.

Eleanor Smeal, president of the Feminist Majority Foundation, notes that, "He not only found a clinic opened on New Year's Eve, but he found one with an anti-abortion demonstration going on attended by people who advocate violence against doctors," She adds, "It could be by chance, but it strains credibility."

When arrested by Virginia authorities, Salvi had \$1,277.04 in his pocket. Investigators who searched his truck found anti-abortion literature, four highway maps and a receipt from "Mass. Citizens in Life." Frances Hogan, executive vice president of Massachusetts Citizens for Life, the state's largest antiabortion group, said she had no idea what the receipt may be.

They hold public masses for my soul. There was a Catholic mass held for my soul at St. Anne's Church, Brentwood, NY. I found out later that, besides the unpleasant things they said about me being the devil, they collected money three times for my soul! I went over and asked them for the money and they threw me out.

The Catholic Church is very big on punishment, also very big in the real estate business. They sell you a piece of land called heaven, none of us really knows if it exists or not. They say: suffer here, it will be better there. I'd rather suffer don't you give up your ermine collars, your satin, your dismond rings, your beautiful stained glass windows, and feed the poor instead. All the little babies that are being born to parents you will not allow to use birth control; why don't you parents you will not allow to use birth control; why don't you yourself? I wonder what he would say.

Most young people have no idea how hard-fought their nights were. And we are in serious danger of losing them by a very organized and insidious Christian Right. Their agenda

who published that picture would have to face the same jail term as me. That's how I got so many newspapers to back me. The **Milwaukee Journal** called me "A plucky crusader from NY." Before that I was an outside agitator.

Those are the kind of things I did that few in the women's movement had the courage or the creativity to do. They really believed that we should take it slowly. They didn't like my "in your face" tactics. In a feature story on me in the New York Times in 1985, Barbara Radford, Director of the National Abortion Federation, stated, "I deplore Bill Baird's confrontational politics."

Let's talk conspiracy. I've got a lot of them.

Would you agree that the **New York Times** is one of the most prestigious newspapers? They're very careful about how they print a story. This headline (April 14, 1993) reads: Bill Baird, the Devil of Abortion. No quote marks around the word Devil! Then Betty Friedan, one of the founders of the National Organization for Women (NOW) stated "Bill Baird is a CIA plant." I am part of a government conspiracy? I wouldn't know a CIA agent if I fell over one. My income is less than \$300 a week. The collection tonight is to pay for my gas to drive up to Rhode Island from Huntington, Long Island [for this lecture]. Friends in the area will put me up for the night. You could never pay me enough for what I've gone through.

Robin Morgan, former editor of MS. magazine, said "Bill Baird is in the movement so women will sleep with him." Think with me. If I wanted to get women to go to bed with me, if that were really my goal, do I have to be jailed eight times, get threatened, firebombed, shot at? Do I have to go \$200,000 in debt for three Supreme Court cases?

Let's expose the incredible conspiracy going on in the women's movement. The women's movement has basically said, to a proven warrior, we don't trust you because you

haven't got a uterus. They basically don't trust any men. But since they cannot invalidate the work I've done, they invalidate me personally by saying I'm a CIA agent or I'm really in this for sex. And I say, document it, prove it. The sad note is: the nation's first birth control/abortion Signs of the Times: In the 1960s, police were on the scene to arrest Bill Baird. In the 1990s, they're there to protect him.

clinic, the Bill Baird Clinic, is now closed. I was evicted in January of 1994 because I couldn't pay the rent. How did I pay the rent? I was a speaker. At one time I was paid \$2000 a speech on the college circuit. Colonel North gets paid fifteen grand! The women's movement has turned on me and has basically said, since men cannot get pregnant, they cannot speak for us. By their logic, a sterile women like Betty Friedan at the age of 74 should not be allowed to speak on abortion rights.

During my challenge to Massachusetts' archaic birth control laws, **Playboy** gave my attorney Joe Balliro the \$2000 needed to file my brief in **Baird v. Eisenstadt**. NOW would not help me at all. What is so now about NOW? They basically said that if my name was Willamena Baird, they'd back me. Part of my anger is that I started before NOW was formed, in 1966. NOW did not take a pro-choice stance until 1969. Whether you like me or not, you will have to agree that before my three Supreme Court cases, single people could not legally have intercourse with birth control protection in this country. Can you take that away from me? Why aren't there any of my so-called "sisters" from the women's movement here tonight? Where is Planned Parenthood?

I see the Betty Friedans and the Gloria Steinems, who have not paid a tenth of the price I've paid for their freedom, disparaging my efforts. I have the anti-abortion people writing to me every day saying that they pray for my death, and I have the women's movement saying, "We don't know you."

I bumped into Abbie Hoffman, my old friend, by chance in New York about two weeks before his death. He felt exactly like I feel right now, isolated, flat broke, and rejected by his so-called peers. I hugged him in the street and said, "Abbie, it's not how many times they knock you down, it's how many times you get back up." I said, "Don't let them break you." And two weeks later they did break him. He took his life...

Nobody in history has ever had three U.S. Supreme Court case victories; no one except the person standing right here. Can you understand the scars that makes? You cannot fight a war without being scarred, but when I say take my hand, you give me the strength to fight for your freedom, your dignity, and your rights.

Let me ask the men in the room, could society treat you the same way it treats women? Would they get away with it? Let's say we offered you a free \$500 vasectomy, but you must agree to these terms: lay on an examining table while we put a scalpel right next to your scrotum and get ready to make an incision. But you also must allow anti-abortionists to scream bloody murder right outside the window. So if you or the doctor suddenly jump out of fear, you are castrated. You tell me now if that's free speech. If we perforate a woman's uterus, is that free speech? You cannot picket the Soviet embassy within 500 ft., you cannot picket an election booth within 300 ft. I'm just asking: Can we not give women the same dignity, the right to medical treatment in a safe environment?

If we came up with a new birth control device called the Intra Penile Device, a little plastic object inserted into the tip of your penis, would you men go for it? It might cause bleed-



My name is Phil and I've belonged to the organization, The Family, for over 20 years. I was in the former movement, too, known as the Children of God ... I read your article with interest, and from what I understand of the "tone" of it, it is your intention to present an "alternative view" of the situation and circumstances surrounding the death of River Phoenix which doesn't normally surface in mainstream media coverage. You seem to view River's death as being shrouded in mystery that might involve a type of "cover-up."

I read on one of the first pages of PARANOIA that the PARANOIA that is represented in this magazine is not one of "personal paranoia or they're-out-to-get me," rather it is an attempt to gain a "heightened awareness" of "news" and events in society and the freedom to question the status quo! In principle, this "goal" is notable.

My reason for writing you is simply to ask: "How much do you really know about The Family?" My intention is to offer a better insight into our organization. We've opened our doors and had many visits to our communities by academics, sincere journalists, professionals, law enforcement officials, social workers, etc. who've wished to "see for themselves" what we are like. There's nothing we are trying to hide!

It seems that you are a writer who proposes an opinion or as you might

say an "alternative view" as a selfstyled critic, without the interest of journalism or news reporting where investigative reporting, gathering of facts and analysis go into producing a written article.

Hence, it is easy to comprehend, judging by your resources (Hustler's article "Family Ties" [by Alex Constantine]; [former member] Deborah Davis' book about the C.O.G.; The New Cults by "self-styled cult expert" Walter Martin; and Mr.Cain's article [from The Humanist]) why you present The Family as a dangerous "cult" and "sinister organization" with its tentacles sucking on politicians, powerful financial figures, and able to manipulate whomever it will! Is this your personal and professional opinion as well? Or is this an article that will "sell a copy" and fascinate its readers? If the case is the latter, let's hope that the readers will take it with a grain of salt ... and let it flow in one ear and out the other. As a Family member, I find it quite erroneous and I've counted 10 such gross misinterpretations of truth and/or wrongly quoted "out of context" statements.

Speculations of The Family being "some sort of intelligence tool" and "escaping criminal prosecution through the efforts of influential friends and backers" and, finally, "whether River Phoenix had been contacted by, or was going to be contacted by, the Argentine prosecutors [investigating the Family.]" And "If so, did the cult want him silenced?" My response is: Would these speculations of yours "hold any water" in a court of law? The Family is not any sort of intelligence tool; nor is it secretly and clandestinely backed by political or financial figures; and we detest the notion that we as an organization would ever even conceive of "silencing someone" to escape the law or justice! Honestly, I can't find anything in The Family that would lend itself to such an allegation or even permit such intentions to exist.

The Family does not permit any substance abuse or abuse of its members and children. Such abuse is against our very basic tenets. We are opposed to any and all forms of violence—and these are not permitted in our communities.

As you also said: "If only for the memory of River Phoenix, that cult's most famous abuse victim, it's time to ask Why?" I, too, would like to ask you "why?" IF any law enforcement agency, prosecutors, or whoever want to assert any type of action against The Family...we'd like to know why and based on what evidence or charges?

I've enclosed some material regarding The Family. I hope it [provides] a better or more conclusive view of our organization and its founder, as well as our true beliefs and practices:

THE FAMILY HAS BEEN THE SUBJECT of a number of reports in the American media recently. While some have been generally fair-minded, and presented our beliefs and practices relatively accurately, others have not. In some cases they have even insinuated that our members are guilty of serious crimes... We therefore find it imperative to correct these media misrepresentations in order that our friends, supporters, and the general public may have a clear under-

standing of our fellowship and the work we are engaged in. Following is a brief explanation of The Family, along with a short rebuttal to some of the points which were distorted by the press. We encourage you to contact us for any further information that you may desire.

WHO ARE THE FAMILY? We are a fellowship of independent Christian missionary communities, and our members are presently active in about 50 countries. We have a full-time membership of 3.000 adults and their 6,000 children. There are approximately 750 of us currently in the United States, 2/3 of whom are children. Generally speaking, our Family has three broad priorities. Our primary mission is to obey Christ's command to "go into all the world and preach the Gospel to every creature" (Mark 16:15). We believe that the miracle-working love and power of Jesus, as portrayed in the Bible, is the one real lasting answer to the many problems that plague mankind today. We are also active in ministering to the socially disadvantaged. Secondly, we live a cooperative, communal lifestyle, which is patterned after the early Christians as recorded in the New Testament's Book of Acts. This has proven to be very economical, greatly facilitating our evangelical mission...

OUR ORIGINS. The Family traces its origins to the Jesus Revolution of the late 1960s. Our founder, Father David, started a ministry to the hippies in southern California, many of whom were subsequently delivered from drugs and chose to work with him to reach and help others. The group grew and was given the name The Children of God (COG) by the media. By 1978, the COG had become established in scores of countries. However, when reports of abuse of authority by some COG officials began to a surface. Father David dissolved the COG and invited those interested to join him in a new fellowship, which over the years became known simply as The Family.

our basic beliefs and doctrines are the same as those of millions of Christians the world over. We hold the Bible to be the divinely inspired Word of God, that Jesus is the only begotten Son of God, and that through His death on the cross redemption was brought to mankind. Salvation is a gift given freely by God to anyone who sincerely acknowledges their need for a savior and asks for Christ's forgiveness. We are persuaded by Scripture that we are living in the last generation prior to Christ's visible return to Earth.

Two of our beliefs which many mainline Christians do not agree with have fueled much of the controversy about our fellowship. We hold that Father David is a prophet of God for this generation, and that loving heterosexual relations between consenting adults is not a sin in the eyes of God, provided that it is with the agreement of all involved, and hurts no one.

OUR CHILDREN ARE SAFE FROM ABUSE. Although much has been made of our sexual beliefs and practices, our children have not been abused. We acknowledge that our sexual beliefs are controversial, but we emphasize that we do not promote nor condone any behavior that

# We acknowledge that our sexual beliefs are controversial, but we emphasize that we do not promote nor condone any behavior that is unloving or perverted, let alone illegal.

is unloving or perverted, let alone illegal. Sex is a very minor part of our lives. But rather than adopt the hypocritical double standard of much of today's secular society and even many professing Christians, we prefer to be honest and state our sincerely held religious convictions on the subject.

Our children are not permitted to engage in any sexual activity that is improper or illegal, and our teens are strongly encouraged to refrain from sexual relations until they are of legal age. If various American polls are to be believed, Family teens are much less active sexually than the average American teenager.

We cannot emphasize strongly enough that we do not tolerate any form of abuse of children within our communities. Sexual contact is prohibited between anyone over the age of 21 with anyone under 21. Offenders are expelled from our fellowship. In spite of the most determined efforts of our detractors to smear us with charges of child abuse, our members have always been completely experated by authorities who have examined our children and communities.

QUOTATIONS TAKEN OUT OF CONTEXT. Many of the quotations from Letters written by Father David were taken out of context in these recent articles. Over a period of 23 years, 35,000 pages of Father David's writings have been published. As he is by nature an outspoken iconoclast, it is inevitable that some of his statements can be misconstrued...

Some articles have also quoted excerpts from a few of the more than 50,000 other pages of literature we have published throughout the years. Many of the controversial publications in question have long since been removed from our communities, and in no way reflect the current 1 practices of our membership.

We must remember the past. History shows us the struggle for freedom has always been between memory and forgetting, remembering

the past, but working for the future. We permitted the demonization of the Branch Davidians. The reason people won't fund an independent investigative panel on Waco, is because this was a "cult"! People say "There was evil there, sin. A threat to our religion, a threat to our established institutions, to our government, to our way of life." Everything that I work in, in terms of fundamental human rights and freedoms and peace, is terribly infected by the capacity for demonization in modern society...

We speak constantly in terms of "cults." but once the word "cult" is pronounced. most people can't think beyond that; the religious group becomes something inherently evil. The well has been poisoned and you can't drink out of it... As concerns The Family, it's absolutely appalling to observe what is happening to them around the world. It's clear beyond question that it involves inter-governmental coordination and communication, and the cooperation and participation of groups that call themselves "anti-cult" groups, who want to protect, as they see it, the population worldwide. Organizations like C.A.N., the Cult Awareness Network—which I've observed in several contexts now-have close relationships with law enforcement...These organizations come

out and create press scandals, so to speak, after having obtained confidential police information about people.

The Family is a very small, highly integrated group, numbering in a handful of thousands, spread all over the world. Since 1990, the attacks on them have been constant in Spain, Argentina, Australia, France and Peru... Argentina is perhaps the most flagrant case, with [over a] hundred children taken from their families. and scores of adults imprisoned. All of these cases have finally totally dissipated. There are some still in progress, but there is not a single case in which a single court or government agency has established a single incident of child abuse. All of these cases have ended—the ones that have ended-not only with a vindication of the church conduct, the parental conduct and the condition of the children, but with criticism or condemnation of government action as being ideologically based rather than factually based, reflecting inadequacy in investigation.

The trauma...is something not talked about—the trauma on those children! Hundreds and hundreds of children all over the world were taken away from their parents. I think of those little kids in Waco, you know what the trauma on them was—they're dead! Suppose a little child had lived, might not that episode consciously and inescapably unconsciously have been a dominant factor for the remainder of his life, affecting his perception of society and his interrelationships?

The government of the United States, including the State Department, has shown awareness, international presence and supervision, regarding The Family. Interpol has involved itself with several Family members, in response to police input. The religious community must address this phenomena of the capacity of governments to brutalize small, unpopular religious groups who can be demonized when called 'cults," and then action is taken against them without evidence. If a conventional crime is committed, it should be addressed, without calling a whole group a "cult" and condemning it and arresting all the adults, taking away all the children. keeping them in institutions, while they wonder where their mommies and daddies

### **New World Order countdown**

### Vatican money laundering alleged

A Mafia informer has accused U.S.
 Archbishop Paul Marcinkus of laundering Mob money while head of the Vatican bank. Vincenzo Calcara, a former member of La Cosa Nostra, has told Italian magistrates that he was part of a delegation that delivered approximately \$6 million to Marcinkus in 1981. At that time, Marcinkus was head of the Vatican bank, known as the Institute for the

Works of Religion, or IOR. Charles Raw, author of The Money Changers, a book on the Vatican bank, says that while Marcinkus was involved in questionable activities while managing the IOR in the 1970s and 1980s, he doubts that the Archbishop would have risked the exposure of such a meeting. Attempts to contact Marcinkus through his Sun City, Arizona parish were unsuccessful. (USA Today)

### New national alert system planned

 In December, 1994, the Federal Communications Commission announced a new Emergency Alert System that would beam information to our television sets, radios, pagers, and compact disc players. The new system would activate specially-equipped consumer electronic devices, even when they are turned off. The FCC re-

ported that many manufacturers have expressed interest in including the feature in their products, but said that it would not be mandatory. The FCC plans to test this new Emergency Broadcast system once a month, though how disruptive the test will be is unclear. (Los Angeles Times)

### Plea from prison

· Supporters of Yorie Kahl, a young man involved in a shoot-out near Medina, North Dakota in 1983, have established a legal fund to gain Kahl's freedom. Though Yorie never fired a shot, and was himself shot by federal marshals after he and his group left a meeting on taxes, he was convicted on two counts of second degree murder of the two federal marshals who died in the shootout. Kahl's father Gordon, who is said to have shot the marshals only after the marshals first opened fire, is presumed to have been killed in Arkansas, after law enforcement officials shot up and firebombed the cabin in which he was staying, in 1983. (The Kahl case is the subject of the documentary video Death and Taxes by Jeffrey F. Jackson, available from Country People Productions, 2554 Lincoln Blvd, Box #456-L, Marina Del Rey, CA 90291, 1-800-BURY-IRS.) Yorie Kahl hopes to gain a new trial, citing several problems with the original trial, including the fact that the judge trying the murder case, Paul Benson, was a friend of one of the dead marshals, and a member of the jury was a life-long friend

### More Water Under the Bridge

R.B. Cutler complicates his explanation for Ted Kennedy's Oldsmobile flipping over when it hits the water. [PARANOIA Issue 7]. He need not concern himself with the weight of engines, but with resistance and inertia. When the front end of the Olds struck the water, it met more resistance than it had flying through the air, slowing it rapidly. The rear end pivoted over the front because the property of inertia kept it in motion. A lightweight bike traveling at speed will do the same when it meets the sudden resistance of its

front brakes being applied.

If Cutler's drawing of the residual blood stains on Mary Jo's blouse even closely approximates the actual blood stains, it suggests that Mary Jo's arms were secured behind her back. Compare the length of the stains from collar to sleeve cuff to that from collar to mid-back. The illustration shows all three as having the same approximate length, possibly indicating that the sleeves and back were touching, bunched together, as if her arms were tied. It would be interesting to know if ligature marks were found on her wrists. Cutler also complicates the presence of blood. He suspects a blood vessel punctured by a syringe through which alcohol was injected. This seems highly irregular to me. An injection or intravenous drip of alcohol could have raised the blood alcohol level, but would not have included the trace elements which distinguish alcohol drinks: com, malt, barley... These would have been present only in the stomach after ingestion, and would have appeared suspect if in the blood stream from direct injection. It is much easier and more plausible to think that the operatives simply forced Mary Jo to drink the alcohol. Think of the scene in Alfred Hitchcock's North by Northwest in which James Mason's henchmen force Cary Grant to drink so that they could engineer a traffic accident. Perhaps Mary Jo's struggles or an escape attempt brought a blow to the head, the more likely cause of the blood stains.


### **False Christians**

# The Newt World Order

ire breather," "bomb thrower," "the man most
Democrats consider the devil incarnate," "the guerrilla leader of Congress' Republican insurgents,"

"McCarthyite," "buildog extremist." These are some
of the nicer epithets that have been hurled at Representative Newton Leroy Gingrich, the Republican
minority whip from Georgia's 6th Congressional District who
replaced defeated Democrat Tom Foley as Speaker of the
House in the Republican-controlled 104th Congress.

To judge from the furious invective he inspires from sputtering Democrat pols and media liberals, this man must be far indeed "to the right of Attila the Hun." Barely a day after the seismic shift of November 8th that swept the GOP to power in Congress and in state houses across the land, Mr. Gingrich had liberal punditdom frothing in high dudgeon for referring to Bill and Hillary Clinton as "counterculture McGoverniks" and to their White House staff as a bunch of "leftwing elitists." Even worse, he charged that Clinton Democrats are the "enemy of normal Americans" and represent the party of "total bizarreness, total weirdness."

### "The Vision Thing"

To millions of Americans, of course, Gingrich's words were merely accentuating verbally what they had already so powerfully expressed with their votes. And the media reaction was not only delicious Icing on the cake, but proof that their new champion had hit the mark. An arrogant, imperial President and an equally contemptuous Congress intent on imposing homosexuals on the military, pushing condoms to gradeschoolers, disposing of the Second Amendment, taxing families into extinction, gutting national defense, regulating businesses to death, spending the nation into oblivion, and entangling America in one UN military operation after another had been resoundingly repudiated in one of the most severe political massacres of modern times. And the victors. who had been scorned and excoriated as nuts, malcontents, and "religious extremists," had earned the right to crowsomething Gingrich does with unmatched flair.

But Newt Gingrich is also a capable exponent of 'the vision thing." In a policy address on November 11th at Washington's Willard Hotel, Gingrich delivered the conservative/populist message that many Americans wanted to hear.

declaring that he was going to pursue the goal of "disciplined, smaller, more frugal government"—with a vengeance. "One of the reasons the American people are so fed up with the current political structure," he charged, "is that they think they send a strong signal on election day and they watch it gradually dribble away in Washington, with all the people in Washington finding excuses not to do what they've [been] asked to do." Amen. The signal the American people were sending, he said, was "based on a pretty clear direction of less government, less regulation, less interference, and lower taxes, not just at the federal level, but at virtually every level across the country in virtually every state...."

Liberal columnist David S. Broder was suitably impressed by the address, calling it "a policy speech that was confident, coherent, and in every way impressive. The words were strong, the thoughts were clear, and no one who heard him was in any doubt that the House Republicans he leads will attempt to enact the conservative governing agenda he described."

Whoaaaa there, Mr. Broder, speak for yourself. For those who were listening closely, there was more than one agenda described. And for those familiar with history, with politicians in general, and with Newt Gingrich in particular, there was plenty of cause for doubt—and concern.

### The GATT Man

Chief and most immediate among those doubts and concerns is Gingrich's zealous commitment to helping President Clinton secure congressional approval of the General Agreement on Tariffs and Trade/ World Trade Organization (GATT/WTO) accord. When asked at his November 11th press briefing, "Will you rally the troops for GATT and the World Trade Organization?" he replied: "Yes. In the first place, the Administration has accepted the amendments of Senator Dole and myself giving Congress dramatically more oversight of the World Trade Organization, including the right to bring up a vote on withdrawal every five years in perpetuity, so at any point that we think it is out of control or inappropriate, we can simply withdraw."

The impression given by his answer was that he and Dole recently had come up with some amendments that would allay all concerns about loss of U.S. sovereignty to, and interference in domestic U.S. concerns by, the proposed supra-national WTO. What he actually was referring to was Section 125 of the agreement, entitled "Review of Participation in the WTO," which hardly provides the security against WTO tyranny he pretends to find. One of the most manifest

weaknesses of the Section 125 "protection" is the five-year cycle of opportunity for withdrawing; the WTO megabureaucracy could do a lot of damage to American interests in five years. Moreover, as far as "congressional oversight" goes, one need only consider how little that has been worth in protecting U.S. interests at the United Nations, the World Bank, IMF, UNESCO, or any of the other internationalist ventures with which we have become entangled.

Earlier this year Gingrich hesitated to support GATT and expressed concern that the WTO smacked of world government. "That is a bizarre turnabout for a man who almost single-handedly bailed out the Clinton Presidency by rounding up Republican votes for a similar accord-the North American Free Trade Agreement—over the opposition of House Democrats," the New York Times chided in a May 8th editorial. The Times had a point about Gingrich's NAFTA role, even though its arguments in favor of GATT/WTO were phony. "The W.T.O. would be more pussycat than tigerand would protect U.S. interests better than the existing General Agreement on Tariffs and Trade," purred the Times. That is about as convincing as the claims of Clinton, Gingrich, and company that GATT would, after ten years, "add an average of \$1,700 to the annual income of every American family." The WTO does indeed present a threat of world government; it is a multinational body with legislative, executive, and judicial branches wielding formidable powers. The myriad of ministries, councils, committees, commissions, panels, and boards to be established under the WTO would make it a global leviathan. It would be far worse than the dozens of international commissions, committees, and secretariats created to oversee and regulate trade between Canada, Mexico, and the U.S. under the 1,700-page NAFTA treaty-which Newt Gingrich gave to Bill Clinton on a silver platter. So much for promises about kinder, simpler, and less intrusive government.

### Fast Track to Disaster

However, the dangers of the GATT/WTO agreement itself are, at this point, of less immediate concern than the immoral and illegal process by which it is being rammed down our throats. And this from Mr. Gingrich, who in the same breath promises a new "openness" and "honesty" in governing and who calls for greater "participation" and "engagement" by the people. It is the rankest hypocrisy to talk about the new "mandate" and "listening to the people" and then to continue with the same sleazy manner of doing "business as usual" in Washington.

Forcing a "fast track" vote on GATTMTO—what some have called "the most important vote of the decade, if not the last 50 years"—in the "lame duck" Congress is an unconscionable act that cannot be justified on any count. It intentionally ignores what is obvious:

- As Gingrich himself has noted, "the people have spoken," and have elected a new Congress; and that new Congress should have the right (and responsibility) to vote on something as important as GATT. It should not be passed by a body that has been repudiated by the voters.
- The GATT system and negotiations have been going on since 1947. It is absurd to suggest that after nearly 50 years

we must now rush this new agreement through, that it cannot wait a couple more months for the new Congress to consider.

• The GATT accord runs some 26,000 pages. No member of Congress has read all of this monstrosity. Gingrich promised to make all bills and documents accessible to the American people, but we certainly have not had full access to all of this document.

If the Clinton health care program deserved to be knocked off the "fast track" because it was a costly, bureaucratic, socialistic nightmare, GATT/WTO deserves the same.

 The matters with which the GATT/ WTO

accord deal clearly qualify it as a treaty and therefore require ratification by a two-thirds vote in the Senate. Gingrich's repeated veneration of the Constitution (not to mention his oath) will be proven false if he does not demand compliance with this constitutional requirement.

However, the new Speaker of the House appears to be taking his direction from the New York Times and from the Council on Foreign Relations (CFR), the driving organizational force behind GATT (Gingrich is a member of the CFR), rather than from the Constitution or "the people" he claims to honor and represent.

### Rhetoric and Reality

Since so many other conservatives have been gulled into embracing GATT under the false banner of "free trade,"

Newt Gingrich's role in promoting NAFTA and GATT is seen by many as insufficient to call into question his "conservative" bona fides. After all, his rhetoric is as fiercely conservative as anyone's. He once denounced Senator Robert Dole, the Republican chairman of the Senate Finance Committee, as "the tax collector for the welfare state." He labeled all of official Washington a large, open conspiracy to take away the money and freedom of the citizens of this country." In 1985, he called President Reagan's rapprochement with Soviet leader Mikhail Gorbachev potentially "the most dangerous summit for the West since Adolf Hitler met with Chamberlain in 1938 at Munich." Over and over again, he has denounced big government. socialism, high taxes, deficits, welfare, bureaucracy, and the "counterculture."

True enough, but in politics deeds speak louder than words. And Newt Gingrich's deeds all too often do not match his words. Since entering Congress, Gingrich has repeatedly voted for big government, deficit spending, welfare, foreign aid, regulatory intervention, and socialism. He has repeatedly voted to send U.S. tax-payer dollars to communist countries and to grant communist tyrannies such as Red China and the Soviet Union most favored

nation (MFN) trade status, while demanding trade sanctions against South Africa.

He has given support to Nelson Mandela and the terrorist African National Congress. He repeatedly has voted for extremist environmentalist measures that are costing Americans billions of dollars. He repeatedly has catered to the "counterculture" and the militant homosexual lobby. Newt Gingrich's rating on the Conservative Index (CI) of THE NEW AMERICAN, while better than many other members of Congress, is far from the stellar rating you would expect from one heralded as "the theoretician in chief" of the conservatives in Congress. His CI ratings for his eight terms in office have fluctuated between fairly good to mediocre to

abvsmal:

96th Congress: 84 • 97th Congress: 77 • 98th Congress: 74 • 99th Congress: 80 • 100th Congress: 80 • 101st Congress: 57 • 102nd Congress: 60 • 103rd Congress: 78

The following sample of votes shows only some of the many decidedly unconservative votes Gingrich has cast:

Welfare Madness. During his 16 years in Congress, Gingrich has inveighed vociferously against the evils of the New Deal/Great Society welfare state—while voting for every kind of welfare program imaginable: for the elderly, children, the "homeless," businessmen, farmers, bankers, leftwing broadcasters, etc. Those votes include: March 21, 1991—\$30 billion to begin the unconstitutional bailout of failed savings and loan institutions; June 26, 1991—\$52.6 billion for agriculture programs, subsidies, and food stamps;

October 5, 1992—\$66.5 billion for housing and community development; September 22,1994—\$250.6 billion in appropriations for the Departments of Labor, HHS, and Education.

**Budget-Busting Profil**gacy, A Balanced Budget Amendment forms the core of the first plank of Gingrich's "Contract with America." He has been calling for such a measure and condemning deficit spending ever since coming to Congress. In an early 1982 speech he called on Congress to reject further increases in the National Debt Limit. "Only by using the debt limit as a leverage point" he bravely declared, "can we force the changes which clearly the liberal leadership of this body wants to avoid." Trouble is, a few months earlier, on February 5, 1981. he had voted with those same "liberals" to raise the National Debt ceiling by another \$49.1

billion to \$985 billion. He has gone this same route many times since. Of course, raising the debt ceiling would not have been necessary had he practiced what he preached. His votes against "more frugal government" include: December 21, 1987—\$603.9 billion for 13 regular appropriation bills larded with many wasteful, extravagant, and unconstitutional items (it passed by a vote of 209 to 208); May 4, 1989—outlays of \$1.165 trillion and a deficit of \$99 billion for a dishonest and spendthrift 1990 budget designed to barely skim in under the Gramm-Rudman \$100 billion deficit limit; March 10, 1994—a vote against a responsible amendment offered by Representative Gerald Solomon (R-NY) to balance the budget by 1999 through \$698 billion in spending cuts (a

mere 3.5 percent cut) over five years.

Considering these and other votes against sound fiscal policy. It is not surprising that Gingrich's spendthrift ways have carried over into his personal finances. The 1992 House banking scandal revealed that he had run 22 overdrafts on his checking account, and this in spite of having voted himself a huge pay raise and having a taxpayerprovided, chauffeur-driven car. Nor is it surprising that his rating from the National Taxpayers Union during the latest session of Congress (the 103rd) was a meager 75 percent. His tax-and-spend record over the years on votes tabulated by Tax Reform IMmediately (TRIM) has so often contradicted his rhetoric that National Director of TRIM James Toft was prompted to remark: "Professor Gingrich hopefully will never be called upon to teach a course in the proper role of our federal government. His rare votes against bloated big government usually have been prompted by the partisan wrangling of the moment, not by any great respect for, or understanding of, the Constitution."

Foreign Aid. If there is anything more unpopular, unconstitutional, counterproductive, fiscally irresponsible, and immoral than welfare for domestic freeloaders, it is welfare for foreign freeloaders. But the "tight-fisted" Mr. Gingrich consistently votes to send U.S. tax dollars to kleptocrats and tyrants abroad: June 27. 1990—\$15.7 billion in foreign aid for fiscal 1991; June 20 1991—\$12.4 billion for fiscal 1992 and \$13 billion for fiscal 1993; June 25, 1992-\$13.8 billion for fiscal 1993; August 6, 1992-\$12.3 billion for the International Monetary Fund and \$1.2 billion for the "republics" of the former Soviet Union; June 17, 1993—\$13 billion for fiscal 1994; September 29, 1993—\$12.9 billion, including \$2.5 billion to Russia; August 4, 1994—\$13.8 billion for foreign aid for fiscal 1995.

Eco-Lunacy. Gingrich, a longtime member of the Georgia Conservancy ("an aggressive environmental group comprised largely of upper-middle class urbanites"-Newt's own words) cofounded by Jimmy Carter, organized one of the early environmental studies programs back in 1970 while a professor at West Georgia State College. According to Current Biography, the success of his early congressional campaigns was due in large part "to the support of environmentalists." Besides being blatantly unconstitutional, virtually all federal environmental legislation involves gross violations of states' rights and the property rights of private individuals, both of which Gingrich claims to champion. Newt's "green" votes include: May 16, 1979—the Alaska Lands Bill, locking up 68 million acres as untouchable "wilderness"; December 17, 1987—\$307 million for continuation of the fraudulent and unconstitutional Endangered Species Act, putting the "rights" of owls, bugs, rats, snakes, and newts above those of people; March 28,1990—elevating the unconstitutional Environmental Protection Agency to Cabinet-level status; May 23, 1990—the badly misnamed Clean Air bill, requiring radical cuts in industry and automobile emissions, adding tens of billions of dollars annually in new costs to our already stringent and costly air standards.

Federalizing Education. The Communist Manifesto calls for nationalizing education, while the U.S. Constitution, to the

contrary, prohibits federal involvement in educational matters. These votes cause one to wonder which document's philosophy is guiding Newt Gingrich's education policy decisions: May 10, 1979-for creation of the new Cabinet-level Department of Education demanded by President Carter and the radical National Education Association May 9, 1989 -\$1.4 billion in federal aid for "applied technology education." the new federalese for vocational education; May 16, 1990—\$2.9 billion for Head Start and Follow Through programs for fiscal 1991, rising to \$7.7 billion in 1994; July 20, 1990—\$1.1 billion for a variety of education programs, none of which the federal government has authority to fund; May 12, 1994—"such sums as may be necessary" for the \$3.3 billion-per-year Head Start program and \$2.6 billion for fiscal 1995 for three low-income and child abuse prevention programs.

Counterculture Values. Despite playing to the 'religious right," Gingrich has racked up a surprisingly "moderate" record on homosexual "rights." His troubling votes include: May 22, 1990—the Americans with Disabilities Act, permitting massive new federal intervention into the private workplace in order to stop "discrimination" in hiring on the basis of disability, including AIDS; June 13, 1990-\$2.76 billion for various AIDS programs demanded by the militant homosexual lobby: July 12, 1990—the final version of the Americans With Disabilities Act.

On July 26,1990 Gingrich voted with the majority in refusing to support a resolution by Representative William Dannemeyer (R-CA) to expel Representative Barney Frank (D-MA) for felony criminal offenses related to his homosexual activities. He actively supported the re-election of Representative Steve Gunderson (R-WI), an open homosexual, and praises Gunderson's "courage" for being "gay" and Republican.

Nationalizing Law Enforcement. On October 22, 1991, Gingrich voted for an amendment to the federal crime bill offered by Representative David McCurdy (D-OK) to establish a National Police Corps. Although he didn't vote for the \$30-billion Clinton crime bill of 1994, he resurrected it and helped make passage possible. As Representative Susan Molinari (R-NY), one of Newt's cheerleaders, explained to Michael Kinsley on CNN's Crossfire, "If it wasn't for Newt Gingrich, you wouldn't have a crime bill."

Indeed. The Gingrich-led opposition "threw" the game, failing to challenge the bill's fundamental flaw-that the federal government has no constitutional authority to take over state and local crime-fighting duties—and focused instead on "pork" in the bill. "That crime bill stank to high heaven," charged Pat Buchanan. "[Ilt federalizes crimes such as spousal abuse, giving the feds police power the Constitution reserves to the states." And the crime package in Newt's "Contract With America" would speed us further down the road toward a national police state.

### **Newt's Roots**

Llewellyn Rockwell, president of the Ludwig von Mises Institute and publisher of The Free Market, observes that, rhetoric notwithstanding, "Newt Gingrich is a Rockefeller Republican, a big-government 'Conservative' who talks a

good line, but like Ronald Reagan will give us higher taxes, more government, and more spending. His 'Contract With America' is a fraud; it should be called a 'Press Conference with America." Or, perhaps, a "Contract On America." New-t's "Contract," with its calls for amendments to balance the budget and impose term limits, seems to imply that our original contract, the U.S. Constitution, is gravely deficient. This could give new impetus to the dangerous movement for a constitutional convention.

The problems with Newt Gingrich's "conservatism" go back to his "roots." Current Biography Yearbook for 1989 gives this snapshot of his early career:

After graduating from Emory [University in Atlanta] in 1965, Gingrich received a master's degree from Tulane University in 1968 and a Ph.D. degree in modern European history in 1971. His behavior at Tulane appeared to belie his future conservatism and hawkish foreign-policy views. He accepted student deferments rather than face the draft during the Vietnam War, experimented with marijuana, led a campus demonstration defending the school paper's right to print a nude photograph of a faculty member, and campaigned for Governor Nelson A. Rockefeller of New York in 1968 because of the governor's support of civil rights.

Nelson Rockefeller, of course, was the bane of all conservatives, the epitome of effete internationalism, and a member of the CFR (run by his brother David) and the ruling elite of the Eastern Establishment. In his unsuccessful runs for Congress in 1974 and 1976. Gingrich showed no deep conservative leanings. He was, and remains, a member of the NAACP, the World Futurist Society, and the New Ageoriented Congressional Clearinghouse on the Future. In 1978 Congressional Quarterly gave this bio of the freshman congressman: "In his previous campaigns Gingrich was considered unusually liberal for a Georgia Republican. But this year he relied on the tax cut issue, using an empty shopping cart to emphasize his concern about inflation." He also capitalized on the widespread anger over President Carter's Panama policy and headed up "Georgians Against the Panama Canal Treaty." He has been using conservative issues to advance his career ever since.

In 1981 this writer asked Georgia Congressman Larry McDonald for an evaluation of the rising Republican star from his neighboring 6th District. His reply was surprising, at the time. Newt Gingrich, he said, was a devious and ambitious politician masquerading as a conservative and not one to be trusted. Gingrich had gone out of his way, Dr. McDonald said, to obstruct and to undermine support of conservative members of Congress for some of McDonald's legislative efforts. This was particularly disturbing since Representative McDonald was the most conservative member of Congress—by virtually all ratings systems—and would have been a natural ally of Gingrich if Gingrich were truly conservative. In July 1983, the Conservative Digest compared the voting scores of the leading conservatives in Congress based on ratings from the American Conservative Union, the Committee for the Survival of a Free Congress, the National Conservative Political Action Committee, and THE NEW AMERICAN's own Conservative Index. Congressman McDonald topped the list at a combined 98.3 percent. Congressman Gingrich weighed in at an anemic 77.5 percent. [Congressman McDonald's career ended aboard the ill-fated KAL Flight 007, presumably shot down by the Soviet Union in 1983. See PARANOIA Issue 4.]

### **CFR Crafted Conservative**

However, by beating his chest more loudly, trumpeting his message more stridently, and pursuing power more ruthlessly than all others, Gingrich has won the title of Maximum Leader of the "Conservative Revolution." Not that it was all his own doing, by any means; the CFR-dominated "liberal" media have been only too accommodating in crafting conservative bona fides for one of their own. It is a sickeningly familiar redux.

In 1976, CFR front man Jimmy Carter was presented to us by the same CFR media elites as a "conservative" Southern Baptist from Georgia who would give us the "change" America needed. In 1992 it was CFR member Bill Clinton, another "conservative" Southern Baptist from Arkansas who was sold to the country as the ticket to positive "change," the "New Democrat" with "traditional values" and a "New Covenant." Now comes "conservative" Southern Baptist and CFR member Newt Gingrich, with promises of drastic "change" and a new "contract." If you're beginning to sense another imminent betrayal, congratulations: you're catching on.\*

# The Four Horsemen of the Apocalypse

nother puzzle-pattern emerged, and I was given to realize that this edict from President Bush (CIA group code-name, Black Rose) was the clue that we are IN the Third Seal, the third of the four horsemen of the Apocalypse, the Black Horse. I had previously perceived the bare outlines of the First Seal, the White Horse, (1776+, Illuminati and

Freemasonry) and the Second Seal, the Red Horse, (1790+, Communist Revolutions), which further confirmed our position in the sequence.

### The Christian Conspiracy

My immediate reaction was to send off a three-page letter to a few of the preachers on the local Christian radio station, figuring they'd be as excited as I was about this startling but prophesied occurrence. The Bible states a

"When he had opened the Third Seal... I beheld, a lo, a black horse, and he that sat on him had a pair of balances in his hand...saying... a measure of wheat for a penny, and three measures of barley for a penny; and see thou hurt not the oil and the wine." (Revelation 6:5, 6:6).

number of times that the end-time prophecies will not be understood until they happen (Revelation 22:10; Daniel 12:9). It further states, "And it shall come to pass afterward that I shall pour out my Spirit upon all flesh; and your sons and daughters shall prophesy..." (Joel 2:28).

Well, I'm a daughter, and I'm made of flesh, so that includes me. But the pastors didn't think so. As I continued

to study, the picture became larger and more accurate, with information pouring in from previously unknown sources. An old computer and printer were given to me by a friend, and the letter became sixteen pages, then twenty, and with additional documentation, it grew to a couple hundred pages. I kept sending it out to these aforementioned "Christians", who continued to dismiss it. Didn't believe in conspiracies, they said. But the Bible itself describes the conspiracy in detail!

After about a year of this, my attention was drawn to a number of chapters and verses that spelled out the situation. A friend pointed out the deeper meaning of Matthew 24:5: "For many shall come in my name (i.e., calling themselves "Christians") saying, I am Christ, (i.e., "Jesus is Lord"), and shall deceive many". If you've ever seen the shenanigans on TBN, you've got the picture. Needless to say, the "ac-

cepted" interpretation of that verse is limited to the David Koreshes and Sun Yung Moons, who proclaim themselves to be Christ, when in fact, it applies to virtually all organized "Christian churches". The modern "Church" as it exists in America-all denominations-is an extremely high-level, deep-cover psy-Ops agency of the Shadow Government. And the Bible said it would be, in Luke 13:21 and Matthew 13:31. While all religions offer false methods of "knowing (or becoming) God", "Christianity" is the most pernicious, because a counterfeit is most difficult to detect when it most closely resembles the real thing.

Check out Matthew 23 for what Jesus thinks about the religionists. Hypocrites is the word He uses most. The apostle Peter wasn't nuts about them either. His description of the "Christian Right Wing", "Eagle Forum", "Moral Majority" and their ilk: "There shall be false teachers among you... and many shall follow their pernicious ways; by reason of whom the way of truth shall be evil spoken of." So, if you have a hard time controlling a gag reflex when you think of "Christians", you and Jesus have a lot in common. He says He will vomit them out of his mouth (Revelation 3:16) after removing His people from among them (Revelation 18:4; Ezekiel 34:10; Jeremiah 5:26-31; 10:21).

If you, like most, reflexively equate these counterfeit "Christians" with the Bible and Jesus, you're living testimony to the overwhelming success of the cryptocracy's most sub-rosa (and most crucial-it's about souls, after all) operation. Obviously it's true not only of those who have resolutely shunned the "Christian Church", but to church-goers who are too obtuse to "Come out of her, my people" (which is the vast majority of them. Matthew 7:21-21: Luke 1:24-30). It was a real relief to realize I didn't have to join that crew. but dismaying to see that there weren't any alternatives, in terms of "Christian" leadership. Having given up on the phony pastors and priests and prophets, but still not comprehending the profound and determined (predetermined!) impenetrable blindness of the "flock", I had rewritten "The Four

Horsemen Exposed" for the layperson. still figuring that it would be the "Christians" who would comprehend it. But alas, "this people hath a revolting and a rebellious heart; they are revolted and gone" (Jeremiah 5:23);... "for the leaders of this people cause them to err; and they that are led of them are destroyed" (Isaiah 9:16). The Bible has also made it clear that His people are not, by and large, hanging around churches. "For the pastors are become brutish, and have not sought the Lord therefore they shall not prosper, and all their flocks shall be scattered" (Jeremiah 10:21) "His watchmen are blind, they are all ignorant, they are all dumb dogs, they cannot bark; sleeping, lying down, loving to slumber". (Isaiah 56:10).

While many are correctly identifying the world's dramatically increasing travail with the "beginning of sorrows", in Matthew 24, Mark 13, and Luke 21, and even pointing out the parallels to the horsemen that ride in the Seals, they are utterly blind to the fact that we are now living in the Time of the Seals. Because of this, they aren't able to use the convicting prescience that God has provided in the following prophecy: "And now, I have told you before it comes to pass, that when it is comes to pass, ye might believe" (John 14:29).

We're victims not only of the elegantly planned and painstakingly applied plans of the Evilarchy, but of our own deceitful hearts and fallen natures (Jeremiah 17:9), without which their Machiavellian machinations could not succeed. We're ever-ready to embrace any "solution" that allows us to continue without confronting our own delusions of grandeur. We insist that we're special by our own merits, exalted on our own account, sovereign by our own power, perfectible by our own design. We close our eyes to the evidence that surrounds us and indwells us, and live and die in our own virtual reality. Every day, in every way, we're getting worse and worse, and we deserve what's coming down.

### Seal Three - Black Horse

The basic warning signs of the impending "end of the age" are given in Matthew 24, Mark 13, and Luke 21, in answer to the disciple's question: "Tell

us, when shall these things be and what shall be the sign of thy coming, and of the end of the world?" The answer, as recorded in Luke 21. is

Take heed that ye be not deceived, for many shall come in my name, saying I am Christ; and the time draweth near: go ye not therefore after them. But when ye shall hear of wars and commotions. be not terrified: for these things must first come to pass; but the end is not by and by....Nation shall rise against nation, and kingdom against kingdom: and great earthquakes shall be in diverse places, and famines, and pestilences; and fearful sights and great signs shall there be from heaven...And there shall be signs in the sun, and in the moon, and in the stars; and upon the earth distress of nations, with perplexity; the sea and the waves roaring; men's hearts failing them for fear, and for looking after those things which are coming upon the earth: for the powers of heaven shall be shaken."

Even those who limit their information-gathering to the nightly television "News" can confirm the occurrence of all of the above, as at no other time in the recorded history of mankind. In astonishing detail and accuracy, however, the Seven Seals of Revelation 6, the first four of which are the Four Horsemen of the Apocalypse, show us precisely where we are on the timetable, and what's to come next. Until now, they have been only vaguely described as the white horse of conquest, the red horse of war, the black horse of famine, and the pale horse of death. But there's much more.

I believe I can conclusively demonstrate that the Four Horsemen of the Apocalypse, the first Four Seals, precede Daniei's Seventieth Week; the Fifth Seal is the first three and a half years of the last seven years of this dispensation: and the Seventh Seal, which contains the First Trumpet, begins the Great Tribulation, the time of the end, the second three and a half years of Daniel's Seventieth Week. which contains both the Wrath and the Judgement. Further, there are two Raptures, the first of which takes place during the Sixth Seal (Revelation 6:12-17) and the second before the

Vial, or Bowl Judgements (Revelation 15:2), just where the Bible says they are, as opposed to the position of the "Pre-Tribulation pillow prophets" (Ezekiel 13) who expect to be evacuated between chapters 4 and 5; a slight miscalculation. We're directed to inter-

pret Scripture literally when the text and context warrant it, and a literal, chronological, and comprehensive understanding of the Seals is now possible, as it has not been previously. This is true of much end times prophecy, due to relatively recent events on the world scene. The Holy Scripture has told us to expect just this phenomenon (Jeremiah 23:20, Daniel 12:9, Matthew 10:26).

The Bible states, shadowed in "And it shall come to pass afterward that I shall pour out my Spirit upon all flesh; and your sons and Rev. 17:1 is daughters shall prophesy..." Well, I'm a daughter, and I'm made of flesh, so

We are in the midst of the Third Seal, and the meaning and content of the first Two Seals have been made abundantly clear, when viewed in the context of recent history, and in the full context of the Bible. The remaining Seals are predictable with considerable precision in regard to both timing and circumstance. With your continued patience, I hope to demonstrate incontrovertibly that the Seals are the stages of the Anti-Christ System, a.k.a. The New World Order, being maneuvered into place for the World Monarchy of the Anti-Christ.

### The Seals are Pre-Second Coming

The very designation "Seals" tells us that they must be opened before the event (The Great Tribulation) begins. One cannot read a letter until all the seals are broken, and we are told that the Lamb (Jesus) alone is worthy to open them. He does so from the right hand of Him that sits upon the throne (Rev.5:7), in Heaven. Therefore. He opens them Before His Second Com-

ing and, thus, before the Rapture of the Church. Some expositors are insistent on referring to the "Seal Judgements". but the Bible does not. The Revelation does not label anything a judgement until Rev.14:7, which announces that "the hour of His Judgement is come".

and this judgement is fore-Rev.11:18. The word "Judgement" is not used until that point, just before the Bowl Judgements. Everything between Rev. 6:17 and referred to as the "wrath", and the beginning of the "wrath" is clearly announced in Rev. 6:17, the Sixth Seal: "for the great day of His Wrath is that includes me. come', beginning, therefore,

with the Seventh Seal, the First Trumpet.

### The Seals are Pre-Judgement

Rev.6:9, the Fifth Seal, shows us all the saints martyred to that time crying with a loud voice, "How long, Oh Lord, holy and true, dost thou not judge and avenge our blood on them that dwell upon the earth?" They are told they must "rest yet for a little season, until their fellow servants also, and their brethren, that should be killed as they were, should be fulfilled". This corresponds to Matthew 24:9-14, Mark 13:9-13, and Luke 21:12-19, a period of time when Christians will be martyred, many of them under the justification of "bio-relativity" (Mother Earth) (John 16:2). This martyrdom precedes the Great Tribulation, which begins, in each of these books, with a verse, referring to the Abomination of Desolation. Therefore, we know that Seal' Five, and the four preceding Seals, takes place prior to the Time of Jacob's Trouble and the Judgement. While this would still allow for the possibility of

Seals 1-5 happening in the first three and a half years of Daniel's Seventieth Week (if we disregard God's precision elsewhere), as we continue I think you'll see why this is not the case. The persecution of Christians has, of course, been continual throughout

half of the world's population should be eliminated by the year 2000. I wonder if they realized that 1/4 of six billion is one and a half billion dead, (Fourth Seal, Revelation 6:8) leaving four and a half billion, of which 1/3 more (1 and 1/2 billion) are killed in Revelation 9:18,

the Sixth Trumpet, for a grand total of 3 billion dead (one half A.D., but to the "oil and wine" of the "end of the age" (i.e. Now!).


The context of Seal Three is commodities and prices, of staple foods (expensive—a day's wages for a day's food) versus luxury foods (such as oil and wine [Prov.21:17] kept affordable—"hurt not"). Both of these conditions of Seal Three are now being fulfilled. The division between the "haves" and

"have-nots" has never in history been so extreme as it is today. A day's wages for a day's food is already the case over much of the globe, if there is food to be had at all. Millions are starving to death each year, and multi-millions more are malnourished to the point of irreversible damage. The depopulation program is moving along right on schedule. Monetary systems of all countries are in wild flux, due to systematic looting and high-level tinkering. Unemployment and underemployment are the

highest since the Great Depression, and companies are still down-sizing drastically, or moving to areas where slave-labor wages are welcomed. Brazil has an accumulated inflation rate of 146 billion percent since 1980, according to the **New York Times**.

The Central Bank in Russia forced a ruble recall of all notes printed before 1993, and allowed each citizen only \$35.00 of the new currency, with the rest to be deposited for six months in savings accounts that will be worthless when they can be retrieved, due to the inflation interest ratio. Mr. Greenspan has decided that the Federal Reserve will abandon previous yardsticks and embark on new plans for controlling our money supply. A double currency, one foreign, one domestic, is being considered.

The unprecedented flooding and drought in our nation does not bode well for food prices here. DuPont has



history, usually at the hands of the religionists, and is now rampant in Red China, where the State-approved "Christian Church" tortures, kills, and often cannibalizes those who own or smuggle a Bible. Much the same thing is going on in South America, Senegal, Pakistan, Mexico, etc., and will soon be happening in the good of U.S. of A (or Magna-Region 1).

### The Four Horsemen are Pre-Tribulation

While some wish to interpret the Seals as an overview of the Tribulation, this cannot be done even mathematically, since the Fourth Seal calls for a quarter of the earth dead, and Rev. 9:18 calls for 1/3 dead. These must be two separate events, as 1/4 cannot equal 1/3. Interestingly enough, the Global 2000 plan fostered by the Club of Rome during the Carter Administration makes the strong suggestion that

the earth's population) by the year

2000, give or take a year or two. John the Revelator wrote the Revelation around 80 A.D. So whose plan is this, really? Truly, "The fear of the Lord is the beginning of wisdom" (Psalm 111:10).

### Seal Three - The Time is Now

With these guidelines in mind, you may come to share my conviction that in November of 1992, we received notification that the Third Seal was being opened. The code signal to "hurt not the oil and the wine" went forth at that time from George Bush. Lest it seem jarring to cite a contemporary as a referent of Biblical prophecy, let it be noted that Biblical prophecy refers to current events and people at the time those prophecies are fulfilled. This also helps us to understand that the "oil and wine" of the Revelation does not refer to the "oil and wine" of the first century

seemingly provided a "fertilizer" (read "defoliant") that has destroyed more crop land, and according to Lindsey Williams, our country has only a three to five month emergency supply of grains, if that. The "leveling process" will bring the Northern Hemisphere to the level of the Third World countries: on our knees, begging for bread. (Time magazine, Nov. 28, 1994, p.96: "You needn't move to the Third World. The Third World is coming to you.")

While the secular world is debating the possibility of a financial "readjustment", we can confidently predict a total, world-wide economic collapse, based on Seal Three. In view of the astonishing specificity of Bible Prophecy, particularly in regard to our Lord's First Coming; and given that God does not change (Malachi 3:6), it seems reasonable to expect that the signs of His Second Coming would have the same specificity. We can see it here. Are we not required to ask ourselves (Matt. 16:4, 11 Timothy 2:15), if this is not a fulfillment of Seal Three, just what would be?

The Third Seal pictures "a black horse, and he that sat on him had a pair of balances in his hand. I heard a voice in the midst of the four beasts say: 'a measure of wheat for a penny, and three measures of barley for a penny; and see thou hurt not the oil and the wine." We've covered the prices and commodities factor, but the color of the horse is manifestly significant. Traditionally, the black horse has simply been portrayed as Famine, but starvation and famine are not even specifically mentioned in this Seal, though they are implied; we don't expect this sort of imprecision in God's Word. I assert that the horse is black because that color defines the Oligarchy now, and we will see that the colors of the other three horses identify those particular stages of the modern New World Order conspiracy, as well. Essentially, in the Four Horsemen of the Apocalypse, we've been given a handy-dandy, color-coded key to the cryptocracy.

### **Black Operations**

The edict to "hurt not the oil and the wine" went forth from George Bush, whose CIA group is code-named the

Black Rose. The Cabalistic philosophy of the Thule Society and it's obeisance to the Black Sun (son, i.e., Lucifer, Satan) formed the impetus for the Third Reich under Hitler, which was the pivot point between the red horse and the black (see the Nazi flag). Hitler, deeply steeped in the Occult, was also planning for the false Millenium, the "Thousand Year Reich". It was the Holocaust (literally, "burnt offering") that was the trade-off for getting the flying disc technology into the hands of humans. "UFOs" are often associated with the "Men in Black" (MIBS).

Most of the current global turmoil is funded by the "Black Budget", garnered from Black Operations off the official records, and by huge sums of money from munitions and drug profits. The Black Budget also funds the Black sciences of mind and weather control, chemical-biological warfare, and the underground eugenics research which picked up speed in this country when we hung a few Nazis and hired the rest, in Operation Paper Clip. (Daddy Prescott Bush was generous in funding this research during World War II, and no wonder, when we look at the products of his loins).

Black, unmarked helicopters and black "ninja" uniforms are becoming omnipresent, as the New World Order forces are being trained and utilized. The helicopters are often seen at trouble spots before the trouble erupts, and have been reported spraying gaseous substances before some new disease attacks an area. The Black nobility of Europe is gaining notoriety, as the Merovingian blood lines are being frantically traced and recorded. (And the movie, The Last Temptation of Christ, from Kazantzakis' novel of the same name, has introduced a generation to the idea that Jesus Christ survived the cross and lived to produce offspring with Mary Magdalene, supposedly forming this blood-line). Jesuits sardonically worship the Black Pope. Genocidal wars and famines and plagues are professionally incited on the "Black" Continent of Africa, and the butchery of darker-skinned peoples is spread throughout the Southern Hemisphere, as a prelude to doing away with the lighter skinned "useless eaters"

of the Northern Hemisphere. The future looks Black, indeed. And so it IS, but, as we shall see, it's defining color will be Green.

### Fourth Seal - Green Horse

Revelation 6:8 reads: "And I looked, and behold, a pale horse: and his name that sat on him was Death, and Hell followed with him. And power was given unto them over a fourth part of the earth, to kill with sword, and with hunger, and with death, and with the beasts of the earth." The word that has been translated for nearly 2,000 years as "pale" is in fact "chloros" ... GREEN as grass. Why this is a green horse will soon become apparent.

The circumstances defined by the Fourth Seal are already looming. Famine is pandemic; sixty wars are being waged (at last count), and more rumoured. "Natural" catastrophes (many, in fact, due to scalar and electromagnetic weather warfare) are breaking all records, and millions have died in the floods, earthquakes, tornadoes, hurricanes, heat waves and cold spells. Birds are feasting on the scattered dead in and around Rwanda (Isaiah 18). Increasingly bizarre incidents of animals attacking humans are reported in the daily papers, along with the spread of rabies, and rodent-borne viruses and bacteria. A.I.D.S. and numerous other diseases (68 STD's, malaria, bubonic plague, anthrax, cholera, tuberculosis, smallpox, etc.) are now utterly resistant to antibiotics, and are epidemic, and new ones are being introduced routinely through vaccinations and by aerial spraying.

Microwave ATP frequencies, Gaiandriana, and/or the results of fetal tissue and genetic research (both high governmental priorities), could account for the upcoming horror of Revelation 9:6. The Earth and its atmosphere are dying from deforestation (less than 30% of the rain forest remaining), and desertification (24,000 square miles a year), and pollution of air, water and soil. Over 22 billion tons of chemical and radioactive pollutants are dumped legally each year from the United States alone, and this doesn't even include airborne pollutants, pesticides, herbicides, and illegal dumping. The depletion of the ozone Is now at 8%

conservatively, and at approximately 13-15% all the phytoplankton will die. They are already mutating and dying in large areas of the ocean. The algae that flourish in polluted conditions are cause for the "red tides" that are becoming increasingly more common in our oceans, and these plus the death of most of the sea's denizens, and flowing blood from the genocidal wars, may well be the phenomena of Rev. 8:8 and 16:3.

The phytoplankton which get choked out are not only the base of the food chain, but have been the primary source of oxygen in our atmosphere, even more than the rainforests. It takes

an excess of oxygen to form the ozone layer and keep it in its place as a protector of the atmosphere. Whether the depleted ozone is a result of chlorofluorocarbons, or whether that story is just another DuPont concoction to corner the market for new patents, or whether Electromagnetic Pulses are the real cause, is moot. The ozone layer is deteriorating in any case. and it is irreversible for at least the next ten years. Meanwhile, we are producing less oxygen, thereby depleting the buffer zone that is meant to keep the ozone in place. This will culminate in Rev. 16:8, when the sun is given the power to "scorch men with fire."

The hoofbeats of the Fourth Horseman are audible, and just a little further in

the distance is the sound of Trumpets. Underground testing of massive bombs has loosened the mantle of the earth from the core, leading to the earth-quakes (or pole shifts, perhaps assisted by nuclear detonations) of the Sixth Seal, and throughout the book of the Revelation. Underground testing has also heated up the volcanos in the Pacific Rim, causing thermal pollution (attributed to a most unusual "El Nino" in California), and likely activating the volcanos themselves. The world has had more earthquakes over 6.5 on the

Richter scale in the last 3 years than in all recorded history combined (Matt. 24:7, Mark 13:8), now accompanied by tsunamis (tidal waves) (Luke 21:25). Rev. 8:8 could well be the result of comets or the return of radioactive space junk we've lofted into the sky; one aerospace project is code-named Woodpecker-Wormwood, and since "Chernobyl" means wormwood in Russian, we can assume that Rev. 8:11, and Jeremiah 23:15 refer to radioactivity, and possibly Rev. 16:2 and 10 to radiation sickness. We're seeing this already, in our troops returned from Iraq, where they were contaminated by their own radioactive

bullet casings, and in the population at large, as a result of domestic experiments and not-so-accidental "accidents".

Numerous citizens militias have been fueled by misguided Patriots in Pavlovian response to the urgent short-wave and AM promptings of the likes of Bill Cooper and Linda Thompson and their countless panicky callers, guaranteeing a Bosnian/Rwandan bloodbath of mammoth proportions in the U.S., when the move is made to designate us Magna-Region 1, if not before. As these professing

"Christians", whose actions/emotions definitively prove they aren't walking the walk (see Matthew 26:52; Isaiah 8:9-20; Luke 6:46,47), squawk and cackle about the immediate threat of UN troops on U.S. soil, and the anymoment round-up of dissidents and patriots for delivery to the "concentration camps", they're witlessly paving the way for a total discreditation of anything that anyone calling himself a Christian has to say. As a result of their premature and hyped-up hollering wolf, few will pay heed to the warnings when the Wolf actually arrives on the scene from a totally unexpected direction. While this contingent is certainly courageous,

and probably means well, their double-mind (James 1:8) is apparent. They are well aware of the chemical-biological and electro-magnetic capabilities of the not-so-secret government, and are clearly operating under strong delusion to suppose their pop-guns are going to get them anything but dead. Ezekiel 32 offers a full report on their fate.

As we have seen, the Third Seal is yet to be completed (as of February, 1995) and when the economic plug is pulled, the UN troops, Multi-Jurisdictional Task Force, BATF, CALIA, and other alphabet soup agencies, will be made heroes by the media for their courageous, selfless service to the huddled masses, as they pass out

soup, fight fires, and put down riots, the Christian Patriots get dead or dine on crow, and we are ushered into the Fourth Seal.

### The "Green" Movement

As noted previously, the Fourth Horseman of Revelation 6:8 has been referred to for two thousand years as the Pale Horse of Death: It is not a pale horse at all, but a bright green one. The word in the Greek is "chloros", the root of our word chlorophyl, and as green as grass. (Just in case we missed it, the same word is used to describe

grass in Revelation 8:7). Minor mistranslations like this one, scarce but crucial, make me wonder if Francis Bacon did a little diddling with the Holy Writ.

The completion of Seal Three, by world-wide economic collapse (which will prove the necessity for a one-world monetary system) and the imminent arrival of the green horse was cleverly heralded to the Cryptocracy at the Economic Summit of the Americas, December 9, 1994, when both Gore and Clinton appeared in green suits, on a green carpeted stage with a green backdrop which held a green sign. The plans they think are theirs are coming along nicely. Witness the economies of Mexico and Canada since the Summit.

Who is next? The U.S. Mexico borders are being beefed up under the direction of Janet Reno, perhaps as much to keep U.S. citizens and their assets in when the collapse comes here, as to keep illegals out.

The significance of the color Green is immediately apparent to the conspiracy student. Already, the Green Revolution is making moves to destroy all national sovereignty in

order to facilitate the enforcement of UN Treaties to save the ozone, the soil, the air and the waters of Gaia, Green Mother Earth. Gorbachev's Green Cross organization, and Benjamin Creme's Tara Institute (Tara's a Green "goddess") under the Club of Rome, are waving the Green flag of environmentalism with fervor. It's a very appealing idea to gather together as world citizens and save our planet, and the controllers have been steadily touting its desirability over the last thirty years. Alex Cockburn, in the September 1994 issue of The Nation does a fine job of exposing the promoters of environmental politics: the Rockefellers, et. al., who made their mega bucks by destroying the earth. And why? To manipulate the masses by offering a false hope of an earth renewed by the power of man. "There is a way that seemeth right unto a man, but the end thereof

are the ways of death" (Proverbs 14:12). God has other plans for the planet He created, and He's been good enough to write them down for us. It's His planet, and His disposable model, at that. (Revelation 21:1; 2 Peter 3:10). Green Money

Another obvious aspect of the Green horse is the formation of a One-World economic and money (Green) system, which is being facilitated by NAFTA, GATT, and APEC consortiums, under the leadership of the rich men of the earth (Micah 6:12)—the bankers of the IMF the FED, World Conservation Bank, World Bank, etc. It's likely that GREENspan will be at the top of the heap, since we're given a name in

each of the four horsemen that coordinates with the color of the horse, and he's valiantly doing his part to destroy the U.S. economy.

### The "MARC" of the Beast

This ongoing centralization will lead, within six years or so, to the "Mark of the Beast" of Revelation 13:16-18, without which no man will be able to buy or sell. In what would seem an impossibly brainless move were these events not foreordained, the Department of Defense has recently (August, 1994) issued a new all-purpose I.D. card to its employees, called the Multitechnological Automated Reader Card ... the MARC card. This is a conditioning preparation for the day when the Anti-Christ (also known as the first beast of Revelation 13) will "cause all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads" in

order to conduct business of any kind. 16,000 pages of information can now be stored in a computer chip smaller than a grain of rice, which can be injected under the skin relatively painlessly. The hand and the forehead are subject to the most temperature change, and it's the constant temperature differential that powers the miniscule Lithium battery.

Interesting that the Bible is the only early prophetic work that refers to the Mark of the Beast, and it says clearly that the mark will be IN the hand or forehead, not ON them. The Greek word for 666 is chi xi stigma, and the definition of stigma is, "a mark incised or punched for recognition of owner-

ship." Interesting, too, that if

lithium leaks into the skin, the result is an infected wound. Revelation 16:2 predicts a "noisome and grievous sore upon the men which had the mark of the beast." The fact that taking it entails agreeing to worship Satan and condemning oneself to damnation will probably be perceived as an exotic and enticing fringe benefit to the hardcore tattoo/punker/S&M crowds.

Given the general state of

(un)consciousness in the population, and the glowing reports we're already hearing in the media about the convenience and security of microchips for pets, prisoners, and patients, it's my guess that some folks will be camping out in line to get one.

Secret Cipher of the UFOnauts Allen H. Greenfield IllumiNet Press, 114 pages, \$9.95

A cipher is the key to understanding a secret message, a way to make seemingly unrelated symbols form a coherent idea. Similarly, Allen H. Greenfield's new book links two seemingly disparate phenomena in conspiracy theory: UFOs and Secret Societies.

While the public often associates ciphers with spying

and covert operations, Greenfield is aware that intelligence operatives are not the exclusive users of coded communications. In fact, members of other secretive (i.e. occult) groups have for centuries used codes and symbols to obscure their true goals and beliefs. However, Greenfield takes this generally accepted fact a step further. He believes that the Masons and other occult groups (collectively, the "Illuminati") have used such codes to communicate not just among themselves, but with their "ultraterrestrial masters," a group Greenfield calls the "Great White Brotherhood" or "UFOnauts."

The actual cipher which Greenfield focuses on is an English-based, 26-letter cipher which follows the ancient rules of decoding used by initiates of Quabalist (Cabalist) number analysis. Essentially, the Secret Cipher assigns numbers to letters, with the "total" of a word's letters being its numerical equivalent. According to Greenfield, a word or phrase of a certain value may

have a hidden relationship to a word or phrase that shares its numerical value. Unfortunately, the cipher is of little value in deciphering contemporary events, since "as soon as the UFOnauts and Illuminati know the knowledge of the cipher is widespread, the code is changed." But any past

event or text is fair game.

A more significant limitation is that, as an analytical tool, such ciphers are easily abused. As Greenfield notes, "Because there are an infinite number of numbers and many combinations of letters ... one can, if persistent, find just about anything." By confining himself to words associated with a specific text (such as Aleister Crowley's The Book of the Law) or incident, and by limiting himself to just one or two connective attempts, the author largely avoids such criticism. However, he also makes seemingly arbitrary associations (i.e. ALEISTER CROWLEY=194=C-OMPUTER KEY) that are most likely based on simple chance.

The Cipher, however, is just one part of Greenfield's exploration. He also takes a fresh look at topics ranging from the similarity between 19th century mediums and 20th century UFO Contactees to the "Magical Origins of

the Men in Black."

Readers who roll their eyes at Greenfield's suggestion of otherworldly conspiratorial Masters should still find this book intriguing, as it is populated by a fascinating collection of Earth-bound figures, including the above-referenced Occultist and possible UFO Contactee Aleister Crowley, 19th century mystic Madame Helena P. Blavatsky, Borderland Research Foundation founder Meade Layne, and pioneer Contactee George Adamski.

In short, Secret Cipher of the UFOnauts gives us a new tool with which researchers might analyze a host of historical events and documents. In addition, it provides a fresh examination of the way Earth-bound humans respond to

what they perceive to be esoteric and powerful knowledge, whether gained through a mystical trance, a UFO abduction, or some other encounter with the Unknown.

Life on Mars in the Twenty-fourth Century features communal dining and automated shopping. The environment observed through the glass of a domed observatory is red, rocky and barren. The sky is deep purple; stars and planets shine through the thin atmosphere. About 25 scientists and scholars make up this tiny community. There are very few children. This subject, Jabal, recalls his death at 85 in the year 2364.

An automated scout ship shuttles between an orbiting space station and a spaceport near a domed city on Earth. This subject describes his clothing as a silvery one-piece uniform with black and white insignia and soft metallic boots. Food is synthetic, squeezed from tubes or

swallowed like pills. He recalls his death around the year 2300 as "like a flash," some type of space accident.

A woman describes her uniform as black and silver with a comet on the breast, and black knee-high boots. She is an officer on a huge military spacecraft carrier, fighting dangerous alien enemies in a distant galaxy. Her death around the year 2500 is a crash-landing into a "heavily jungled world" followed by total blankout.

A woman reports that she is a young man living in a pueblo-style community with flat roofs and translucent domes. Travel is by battery powered vehicles; vegetarian meals are eaten communally off of shining metal plates. No animals are killed for food or products. The Tree of Lies Christopher S. Hyatt Ph.D. New Falcon Publications 224 pp. \$12.95

The so called "self-help" section of most bookstores can be a jungle of intertwined and often contradictory information. All too many of the trails blazed through the undergrowth tend to lead the reader in circles. This misleading of the reader is a natural byproduct of pretensions brought to the reading by both the reader and writer. You have thus been warned that any pretensions you uncover while reading The Tree of Lies are strictly your own. (This of course, is a lie.)

Semantics have power because the words we use to create semantic forms have inherent power in themselves. Some combinations of words have the power to make us feel "good." These we call "truths" at the risk of self delusion. If we could employ words to separate fact from fancy, we could perform transformational Magick. Is this Magick truly attainable? There are no guarantees. After all, if one book had the power to change the world, it would negate the need for all other books.

Any Epiphanies caused by The Tree of Lies are born within the cortex of the honest reader. This birth is facilitated by author Hyatt's judi-

cious use of sentences designed to either fit comfortably into the preconceptions of the reader, (i.e. truth); or conversely, to grate on a raw nerve, (i.e. a lie). Hyatt passes no judgment on the relative truth or falsehood of any given statement. All that really matters is the reaction of the reader to these statements. In this way, Hyatt uses words as any Magician would use runes.

A major ingredient in any magical formulation is humor. This book was written for the person who understands that the power of satire lies in the fact that pain is the basis of satire, and thus all humor. While much of the writings in this genre merely bandage the wound and send you off with case of the warm fuzzies, The Tree of Lies uses words against themselves in a way that chips away at psychic armor in which we array ourselves. (This is no lie.)

**Preparing** for the Next **Plague**

If you think the AIDS epidemic is awful, just wait till you see the new plagues that scientists expect in the future. Two new doomsday books try to convince us that sexual promiscuity, increased plane travel, and the destruction of the rain forest (rather than crazy, out-ofcontrol scientists) are at the

root of the next biologic

holocaust.

Weighing in at almost 3 pounds and a whopping 750 pages, Laurie Garrett's The Coming Plague: Newly Emerging Diseases in a World Out of Balance (Farrar, Straus & Giroux, \$25) presents a treasure-trove of horrific new viral diseases of obscure NEWLY EMERSING BISEASES IN A origin that makes AIDS look like a piece of cake. One of the most interesting is the recent mysterious outbreak of "Navajo flu" that erupted in May 1993 in the Four Corners area of Arizona, New Mexico, Colorado and Utah. Of the initial two dozen respiratory cases, half were fatal. Officials soon discovered a virus related to the Hanta virus, known to cause epidemic hemorrhagic fever in Manchuria and Korea. During World War II, Japanese physicians in their notorious biowarfare laboratory Harbin, Manchuria, proved Hanta virus hemorrhagic disease

was infectious by injecting body fluids of sick patients into helpless prisoners of war. After the war, the results of hundreds of diabolic human medical experiments were turned over by the Japanese to the U.S. military biowarfare establishment at Ft. Detrick. Thus, Hanta virus became part of the military's biowarfare arsenal. During the Korean war, hemorrhagic fever primarily affected the kidneys, but never the lungs, and most infected GIs eventually recovered. Scientists cannot fully explain how the Manchurian virus ended up on a Navajo reservation.

Also fascinating are chapters on Lassa and Ebola fever, both highly contagious hemorrhagic diseases out of Africa. Lassa virus, an airborne virus of unknown origin with a peculiar proclivity for killing doctors and nurses, first broke out in 1969 at a remote mission hospital in Nigeria. Quickly alerted to the new menace, medical officials arranged the transportation (by commercial Pan-Am jet) of one deathly ill

nurse to Columbia-Presbyterian Hospital in New York City for extensive study and treatment. Despite a badly damaged immune system, she miraculously survived. A Yale University technician working in a lab housing Lassa was not so lucky. He suddenly contracted the disease and died ten days later. Officials claimed he had no direct contact with the virus, and how he became exposed to Lassa virus was never ascertained.

> In 1976, the same year of the Swine flu fiasco and the peculiar outbreak of Legionnaire's Disease in Philadelphia, another African virus suddenly erupted out of nowhere, attacking the medical staff at a mission hospital in Zaire. Ebola quickly killed 90% of its victims. An international team of top virologists, epidemiologists, and biowar-

Laurie Garrett Lassa and Ebola virus, and other highly lethal viruses, were being studied in labs in Moscow, Leningrad, Paris, London, Porton Down (England's biowarfare lab), Fort Detrick (the Army's biowarfare lab), Atlanta, and elsewhere. In 1979 the Soviets deliberately released

If you think the whole world is doomed and we can't avoid the prophesies, think again! According to Bob Frissell, all has changed. The Grays have left the Earth thinking they would not win. anthrax spores, infecting their own citizens in a biowarfare experiment in Sverdlovsk. As many as 1,000 people may have died. In 1989, an outbreak of Ebola erupted in a building housing monkeys for medical research in Reston, Virginia, outside of Washington, D.C. The animals had been shipped in from the Philippines. As many as sixteen thousand wild monkeys from the tropics are shipped in yearly to the U.S. for medical use; and Garrett writes that hundreds of millions of animals are shipped from continent to continent annually. These include house pets, research animals, horses, livestock, illegally smuggled endangered species, aquarium fish, and a host of other broad categories of animals.

The monkey house in Reston was a biologic holocaust ready to explode. Health officials feared the airborne Ebola virus could easily spread to infect millions of Americans residing in the D.C. area. If the public were alerted to the danger, there would be panic in the streets. Without alerting the media, how could scientists stop an Ebola epidemic in a building containing 450 sick and screaming monkeys? How could personnel enter a contaminated lab, knowing that the breath, or bite, or body fluids of an infected monkey could easily prove fatal in less than ten days?

This scary scenario is the subject of Richard Preston's terrifying thriller, The Hot Zone (Random House, \$23). If you're a fan of Stephen King, you'll love Preston's prose. Graphically describing a deathly ill patient with Ebola vomiting over his Nigerian physician, Preston writes: "The black yomit blew up around the scope and

out of Monet's mouth. Black and red fluid spewed into the air, showering down over Dr. Musoke. It struck him in the eyes. It splattered over his white coat and down his chest, marking him with strings of red slime dappled with dark flecks. It landed in his mouth." Hollywood is planning to film Preston's page turner. Originally Robert Redford and Jodie Foster signed on for lead roles, but bowed out due to script problems.

As a physician who has written two books on AIDS as a man-made disease, I was eager to read what Garrett and Preston had to say about

the origin of the AIDS. Garrett tells us that by the mid-1970s virologists were inserting new genes into viruses. These genetically-altered viruses were allowed to infect cells, thereby bringing along the new gene into the infected cell and altering it forever.

A few years later, in 1979, a new "gay" immune deficiency disease suddenly erupted in the U.S. In her research, Garrett specifically acknowledges "insights" provided by Michel Callen, AIDS activist and long-term survivor. Callen, who

died of AIDS in 1994, readily admitted having sex with over 3000 men in bathhouses, backrooms, meat racks, and tearooms. Garrett reminds us that Callen believed the AIDS epidemic was a consequence of his "wallowing in what was, to put it bluntly, an increasingly microbiologic sewer."

In her 108-page chapter on the origins of AIDS, Garrett claims "a decided timidity in AIDS epidemic and policy circles about broaching the subject of the origins of the global pandemic." The official World Health Organization's position is simply that "AIDS emerged simultaneously on at least

three continents."

Noting that nearly 40% of African-American college students in the Washington D.C. area believe the AIDS virus was produced in a germ warfare laboratory, Garrett devotes two pages to the conspiracy theory of AIDS. She cites Dr. Robert Strecker's belief that HIV was genetically engineered by combining bovine (cow) leukemia

### Votescam: The Stealing of America by James and Kenneth Collier \$9.95

The electronic hoodwinking of the American public works something like this: After the voter makes a ballot selection, vote-counting software either records that vote or it does not. Either way, the computer program immedi-

She mentions a London Times article (May 11, 1987) connecting the outbreak of AIDS in Africa to the WHO's smallpox vaccine program. However, Garrett conveniently fails to mention the hepatitis B vaccine experiments, which used gay men as guinea pigs during the years 1979-1981, and which preceded the official outbreak of "the gay plague" in 1981. Nor does she cite the research of Japanese molecular biologists, and others, who claim no genetic relationship exists between HIV and a monkey virus. Garrett simply concludes that the evolutionary link of HIV to a family of monkey viruses is "overwhelming."

It is a fact that people are unwittingly used as guinea pigs in covert medical experiments. Unethical experiments have been conducted at our leading medical institutions, and have been authorized by our most prestigious scientists. Medical conspiracy buffs do not have to be reminded about covert nuclear experiments, the Army's LSD experiments, the Tuskegee syphilis experiment, Agent Orange, the exploding Persian Gulf War Syndrome, as well as hundreds of documented biowarfare experiments conducted by the military on unsuspecting civilians. Science writers like Garrett and Preston never dwell on the dark side of science, even though their books hint of misdeeds by scientists. For example, Garrett claims that health officials were repeatedly Interrogated by CIA officials about their experiences with Lassa and other hemorrhagic viruses. No public records were ever kept of these meetings, nor is there clear indication of what inspired such interest in the intelligence community. Nevertheless, Centers for Disease Control officials repeatedly advised the CIA that these viruses would make poor biologic weapons. Unable or unwilling to pursue such cloak and dagger medical research, Garrett would rather popularize the propaganda of virologists eager to blame naturally mutating viruses, the destruction of rain forests, and disease carrying animals and insects, as the explanation for the coming plagues they predict.

Not surprisingly, sex also gets a bad rap, particularly multiple partner sex. Sex is a "disease amplifier," and Garrett presents a scientist's mathematical equation (Ro = B x C x D) to describe this amplification. (Read the book!) To emphasize the horrors wrought by the sexual revolution of the 1970s, Garrett presents CDC data showing the reported cases of venereal disease during the years 1940-1982. What is not explained is why there were more than twice as many syphilis cases in 1952 then there were in 1982.

> Preston believes "the emergence of AIDS, Ebola, and any number of

> > other rainforest agents appears to be a natural consequence of the ruin of the tropical biosphere." As the sun sets over the African jungle, I wonder if the movie version of The Hot Zone will contain Preston's prophetic words: "The strain of Ebola virus that had erupted near Washington went into hiding somewhere in the rain forest," and "AIDS is the revenge of the rain forest. It is only the first act of revenge." For conspiracy buffs, The Coming Plague and The Hot Zone are informative books, but don't believe everything these science

writers tell you without checking out. Failure to heed this warning may result in a terminal case of fuzzy thinking caused by Rain Forest Fever!.



# Stalking the Strange

ieques Island, forty miles off the eastern coast of Puerto Rico, has a long tradition of armed conflict which predates the arrival of the Europeans, for it was on Vieques that the first bloody clash took place between the warlike Carib Indians and the more peaceful Tainos. However, that early conflict pales in comparison with the dimensions of the perils that the area experiences today.

Affectionately referred to as "la isla nena"—the baby island—Vieques continues to be a frontier region of grave strategic to this day. Opposite ends of the island are currently occupied by the U.S. Navy, leaving the civilian population sandwiched in the middle. Local residents find themselves at the mercy of stray shells from the numerous targeting exercises conducted in the military areas, which constitute the air-to-ground testing ranges used for naval aviation training. One of these sites, given the innocuous name of "Bullseye Target Two," is in fact designated for nuclear practice bombing. (1)

The Atlantic Fleet Weapons Range, a triad composed by the Roosevelt Roads Naval Base, Vieques, and until 1980, the island of Culebra, is one of the most active naval testing sites in the world, since it is jointly utilized by the allied navies. Significant pieces of naval ordnance have been tested in the area: the Walleye, Bulldog and Bullpup air-toground missiles along with a number of air-to-air projectiles. Fire support for amphibious landings is tested on the island's beaches in order to develop the skills of both gun crews and fire control teams. Ship firing activity, most intense during the spring months, runs an average of 140 firing exercises with an average of two dozen ships, while ship-to-shore gunfire occurs some hundred days out of the year. Aircraft sorties and bombing runs vary on a monthly basis.

The islanders' plight has been a sore point in Puerto Rican politics since the late Sixties. Politicians from both ends of the spectrum have called for the Navy to cease its use of the island and take its bombing practice elsewhere. During the administration of governor Carlos Romero, the Navy was offered use of the offshore islands of Mona, Monito, and Desecheo, located in the passage separating Puerto Rico from the island of Hispaniola, in exchange for

the immediate discontinuation of Navy exercises on the island of Culebra, to the north of Vieques. The governor ultimately agreed to give the Navy a larger share of Vieques, which had boasted prosperous sugar plantations and cattle ranches.

Victims of this agreement, Viequans now find themselves living in a perpetual state of siege, suffering from the relentless detonations of naval shelling exercises, which produce such tremors that the buildings

on the island has been affected. But Navy activity on the island remains unabated, and a new and more ominous threat has appeared on the horizon: the military recently proposed the confiscation of 100 acres of land to install an array of radar antennae, that will include over 30 vertical antennae with a matching number of structures used to support a curtain of cables. The proposed radar net will reach a height of between seventy-one to one hundred twenty-five feet, and will allegedly be utilized to "combat the drug trade" (a similar reason was given in 1991 to justify the deployment of the "aerostat" near Laguna Cartagena. Aerostats are early-warning radar blimps that plug low altitude gaps in radar coverage.)

Concern over this unknown quantity has once again united the islanders against the Navy, and has attracted the support of a number of different stateside interests. The foremost question on everyone's mind remains: what is the purpose of the proposed array, and why Vieques? Perhaps the answer to the question lies as far away from the tropics as one could imagine, near the Alaskan town of Gakona, where the locals have already discovered their nemesis. According to an article in Flashpoint, (2) an ionospheric heater of some sort, utilizing computer-guided radio transmitters, is being built in northern Alaska: Project HAARP (standing for High Frequency Active Auroral Research) is a joint venture between the USAF and the Navy. Among the goals of this massive complex is obtaining magnetospheric reactions that may be used for military applications. The article goes on to mention that similar ground-based lonospheric heaters exist elsewhere in the world. Curiously, one such site is the Arecibo Observatory in Puerto Rico, which has just been awarded a \$23 million grant to update its equipment. (3) The northern lights are only visible as far south as the Pennsylvania/Maryland border, so what pur-

pose does such equipment serve in the Caribbean?

The article in **Flashpoint** goes on to state that documents pertaining to the HAARP project indicate that the antenna will cause perturbations of the ionosphere by means of directed beams of energy to conduct experiments aimed at destroying an adversary's communications capabilities while leaving our own unscathed. It appears that the scientific community has denounced such technological adventurism by the military, stating that the planet could be set into "an unexpected vibration...similar to an axis wobble." (4)

It would appear that the true function of the HAARP facility in Gakona is an offensive one. Given Puerto Rico's recent experiences with UFO activity over its major military

communications centers (such as Pico del Este on El Yungue and the Sabana Seca Communications Center in Punta Salinas. opposite San Juan), it is not entirely off-the-mark to speculate that if the Vieques Array has a mission and hardware similar to that of its Alaskan counterpart it could perhaps be either an attempt at defending military communications from the attention of the phenomenon, or even a means knocking UFOs out of the sky, since the vulnerability of these "craft" to simple radar emissions had already been suggested in the late '80s. While admittedly farfetched, the development of the ability to negatively impact the ionosphere might even be an effort at creating a "UFO repellent" of some sort.

A number of authors have pointed to the very real existence of a " state of war " between U.S. military personnel and UFOs in the Carib-


bean. Proof of this is the loss of one or more Navy fighters to UFOs in 1988 as well as a number of small, isolated incidents, such as the close encounter between members of the National Guard and five simian creatures on El Yunque. Units of surface troops have appeared in the wake of UFO sightings in the Arecibo Radiotelescope area and in the controversial Laguna Cartagena region. Soldiers training at Camp Santiago near the city of Ponce have witnessed intense UFO activity in the night sky over the training grounds. Mysterious subterranean detonations at both El Yunque and Laguna Cartagena suggest the possibility that an effort to eradicate a supposed alien "nest" underneath cave-riddled Puerto Rico may have been initiated in the late

'80s, (5) and local ufologist Jorge Martín has documented cases describing the involvement of regional Civil Defense agencies in the struggle.

Why would an alleged "anti-UFO" battery be placed on Vieques instead of the main island itself? The argument returns once more, perforce, to the existence of the Naval facilities on the former and to the unfortunate fact that the Viequans' cries for justice stand little chance of being heard. The array will no doubt emit high levels of radiation which would be lethal in overcrowded Puerto Rico, but which can be concealed on smaller Vieques. As with its Alaskan counterpart, the quantities of electromagnetic radiation generated bar its installation on any military base at which nuclear

weapons might be stored, mainly because of the very real threat of HERO ("Hazard of Electromagnetic Radiation") which can produce conventional and nuclear weapons accidents, of which the military has documented at least 25. (6)

A more cynical consideration is that whatever negative physical side-effects the array may present/ they would hardly be noticed: A local physician has pointed out that Viegues already has the highest cancer rates in Puerto Rico, and that the pollution created by naval bombardments and their residue has strongly impacted the situation (during naval war games in which U.S., Dutch and South American fleets par-

ticipate, the average number of shells fired against Vieques exceeds 2000). TNT has been found in the local water table and there exists the possibility that ammunition tipped with enriched uranium slugs ("tank-killing" bullets of the variety recently deployed in the Gulf War) may have been used during military exercises; fishermen must contend with unexploded ordnance both in the sea and on the beaches, while the reefs that once housed a teeming population of fish are recklessly destroyed. Nonetheless, the EM hazard question was raised by Myrna Pagan of the CPRDV (the Vieques activist movement), whose objections were focused

on the electromagnetic pollution and the nearness of the civilian communities to the Raytheon-built array.

On July 7 1994, a delegation of the Armed Services Committee visited Vieques to collect information on the Navy's impact upon the island. The group included Bob Brauer and Alma Moore, aides to Congressman Ron Deliums, and Marilyn Elrod of the Military installations Subcommittee. The congressional representatives also gathered information pertaining to a proposal which demands the return of the 8000 acres controlled by the Navy (H.R. 3831). One Lt. Cmdr. McCloskey tried to keep the press from attending the meeting between local activists and the congressional delegation, in a bid to control and conceal the negative information of the Navy's presence on Vieques. Television reporters were allegedly told that they would not be allowed to cover the live event. (7)

When asked why the Navy could not relocate its activity elsewhere, a high-ranking spokesman replied that Vieques possessed numerous training facilities, and that part of the training complex included a range for electronic warfare. which could not be resettled on the mainland because of interference with commercial and military radio transmissions. The Navy also insisted that alternative locations that duplicate the facilities currently available on Viegues are nonexistent, and the inability to make use of the island would seriously affect tactical proficiency in the event of another Gulf War-type situation. Artificial island construction. a possibility raised by a number of studies in the early 1970's, is financially out of reach in the deficit-burdened 90's. A Harvard University ecologist observed that the noise pollution and vibration from military exercises, coupled with the stress produced by marines "on leave" prowling around the small island communities, pales in comparison with the "helplessness the islanders feel in the face of a power they cannot control." (8) •



These expanded efforts continued the political and irregular military operations of
the Masonic Scottish Rite which had been
led by John Quitman, and by Albert Pike
after Quitman's death.



(Secret Roots of the KKK) by Anton Chaitkin Part II, The Lost Cause

This is the edited text of a speech delivered by Mr. Chaitkin to a Labor Day weekend conference of the Schiller Institute in suburban Washington, D.C. It originally appeared in the New Federalist (v6, #35), PO Box 889, Leesburg, VA 22075, \$20 for 50 weekly issues. Illustrations for this article appeared in James Ridgeway's Blood in the Face (Thunder's Mouth Press, 1990), \$19.95.

For the final three years of the four-year Civil War, Judah P. Benjamin served as Confederate secretary of state. Benjamin supervised the financial and supply relations to the British Empire and its ally, Napoleon III of France, and ran the Confederacy's international network of spies and saboteurs. Benjamin's secret service liaison man in England and the Confederacy's chief arms procurer there was James Bulloch, the man who had been arrested during Quitman's 1854 Cuba fiasco.

John Slidell became the famous Confederate commissioner to France, where he married off his daughter Mathilde to Baron Emil Erlanger. The baron was an eminent German-French Jewish banker, closely tied to the British government and the highest levels of British freemasonry. Slidell and Benjamin negotiated the famous Erlanger Loan, the series of Confederate war bonds floated by this banker. They sold the bonds primarily to British oligarchs who felt poisonous hatred for

the American republic. The collateral for the Erlanger loan was Southern slave cotton, that was smuggled out past the Union blockade. John Slidell handled relations between the French Empire and the Masonic "filibusters," the raiders of Latin America. Slidell promoted the joint European/ Confederate invasion of Mexico in the 1860s.

The Confederate secret service. meanwhile, attempted to weaken the resolve of the Union to carry on the war. The key to their strategy was the old Knights of the Golden Circle organization, still in place in the north, midwest and southwest, involving pro-slavery whites-and American Indians. Sioux Indians, strangely organized into military Masonic lodges, wiped out 700 citizens of New Ulm, Minnesota and the surrounding area, while the town's young men were off in the Union Army. Albert Pike was at the time the Confederate general officially in charge of arranging Indian attacks against the Union; Minnesota was also part of Commander Pike's Masonic Southern Jurisdiction.

Judah Benjamin based his main secret service group in Montreal, a safe haven since Canada was then still British territory. They coordinated across the border with Golden Circle networks in Illinois, Indiana, Ohio, and Wisconsin, and with the August Belmont Democratic Party machine in New York. Agents led by Jacob Thompson planned prison breaks, tried to burn down northern cities, and instigated anti-draft riots in which drunken mobs lynched black people and burned orphanages.

This ugliness was in vain. But just when Lincoln's nationalist money policies and our industrial strength overwhelmed the rebellion, President Lincoln was murdered. A dragnet went out for the Confederate secret service operators, accused of participation in the assassination. Albert Pike escaped and joined Jacob Thompson in Canada. Judah Benjamin fled to England, joining the exiled Robert Toombs and James Bulloch. John Slidell stayed

permanently in France.

Confederate secret service agent John Surratt made it to Italy and hid in the Vatican, while Surratt's mother was convicted and hanged on the charge of plotting with John Wilkes Booth to kill Lincoln, John Surratt was discovered and returned for trial. He was acquitted. But in 1870, Surratt admitted publicly that he had plotted with Booth to "abduct" Lincoln. He told of the days preceding the murder, of his trip to Montreal carrying money and messages from Judah Benjamin. The secret service bank in Montreal, where gold from Britain was deposited for Benjamin's crew, was the same bank in which Lincoln's assassin John Wilkes Booth had made his deposits six months before the killing. The war was over. But the defeated Confederacy was transformed into the romantic Lost Cause, an object of cultish reverence.

Anti-slavery congressmen pressed ahead with plans for Reconstruction, designed to break up the power of what was called the "chivalry," the feudalist lords of the prewar South. In Tennessee, the pro-Union faction tried to increase its political strength by putting through a law, granting the right to vote to the newly freed blacks.

The Knights of the Ku Klux Klan was a terrorist counterattack, beginning in Tennessee, designed to block Reconstruction and reverse the outcome of the Civil War. The Klan and the Scottish Rite were one and the same enterprise, continuing the imperial effort behind the slaveowners' rebellion.

Pike, Benjamin, Slidell, Toombs, Bulloch, and Thompson were all in exile at war's end. Though Judah Benjamin had quickly become a wealthy lawyer for the British merchant oligarchs, his continuing preoccupation with defeating Reconstruction is indicated in letters he wrote back to the U.S.A. with complaints such as these:

"I have always looked with the utmost dread and distrust on the experiment of emancipation so suddenly enforced on the South by the event of the war. God knows how it will all end!"; and: "the South is kept crushed under negro rule"; and: "I can never consent to go to New Orleans and break my heart witnessing the rule of negroes and carpetbaggers"; and: "nothing is so abhorrent to me as Radicalism which seeks to elevate the populace into the governing class."

From Albert Pike's British sanctuary in Canada, on July 15, 1865, Pike issued a summons to the Supreme Council, to resume the operations of the Scottish Rite of Freemasonry, Southern Jurisdiction. Six weeks later, "under pressure from Masonic officials in the government," the new President Andrew Johnson permitted Pike to re-enter the U.S.A. The Rite was reborn over the next few years, as money and messengers went back and forth between Pike and the Confederacy's



sponsors in England. In April 1866, a year after the murder of Abraham Lincoln, Albert Pike's Supreme Council met in full costume inside the White House. There Lincoln's successor President Andrew Johnson granted a pardon to Pike. The following year, the awed and grateful Johnson was granted advanced degrees 4 through 32 by the Scottish Rite. The Masons claim that Johnson's Freemasonic involvement was an important reason why the pro-Reconstruction congressmen tried to impeach Johnson.

Albert Pike could not go home to Arkansas, however. He was still under indictment for treason by state authorities there, for inciting the Indians to break laws or treaties. So he settled in Memphis, Tennessee, just across the Mississippi River from Arkansas, becoming a newspaper publisher, lawyer, and president of the Tennessee Bar Association.

Tennessee blacks got the right to vote in February 1867. Beginning that spring, Albert Pike and a small group of Confederate generals held several meetings in Nashville, at the Maxwell House Hotel, to form the Knights of the Ku Klux Klan.

The name was taken from the Greek, [kyklos], meaning "circle." It was no mystery to the pro-Unionists: The Knights of the Golden Circle had reappeared.

Pike was appointed chief judicial officer of the Invisible Empire. He is said to have written the Klan's military manual and ritual, and was the Klan's expert on secrecy of organization-its secret grips, signs, and passwords. At one of the later Nashville meetings, General Nathan Bedford Forrest was chosen Imperial Wizard of the Klan. Albert Pike organized the Ku Klux Klan in Arkansas after General Forrest appointed Pike the Grand Dragon of that Realm. The Tennessee leaders of the Klan at the time of its founding were prominent Masons subordinate to Grand Commander Pike. Pike's old comrade and financial backer Robert Toombs returned from England in 1868. Toombs was appointed dictator of Scottish Rite activities inside Georgia, and Toombs and his family ran all aspects of the Klan within Georgia. President Ulysses Grant said that the Klan worked "by force and terror to prevent all political action not in accord with the views of the members; to deprive colored citizens of the right to bear arms and of the right to a free ballot; to suppress [i.e. burn] schools in which colored children were taught and to reduce the colored people to a condition akin to that of slavery." In his newspaper the Memphis Daily Appeal for April 16, 1868, publisher Albert Pike wrote: "With negroes for witnesses and jurors, the administration of justice becomes a blasphemous mockery. A Loyal League of negroes can cause any white man to be arrested, and can

prove any charges it chooses to have made against him.

"The disenfranchised people of the South ... can find no protection for property, liberty or life, except in secret association.... We would unite every white man in the South, who is opposed to negro suffrage, into one great Order of Southern Brotherhood, with an organization complete, active, vigorous, in which a few should execute the concentrated will of all, and whose very existence should be concealed from all but its members."

In the latter decades of the nineteenth century, British-centered finance gained supremacy over American industry and U.S. policy-making. Under British sponsorship, Pike's Scottish Rite, Southern Jurisdiction, came to rule over much of the world's Freemasonry. At length, its headquarters moved from South Carolina to Washington, D.C.

Theodore Roosevelt, a racialist Anglophile and passionate Freemason, became U.S. President September 14, 1901, upon the shooting death of William McKinley. Teddy Roosevelt's reign was the Lost Cause triumphant: Roosevelt's revered exiled uncle, James Bulloch, Judah Benjamin's secret service chief in England, had ghostwritten young Teddy's book on naval history; and Teddy's clique had finally conquered Cuba in the 1898 U.S. War with Spain.

The Washington, D.C. statue honoring Klan founder Albert Pike was dedicated 39 days after Teddy Roosevelt's inauguration.

In his admiring biography of Judah Benjamin, Eli Evans quotes the famous attack against Benjamin's pro-slavery fanaticism by Ohio's Senator Ben Wade: "When old Moses, under the immediate inspiration of God Almighty, enticed a whole nation of slaves, and ran away ... to old Canaan, I suppose that Pharaoh and all the chivalry of old Egypt denounced him as a most furious abolitionist. ... There were those who loved Egypt better than they loved liberty.... They were 'Israelites with Egyptian principles."

Senator Wade's barb hit its mark. Judah Benjamin had deserted the religion of Moses. He had spat on the law of freedom, the gift that Jews celebrate in the Passover seder (which was also Christ's last supper). Since then, other "Israelites with Egyptian principles," those Jews who like Benjamin attached their destinies to the British Empire and its racialism, have become a vital component of the Anglo-American Eastern Establishment: "honorary Anglo-Saxons," they have helped transform the United States into an essentially mindless British model imperium. And the racialism they co-authored has brought tragedy to Jews as well as to others outside the racial pale. In the Civil War, twice as many Jews fought for the

## Leaders of U.S. black Freemasonry have attacked white Masonry, particularly the Scottish Rite, as a center of racialism.

Union as for the Confederacy. Northern Jews, many of them recent German immigrants, were strongly prorepublican and anti-slavery.

The predominant Jewish tradition in the South was not only pro-slavery, but overwhelmingly Freemasonic. The Independent Order of B'nai B'rith formed in 1843 as a Jewish community sub-project in the restoration of Masonry by the Scottish Rite and the British foreign office. Though most of its lodges were in the North, B'nai B'rith was openly pro-Confederate. Though it claimed to be neutral in the war, many of the Order's Northern spokesmen were stridently pro-slavery. B'nai B'rith's post-Civil War leaders were pro-Confederate operatives, including later president Simon Wolf, who had been arrested by the War Department in Washington, D.C. as the lawyer for a Confederate spy ring.

Rabbi Isaac Wise established B'nai

B'rith's center for the "liberalizing" of Judaism in Cincinnati, Ohio-coinciding with Cincinnati's other great Scottish Rite scheme, the launching of the Knights of the Golden Circle. Wise was officially neutral in the Civil War. Core leaders of the B'nai B'rith from then on have been Scottish Rite Masons. The political establishment associated with the Order has always had its headquarters in London.

In Richmond, the Confederate capital, Gustavus A. Myers was Secretary of State Judah Benjamin's closest friend, and Benjamin's channel to banker August Belmont. The former president of the Richmond City Council, and the undisputed head of Rich-

mond's Jewish community, Myers was Freemasonry Incamate. Myers' matemai grandfather, Moses Michael Hays, had brought the original "patent" and rituals from England to found the Scottish Rite in the American colonies. A tory and financial partner of Boston's slave trade millionaires. Havs passed his fortune and his Masonic and British underground connections to his daughter's husband and sons, the Richmond Myers clan.

Moses Myers, merchant partner of the Richmond family, was head of Norfolk's Jewish community. His house is now a public museum, located on Norfolk's Freemason Street. Inside is a large wooden plaque given to the family by Queen Victoria, in recognition of the family's long service to the British crown and cause. Several generations, living in that same Moses Myers house, were British consuls. All of Virginia's Jewish leaders then were Masons, one of them Rothschilds' official Virginia agent who was grand master of Virginia Masons during the war of 1812.

After the Civil War, the Belmont/
Rothschild faction took absolute control
over the Jewish leadership within New
York and trans-Atlantic finance. Joseph
Seligman, who had been pro-Union like
most American Jews, joined the British
banking syndicate of Rothschild and
J.P. Morgan, which ran U.S. government finance from the 1870s onward.

Confederates against Lincoln's nationalist money policies, were now merged as the Eastern Liberal Establishment.

While Alabama cotton broker Emanuel Lehman lived in Civil War New York, he sailed back and forth to England raising money for the Confederate war machine. Continuing the family tradition, his Lehman Brothers firm supported the racialist eugenics movement, and tenaciously defended their investments in Nazi Germany.

But the bigshot was Jacob Schiff of private bank Kuhn Loeb. Schiff's power was entirely trans-Atlantic: Traveling back and forth between London and New York, Schiff was Sir Ernst Cassel's U.S. partner and representative; Cassel was the personal banker and the most intimate friend of

Prince Edward VII, the grand master of British freesmasonry. (Edward's son Albert Victor was supposed to be the subject of the Jack the Ripper story: His unapproved marriage was broken and covered up by the Freemasonic murders of witnesses.)

On behalf of the royal family, Ernst Cassel managed the finances of the British Fabian Society leaders, and the British Round Table in its outrageous African racialist endeavors such as apartheid. At Kuhn Loeb in the 1890s, partner Otto Kahn (a British subject) directly supervised Schiff and Cassel's project to build up a certain snarling little railroad man who was a favorite of the old Belmont Confederate machine, Mr. E. H. Harriman. At that same time, the Warburg family joined Kuhn Loeb; the Warburgs' preoccupations were anchored in their Masonic Occult Institute in Hamburg and London.

Look at the first years of this century: Teddy Roosevelt is President, Edward VII is King, and the racist

cult-master Lord Arthur Balfour is his Prime Minister. The British Masonic clique at Kuhn Loeb founded the American Jewish Committee, and made its president, Louis Marshall, the official legal advisor to the Harriman eugenics laboratory—mother of this century's nightmare race theories. It was Kuhn Loeb and the Warburgs who officially brokered New York's banking ties to Hitler's Nazis, as well as Harriman's entree to the Soviet dictatorship.

A striking instance of the Confederate "Lost Cause" persisting and haunting the present century, is to be seen in the attic of the **New York Times**. Iphigenie Ochs married Arthur Hays Sulzberger in 1917. He succeeded her father Adolphe Ochs as publisher of the **Times**, which Mr. Ochs had bought in the 1890s.

Adolphe Ochs and his father founded the "Baroness Erlanger" Hospital in Chattanooga, Tennessee. The hospital was named for John Slidell's daughter, who married the Confederacy's chief financier Baron Emil Erlanger. The

Baron had bought up the main railways between the bankrupt South and Cincinnati. Adolphe Ochs had married Iphigenie Wise, the daughter of B'nai B'rith's Cincinnati leader Isaac Wise. When the Ochs family had lived in Cincinnati during the war, Adolphe's mother Bertha had been arrested for smuggling drugs to the Confederate army.

In 1991, Arthur Sulzberger's daughter Ruth sponsored the visit to America of British banker Rodolphe d'Erlanger, John Slidell's great-great grandson. At a reception for Erlanger Hospital, he said that his great grandfather, Baron Emil, was the partner of Cecil Rhodes in his nightmare race projects in Africa, and that Emil and his wife Mathilde Slidell had introduced Wagner's **Tannhauser** to the stage in Paris—which was booed off the stage.

Arthur Sulzberger's Philadelphia Uncle David Sulzberger joined the Confederate army in Arkansas. Cousin Cyrus Adler, born on the Sulzbergers' Arkansas slave plantation, became the occult, psychic, Masonic, and gnostic expert for the New York Jewish establishment and for London and Cambridge Freemasonic strategists. At the same time, under the Teddy Roosevelt regime. cousin Mayer Sulzberger was president of B'nai B'rith International and president of the American Jewish Committee. At that time. B'nai B'rith leaders (such as the Sulzberger's partners the Morgenthaus) directly represented British crown interests in the Middle East. and worked as a bridge for Scottish Rite Masonry

between the Middle East and Washington.

In the 1930s, Cyrus Adler, president of the American Jewish Committee, coordinated with the family's B'nai B'rith, and the family's **New York Times**, to crush all U.S. political action against Adolf Hitler in Germany. The B'nai B'rith was the one Jewish organization that Hitler deliberately left open and functioning under Nazi rule from 1933 on.

In 1939, Britain made a dramatic change in its policy toward Hitler–after teaching Hitler his race theories, after forcefully backing his takeover of Germany, after financing and equipping his armies, Britain now changed publicly to opposing Hitler. Only at that point, in 1939, about a year after Hitler finally closed B'nai B'rith's Nazi-authorized German operations, B'nai B'rith decided to "approve" an international boycott against the Nazi regime.

B'nai B'rith's Anti-Defamation League recently opened a

#### The 60's ... I Get By with a Little Help

"Many have imagined republics and principalities which have never been seen or known to exist in reality; for how we live is so far removed from how we ought to live, that he who abandons what is done for what ought to be done, will rather learn to bring about his own ruin than his preservation."

During the earlier part of the decade, the collective psyche was being assaulted with this message: "The Great Melting Pot Has No Cultural Identity." Our children were becoming aimless James Dean clones. Mom, trapped in her Naugahyde ghetto, needed a little yellow "helper." For his part, Dad was drinking way too meeny martoonies.

Suddenly, the Beatles came across the great Atlantic, bringing with them a "British Invasion." In the midst of a cultural vacuum, we were offered an imported lifestyle. It was "groovy" to wear your hair long. Ties were relegated to the closet in favor of the Nehru Jacket. Women didn't have to look like Racquel Welch anymore. The new feminine ideal, one "Twiggy," looked more like your eleven year old daughter with a page boy haircut. Although Mr. and Mrs. America didn't buy it at first, the intelligentsia did. 
the Intelligentsia would teach the children of Mr. and Mrs. America.




hard on independent dealers who might dilute the market.

Beit Shemesh, Israel—Between 1948 and 1956, the highest echelons of the Israeli government and the Jewish Agency participated in the ugliest crime of the country's history. During that period, at least 650 and perhaps some 4,500 infants and young children, all immigrants, most from Yemen, were kidnapped and sold to adoptive parents abroad.

The children were taken from Jewish Agency child welfare centers, from clinics in immigrant camps (maabarot) and even directly from maternity wards. The parents were told that their children had died and were issued forged death certificates.

Those parents who sought their children's graves failed for none existed. In fact, the children were sold for \$5,000 each to childless couples, mostly in America. There is evidence that some of the children were sold for medical experiments or strange cult practices.

The roots of the crime lay in the thousands of Holocaust orphans brought to Israel in the late 1940s. Sincere American couples requested the right to adopt indigent children and raise them in dignity. The Israeli government was reluctant to agree to the many requests, desiring instead to populate the new nation with European Jews.

But the temptation to earn money selling babies may have proved too much for the new nation which sorely needed income sources to pay for defense and ironically, immigrant absorption. At some point in time a decision was made at the highest levels to substitute orphaned European children with dark Yemenite babies whose parents were very much alive. The total income derived from the black market in babies was some \$25 million, a figure equivalent today to several hundred millions of dollars.

Naturally, the disappearance of thousands of babies did not go unnoticed and the parents tried to recover them. Those few newcomers with enough sophistication and knowledge of Hebrew did turn to the press and throughout the 1950s numerous reports of babies disappearing were published in the local papers.

Any parent who objected too much was treated brutally. Today's mayor of Rosh Haayin, Ylgal Yosef recalls how his sister was stolen shortly after her birth. His mother made a screaming exhibition of herself at the maternity hospital demanding her baby alive or the right to see its corpse. She was taken by the police, beaten, warned never to open her mouth again and thrown wounded from a moving car onto the street outside her house. Such incidents were commonplace in the 1950s.

In 1967, journalist Uri Avineri exposed the scandal in his controversial publication, **Haolam Hazeh**. Shortly after, he was the target for assassination. Fortunately for him, his intended killer's gun jammed and Avineri captured him. He was exposed as an agent for the Shabak, the country's internal security apparatus.

Avineri's successor in trying to expose the hideous crime was a young rabbi, Uzi Meshulum. Beginning in the early

1970s, Meshulum began gathering the names of the kidnapped children in an attempt to trace them. He was well placed to break through the bureaucratic silence on the issue. As a soldier, he led some of the IDF's most secret operations. (He lost his body hair in an attack on a Syrian biological warfare center.) Using his contacts in the security services, while recruiting new agents, many of Yemenite background, Meshulum infiltrated deep into the cover-up of the affair and became the driving force behind a lobbying campaign aimed at pressuring the government to open a commission of inquiry into the kidnappings.

In 1985, at the initiative of Knesset members Virshuvsky

and Shilansky, the Knesset's Interior Committee began a preliminary investigation of the charges. At this point, the veil of secrecy was momentarily lifted when Avigdor Peer, who was the Deputy Head of the New Immigrants Department of the Ministry of Welfare during

the period of the kidnappings, broke his thirty year silence.

### Railroading Of Rabbi Uzi Meshulum

He informed the committee that numerous illegal adoptions took place and pointed to the involvement of the government es-

tablishment in the affair as expressed by the allotment, according to the recognized relative power of the political parties, of quantities of children for the purpose of adoption to four women's organizations associated with the members of the government coalition; Naamat of Labor, Aguda Women of Agudat Yisrael, Emuna Women of the National Religious Party and the General Zionists Women's Organization.

As a result of this and other testimony, the committee recommended a public inquiry into the affair but the Knesset turned down the recommendation.

And with good reason. Peer's testimony implicated one cabinet minister, Dr. Yosef Burg, who was Interior Minister for part of the time during the kidnappings, of being a perpetrator of the crime. Burg's son Avraham is today a member of the Labor government.

But Burg was not the only member of the government who likely knew that the kidnappings were taking place. In order for an operation of this scope and profit to succeed, the health, welfare, defense and interior ministries had to be involved as did the Jewish Agency which supplied many of the children. None of this could have been kept secret from the Prime Minister during most of the period of the crime, David Ben Gurion.

While the kidnapping and illegal adoption operation was taking place, Amos Ben Gurion, the PM's son, was the Police Minister, former President Chaim Herzog was head of military intelligence, and today's Foreign Minister, Shimon

Peres, was a close aide of Ben Gurion in charge of arms of acquisitions. While much of the profit of the baby trade was funneled into the parties and pockets of the kidnappers, much undoubtedly went towards the purchase of arms.

Meshulum's campaign seemed to have borne fruit in 1988 when the Shamir government appointed a commission of inquiry, lead by Judge Moshe Shalgi, to get to the bottom of the matter. The commission's early finding was that "only" some 650 babies were kidnapped and sold illegally. In the six years since the commission has theoretically been at work seeking the truth, no further revelations have been forthcoming.

However, Meshulum would not give up the fight, and over time his work earned him a dedicated congregation of hundreds, and many tens of thousands of sympa-

thizers. This congregation would later be described by the government and media as a cult, and Meshulum was painted as an Israeli version of David Koresh.

By 1992, Meshulum had begun videotaping and distributing cassettes of parents who had been threatened by paid killers, of journalists who were told their jobs were at stake if they reported on the affair and of witnesses who had participated in the crime and could no longer live with themselves.

He also began naming names of the criminals and they were a who's who of early Zionist legend. They include Labor's Finance Minister and kingpin dealmaker Pinchas Sapir who was chairman of the Jewish Agency during the kidnappings. Also implicated is Moshe Rivlin, the current chairman of the Jewish National Fund, and Treasurer of the Jewish Agency Ben Maimon. Displaying almost suicidal courage, he named the Shabak agent in charge of suppressing the crime, Ilan Raz.

Meshulum was not alone in exposing the crime. The ultra-orthodox sect, Satmar, published a book called **Genocide In Israel**, which documented the tragedy. The Shabak threatened the sect and mostly succeeded in suppressing the book. However since 1993, when reports first appeared that Yemen was going to release its Jews to Israel, the sect has been sending agents to Yemen to redirect them to New York.

On March 9, 1994, Meshulum released a magazine that was the most detailed expose of the crime to date. Two weeks later a "contractor" was sent to provoke an incident. The "contractor" dumped cement in Meshulum's sewage system and returned the next day to try it again. This time he was stopped by Meshulum's students and an army of 250 police and Shabak units descended on his property to settle the problem. Such a concentration of sharpshooters, sappers, helicopters, attack dogs etc. is rarely gathered for

an operation against terrorists in Lebanon or Gaza, let alone to help out in a dispute with a rude contractor.

Meshulum and his followers were under siege. Anyone who left the property was beaten and arrested. Six weeks later, a thousand police and Shabak officers descended on Meshulum at the order of the Prime Minister and Police Minister Moshe Shahal. A nineteen year old boy, who the police claimed had shot at a helicopter, was murdered by a police

sharpshooter. Witnesses to the murder insist the boy was unarmed.

The boy was not shot fatally and a Hebrew University historian, Natan Shipris, left the property in order to persuade the police to call an ambulance to save the shooting victim. He was bound, dragged 150 yards, kicked mercilessly and arrested. An hour and a half later, the boy bled to death.

The next day Meshu-

lum and his followers at the property were in custody. Meshulum was beaten for seven hours and about a third of his congregation suffered the same fate. Meanwhile, 150 sympathizers of Meshulum's cause were rounded up across the country and arrested.

Meshulum and his closest followers were charged with fifteen different crimes including attempted murder and conspiracy. The government hopes that by imprisoning them all it can wipe the ugliest stain out of the country's fabric. However, the stain may prove to be indelible.

## Stael's (Hidden) History

If politics makes strange bedfellows, then a certain parley of 1941 may qualify as political pornography. In January of that year, a clandestine meeting took place between a representative of right-wing Zionist Avraham Stern and two emissaries of Adolf Hitler. Stern's agent, Naftali Lubenschik, had a shocking proposal for the two Nazis.

The written proposal began by establishing Stern's ideological kinship with Nazism and his sympathy for Hitler's goal of a Jew-free Europe. It also praised the German Reich government for its support of Zionist activity inside Germany and efforts towards Zionist "emigration plans." Then, the proposal stated that:

The establishment of the historical Jewish state on a national and totalitarian basis, and bound by a treaty with the German Reich, would be in the interest of a main-

tained strengthened future German position of power in the Near East. Proceeding from these considerations, the NMO [i.e. The Stem Gangl in Palestine, under the condition that the above-mentioned national aspirations of the Israeli freedom movement are recognized on the side of the German Reich, offers to actively take part in the war on Germany's side.

Amazingly, the Stern organization, then fighting against British control of Palestine and for the establishment of a Jewish state, was prepared to ally itself with Hitler against their common enemy Britain. Of course, Stern's sympathy for Hitler's goal of a Jew-free Europe was based on his assumption that these Jews would end up in the newly-formed state of Israel, rather than the barracks of a concentration camp. Nevertheless, as journalist Christopher Hitchens points out, "It is important to note here that the [Stern] approach was not based, like that of some Indian nationalists, simply on a rejection of Britain as the colonial enemy. The proposal clearly affirmed that the Stern Gang was 'closely related to the totalitarian movements of Europe in its ideology and structure'."

#### **Gang Warfare**

Of course, not all Zionists were pro-Nazi. In fact, at the outbreak of World War II, Zev Jabotinsky, the leader of the major right-wing Zionist organization in Palestine, agreed to suspend military operations against the British and was even willing to cooperate with them against Germany if the need arose. Jabotinsky's position caused a rift with fellow Zionist Avraham Stern, who broke with Jabotinsky and founded the Stern Gang, later known as LEHI (a Hebrew acronym for Fighters for the Freedom of Israel). When Stern was killed by the British in

a shoot-out, leadership of the group was assumed by his loyal lieutenant Yitzhak Yezernitsky, today known as Yitzhak Shamir, the former Israeli Prime Minister.

According to Hitchens, Shamir never renounced his association with LEHI, even after LEHI members murdered Count Folke Bernadotte, the United Nations mediator in Palestine, who had earlier helped rescue the Jews of occupied Hungary from Hitler's Final Solution.

Hitchens reports that, in July of 1986, Shamir's past led Professor Yeshayahu Leibovitz, former editor of the Encyclopedia Hebraica, to warn, "Within three months, we will have a Prime Minister who was a leader in an organization which offered its services to Hitler." Leibovitz then compared Shamir and Stern with former UN Secretary General Kurt Waldheim, saying that Waldheim was at least drafted into Hitler's army, while LEHI volunteered.

#### Fans of Mussolini, Too

Zionist links to fascism did not begin with the Beirut meeting of 1941. In the 1930s, even the relatively moderate Zev Jabotinsky expressed admiration for Mussolini's Italian regime. (Indeed, many American politicians did likewise.) In fact, Jabotinsky's and later Stern's gunmen even received training in Italy, and repaid Mussolini by participating in terrorist strikes against his enemies. In addition, Avraham Stern had been sending signals to the Axis as early as the fall of 1940. At that time, with Britain alone standing in opposition to the Nazis, Stern met with one of Mussolini's agents in Jerusalem, but the discussions apparently had no concrete result.

One wonders why such cases of uncompromising Zionist pragmatism, the subject of spirited and informed debate in Israel itself, are barely acknowledged by America's "free press." Then again, maybe these examples are not all that shocking. Rather, they may be among the many historical examples of an old Middle Eastern proverb: The enemy of my enemy is my friend.•



## The Burning Bush

Cannabis, Petroleum, and Biblical Prophecy

en thousand years ago, the area between the Tigris and the Euphrates rivers was known as the Garden of Eden. It was a paradise where all the necessities of human life (food, clothing, shelter, fuel, medicine and sacrament) could be met with plants which grew there. (Genesis 1.11,12). Today we might think of the entire "civilized" world as being "Babylon." Petroleum is the mortar which holds together the bricks in the walls which imprison the entire human race which lives in slavery, ignorance, and suffering. The wine of Babylon (Jeremiah 51.7), which has made the nations drunken and mad, is petroleum. When people began civilization they started to believe themselves to be separate from and superior to Nature. They believed themselves to be smarter than God.

#### is there a link between a series of high-profile Hollywood deaths?

The following is excerpted from a correspondence sent to PARANOIA by Mr. Nakao.

n the apparent deaths of Brandon Lee, John Candy, and Erik and Lyle Menendez' father, Jose, the motion picture production company, Carolco, keeps surfacing. Brandon had a multi-picture deal with Carolco (New York Times, May 2, 1993) and was killed at the Carolco Studios in

Wilmington, North Carolina, while filming The Crow.
John Candy died while filming Wagons East, a Carolco production. Jose was board chairman and CEO of LIVE Entertainment, a then partially-owned subsidiary of Carolco. For OJ, I have found only an indirect connection with Carolco, but there is a possible connection with Scientology.

According to a May 31, 1987 Los Angeles Times article, even Hollywood insiders knew little about Carolco. It had its first hit in 1982 with the Rambo movie, First Blood, which was partially financed by a Panamanian entity, Bonaparte International, whose owners' identities were unknown.

In 1986, Jose Menendez became the financial manager of International Video Entertainment at the request of then Carolco president and CEO, Peter Hoffman. Noel Bloom, the former owner of International Video Entertainment, reportedly had ties to the Galante crime family. When Jose was killed, he had been testifying in a lawsuit filed by Bloom against Carolco. LIVE got \$15 million for a "key man" life insurance policy they had on Jose. (Blood Brothers by Ron Soble and John Johnson.)

Carolco's Wilmington studios formerly belonged to DEG. DEG was owned by film producer Dino De Laurentiis (Year of the Dragon, Dune). His daughter, Raffaella, produced Dragon: The Bruce Lee Story, where a heart attack and deaths of family members associated with the film occurred

during pre-production. (New York Times, May 2, 1993.)
There were also several violent episodes on Brandon Lee's
The Crow, which was filmed at the Carolco Studios.

John Candy also had a Carolco connection, apparently dying of a heart attack during the filming of Carolco's Wagons East. In addition, he had recently completed two other films, though not for Carolco. He directed a TV movie Hostage For a Day (a man pretends to be held hostage by the KGB) and Canadian Bacon (a military plot to make Canada into America's new Cold War enemy). These two films are

similar to two films that Carolco was readying for production at the time of Jose Menendez' death: Air America (drug-running CIA airline in Laos) and Jacob's Ladder (Vietnam vet is possibly part of a military chemical warfare experiment.) (Variety, August 23, 1989).

I could only find an indirect link of Carolco to OJ Simpson. OJ was a spokesman for Hertz from 1975 to 1994. Jose Menendez was a key executive at Hertz from 1971 to 1980

before joining IVE in 1986. According to the New York Post, June 24, 1994, Jose introduced his son, Erik, to OJ when Erik was 11 years old. Nicole Simpson's father also operates a Hertz franchise. (New York Times, June 23, 1994.) OJ also seems to have suffered a string of tragedies like the people involved with Dragon and The Crow. In 1979, the

same year he divorced his first wife and retired from football, his former manager, Chuck Barnes, his friend and adviser. LA Rams owner Carroll Rosenbloom, a cousin's child, and his own daughter, Aaren, all perished in drowning incidents. (OJ Simpson: American Hero-American Tragedy by Marc Cerasini.) OJ was also very much interested in playing the role of Coalhouse

Walker, Jr. in the Framed? The Menendez Bro Dino De Laurentiis production of Ragtime. OJ's last project was the TV-pilot Frogmen, produced by Arnold Kopelson.

The majority of Kopelson's career as a producer, with the exception of **Platoon** in 1986, seems to have been involved in the making of fairly unmemorable films (**Warlock**, **Fire** 

Birds). Then, starting in 1993, he became involved in successful pictures starring major stars with the films Falling Down (Michael Douglas), The Fugitive (Harrison Ford) and the upcoming Outbreak (Dustin Hoffman). Why would someone who has finally reached the top of his profession as a motion picture producer take time out to produce a TV pilot starring an OJ Simpson? (After he won the Oscar for Platoon, Kopelson had taken advantage of his situation to make a film about the Holocaust.) And also, there is no listing for any previous TV work by Kopelson in the Motion

Picture Almanac of 1994.

It's also possible that the Naked Gun film series in which OJ had been appearing has a tie to Scientology. Priscilla Presley, who apparently has been in only one other film, appears in the series and she is a Scientologist. Naked Gun writer/producer Jerry Zucker also directed My Life, starring Nicole Kidman, wife of Scientologist Tom Cruise. Furthermore, former San Francisco 49er quarterback John Brodie, used to be

a prominent spokesman for Scientology. (Los Angeles Times, June 25, 1990.) Brodie played for the 49ers from 1957 to 1973. OJ was raised in San Francisco and was a record-breaking football player for City College in San Francisco in 1965 and 1966. He also finished his career with the 49ers in 1978 and 1979.

### "FREEDOM FIGHTERS"

ccording to the mainstream press, it's merely a coincidence that a half dozen postal workers in as many cities have taken their semi-automatics to the post office and blown their supervisors away. It's also a coincidence that at least 22 postal workers in four different cities have died of violent "suicides" in the past seven years. At the last count Salt Lake City is the highest with ten, Palm Beach is next with five, San Diego and the state of Oklahoma tie for third with three and Seattle is in final place with one.

In March, 1989 a Seattle postal worker by the name of Oscar Manassa "killed himself" by jumping from the fifth floor of the Seattle YMCA. His "suicide" followed five years of vicious "anonymous" harassment related to a worker's compensation claim against the post office. The techniques employed-which included threatening and prank phone calls, conspicuous surveillance, break-ins and anonymous "fatal attraction" calls to his wife-were very familiar to local Trident, AIDS and civil rights activists in the area. Ironically, Oscar won his claim. His legal representative received notification two

the police to initiate a homicide investigation: to no avail. Beyond the uncharacteristically violent nature of Oscar's demise and the absence of suicidal ideation or intent, his eyes in his autopsy photos were bloody and swollen, revealing he was beaten before he "jumped."

Even more puzzling and alarming was the speed with which federal postal inspectors claimed federal jurisdiction, forcing the Seattle police to close their investigation. Those of us unfamiliar with postal operations assumed the postal inspectors were limited to investigating mail fraud. Imagine our surprise when we learned the PIs run an intelligence/ security operation similar to CIA and FBI domestic counterintelligence programs. The National Association of Federal Injured Workers in Puyallup, Washington has compiled dozens of complaints by living postal workers harassed by postal inspectors-with such tactics as tire flattening, beating, threats at gun point and even rape-for filing worker's compensation claims. According to the NAFIW, which is the organization compiling statistics on violent suicides, the PI's also claimed jurisdiction in the other 21 suicides, forcing local police to close their investigations.

It goes without saying the PIs have made no pretense of initiating homicide probes in any of them. Even in cases such as Oscar's, where there was irrefutable evidence of foul play. More curious still are a series of executive orders the NAFIW has discovered, issued under the Reagan-Bush administration and calling for across the board cuts in worker's compensation benefits and Department of Transportation appropriations. Funds which, according to former intelligence officers in the NAFIW, were secretly diverted to military aid to the Contras. In fact there appears to be some

connection between Ronnie's and George's decision to milk the worker's compensation pool and a systematic campaign by the post office to terrorize injured postal workers who filed claims. None of this, of course, has made the mainstream press despite the bill Representative Bloomfield of Michigan introduced during the last session of Congress to abolish the postal inspectors and mountains of letters and news releases NAFIW's 3,000 plus members have directed to the major networks and newspapers. The six corporations which dominate our print and broadcast media have totalitarian control over the information that reaches the average American citizen. For the public to learn the truth—that our government is run by a bunch of goons and thugs—is obviously too threatening to the corporate way of life.

ing or infection, or if it turned sideways it might perforate your penis. What if you men could take a birth control pill that had the side effect of making you depressed, or causing headaches, blood clots. No man would take it. So women take all the risks of birth control: the Pill, the IUD (childbirth is about nine times more dangerous than a clinical abortion) while we men make the laws, and run the churches to make you feel guilty...

I think that the strategy behind the murder of abortion doctors is to make those people who blockade clinics look moderate. I can tell you firsthand stories about what the antiabortionists do. They would copy down the license plate of people pulling into clinics. In New York, if you've got a policeman buddy, you can find out where the person lives in a matter of minutes. So often, at 3:00 in the morning, the patient gets a phone call and hears a prerecorded voice of a baby crying "Mommy, why did you murder me?" Often they would stand in front of the clinic in white lab coats offering donuts and coffee to women patients. If the patient eats anything, they cannot undergo the procedure.

Even though abortion is legal in many states, clinics are closing down because so few doctors will perform abortions, especially after the [Florida murders]. Rule by terror is an effective tool. If they're already murdering relatively unknown pro-choice people, then why wouldn't they want to shoot a Bill Baird, with 32 years of a very public fight against the anti-abortionists? My most dangerous time is when I leave here tonight; I never know who is outside, who might be following me.•

vicious campaign to label American black leaders as anti-Semites, aiming at a racial conflict, and stomping on the memory of the young Jews who fought for civil rights in the 1960s. It is essential that the religious, national, and historical character of this racialism be precisely understood. Now a surprising breakthrough has occurred. Leaders of U.S. black Freemasonry have attacked white Masonry, particularly the Scottish Rite, as a center of racialism. The attack is contained in the latest issue of the News Quarterly, official publication of the "Supreme Council, Scottish Rite, Southern Jurisdiction," Prince Hall affiliation, in an article by editor Joseph A. Walkes.

Walkes exposes Albert Pike as the national Chief Justice of the Invisible Empire of the Ku Klux Klan, and the organizer and Grand Dragon of the Klan in Arkansas. Walkes describes Albert Pike as a "traitor to his country." The article carries a photograph of the Washington memorial statue to

the KKK founder. Walkes calls the statue "an affront" to the residents of the nation's capital, a majority of whom are black. With this and similar initiatives, a strong potential now exists for members of all faiths and ethnic groups to think about and to solve a central problem of our era:

Fanatical Zionists are urged on by Anglo-American backers, to brutalize and displace Arab residents and Muslim religious institutions from Israeli-occupied territory. Among the Anglo-Saxons cheering them on in their blind racialism are many known as "fundamentalist Christians." They have seen a vision of Semitic warfare in the Holy Land, ending in mankind's annihilation, which they cheer as "Gcd's will" and "Bible Prophecy."

This madness has been called the British balance-ofpower strategy. But its familiar name is, British Freemasonry.•

Dexter King, son of the Rev. Dr. Martin Luther King and the new chairman and chief executive officer of the King Center for Non-Violent Social Change, has announced that the National Parks Service, previously employed as tour guides, has been ejected from the King Center. This action comes as a result of the ongoing dispute between civil rights activists, including the King family, and the Park Service, which has announced its intention to build an \$11 million Visitors Center in time for the Olympics, on the site of what the Center intended to be the location of a museum dedicated to the slain civil rights leader.

"They began as a tour guide, but in their dark ambition they have become landlords. I don't expect any of my beloved neighbors to see this, because I am ashamed to admit that my family did not see it until it was too late." said Dexter King.

Readers of New Federalist newspaper will not be surprised at the nefarious role attributed by Dexter King to the National Park Service. In 1993, spokesmen for the NPS, including Gary Scott, chief historian for the Washington, D.C. District, opposed the removal of the statue of Ku Klux Klan founder Albert Pike from Judiciary Square. Scott contended that "there was no evidence that proved" Pike was a Klansman—despite evidence gleaned from members of Pike's family and other Klansmen proving that indeed he was.

The same Gary Scott has also written a book praising the Kappa Alpha Society, the official campus recruiting group of the Klan. J. Edgar Hoover, the late director of the FBI and a chief opponent of Martin Luther King, was the head of his chapter of the Kappa Alpha fraternity at George Washington University. Further, recent revelations in the King assassination, particularly in Memphis, implicate the FBI in a coverup of the actual story behind the King murder.•
