

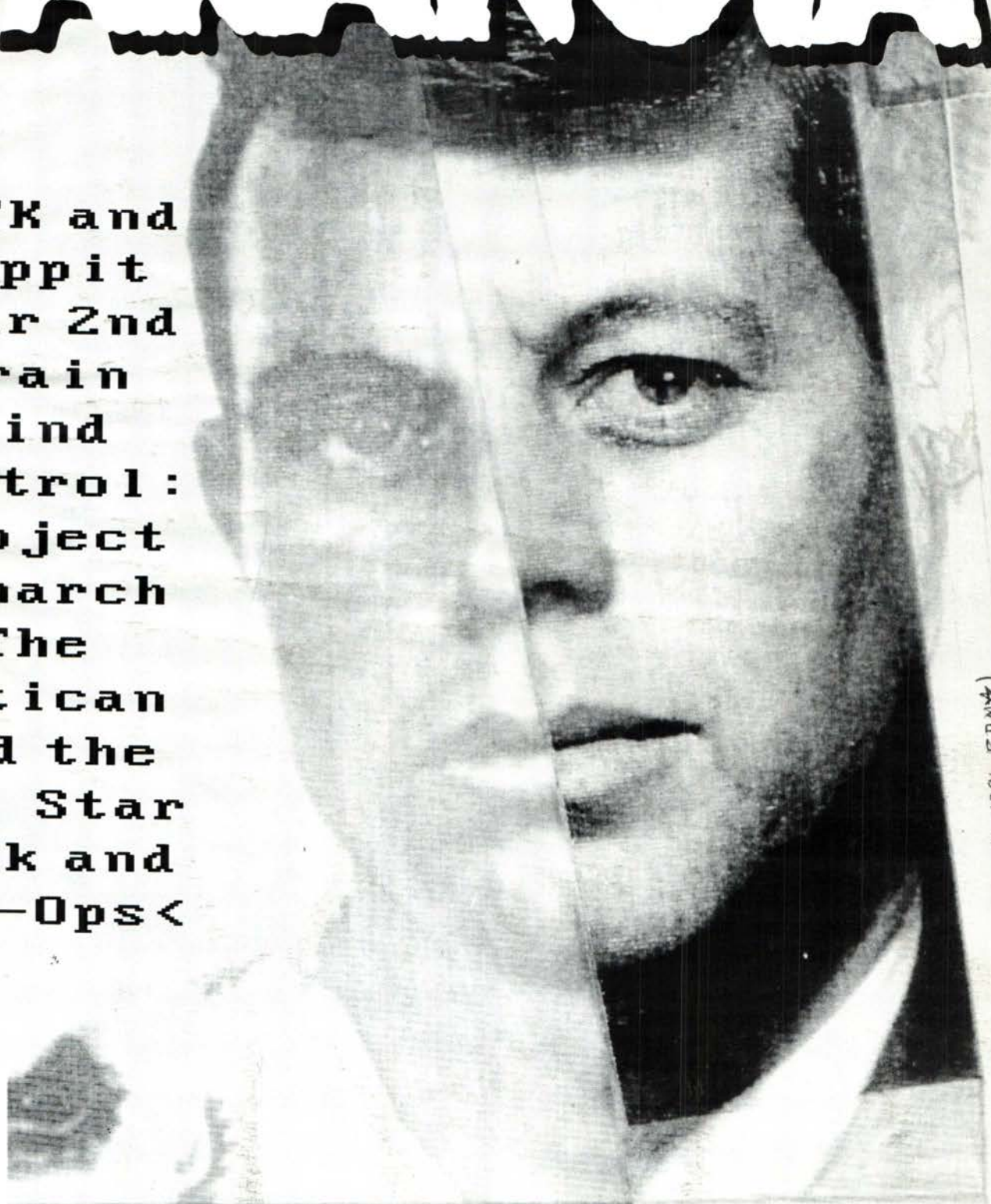

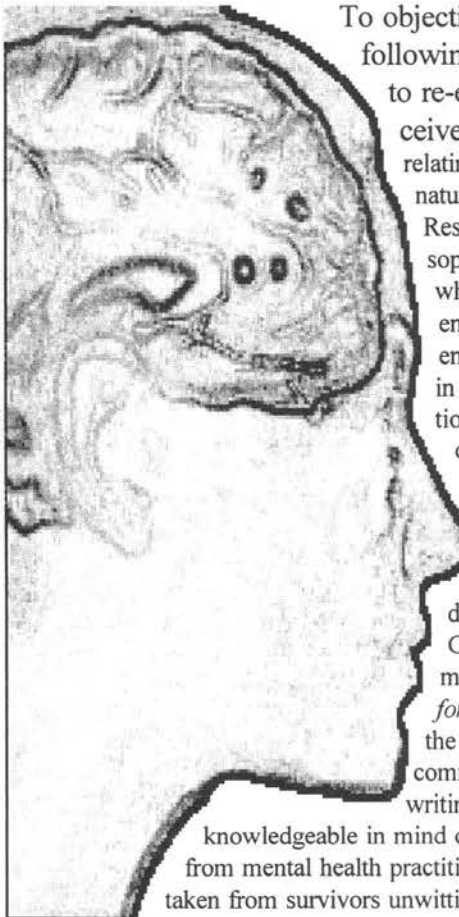

Project Monarch: Nazi Mind Control

A *midst the subtle cerebral circumvention of the gullible populace, through a multitude of manipulated mediums, lies one of the most diabolical atrocities perpetrated upon a segment of the human race: a form of systematic mind control which has permeated every aspect of society for almost fifty years.*

To objectively ascertain the following, one may need to re-examine preconceived ideologies relating to the dualistic nature of mankind. Resolving the philosophical question of whether we are inherently good or inherently evil is tantamount in shaping our perception of reality; specifically, the spiritual variable within the equation of life.

This exposition is substantiated by declassified U.S. Government documents, individuals formerly connected to the U.S. intelligence communities, historical writings, researchers knowledgeable in mind control, publications from mental health practitioners, and interviews taken from survivors unwittingly subjected to a

highly complex form of trauma-based mind control known as MONARCH programming.

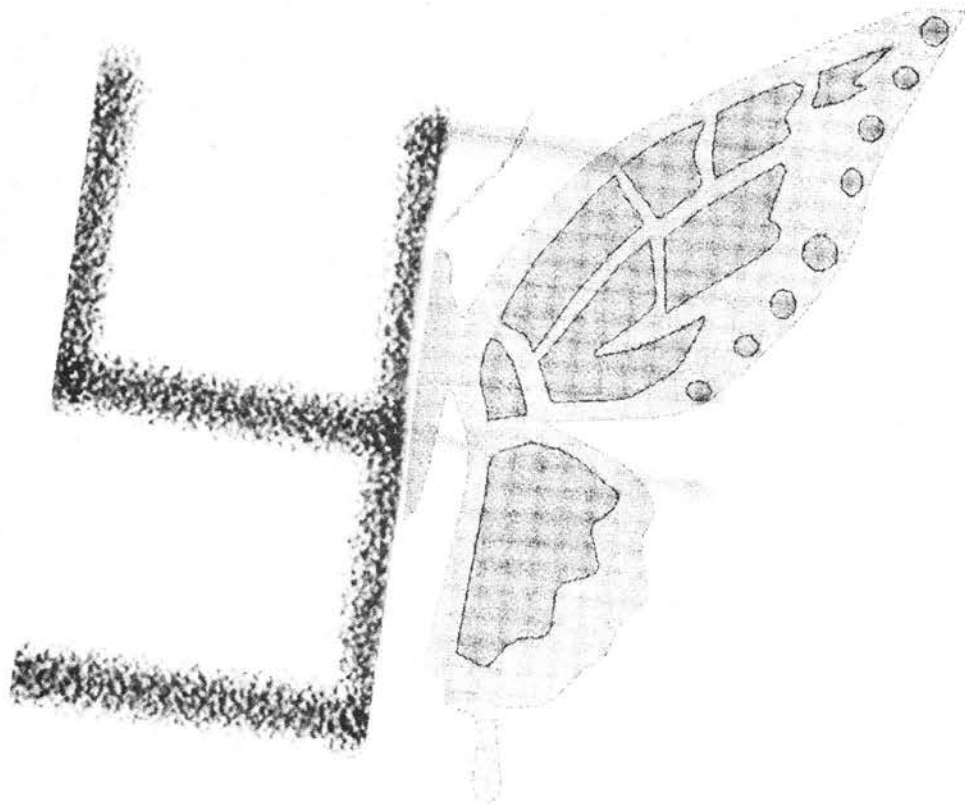
A word of caution for survivors of intensively systematic mind control and/or some form of ritualized abuse: There are numerous "triggers" in this article. It is therefore recommended not to read it unless appropriate support systems are in place or if you have a thoroughly reintegrated personality.

A Brief History of Control

The Mystery Religions of ancient Egypt, Greece, India and Babylon helped lay the foundation for occultism, meaning "hidden knowledge." One of the earliest writings giving reference to occultism is the *Egyptian Book of the Dead*, a compilation of rituals explicitly describing methods of torture and intimidation (to create trauma), the use of potions (drugs) and the casting of spells (hypnotism), ultimately resulting in the total enslavement of the initiate. These have been the main ingredients for a part of occultism known as Satanism, throughout the ages.

During the 13th Century, the Roman Catholic church increased and solidified its dominion throughout Europe with the infamous Inquisition. Satanism survived this period of persecution, deeply entrenching itself under the veil of various esoteric groups.

In 1776, a Bavarian Jesuit by the name of Adam Weishaupt was commissioned by the House of Roth-



schild to centralize the power base of the Mystery Religions into what is commonly known as the Illuminati, meaning "Enlightened Ones." This was an amalgamation of powerful occultic bloodlines, elite secret societies and influential Masonic fraternities, with the desire to construct the framework for a "New World Order." The outward goal of this Utopia was to bring forth universal happiness to the human race. However, their underlying intention was to gradually increase control over the masses, thus becoming masters of the planet.

The Anglo Alliance

By the 19th century, Great Britain and Germany were recognized as the primary geographic areas of Illuminati control. It then should be of little surprise to know the first work in Behavioral Science research was established in England in 1882, while much of the early medical and psychiatric techniques involved in mind control were pioneered at the Kaiser Wilhelm Institute in Germany.

The Tavistock Institute of Human Relations was set up in London in 1921 to study the "breaking point" of humans. Kurt Lewin, a German psychologist, became the director of the Tavistock Institute in 1932, about the same time Nazi Germany was increasing its research into neuropsychology, parapsychology and multi-generational occultism. Interestingly, a progressive exchange of scientific ideas was taking place between England and Germany, most notably in the field of eugenics: the movement devoted to "improving" the human species

through the control of hereditary factors in mating. The nefariously enigmatic union between the two countries was bonded, partly through the Order of the Golden Dawn, a secret society which consisted of many high ranking officials in the Nazi party and British aristocracy.

Top SS Nazi officer, Heinrich Himmler, was in charge of a scientific project called *Lebensborn*, which included selective breeding and adoption of children, a peculiarly large number of twins among them.² The purpose of the program was to create a super-race (Aryans) who would have total allegiance to the cause of the Third Reich (New Order). Much of

the preliminary experimentation concerning genetic engineering and behavior modification was conducted by Dr. Josef Mengele at Aushwitz, where he coldly analyzed the effects of trauma-bonding, eye-coloring and "twinning" upon his victims.

Besides the insidious surgical experimentation per-

formed at the concentration camp, some of the children were subjected to massive amounts of electroshock. Sadly, many of them did not survive the brutality. Concurrently, "brain-washing" was carried out on inmates at Dachau, who were placed under hypnosis and given the hallucinogenic drug mescaline. During the war, parallel behavioral research was led by Dr. George Estabrooks of Colgate University. His involvement with the Army, CID, FBI and other agencies remains shrouded in secrecy. However, Estabrooks would occasionally "slip" and discuss his work involving

the creation of hypno-programmed couriers and hypnotically-induced split personalities.³

After WWII, the U.S. Department of Defense secretly imported many of the top German Nazi and Italian Fascist scientists and spies into the United States via South America and the Vatican. The code name for this operation was Project PAPERCLIP.⁴ One of the more prominent finds for the U.S. was German General Reinhard Gehlen, Hitler's Chief of Intelligence against Russia. Upon arriving in Washington D.C. in 1945, Gehlen met extensively with President Truman, General William "Wild Bill" Donovan, Director of the Office of Strategic Services

To keep MK-ULTRA from being easily detected, the CIA segmented its subprojects into specialized fields of research and development at universities, prisons, private laboratories and hospitals.

(OSS) and Allen Dulles, who would later become the stalwart head of the CIA. The objective of their brain-storming sessions was to reorganize the nominal American intelligence operation, transforming it into a highly-efficient covert organization. The culmination of their efforts produced the Central Intelligence Group in 1946, renamed the Central Intelligence Agency (CIA) in 1947.

Reinhard Gehlen also had profound influence in helping to create the National Security Council, from which the National Security Act of 1947 was derived. This particular piece of legislation was implemented to protect an unconscionable number of illegal government activities, including clandestine mind control programs.

The Evolution of Project MKULTRA

With the CIA and National Security Council firmly established, the first in a series of covert brain-washing programs was initiated by the Navy in the fall of 1947. Project CHATTER was developed in response to the Soviet's "successes" through the use of "truth drugs." This rationale, however was simply a cover story if the program were to be exposed. The research focused on the identification and testing of such drugs for use in interrogations and the recruitment of agents.⁵ The project was officially terminated in 1953.

The CIA decided to expand their efforts in the area of behavior modification, with the advent of Project BLUEBIRD, approved by Director Allen Dulles in 1950. Its objectives were to: (1) discover a means of conditioning personnel to prevent unauthorized extraction of information from them by known means, (2) investigate the possibility of control of an individual by application of special interrogation techniques, (3) investigate memory enhancement and (4) establish defensive means for preventing hostile control of agency personnel. In August 1951, Project BLUEBIRD was renamed Project ARTICHOKE, which evaluated offensive uses of interrogation techniques, including hypnosis and drugs. The program ceased in 1956. Three years prior to the halt of Project ARTICHOKE, Project MKULTRA came into existence on April 13, 1953 along the lines proposed by Richard Helms, Deputy Director of Central Intelligence CDCI with the rationale of establishing a "special funding mechanism of extreme sensitivity."⁶

The hypothetical etymology of "MK" may possibly stand for "Mind Kontrolle." The obvious translation of the German word "Kontrolle" into English is "control."⁷ A host of German doctors, procured from the post-war Nazi talent pool, were an invaluable asset toward the development of MKULTRA. The correlation between the concentration camp experiments and the numerous sub-projects of MKULTRA are clearly evident. The various avenues used to control human behavior under MKULTRA included radiation, electroshock, psychology, psychiatry, sociology, anthropology, graphology, harassment substances and paramilitary devices and materials (LSD being the most widely dispensed "material"). A special procedure, designated MKDELTA,

was established to govern the use of MKULTRA abroad. MKULTRA/MKDELTA materials were used for harassment, discrediting or disabling purposes.⁸

Of the 149 subprojects under the umbrella of MKULTRA having been identified, Project MONARCH, officially begun by the U.S. Army in the early 1960's (although unofficially implemented much earlier) appears to be the most prominent and is still classified as TOP SECRET for "National Security" reasons.⁹ MONARCH may have culminated from MKSEARCH subprojects, such as operation SPELLBINDER, which was set up to create "sleeper" assassins (i.e. "Manchurian Candidates") who could be activated upon receiving a key word or phrase while in a post-hypnotic trance. Operation OFTEN, a study which attempted to harness the power of occultic forces, was possibly one of several cover programs to hide the insidious reality of Project MONARCH.

Definition and Description

The name MONARCH is not necessarily defined within the context of royal nobility, but rather refers to the monarch butterfly. When a person is undergoing trauma induced by electroshock, a feeling of light-headedness is evidenced; as if one is floating or fluttering like a butterfly. There is also a symbolic representation pertaining to the transformation or metamorphosis of this beautiful insect: from a caterpillar to a cocoon (dormancy; inactivity), to a butterfly (new creation) which will return to its point of origin. Such is the migratory pattern that makes this species unique.

Occultic symbolism may give additional insight into the true meaning. Psyche is the word for both "soul" and "butterfly," coming from the belief that human souls become butterflies while searching for a new reincarnation.¹⁰

Some ancient mystical groups, such as the Gnostics, saw the butterfly as a symbol of corrupt flesh. The "Angel of Death" (remember Mengele?) in Gnostic art works was portrayed crushing the butterfly.¹¹ A marionette is a puppet that is attached to strings and is controlled by the puppet master, hence MONARCH programming is also referred to as the "Marionette Syndrome." "Imperial Conditioning" is another term used, while some mental health therapists know it as "Conditioned Stimulus Response Sequences."

Project MONARCH could be best described as a form of trauma-structured dissociation and occultic integration, in order to compartmentalize the mind into multiple personalities within a systematic framework. During this process, a Satanic ritual, usually including Cabalistic mysticism, is performed with the purpose of attaching a particular demon or group of demons to the corresponding alter(s). Of course, most skeptics would view this as simply a means to enhance trauma within the victim, negating any

irrational belief that demonic possession actually occurs.

Alters and Triggers

Another way of examining this convoluted victimization of body and soul is by looking at it as a complex computer program: A file (alter) is created through trauma, repetition and reinforcement. In order to activate (trigger) the file, a specific access code or password (cue or command) is required. The victim/survivor is called a "slave" by the programmer/handler, who in turn is perceived as "master" or "god." About 75% are female, since they possess a higher tolerance for pain and tend to dissociate easier than males. Subjects are used mainly for covert operations, prostitution and pornography; involvement in the entertainment industry is notable.

A former military officer connected to the DIA, told this writer, "In the 'big picture' these people [MONARCH victims] are in all walks of life, from the bum on the street to the white-collar guy." In corroboration, a retired CIA agent vaguely discussed the use of such personnel to be used as "plants" or "chameleons" for the purpose of infiltrating a designated group, gathering information and/or injecting an ulterior agenda.

There are an inordinate amount of alters in the victim/survivor, with numerous back-up programs, mirrors and shadows. A division of light-side (good) and dark-side (bad) alters are interwoven in the mind and rotate on an axis. One of the main internal structures, (of which there are many) within the system is shaped like a double-helix, consisting of seven levels. Each system has an internal programmer which oversees the "gatekeepers" (demons?) who grant or deny entry into the different rooms. A few of the internal images predominately seen by victims/survivors are trees, the Cabalistic "Tree of Life," with adjoining root systems, infinity loops, ancient symbols and letters, spider webs, mirrors or glass shattering, masks, castles, mazes, demons / monsters / aliens, sea shells, butterflies, snakes, ribbons, bows, flowers, hour glasses, clocks, robots, chain-of-command diagrams and/or schematics of computer circuitry boards.

Bloodlines and Twinning

A majority of the victims/survivors come from multi-generational Satanic families (bloodlines) and are ostensibly programmed "to fulfill their destiny as the chosen ones or chosen generations" (a term coined by Mengele at Aushwitz). Some are adopted out to families of similar origin. Others used in this neurological nightmare are deemed as the "expendable ones" (non-bloodliners), usually coming from orphanages, foster-care homes, or incestuous families with a

long history of pedophilia. There also appears to be a pattern of family members affiliated with government or military intelligence agencies.

Many of the abused come from families who use Catholicism, Mormonism, or charismatic Christianity as a "front" for their abominable activities (though members of other religious groups are also involved.) Victims/survivors generally respond more

readily to a rigid religious (dogmatic, legalistic) hierarchical structure because it parallels their base programming. Authority usually goes unchallenged, as their will has been usurped through subjective and command-oriented conditioning.

Physical identification characteristics on victims/survivors often include multiple electrical prod scars and/or resultant moles on their skin. A few may have had various parts of their bodies mutilated by knives, branding irons, or needles. Butterfly or occult tattoos are also common. Generally, bloodliners are less likely to have the subsequent markings, as their skin is to "remain pure and unblemished."

The ultimate purpose of the sophisticated manipulation of these individuals may sound unrealistic, depending upon our

interpretive understanding of the physical and spiritual realms. The deepest and darkest alters within bloodliners are purported to be dormant until the "Anti-Christ" is revealed. These "New World Order" alters supposedly contain call-back orders and instructions to train and/or initiate a large influx of people (possibly clones or "soulless ones"), thereby stimulating social control programs into the new millennium.

Non-biological "twinning" is yet another bizarre feature observed within MONARCH programming. For instance, two young non-related children would be ceremoniously initiated in a magical "soul-bonding" ritual so they might be "inseparably paired for eternity" (possibly another Mengele connection?). They essentially share two halves of the programmed information, making them interdependent upon one another. Paranormal phenomenon such as astral projection, telepathy, ESP, etc. appear to be more pronounced between those who have undergone this process.

Levels of MONARCH Programming 12

ALPHA. Regarded as "general" or regular programming within the base control personality; characterized by extremely pronounced memory retention, along with substantially increased physical strength and visual acuity. Alpha programming is accomplished through deliberately subdividing the victims personality which, in essence, causes a left brain-right brain division, allowing for a programmed union of L and R through neuron pathway stimulation.



BETA. Referred to as "sexual" programming. This programming eliminates all learned moral convictions and stimulates the primitive sexual instincts, devoid of inhibitions. "Cat" alters may come out at this level.

DELTA. This is known as "killer" programming, originally developed for training special agents or elite soldiers (i.e. Delta Force, First Earth Battalion, Mossad, etc.) in covert operations. Optimal adrenal output and controlled aggression is evident. Subjects are devoid of fear; very systematic in carrying out their assignment. Self-

destruct or suicide instructions are layered in at this level.

THETA. Considered to be "psychic" programming. Bloodliners (those coming from multi-generational Satanic families) were determined to exhibit a greater propensity for having telepathic abilities than did non-bloodliners. Due to its evident limitations, however, various forms of electronic mind control systems were developed and

introduced, namely, bio-medical human telemetry devices (brain implants), directed-energy lasers using microwaves and/or electromagnetics. It is reported these are used in conjunction with highly-advanced computers and sophisticated satellite tracking systems.

OMEGA. A "self-destruct" form of programming, also known as "Code Green." The corresponding behaviors include suicidal tendencies and/or self-mutilation. This program is generally activated when the victim/survivor begins therapy or interrogation and too much memory is being recovered.

GAMMA. Another form of system protection is through "deception" programming, which elicits misinformation and misdirection. This level is intertwined with demonology and tends to regenerate itself at a later time if inappropriately deactivated.

Methods and Components

The initial process begins with creating dissociation within the subject, usually occurring from the time of birth to about six years. This is primarily achieved through the use of electroshock (ECT) and is at times performed even when the child is in the mother's womb. Due to the severe trauma induced through ECT, sexual abuse and other methods, the mind splits off into alternate personalities from the core. Formerly referred to as Multiple Personality Disorder, it is presently recognized as Dissociative Identity Disorder and is the basis for MONARCH programming. Further conditioning of the victim's mind is enhanced through hypnotism, double-bind coercion, pleasure-pain reversals, food, water, sleep and sensory deprivation, along with various drugs which alter certain cerebral functions.

The next stage is to embed and compress detailed commands or messages within the specified alter. This is achieved through the use of hi-tech headsets, in conjunction with computer-driven generators which emit inaudible sound waves or harmonics that affect the RNA covering of neuron pathways to the subconscious and unconscious mind. "Virtual Reality" optical devices are sometimes used simultaneously with the harmonic generators-projecting pulsating colored lights, subliminals and split-screen visuals. High voltage electroshock is then used for memory dissolution.

Programming is updated periodically and reinforced through visual, auditory and written mediums. Some of the first programming themes included the *Wizard of Oz* and *Alice and Wonderland*, both heavily saturated with occultic symbolism. Many of the recent Disney movies and cartoons are used in a two-fold manner: desensitizing the majority of the population, using subliminals and neuro-linguistic programming, and deliberately constructing specific triggers and keys for base programming of highly-impressionable MONARCH children.

A prime example of how subliminal programming works is by looking at the recent Disney cinematic sensation *Pocahontas*, curiously billed as their "33rd" (highest degree in Scottish Rite Freemasonry) animated movie. In the movie, Grandmother Willow is a mystical 400 year old tree who counsels the motherless Pocahontas to listen to her heart and help her realize all the

answers lie within. Grandmother Willow is constantly talking in "double-speak" and using "reversals" i.e. "Sometimes the right path is not the easiest one"; the esoteric derivative being: the left path [the path that leads to destruction] is the easiest one.

In Illuminati Structured MPD Systems, the willow tree represents the occultic powers of Druidism. The intrinsic imagery of the tree's branches, leaves and root systems are very significant, as some of the dark spiritual properties associated with the Willow Tree Programming are: (1) The branches are used to whip victims in rituals for "cleansing" purposes, (2) A willow tree can endure severe weather disturbances (i.e. storms) and is known for its pliability or flexibility. Victims/Survivors of the programming describe the willow's branches wrapping around them, with no hope of escape, (3) The deep root system of the willow tree makes the victim/survivor feel as if they are falling deeper and deeper into an abyss while in a hypnotic trance.

Music plays an instrumental role in programming, through combinations of variable tones, rhythms and words. Frightmeister Stephen King's numerous novels and subsequent movies, are purported by credible sources to be used for such villainous purposes. One of his latest books, *Insomnia*, features a picture of King with the trigger phrase "WE NEVER SLEEP," (indicative of someone with MPD/DID) below an all-seeing eye.

A partial list of other mediums used to reinforce base programming are: *Pinnocchio*, *Sleeping Beauty*, *Snow White*, *Beauty and the Beast*, *Aladdin*, *The Little Mermaid*, *The Lion King*, *E.T.*, *Star Wars*, *Ghost Busters*, *Trancers II*, *Batman*, *Bewitched*, *Fantasy Island*, *Reboot*, *Tiny Toons*, *Duck Tails*, *The Dead Sea Scrolls* and *The Tall Book of Make Believe*.

A few movies which depict or portray some aspect of MONARCH programming are *Hell-raiser 3*, *Raising Cain*, *Labyrinth*, *Telefon*, *Johnny Mnemonic*, *Point of No Return*, *The Lawnmower Man* and *Closet Land*.

Programmers and Places

It's difficult to figure out who the original programmer of this satanic project was, due to the substantial amount of disinformation and cross-contamination propagated by the "powers that be." The two that went by the color-coded name of Dr. Green are a Jewish doctor named

Dr. Gruenbaum, who supposedly collaborated with the Nazis during WWII, and Dr. Josef Mengele, whose trademark of cold-blooded and calculating brutality has not only scarred the souls of survivors from Auschwitz, but also a countless number of victims throughout the world. Mengele's direct involvement at the infamous Auschwitz concentration camp was suspiciously downplayed during the Nuremberg Trials,

and consequently no intensified effort by the U.S. and its allies was directed toward his capture.¹³

As a means to confuse serious investigators as to his whereabouts, U.S. officials would report Mengele being a non-threatening recluse in Paraguay or Brazil, or that he was simply dead (the "Angel of Death" miraculously must have come back to life at least five different times). His

unprecedented research, at the expense of thousands of lives, undoubtedly was a significant bonus to U.S. interests. Besides using the pseudonym of Dr. Green, survivors knew him as Vaterchen (daddy), Schoner Josef (beautiful Joseph), David and Fairchild. A gracefully handsome man of slight stature, Mengele would disarm people with his gentle demeanor, while at other times, he would explode into violent rages.¹⁴

Other characteristics remembered by survivors were the cadence of his shiny black boots as he paced back and forth and his "I-love-you/I-love-you-not" daisy game. When he pulled off the last daisy petal, he would maliciously torture and kill a small child in front of the other child he was programming. Distraught survivors also recalled being thrown naked into cages with monkeys, who were trained to viciously abuse them. Evidently, Mengele enjoyed reducing people to the level of animals. He also would purposely restrain his victims from crying, screaming, or showing any excessive emotion.

Dr. D. Ewen Cameron, also known as Dr. White, was the former head of the Canadian, American and World Psychiatric Associations. Because of Cameron's extensive experience and credentials, the CIA's Allen Dulles funneled millions of dollars through front organizations like the society for the Investigation of Human Ecology, which Cameron ruthlessly presided over. Experimentations were conducted at several locations in Montreal, mostly at McGill University, St. Mary's Hospital and Allan Memorial Institute.

Besides the conventional methods of psychiatric tyranny, such as electroshock, drug injections and lobotomies, Cameron conceived the technique of "psychic driving," wherein unsuspecting patients were kept in a drug-induced coma for several weeks and administered a regimen of electroshocks, while electronic helmets were strapped to their heads and repetitive auditory messages were transmitted at variable speeds.¹⁵ Many of those exploited were abused children who had been run through the Roman Catholic orphanage system.

Not surprisingly, Dr. Cameron has been conveniently left out of most psychiatric journals. This may have been, in fact, largely due to Project MKULTRA being publicly exposed in 1970, through lawsuits filed by Canadian survivors and their families. The CIA and Canadian government settled out of court so as not to be required to officially admit to any wrongdoing.

A former U.S. Army Lt. Col. in the DIA's Psychological Warfare Division, Michael Aquino, is the latest in a line of alleged government-sponsored sadists. Aquino, an eccentric genius, founded the Temple of Set, an offshoot of Anton LaVey's Church of Satan. His obsession with Nazi pagan rituals and his hypnotic manipulation of people made him an ideal candidate for the position of "Master Programmer." Aquino was connected with the Presidio Army Base Day-care scandal, in which he was accused child molestation. Much to the dismay of the young victims' parents, all charges were dismissed. Code-named "Malcolm", Aquino developed training tapes on how to create a MONARCH slave and worked as a liaison between Government/Military Intelligence and various criminal organizations and occult groups in the distribution of MONARCH slaves.¹⁶

Heinrich Mueller was another important programmer who went under the code names "Dr. Blue" or "Gog." He apparently has two sons who have carried on the trade. The original "Dr. Black" was apparently Leo Wheeler, the nephew of deceased General Earle G. Wheeler, who was the commander of the Joint Chiefs of Staff during the Vietnam War. Wheeler's protege, E. Hummel, is active in the Northwest, along with W. Bowers (from the Rothschild bloodline).

Other alleged master mind manipulators, past and present, are: Dr. Sydney Gottlieb, Lt. Col. John Alexander, Richard Dabney Anderson (USN), Dr. James Monroe, Dr. John Lilly, Lt. Comdr. Thomas Narut, Dr. William Jennings Bryan, Dr. Bernard L. Diamond, Dr. Martin T. Orne, Dr. Louis J. West, Dr. Robert J. Lifton, Dr. Harris Isbel and Col. Wilson Green.

In order to keep MKULTRA from being easily detected, the CIA segmented its subprojects into specialized fields of research and development at universities, prisons, private laboratories and hospitals. Of course, they were rewarded generously with government grants and miscellaneous funding. The names and locations of some of the major institutions involved in MONARCH programming experimentation were/are: Cornell, Duke, Princeton, UCLA, University of Rochester, MIT, Georgetown University Hospital, Maimonides Medical Center, St. Elizabeth's Hospital (Washington D.C.), Bell Laboratories, Stanford Research Institute, Westinghouse Friendship Laboratories, General Electric, ARCO and Manking Research Unlimited.

The "final product" was/is usually created on military installations and bases, where maximum security is required. Referred to as (re) programming centers or near-death trauma centers, the most heavily identified are: China Lake Naval Weapons Center, The Presidio, Ft. Dietrick, Ft. Campbell, Ft. Lewis, Ft. Hood, Redstone Arsenal, Offutt AFB, Patrick AFB, McClellan AFB, MacGill AFB, Kirtland AFB, Nellis AFB, Homestead AFB, Grissom AFB, Maxwell AFB and Tinker AFB. Other places recognized as major programming sites are Langley Research Center, Los Alamos National Laboratories, Tavistock Institute and areas in or by Mt. Shasta, CA, Lampe, MO and Las Vegas, NV.

Notable Names

One of the first documented cases of a MONARCH secret agent, was that of the voluptuous 1940's model, Candy Jones. The book, *The Control of Candy Jones*, (Playboy Press) portrays her 12 years of intrigue and suspense as a spy for the CIA. Jones, whose birth name is Jessica Wilcox, apparently fit the physiological profile as to be one of the initial experiments or human guinea pigs under the government's "scientific" project, MKULTRA.

The most publicized case of MONARCH monomania has surfaced through the book *TRANCE Formation of America: The True Life Story of a CIA Slave* by Cathy O'Brien. On the back cover it emphatically states, "Cathy O'Brien is the only vocal and recovered survivor of the Central Intelligence Agency's Mk-Ultra Project Monarch mind control operation." This documented autobiography contains compelling accounts of O'Brien's years of unrelenting incest and eventual introduction into Project MON-

ARCH by her perverted father. Along with co-author Mark Phillips, her rescuer and deprogrammer, Cathy covers an almost unbelievable array of conspiratorial crime: forced-prostitution (white slavery) with those in the upper echelons of world politics, covert assignments as a "drug mule" and courier, and the country-western music industry's relationship with illegal CIA activities.

Paul Bonnaci, a courageous survivor who endured almost two decades of degradation under Project MONARCH, has disclosed strong corroborating evidence of widescale crimes and corruption from the municipal/state level all the way up to the White House.¹⁷ He has testified about sexually-abused males selected from Boy's Town in Nebraska and taken to nearby Offutt AFB, where he says they were subjected to intense MONARCH programming, directed mainly by Commander Bill Plemmons and former Lt. Col. Michael Aquino.¹⁸ After thoroughly tormenting the young boys into mindless oblivion, they were used (along with girls) for pornography and prostitution with several of the nation's political and economic power-brokers. Bonnaci recalled being transported from the Air Force base via cargo planes to McClelland AFB in California. Along with other unfortunate adolescents and teenagers, he was driven to the elite retreat, Bohemian Grove. The perpetrators took full advantage of these innocent victims, committing unthinkable perversions in order to satisfy their deviant lusts. Some victims were apparently murdered, further traumatizing already terrified and broken children.

An insatiable actress of marginal talent (now deceased), a morally-corrupt T.V. evangelist, a heralded former Green Beret officer and a popular country-western singer are a few others likely having succumbed to MONARCH madness. Lee Harvey Oswald, Sirhan-Sirhan, Charlie Manson, John Hinckley Jr., Mark Chapman, David Koresh, Tim McVeigh and John Salvi are some notable names of infamy, strongly suspected of being pawns who were spawned by MKULTRA.

Deprogrammers and Exposers

Dr. Corydon Hammond, a Psychologist from the University of Utah, delivered a stunning lecture entitled "Hypnosis in MPD: Ritual Abuse" at the Fourth Annual Eastern Regional Conference on Abuse and Multiple Personality, June 25, 1992 in Alexandria, Virginia. He

essentially confirmed the suspicions of the attentive crowd of mental health professionals, wherein a certain percentage of their clients had undergone mind control programming in an intensively systematic manner. Hammond alluded to the Nazi connection, military and CIA mind control research, Greek letter and color programming and specifically mentioned the "Monarch

Project" in relation to a form of operative conditioning.

Shortly after his groundbreaking speech, he received death threats. Not wanting to jeopardize the safety of his family, Dr. Hammond stopped disseminating any follow-up information, until recently.

Mark Phillips, a former electronics subcontractor for the Department of Defense, was privy to some of the top secret mind control activities perpetrated by the U.S. government. His inquisitive demeanor, strong conscience

and heart-felt concern for Cathy O'Brien, a "Presidential Model" under Project MONARCH, prompted him to reveal the inner-workings of this grand deception beginning about 1991. As the story goes, he helped Ms. O'Brien escape from her captors and was able to deprogram her in about a years time in Alaska. The controversial Phillips has his share of critics who are skeptical of the veracity of his claims.

New Orleans therapist Valerie Wolf introduced two of her patients before the President's Committee on Human Radiation Experiments on March 15, 1995 in Washington D.C. The astonishing testimony made by these two brave women included accounts of German doctors, torture, drugs, electroshock, hypnosis and rape, besides being exposed to an undetermined amount of radiation. Both Wolf and her patients stated they recovered the memories of this CIA program without regression or hypnosis techniques.¹⁹ Wolf presently devotes much of her time to counseling such survivors. A former labor attorney for Atlantic Richfield Co., David E. Rosenbaum, conducted a nine-year investigation (1983-1992) concerning allegations of physical torture and coercive conditioning of numerous employees at an ARCO plant in Monaca, PA.²⁰ His clients, Jerry L. Dotey and Ann White, were victims of apparent radiation exposure; but as Mr. Rosenbaum probed deeper in the subsequent interview sessions, a "Pandora's Box" was unveiled. His most astonishing conclusion was that Jerry Dotey and Ann White were likely the off-spring of Adolf Hitler, based in part on the uncanny resemblance from photos (facial features, bone structure and size were taken into consideration). Rosenbaum also states, "They both exhibit feelings and experiences that indicate they are twins." Dotey and White were allegedly subjected to torture of many kinds while under drug-induced hypnosis, with each one undergoing at least three training techniques by plant physicians.

Each victim was trained to enter into a hypnotic state upon the occurrence of specific stimuli, usually involving a "cue" word or phrase and trained to "remember to forget" what transpired in the hypnotic state. They were repeatedly subjected to identical stimulus-response sequences to produce nearly automatic reactions to the particular status. MKULTRA veterans Dr. Bernard Diamond, Dr. Martin Orme and Dr. Josef Mengele regularly visited the ARCO plant, according to Rosenbaum. The special conditioning of Dotey and White was intended for the artificial creation of dual German personalities. Rosenbaum, who is Jewish, has maintained a deep friendship with the two, despite the seemingly precarious circumstances.

Other renowned therapists involved in deprogramming are Cynthia Byrtus, Pamela Monday, Steve Ogilvie, Bennett Braun, Jerry Mungadze and Colin Ross. Some Christian counselors have been able to eliminate parts of the programming with limited success. Journalists who have recently expounded on the subject matter in exemplary fashion are Walter Bowart, *Operation Mind Control*, Jon Rappoport, *U.S. Government Mind-Control Experiments on Children* and Alex Constantine, *Psychic Dictatorship In The USA*.

Conclusion

The most incriminating statement to date made by a government official as to the possible existence of Project MONARCH was extracted by Anton Chaitkin, a writer for the publication, *The New Federalist*. When former CIA Director William Colby was asked directly, "What about monarch?" he replied angrily and ambiguously, "We stopped that between the late 1960's and the early 1970's."

Suffice to say that society, in its apparent state of cognitive dissonance, is

generally in denial of the overwhelming evidence of this multifarious conspiracy. Numerous victims/survivors of Project MONARCH are in desperate need of help. However, the great majority of people are too preoccupied with themselves to show any genuine compassion toward these severely wounded individuals. Apathy has taken over the minds of the masses, who choose to exist within the comforts of this world. Reality has thus become obscured by relativism and selfishness.

Although there has been some progress in deprogramming and reintegrating therapies, a much greater problem needs to be rectified. The Holy Bible addresses this problem as the fragmentation of the soul (Ezekiel 13:20). A spiritual restoration is what is truly needed (Psalm 23:3) but can only take place by completely trusting in Jesus Christ as the way to salvation (John 3:16; 1 Peter 3:18) and deliverance from demonic oppression and/or possession (Mark 16:17).

The true humility of Christ and the love of God effectively counters

the pride and hatred of Satan.

Statistically, the road to recovery for these survivors of unimaginable depravity is a long and tedious one, but God is the ultimate healer and only within his time, through His strength and by His grace, can the captives be set free (Isaiah 61:1).•

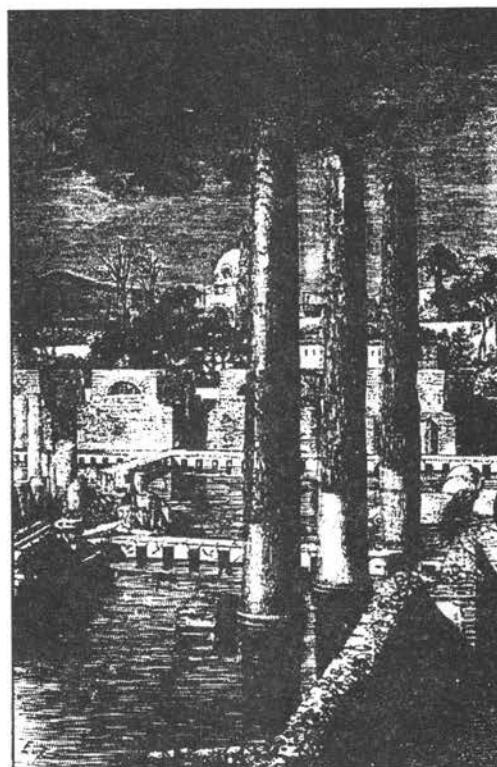
A New Generation of Vipers Part I

Liberation Theology, Ecumenicism and the New World Order by D. Guide

Ruling class conspiracy research has long neglected one key facet, and therefore the overarching theme of the principals has been missed. Economic and political maneuvers are secondary considerations to the ultimate scenario. A spiritual dimension underlies ruling class aspirations without exception. First and foremost, Masonry, Judaism, and the Roman Catholic Church are all religions. Each uses the same book—the *Bible*, or parts thereof—to create an aura of legitimacy for their designs upon the hearts of men.

The prophets prophesy falsely, and the priests bear rule by their means; And my people love to have it so: And what will ye do in the end thereof? (Jeremiah 5:31)

While Masonic, Romish, and Jewish scholars labour unceasingly to discredit the *Bible* in the minds of the masses, they all stake their claims to the Kingdom of God (and their own anticipated thrones) upon the Scriptures. Using end-time *Bible* prophecies to substantiate their doctrines, they loudly condemn others doing the same. This is not to say that the *Bible* agrees with interpretations emanating from these theologians. It is only textual malfeasance on their part and scriptural illiteracy on the part of their followers that has permitted this folly to continue. Collusion between these former opponents has begotten the Beast, and they now move forth with one voice, toward a common goal....to impose upon us their own "Kingdom of God."



The Fish at the Top Float Belly Up

Behold, ye trust in lying words, that cannot profit.
(Jeremiah 7:8)

The attack upon the West is the battle for its soul. The West will be destroyed with the conscious cooperation of the Judeo-Christian religions: the greatest enemy of the West is her own corrupted religious leadership. Their utter misrepresentation of the God of the *Bible* (undeniably the God of the West) pinpoints the spiritual nature of the battle. This betrayal by religious leaders will inevitably rob the West of her pre-eminent global position, and reduce her station to one more in keeping with the desired New Order.

Thus, the decline of Western Civilization stems from the manipulation of man's spiritual desires. Conspiracy theories are useless without the knowledge of history (where this scenario has played out before), the knowledge of religions (which fleshes out their true nature hidden in secret doctrines and coded symbols), and knowledge of the Scriptures. Without understanding of the sacred, no sense can be made of the profane. In particular, two false theologies are bearing fruit of a most malevolent variety: liberation theology and ecumenical-interfaith theology. Once these are understood, the ultimate conspiracy scenario comes sharply into focus.

Let it be clear that we are not facing a benevolent journey into the Promised Land, but instead a forced march into cruel bondage. Irrespective of the scenarios

playing out for our benefit on the world stage, all of the real action is in the religious sphere where Rome now enjoys the support of her erstwhile opponents. Impossible, you say? Let us weigh the evidence.

Liberation Theology

"Let your conversation be without covetousness; and be content with such things as you have: for he hath said, I will never leave thee, nor forsake thee." (Hebrews 13:5)

Liberation theology is theology straight from hell: the intentional seeding of world revolution. It is also the social teaching of Roman Catholicism, which sees itself as the Kingdom of God on earth. "Liberation" is the means of destroying that which stands in the way of Rome's Kingdom—secular governments. The National Council of Churches (NCC) is the Protestant spearhead for liberation theologians. "The real goal of all religion is political and economic liberation from the bondage of Western capitalism, imperialism, colonialism, racism, sexism, and classism." (Class warfare is the hallmark and centerpiece of all liberation theology.) In league with Judaism and Roman Catholicism, the NCC is fighting for "social justice," and creating an ecumenical-interfaith octopus that seeks "a stronger role of churches in guiding the nation's international affairs." (Where is separation of church and state when it's really needed?)

To foster the austere lifestyle planned for the manmade "Kingdom of God," the Western consciousness is receiving a drubbing of a distinctly Catholic bent, suffering massive doses of guilt for the blessings inherited from the God of the West. Churches and schools are major conduits for re-education of the masses. (One program developed for grades K through 2 teaches schoolchildren a song called "O Scarcity" to the tune of "O Christmas Tree.") Capitalism is no longer an extension of the Protestant work ethic, but a dragon that must be slain. Ruling class corporations are not the target: the middle class will largely take the hit.

This religious attack upon capitalism is a classic deception considering the Vatican's heavy corporate presence in the West, the Vatican's extensive real estate holdings, and the hypocrisy of anti-capitalist rhetoric coming from a man living in unparalleled wealth, amidst the gaudy splendour of Vatican City — a clear-cut case of "conspicuous consumption" if ever there was one. The Church assails the faithful for the "greed" of the West, but ignores the fact that Western taxpayers are already footing a bill of untold billions for every manner of aid to foreign lands, supporting the indigent in the West and throughout the world, generously sustaining a growing immigrant population, propping up failing regimes, heavily subsidizing emerging democracies and underwriting the manifold global efforts of the UN as well.

But the Church (as ecumenically understood: Rome and her ilk) well understands the spiritual longings of humanity, and finds success where Marxism failed. ("The Church...reaches deep into the innermost part of man.") The inability to "marxise" the inner man left a void that socialism could not fill. In order to liberate the middle-class West from its prosperous lifestyle, the Christian message has been twisted to serve the interests of one-worlders. (Obviously, the rest of the world will not be elevated to the level of the West; the U.S. must be humbled.)

Under a mask of human rights and dignity, the Church is weaving ideas of class warfare and rebellion into the fabric of society. Even the Denver World Youth Day's official litany was spiked, invoking a God

unfamiliar to most Americans: "Justice Seeker...Parent of the Poor...God of Struggle...Justice Seeker...Liberating and Loving Friend...God of Our Struggle...Liberating Friend...Liberator...God of Justice...Seeker of Justice and Joy."

Queerly out of sync with its youthful, privileged audience, this litany was clearly a brainwashing exercise. The mass-consciousness, by repetitious use of liberation buzzwords, is being seeded for revolution. (Notably absent were any links to a personal God—but any knowledge of the Living God is withheld to increase dependency upon religious leaders and to promote blind obedience to the Church.) And what of the poor? Instead of dignity, liberation theology instills a mindset of implacable

discontent. Liberation messages corrupt the Gospel of Jesus Christ. Luke 3:14 gives the precise command to "Do violence to no man...and be content with your wage," not to mention the call to personal (not collective) holiness found throughout the New Testament. This gospel applies to rich and poor. The rich Christian is exhorted to voluntarily minister to the poor, but the *Bible* was never meant to be used as the wealth-equalization plan envisioned by liberation theologians.

A personal relationship with God exists for each person, and consists of two elements—responsibility towards

God for one's behaviour, and dependence upon Him for one's needs. But this kind of teaching is dangerous. The widespread practice of reliance upon God as Lord of one's life would render much religious ministry useless; taken to its fullest extent, the Church would be powerless. By perpetuating the illusion that one is responsible to the Church, and that by the Church one subsists, artificial dependency is established where none is necessary. The Church must usurp the relationship between God and man to maintain its economic power and political control. Therefore it is the Church that needs the poor, not vice versa.

Rome's new catechism "justifies armed resistance to repression by political powers if the oppression is severe and prolonged." Armed resistance! This catechism (a teaching document to be spread to the remotest areas of the world) sanctifies bloody violence, while pretending to speak as God Almighty. But for whose sake? "For the poore he pleads, but himsele is the poore he means well to." The Church's "preferential option for the poor" and "apologies" to native groups are transparent ploys to gain the confidence of the alienated. Sustained by a rage born of self-pity, the malleable underclass can be summoned in opposition to governments when the time is right. (Like the preaching from the altar of Aristide: "During mass, he always talked about killing the bourgeois.")

The Roman Catholic *New Jerome Bible Commentary* states that "Satan is the personification of all disorder, dissension and scandal in the community." Thus the Church is hoisted upon her own petard: found engaging in Satanism by her own definition. Disorder, dissension and scandal in the community? One would be hard-pressed to find a more fitting description of liberation theology.

Ecumenical-Interfaith Theology

"Why boastest thou thyself in mischief, O mighty man? ...Thy tongue deviseth mischiefs, like a sharp razor, working deceitfully." — Psalm 52:-12

From antiquity as early as Babylon, ruling class control over the masses consisted of cleverly devised myths. Only one threat to this control existed—the knowledge of truth. Yet the ruling class formula continues successfully to this day, and remains unchanged.

Today's ruling class myth is the second theology under consideration: the cloying, brainless ecumenical-interfaith theology (*prima facie* evidence of this generation's inexcusable doltishness). The myth emanated from and was maintained by manipulations of religion. The Babylonian priesthood regularly tinkered with religious belief to create the oneness necessary for complete control. When Babylon dominated Mesopotamia, the priesthood worked to shore up its power by

incorporating local deities in "a process of syncretism and ecumenical fervour."

As historian Michael Grant notes of a later culture using the same technique, "It was in vain that the Epicureans attacked this conception of religion and mythology as an improper means of bolstering the power of priests and rulers. The priests and rulers, and the imaginative writers who were their friends, knew just what they were doing." This syncretism occurs over and over throughout history. The cult of Serapis was created by Ptolemy Soter who used it "in an attempt to blend the existing Egyptian concepts with those of the Greeks who settled in Egypt after the conquest by Alexander the Great." Ptolemy moved to cap his conquest by combining Greek worship of Hades with Egyptian religion. Religious belief transcends even patriotism.

"In his Laws, Plato advocates a cult of Apollo and Helios, so as to combine ancient ritual and rational thought." Neo-Platonic and Neo-Pythagorean authors proclaimed the unity of all Mysteries. The Caesars embraced their *interpretatio Romana*, laying claim to all foreign gods worshipped in the Empire and exporting emperor-worship to the provinces. Constantine attempted to combine the worship of Apollo (god of the Caesars) with the worship of Christ. Philo syncretized Greek philosophy with Judaism and medieval Jews worked to harmonize Greco-Arabic philosophy with Kabbalah.

Origen tried to synthesize Stoicism and Neoplatonic philosophy with Christianity. Augustine sought to lump the Mithraic Mystery cult with the Christians. The patriarchs of Roman Catholicism (Justin Martyr, Clement, Augustine, etc.) mixed Platonism with Christianity; Aquinas endeavored to reconcile Aristotle with Augustine's platonic brew. None of these hybrids elevated man spiritually, but rather served regimes (and hopefuls) seeking to consolidate their power through spiritual control. Recently, John Paul II congratulated Voodoo priests for their "faith in the one and good God." What better proof that Roman Catholicism is pagan?

The pontiff calls Muslims "brothers and sisters in faith in our God," and Billy Graham's evangelical *Christianity Today* has christened the Muslims "estranged half-brothers and sisters." This is not "the faith once delivered to the saints" but a pernicious mutation with an evil end. Examine elitist structures purveying the myth for our time: recognize that all contestants—the leaders of the Jews, Masons, and Romanists alike—have been promoting spiritual integration for some time now. This not only identifies the controlling myth, but confirms that harmony is afoot among the elite (an absolute prerequisite for any world government.)

Interfaith-ecumenical organizations abound, but one worth noting is the Temple of Understanding, connected to the Cathedral of St. John the Divine (seat of the

Episcopal bishop of New York and a recipient of Rockefeller money.) With the creation of "a Spiritual United Nations" as the Temple's goal, it is a principal prolocuter of today's controlling myth. The Temple's founders included Eleanor Roosevelt, Orthodox Patriarch Athenagorus, the Dalai Lama, "Father" Thomas Merton, Jawaharlal Nehru, Anwar Sadat, Dr. Albert Schweitzer, former UN Secretary General U-Thant, and Pontiffs John XXIII and Paul VI. The Board of Advisors includes Hans Kung, Robert Muller, Dalai Lama, and Hasidic Rabbi Zalman Schachter. Henry Luce III and Iroquois Chief Oren R. Lyons are on the Board of Directors; Bill Moyers and "Mother" Teresa are among its cheerleaders.

With such notables involved from its inception and an agenda devoted to world religion essential to their New Order, the Temple of Understanding is undeniably a ruling class entity. This pseudo-religion needs come first, because the controlling myth must lay the groundwork by establishing behavioural norms, and later serve as a bulwark during the World Government's potentially difficult implementation period.

The ecumenical-interfaith myth has been upon us for some time now. Malachi Martin identifies J.D. Rockefeller IV, Yehudi Menuhin, Dwight D. Eisenhower, John Foster Dulles, Henry R. Luce, George Meany, Queen Elizabeth II, the Duke of Edinburgh, Earl Mountbatten, Teilhard de Chardin, Pierre Trudeau, Robert McNamara, and Cardinal Leo Suenens as past and present "Mega-Religionists."

Apart from minor skirmishes, the struggle for supremacy was over some time ago. Even Queen Elizabeth's father, King George VI, had "ecumenical perceptions before that word was popular....his heir was to tread in his footsteps." King George and his archbishop of Canterbury were also both Freemasons. The current Anglican Archbishop of Canterbury, George Carey, is an ecumenist. With ecumenical bliss in such abundance, the recent flap about Anglican women pastors is likely a disagreement scripted to dissipate traditional British abhorrence of Catholicism and to tilt conservative believers toward Rome.

The Temple of Understanding was established in 1959. During the sixties, major thrusts such as Vatican II propelled the controlling ideology forward. Today, people are positively giddy with this warm, fuzzy deception and ripe for the main event. Lyndon LaRouche is a big booster of ecumenicism; curiously, both LaRouche and the Masonic-Theosophist organization World Goodwill have been singing the praises of a 15th century Catholic ecumenist, Cardinal Nicholas of Cusa. Even Herbert "British-Israel" Armstrong's Worldwide Church of God has reversed its course, and its offending doctrines as well, to become properly ecumenical — certainly a telling point!

Any doubts concerning ecumenical-interfaith theology as indoctrination to control mankind are dispelled with a speech given by John D. Rockefeller Jr. to the Baptist Social Union in December, 1917. "Would that I had the power to bring to your minds the vision as it unfolds before me! I see all denominational emphasis set aside. I see cooperation, not competition. In the large cities I see great religious centers....In small places, instead of half a dozen dying churches, competing with each other, I see one or two strong churches, uniting the Christian life of the town." This goes only slightly beyond the standard ecumenical palaver. But then Rockefeller brazenly announced his intended result: "I see the

church molding the thought of the world, as it has never done before, leading in all great movements as it should. I see it literally establishing the Kingdom of God on earth."

Long before ecumenicism was fashionable, Rockefeller had openly identified the design to control the whole world, the brainwashing required to establish the New World Order (a.k.a.

Liberation theology is theology straight from hell: the intentional seeding of world revolution. It is the social teaching of Roman Catholicism, which sees itself as the Kingdom of God on earth.

"the Kingdom of God"), and the means to do so by use of religious myth to achieve control.

NWO="Kingdom of God"

For they speak not peace: but they devise deceitful matters against them that are quiet in the land. —Psalm 35:20

Rockefeller pursued his vision. By the early thirties, he was "the most important financier of liberal and ecumenical Protestantism." His money was spread into the coffers of evangelists (such as Billy Sunday) and seminaries (such as

Union Theological Seminary and Jewish Theological Seminary). Rockefeller set about to gut Christian mission work abroad, by substituting an agenda corresponding to global goals of internationalist groups, contributing over \$1 million to the Interchurch World Movement, and making donations to the National Council of Churches. Today's elitists have neither abandoned nor deviated from this plan, but are vigorously preparing the man-made "Kingdom of God" on the strength of their popular religious myth. The Episcopal Cathedral of St. John the Divine is a hotbed of ruling class schemes. Besides its Temple of Understanding, the Cathedral has spawned other ecumenical-interfaith groups to purvey their myth, such as the Joint Appeal by Religion and Science for the Environment, and The National Religious Partnership for the Environment.

Founded in 1992, the Joint Appeal brought together Roman Catholics, Orthodox, Native Americans, Protestants and Jews from 400,000 congregations to invade the national consciousness at its most vulnerable level—that is, the soul. Vice President Al Gore is "playing a central role" in the organization. And in 1993, Vice President Al Gore established the National Religious Partnership for the Environment—with offices also located at the Cathedral. The Partnership is the U.S. Catholic Conference, the National Council of Churches, the Evangelical Environmental Network, and the Consultation of Jewish Life and the Environment. It received a multi-million-dollar commitment from The Rockefeller Foundation and others to fund a major ecumenical/eco-spiritual broadside aimed at churchgoers. Every Roman Catholic Church in America will soon be the object of ruling class largesse.

The Green Cross and Agenda 21

The Temple of Understanding is associated with the Green Cross, an eco-spiritual organization headed by Mikhail Gorbachev, and aimed at Christian schools and colleges, to supplant traditional studies with "ethical and moral issues relating to ecology." Maurice "Earth Summit" Strong and Gorbachev (in his Green Cross capacity) will compose the UN Earth Charter, creating an international environmental regulatory code. Documentation supplied by Leading Edge Research describes the Earth Charter as a statement of *the principles by which people should conduct themselves in relation to each other and the environment.*

The Earth Charter will be developed under the auspices of Agenda 21, a far-reaching agreement springing from the Earth Summit of 1992. "Agenda 21 proposes an array of actions which are intended to be implemented by every person on Earth. Effective execution of Agenda 21 will require a profound orientation of all human society unlike anything the world has ever

experienced." The State of the World Forum ("the birth of the first Global Civilization") hosted by the Gorbachev Foundation, was held September 27—October 1, 1995 at the Presidio military base. Plans for the forthcoming profound orientation — "the state of the world," "new directions," and "the future of the nation-state" — were hatched by George Bush, Margaret Thatcher, Czech President Vaclav Havel, former Japanese Prime Minister Yasuhiro Nakasone, South African Anglican Bishop Desmond Tutu, Ted Turner, Microsoft chairman William Gates, Newt Gingrich, and Alvin Toffler (author of *Future Shock* and *The Third Wave*). Called "A Bill of Rights for the Planet," and "A Magna Carta for the Earth," the Earth Charter will likely appear in the 1997 U.N. General Assembly for ratification, to be adopted by the year 2000.

The Temple of Understanding also founded the Global Forum of Spiritual and Parliamentary Leaders on Human Survival. Participants at a 1988 conference in Oxford included Dalai Lama, "Mother" Teresa, Anglican Archbishop Robert Runcie, Carl Sagan, members of the Central Committee of the Soviet Communist Party, the Chief Rabbi of Romania, the Metropolitan of Moscow's Russian Orthodox Church, goddess-worshipping James Lovelock, Forum founder Dean Parks Morton (president of the Temple of Understanding), plus senators, cabinet ministers, and the media. Morton said that participants "recognized that the much touted separation of church and state is a very recent part of the history of the human family....there is a profound sense in which this separation is very artificial."

Fruits from the Temple of Understanding's labours: (1) Earth Charter principles to support overthrow of the West's prosperous lifestyle by means of "environmental reforms," (2) National Religious Partnership, Joint Appeal, and Green Cross-Christianity infiltrated with pagan doctrines as old as Babylon, and (3) Global Forum-Religious Rights subverted. Every improvement from the Protestant Reformation is being stolen away. We shall all rue the day when Rockefeller's "Kingdom of God" comes to pass.

The *Bible* plainly states that the short-lived Kingdom of AntiChrist comes immediately prior to the Kingdom of the true God. In 2 Thessalonians 2:1-12, Paul writes that the time of Christ and his kingdom would follow certain events: "Let no man deceive you by any means: for that day shall not come, except there come a falling away first, and that man of sin be revealed, the son of perdition." We are living in the time of "the falling away." This refers to Christianity in apostacy, departing from God to follow idolatrous mythology. (The world has always been in a fallen state.) The man of sin (AntiChrist) heralds Satan's kingdom. After the reign of AntiChrist, Jesus Christ returns to establish the true

Kingdom of God for 1,000 years on earth. *While all other religions currently await their messiah, the Christian Scriptures teach that AntiChrist is coming.*

Such information does not suit empire-building tyrants as it identifies their plan. This part of the *Bible* has been furiously denied from the days of Eusebius, "that great falsifier of history." Roman Catholicism and every major denomination, plus many nominal churches, prefer to deny the words of the God that they pretend to serve, and "put far away the evil day, and cause the seat of violence to come near" (Amos 6:3). The Church instead supports Rockefeller's Kingdom of a very strange god indeed, the AntiChrist.

World Parliament of Religions

O generation of vipers, how can ye, being evil, speak good things? for out of the abundance of the heart the mouth speaketh. —Jesus Christ (Matthew 12:34)

In August, 1993 when the Parliament for the World's Religions gathered in the name of "brotherhood" and the "unity of all faiths," Rockefeller money subsidized the event. (It is reported that Rockefeller \$ was involved in the initial Parliament held one hundred years earlier in Chicago, where elitists first introduced their religious controlling myth to staunchly Protestant America.) The 1993 Parliament received the Temple of Understanding's stamp of approval and worldwide media coverage. Along with pagans of every stripe, the attendance and approbation of ruling class players gave the Parliament its requisite whiff of respectability and importance. Reportedly, a number of high-level Masons attended, along with Dalai Lama, Hans Kung, Louis Farrakhan, Vatican officials including Chicago Cardinal Joseph Bernardin, Jewish rabbis and Muslims, plus theosophists, Hindus, Kabbalists, Native American shamans and goddess-worshipping New Agers.

The Parliament's entertainment value made its motley crew appear less dangerous than they are. These foot-soldiers will bring the controlling myth into fruition for the elite! Biblical Judaism and Christianity are targeted for extinction because they uphold principles of freedom. During approximately 600 presentations, Christianity and Judaism were newly invented ("renewed") by the controlling myth. "Toward an Eco-Kosher Judaism"? Or how about "Judaism Beyond God: A New Way of Being Jewish"? Oy vay! The Parliament's "plenaries by politicians and technocrats made it clear that the organizers had a preprogrammed agenda 'to create liberal-humanistic unity' [and] 'facilitators were primed to ensure that nothing...would stop the parliament from realizing its unstated goal'."

The Temple of Understanding's philosophy clearly

dominated the Parliament. Temple president Dr. Karan Singh told the Parliament: "...we need not a linear progression in thinking but a paradigm shift in consciousness." Temple founder Robert Muller beseeched the Parliament's religions, "You must give humanity the divine or cosmic rules for our behaviour on this planet." Without missing a beat, Temple board member Hans Kung (a Roman Catholic priest) drew up the Parliament's Declaration of Global Ethics. In his book *Global Responsibility: In Search of a New World Ethic*, Kung—typically overflowing with elitist angst—expresses fears that survival is quite impossible unless "spheres of differing, contradictory or even conflicting ethics cease to exist." Kung offers his solution: "This one world needs one ethic...[consisting of] binding norms, values, ideals and goals." Elected government is clearly insufficient for Kung. What we really need are binding norms, values, ideals and goals perpetrated by self-appointed elitists who will decide what is best for us—on a universal basis. Ruling class self-aggrandizement knows no bounds.

The Parliament's Declaration of a Global Ethic echoed Kung's book, calling for "Binding values, irrevocable standards and fundamental moral attitudes....," "binding values, convictions, and norms....," "binding values, irrevocable standards and personal attitudes....," and "irrevocable, unconditional ethical norms...." There can be no mistaking such words: all personal freedom will be lost. (Binding and irrevocable personal attitudes?) The "ancient wisdom" of the religious traditions is invoked repeatedly as a standard—an unlikely source of good in the mind of

anyone familiar with the history of religion. In the end, truth will be sacrificed for The Big Lie: The Controlling Myth. Kung warns that any dissent (those troublesome personal attitudes!) will receive "the condemnation of humankind."

And what are the binding values, irrevocable standards and personal attitudes of this New Age ruling class bondage? What manner of yoke do they now approach us with? According

to Kung's Declaration of a Global Ethic for the Parliament, "Every form of egoism should be rejected. All selfishness, whether individual or collective, whether in the form of class thinking, racism, nationalism or sexism." Unmixed collectivism is the bitter fruit of "liberation" theology and ecumenicism...and we shall all soon partake of it.

Kung's "noble" goals were presented earlier with a somewhat different spin. A Lutheran theologian quoted in the *Cleveland Plain Dealer* on April 14, 1991 proclaimed "What society needs now...is a noble lie, a mythos that deceives us, tricks us, compels us beyond

self-interest, beyond ego, beyond family, nation, race, even beyond the self-evident truth that human beings are the crown of creation. The noble lie will deceive us into placing other people, or the Earth as a whole, above self." This is identical to Kung's vision in the Parliament's Declaration, but defined as "a lie." The Global Ethic being foisted upon the world by its religious leaders is lies and mythology with the sole purpose to deceive us.

Kung ignores the ancient wisdom of the Holy Scriptures in the process. He declares that "wherever those ruling threaten to repress those ruled, wherever institutions threaten persons, and wherever might oppresses right, we are obligated to resist - whenever possible nonviolently." Bloodshed is evidently anticipated in Kung's Camelot. Here the liberation theology of Rome's Universal Catechism kicks in with the threat of violence to deal with recalcitrant nations preferring to remain aloof from the New Order. The Parliament's Global Ethic puts such governments on notice that they face internal disorder and violence orchestrated by religious leaders.

But in Romans 13:1-2, Paul writes, "Let every soul be subject unto the higher powers. For there is no power but of God: The powers that be are ordained of God. Whosoever therefore resisteth the power, resisteth the ordinance of God: and they that resist shall receive to themselves damnation." Rebellion is not the business of Christians. Kung (who presumably considers himself Christian) not only advocates the destruction of civil governments, but the damnation of souls. Kung calls this declaration "a moral foundation for a new global order" and within the Global Ethic cites the UN Declaration of Human Rights. The first item of business in the Parliament's declaration is "No new global order without a new global ethic!" Thus he links religion to the UN and provides the basis for the Beast of Revelation: One World Government, One World Religion, all to be ruled by the approaching AntiChrist.

Joining Kung in his vision were 250 other "religious leaders" who signed the document. Chicago Cardinal Joseph Bernardin called it "a wonderful framework in which to continue discussions on further issues." (Further issues??) This "wonderful framework" will mark the extinction of our every liberty. Bernardin's smug remark breezily dismisses the constitutional premise of the separation of church and state as if it is a mere passing annoyance.

What is being done—without the consent of the governed—by unelected, self-serving, self-appointed "religious leaders" is a tad presumptuous. Yet they are succeeding for the simple reason that people no longer know their own God. These religious leaders "hold [back] the truth in unrighteousness" (Romans 1:19) and substitute instead the traditions of men. The *Bible* is thoroughly unknown, to our distinct disadvantage. It's the book they use to justify their own exalted positions by "handling the word of God deceitfully." (2 Corinthians 4:2)

Having forfeited our God, who will save the West? Kung's Statement of Global Ethics for the Parliament could not even include the word "God" because no agreement could be reached

on the meaning—or the propriety—of this term! Although breathtaking in its arrogance, this move betrays their “Kingdom” as, in the last analysis, a “Kingdom” without God. In order to lure evangelical Christians into the fold, Vatican point-man and self-styled “agenda-setter” Chuck Colson received the million-dollar Templeton Prize at the University of Chicago’s Rockefeller Chapel in conjunction with the Parliament. (The prize is normally awarded at Buckingham Palace by Prince Philip. “Mother” Teresa is also a past recipient.) Colson is purportedly being groomed to assume Billy Graham’s mantle and purveys the controlling myth with as much elan as Graham, who greatly accelerated the ruling class cause with his scandalous visits to Russia and his papal bootlicking.

The near-deified Graham previously received the Templeton Prize, and like his predecessor Billy Sunday, is also a past recipient of Rockefeller money. Early on, Graham also gained generous publicity when publishing tycoon William Randolph Hearst wired his newspapers throughout the U.S. to “Puff Graham.” Graham has denied that he is a Mason—a rumour stemming from reports that he attended a 33rd degree Masonic initiation in Washington, D.C. in 1966. All in all, Graham has received many advantages as the ruling class favourite.

During the parliament, a *Chicago Sun Times* reporter neatly skewered Colson and his constant call for education in “moral values” (the conservative drum beat for a New Moral Order). Colson, trumpeting the morals imparted to him as a child, could not then adequately explain his subsequent crimes in the Watergate affair. It was a delicious moment, all things considered.*

My Half Brain Considers Flight 800

- As this is being written, the cause of the destruction of TWA Flight 800 has not been determined. However, a bomb or missile attack is currently the most likely scenario. Initial radar and eyewitness reports suggested a missile, but the normally congenial White House spokesman Mike McCurry was quick to condemn those who suggested this scenario as having "half a brain."

If it was a missile (indeed, even if it wasn't), the following report from Brian Redman's *Conspiracy Nation* e-mail list is intriguing. On October 20, 1995, Rodney Stich, author of *Defrauding America* and *Unfriendly Skies: A History of Corruption and Air Tragedies*, sent a Certified letter to Senator Arlen Specter regarding the "Refusal by CIA and Justice Department officials to accept [a]" gift" of 30-40 Stinger missiles... with possible catastrophic consequences in shooting down commercial airliners."

Stich warned the Senator that his sources in the intelligence community had told him of efforts by Afgani rebels to turn over to the U.S. without charge 30-40 Stinger missiles.

The deal, which involved an Afgani rebel leader, a CIA attorney, and a former CIA agent, was rejected by U.S. government officials. Stich noted the "strong possibility" that these missiles would now end up in the hands of terrorists, and would be "used to shoot down commercial airliners."

Meanwhile, while news reports focus on *what* caused the crash, there has been little mention of the more important questions of *who* and *why*. Of course, this could be because it is simply too early to tell. Or perhaps government officials know the group responsible, but are keeping silent in order to deny the terrorists their presumed goal of publicity. Another possibility is that the attack was financed by a foreign government whom the U.S. does not want to name. On the other hand, if evidence eventually points to a domestic militia group or a "pariah" nation such as Iran, you can be sure this news will be widely reported. Banking Family Feud?

- Amschel Rothschild, the man seen as the heir apparent to the Rothschild banking dynasty, died in a Paris hotel room in mid-July. The death of Rothschild, 41, was kept secret for three days, and was

initially reported to be a "heart attack." Police now say that he committed suicide using a bathrobe belt and towel-rail. Since the rail was less than 5 feet off the ground, he apparently had to "jerk back suddenly," according to a hotel employee who asked not to be identified. Police refused to say whether they had found a suicide note. Rothschild's death came almost 18 years to the day that U.S. banker John D. Rockefeller was killed in an automobile accident, leading some to speculate that the deaths are part of a long-term feud between the powerful banking families. The Rockefellers and the Rothschilds are players in several conspiracy theories, from the assassination of Abraham Lincoln to the push for the New World Order. (*The Times of London*)

Bilderbergers Exposed

- For the first time, a major newspaper has given serious coverage to the Bilderbergers, the shifting group of powerful international media, business, and political elites that meets once a year in secret. Like the Trilateral Commission, they are a group thought, to a large extent, to secretly set the world political agenda and shape world events.

On May 31, the *Toronto Star* ran a major article on the group, which was meeting in nearby King City. The article made the important point that members of the group "are unhappy at suggestions by extremists of the left and right that the private event is part of a system of secret government." That is, the Bilderbergers and related groups have raised concerns not just on the political right, but of the left as well. The *Star* was alerted to the meeting by Toronto-based New World Order Intelligence Update (<http://www.inforamp.net/~jwhitley>).

Bilderberger members include international financier David Rockefeller, The Queen of Spain, Defense Secretary William Perry, Presidential Advisor George Stephanopolous, William F. Buckley, Canadian Prime Minister Jean Chretien, and the ubiquitous Henry Kissinger. All members are required to take a vow of silence regarding the meetings.

Two other Bilderbergers are Gazil Ercel, Governor of the Central Bank of Turkey, and Emre Gonesay, Turkish Foreign Minister. Interestingly, four days after they returned home from the secret conference, the Turkish government fell. (*Toronto Star*)

UFO Leader in Radioactive Plot?

- In June, several suspects in New York State were arrested in an alleged bizarre plot to kill local Republicans by exposing them to radioactive material. Police found a small quantity of radium and weapons in the Medford, NY home of Edward Zabo.

Another alleged plotter, John Ford, is president of the Long Island "UFO Network." According to officials, the plotters planned to spread radioactive material in their targets' cars or food. (Reuters)

U.S. POWs May Still Be Alive

• The possibility of U.S. POWs still being held in Communist North Korea, long ridiculed as a baseless "conspiracy theory," now has official Pentagon support. An internal Pentagon report dated March 26, 1996 admits that 10 to 15 men taken prisoner during the Korean War may still be there. The report, stamped "For Official Use Only," states that the Defense Department's POW-MIA Office has concluded that "there are two groups of Americans in North Korea: a small group of defectors, and a larger group of 10-15 possible POWs." The report refers to POW "escorts," which suggests that their movements are still being controlled by North Korea. The internal report contradicts the previous official U.S. position that there are no POWs from the Korean War being held in North Korea. The report also raises the question of whether any Vietnam-era POWs are still being held in Vietnam. (Associated Press)

The Other FBI File Story

• While the Clinton Administration's possible collection and misuse of FBI files has received wide coverage, a potentially more important "FBI File" story has gone un-noticed. Michael Ravnitsky, a freelance writer and law student, has during the past six years filed several hundred Freedom of Information Act (FOIA) requests with the FBI for the records of well-known Americans. The reason? These files can routinely be destroyed under guidelines developed jointly by the FBI and the National Archives in the early 1980s. "They've made provisions to save important *criminal* case files...But the National Archives forgot that the Bureau watched a lot of people for political reasons having nothing to do with crime fighting." The guidelines, continues Ravnitsky, "inadvertently allow the FBI to eliminate some dirty laundry." Files requested by Ravnitsky include those of Clark Gable, Telly Savalas, Harpo Marx, Grace Kelly, Jack Webb, Babe Ruth, Joseph Kennedy, Miles Davis, and Otis Redding. The FBI has begun to process Ravnitsky's requests, which could take between 2-5 years. (Project to Open FBI Files, 612 Lincoln Avenue, #301, St. Paul, MN 55102)•

Diet for a Zombified Planet

A recent *New York Times* article reported the startling news that a second brain has been discovered in the human body. This second brain, dubbed the Enteric Nervous System, has been the subject of scientific investigation for a number of years, and has spawned a new medical discipline known as Neurogastroenterology. (1) One would think that such an important discovery would be the subject of much debate and conjecture, yet, aside from the aforementioned newspaper article, the guardians of the fifth estate seem strangely reticent.

Of Two Minds

According to Dr. Michael Gershon, a professor at Columbia-Presbyterian Medical Center in New York, this second brain extends from the esophagus down to the colon and has thus been referred to as the "gut brain." It consists of a network of neurons, neurotransmitters and proteins just like the brain located in the head. It is connected to the head brain through the spinal cord and utilizes this pathway to carry on a continuous two-way communication. For instance, when the "head brain" is upset, the "gut brain" reacts accordingly (and vice-versa). This new knowledge goes far in explaining a whole range of maladies, from "butterflies in the stomach" to peptic ulcers. It also lends credence to the belief that too much to eat before bedtime causes nightmares.

Research has shown that the two brains have few, if any, connections from birth through infancy, developing these connections only when the

child's motor skills start to develop. It has been theorized that this initial separation enables the baby's "gut brain" to take care of it's physical needs (feeding / elimination), while freeing it's "head brain" to study it's environment (learning / social interaction).

All of this research would only amount to a scientific curiosity if it weren't for the discovery of two very intriguing facts. The first is that the "gut brain" naturally produces a family of psychoactive compounds known as benzodiazepines. (2) We recognize some of these compounds by such brand names as Valium and Xanax. The second discovery is that the "gut brain" can be trained to react to outside stimuli. (3) These two facts ought to concern every one of us, for if our stomachs truly can control how we feel and think, then it is up to ourselves, and ourselves alone, to control exactly what goes into our stomach. If our gut *can* be trained, then we should make sure

that it is we ourselves who are doing the training. The issue of personal sanctity is paramount here. Could it be that we are purposely being fed a diet that turns us into happy little consumers, at the expense of our sense of self? Is the best way to our hearts (and minds) truly through our stomachs? What follows is a collection of evidence that this may be the case.

Sodium Fluoride

The fluoridation of the public water supply was one of the first Cold War conspiracies to be brought to public attention. Those who decried the spiking of one of life's essential elements were painted as right wing "commie under the bed" kooks. As is often the case, however, the historic record seems to lend credence to what these lone voices have been attempting to warn us about. In fact, the trail leads not to "commies," but our government's old friends in the German Socialist (Nazi) party.

The trail begins way back in 1924, when a cartel of American bankers, led by J. P. Morgan, made arrangements to set up shop in Germany under the "Dawes Plan." (4) Such august American business concerns as Ford, Standard Oil, Du Pont, International Harvester and General Motors lined up to provide post WW I Germany with all the material necessary to prosecute WW II. Hobnobbing with the visionary leadership of these companies was the Mellon family (of Carnegie Mellon University).

The Mellons were also the owners of the American Aluminum Co. (ALCOA). They had a huge waste disposal problem in the form of sodium fluoride, which is a highly toxic by-product of aluminum production. When post WW II production of aluminum really took off, something had to be done. Imagine their good fortune when the family-owned Mellon Institute discovered that fluoride helped prevent tooth decay! So the family contracted with Proctor & Gamble in 1958 to produce "Crest," the first fluoridated toothpaste. This was done in tandem with efforts to fluoridate the nation's water supply. The reason given for water fluoridation was that it was helpful in preventing tooth decay in children. If this were the real reason, then why target the whole population, young and old alike?

It should be noted here that Proctor & Gamble has financial ties (as do the other firms listed above) with the infamous I. G. Farben, the German pharmaceutical company which was Hitler's major financial backer. This is where the Nazi connection comes in. After WW II, scientists from the U. S. were sent to Germany to take over the I. G.

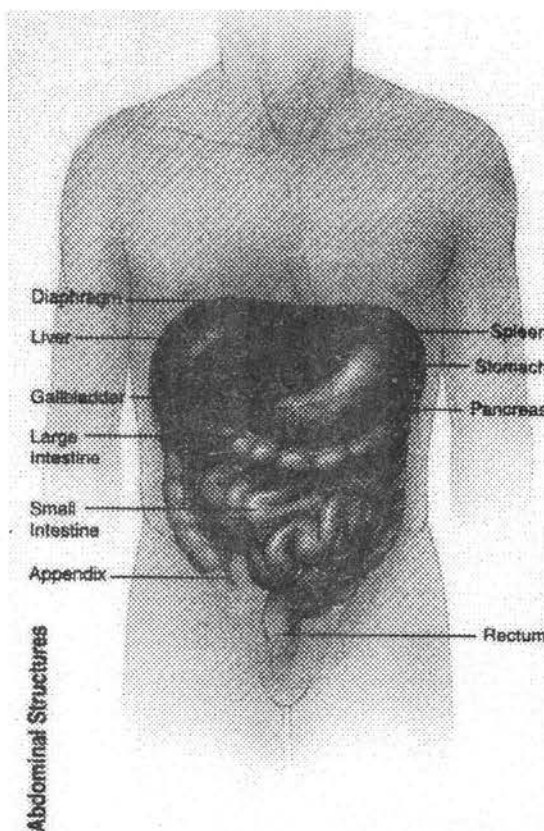
Farben plant. One of these scientists was Charles Eliot Perkins, a researcher in chemistry, biochemistry, physiology and pathology. While there he supposedly learned the truth about fluoride. This he related to Mr. Harley Rivers Dickinson in 1987, who was at the time a Liberal Party Member of the Australian Parliament. The following is the story as told by Mr. Dickinson to the Victorian *Hansard*, on Aug. 12, 1987:

"While there he was told by a German chemist of a scheme which had been worked out by them during the war and adopted by the German

These statements are backed up by Mr. George Racey Jordan, who was a Major in charge of the post WW II "Lend Lease Airlift" which brought much needed supplies from the U. S. to Russia. When he inquired why the Russians needed large quantities of sodium fluoride, he was informed that it was to be put into the drinking water of pris-

General Staff. This was to control the population in any given area through mass medication of drinking water. In this scheme, sodium fluoride occupied a prominent place. Repeated doses of infinitesimal amounts of fluoride will in time reduce an individual's power to resist domination by slowly poisoning and narcotizing a certain area of the brain and will thus make him

oners of war in order to take away their will to resist. (6)

This information should not surprise anyone familiar with our government's research into incapacitating warfare agents. One only needs to look back on MK-ULTRA plans to dose the enemy's water supply with such substances as LSD, BZ (an amnesiac 10 times more

potent than LSD), or a schizophrenic agent known as Bulbocapine. These agents, according to the *Rockefeller Report on CIA Activities*, was "part of a much larger CIA program to

study possible means of controlling human behaviour." (7)

More telling still is the fact that as of 1984, no less than twenty five percent of the "major tranquilizers" listed in doctor's reference books contained fluoride. Sodium fluoride is also sold as an insecticide / rat poison. (8)

Pasteurized Milk

Modern pasteurization methods require heating the milk to a temperature of 150 to 170 degrees for 15 to 22 seconds. (9) This is done to kill pathogenic bacteria which could cause disease. Unfortunately, this process also destroys enzymes in the milk. These enzymes are necessary in helping us to digest food. In the case of pasteurized milk, the enzyme phosphatase is totally eradicated. Without this phosphatase, as much as fifty percent of the milk's calcium

is not absorbed into the body. This heating is also responsible for as much as a two-thirds loss of vitamins A and E, up to 80 percent of vitamin B and better than 50 percent of vitamin C. To this list should be added a 20 percent loss in iodine. In all, pasteurization of milk is responsible for the mutation or outright destruction of at least thirty eight food factors. It is also now a recognized culprit in such coronary ailments as thrombosis and arteriosclerosis, as well as skeletal / tooth deformities.

All of this information causes one to wonder just why milk should be pasteurized in the first place? The answer, as always, lies purely in economic considerations. Simply put, pasteurized milk lasts longer on the store shelves. (10) (This is the same reason for that latest of consumable horrors, irradiated milk.)

Prozac

Prozac, one of the most controversial drugs ever brought to market, has been described as either the end of emotional depression or the main brainwashing tool in Big Brother's medicine cabinet, depending on whom you read. If you read Peter Kramer's book *Listening to Prozac* for instance, you will be told by this self proclaimed advocate of "cosmetic psychopharmacology" that Prozac has power to give "social confidence to the habitually timid, to make the sensitive brash, to lend the introvert the social skills of a salesman." (11) These are personal qualities which are highly valued in a service economy. As social historian David Rothman has duly noted, Prozac is "a quintessentially American drug." While not producing any of that pesky, anti-social euphoria, it instead "promotes adroit competitiveness" and is "an office drug." (12) Still, others simply view Prozac as the drug of choice for the "take your

gun to work" crowd.

But I digress. The focus of this article is the gut, which leads us back to the gut brain's discoverer, Dr. Gershon. He wanted to find out why a quarter of people taking Prozac experienced gastrointestinal distress such as diarrhea and constipation. So he took a section of a guinea pig's colon and mounted it on a stand. (I am not making this up.) If you put something in what used to be the "mouth" end, the hair-like scillia on the colon wall will force the material toward the "anus" end. When you put a small dose of Prozac in the "mouth," these scillia go into hyper-drive (diarrhea). Feed it a large Prozac dose, and the colonic system freezes shut (constipation). (13) This simple experiment clearly demonstrates that any nutrients lying in the intestines along with a dose of Prozac will be restricted from proper assimilation into the bloodstream.

Olestra

In the film *Sleeper*, Woody Allen's character awakens to find himself in a wonderful future world where "junk food" is considered by the enlightened citizenry to be an integral part of a healthy lifestyle. Doubtful as this scenario may seem, a recently developed fat substitute being marketed under the name Olestra may soon be touted as the next best thing. The Food and Drug Administration has given Olestra's manufacturer, Proctor & Gamble Co., the green light to produce Olestra for use in certain snack foods such as potato chips, corn chips and crackers. Some of these products are presently being test marketed in Cedar Rapids, Iowa, Eau Claire, Wisconsin and Grand Junction, Colorado. (14)

Because Olestra contains no fat or calories, products cooked in the stuff will automatically be healthier for a diet conscious populace. Or will they? According to Ronald M.

Krauss, MD, National Chairman of the American Heart Association's Nutrition Committee, "Questions about the overall safety of Olestra have not been answered." (15) In a statement issued by the Rhode Island Affiliate of the AHA, he states that "it's manufacturer, Proctor & Gamble Co., will conduct studies to monitor it's long-term effects." He then goes on to declare that "The AHA urges Proctor & Gamble to support a widespread effort to educate the public and health professionals in the appropriate use of this product." (16) It's the same old story: the FDA tells big business to go for it, and damn the consequences. *We will be the guinea pigs to be "monitored" for "long-term effects."*

Although any adverse long-term effects are as yet to be observed, enough research has been made known on this product's shortcomings that one wonders if P & G is putting short-term monetary gain above any concern for long-term health concerns. What do we now know about Olestra? Quoting Dr. Krauss once again, "Olestra may cause abdominal bloating and loose stools in some individuals, and *it inhibits the body's absorption of certain fat-soluble vitamins and other nutrients.*" (17) (emphasis added). The vitamins in question are A, D, E and K, and according to Dr. Krauss, "A particular concern in this regard has been the possible consequences of the reduction in absorption of carotenoids that can occur with Olestra use. The role of carotenoids in human health is not fully understood, and further research in this area is necessary. (An example of a carotenoid is the yellow pigment found in carrots and sweet potatoes that the body converts to vitamin A)." (18) Our watchdogs at the FDA are requiring that products containing Olestra must be fortified with vitamins A, D, E and K. One must assume that the reasoning

behind such an order is that increasing the intake of these vitamins will overwhelm the intestinal system, thereby forcing absorption into the body. Whether or not this is a viable approach is left to question, as Dr. Krauss is silent on the issue.

I recall reading about research into fat substitutes in a plastics industry trade journal about twelve years ago. Why was this product ballyhooed in a magazine devoted to the plastics industry? Because the fat substitute that they were so proud of was actually made out of plastic! Now I'm not sure if Olestra is the same product, but I do know that back then in the 80's, word was that the product was considered perfectly safe for human consumption. The reason given for this lack of concern was that the material passed through the intestinal tract without being absorbed.

Two other issues disturb me regarding the planned vitamin fortification of products containing Olestra. Foremost is the question of the efficacy of the vitamin fortification itself. If the product inhibits absorption of these fat-soluble nutrients, then does it naturally follow that these nutrients will still not be absorbed, regardless of volume? Also, is there any perceived adverse effect stemming from introducing large quantities of these vitamins into the digestive tract. Of special concern is the introduction of vitamin K. I have long been led to believe that this nutrient is contained solely in the lower intestine, and if some trauma (such as peritonitis), should cause it to escape into the upper intestinal tract, death will be only hours away. I have also seen vitamin K used as the sole active ingredient in industrial rat poison.

Americans literally eat tons of the snack foods that will be subject to "Olestrazation." It shouldn't be long before the marketing of these "low

fat," "reduced fat," and "fat free" goodies causes more traditionally prepared products to become a rare commodity indeed.

Aspartame

Following the news that the artificial sweetener saccharin caused cancer in lab animals, aspartame was presented to the calorie-conscious consumer as an FDA approved sugar substitute. And it didn't leave a bad aftertaste! Little blue packets were soon to be seen edging out the familiar pink in restaurants and coffee shops. Sold under such brand names as NutraSweet, Equal And Spoonfuls, aspartame quickly became the sweetener of choice in everything from soft drinks to laxatives. Concurrent with its growing popularity however, is an equally expanding body of evidence which suggests that lab results were tam-

pered with, and bribes were paid to keep the buying public in a state of ignorance.

Erik Millstone, a researcher from Sussex University, U.K., has used the Freedom of Information Act to compile evidence to demonstrate that a) test results were falsified, b) the FDA Commissioner at the time

overruled his own board of inquiry to get Aspartame approved (then left to take a position at one of its manufacturer's public relations firms), and c) that two U.S. attorneys who were supposed to bring fraud charges against Aspartame's manufacturers instead took positions with the manufacturer's law firm and let the statute of limitations run out.⁽¹⁹⁾ This kind of nepotism appears to be standard operating procedure at the FDA. It has been reported in a recent study that out of 49 top officials at the FDA, 37 took positions at companies they had regulated. Also, 150 FDA officials owned stock in companies under their jurisdiction.⁽²⁰⁾

Aspartame may be responsible for a myriad of maladies, according to Dr. H. J. Roberts of the American Diabetes Association.

Aspartame has also been implicated in the occurrence of some epileptic seizures. The Massachusetts Institute of Technology recently conducted a study on 80 people who's seizures were induced by aspartame.⁽²²⁾ The possibility of artificially induced seizures has caused the aviation industry to set up a hot line for pilots to report adverse aspartame reactions. Some of the more than 600 pilots who called in reported experiencing *grand mal* seizures while in the cockpit!⁽²³⁾ (Could this explain some of the mysterious crashes that occur when, all other systems appearing normal, the aircraft inexplicably cork-screws into the ground?)

The adverse reactions to aspartame listed above, terrible as they are, can still be seen as temporary and easily avoided by not consuming it. This choice may not be available to future generations whose neurophysiology has been permanently altered by this chemical compound which science considers not only a sweetener, but also a neurotoxin.⁽²⁴⁾ While it is common knowledge that alcohol is a major cause of birth

defects, few pregnant women realize that the can of diet cola that they are enjoying instead of their favorite alcoholic beverage contains highly poisonous wood alcohol. This is because aspartame contains 10% methanol (wood alcohol) by weight. Research conducted by Dr. William H. Pardridge of the University of California indicates that mothers with as little as 250 parts per million of phenylalanine in their bloodstream are likely to give birth to a child with a 10 point drop in IQ.⁽²⁵⁾ (Could this explain why Johnny can't read?) This information, combined with the results of studies conducted by Dr. Ralph G. Walton on aspartame's deleterious effects on people subject to mood disorders bodes ill for the future. According to Dr. Walton, "its use in this population should be discouraged."⁽²⁶⁾

Conclusion

The discovery of the "gut brain's" relationship to our emotional and physical well being should cause us to reconsider our relationship with the chemicals that we let pass our lips. If the tiniest traces of certain compounds are capable of severely affecting the synaptic firings of the tissue mass in our skull, then it stands to reason that the tissue mass responsible for instinctive knowledge is subject to the same kind of influences. Is that glass of tap water turning you into an obedient automaton? Is the pasteurized milk you're drinking robbing you of nutrients that your body (and both brains) require for proper functioning? Is Prozac also blocking out the vitamins and minerals while addicting both brains to its Siren's song? Will Olestra prove to be the final insult? Is the NutraSweet logo a downward spiral?

The ancient Latins employed a phrase which holds true in this case. The phrase in question is "caveat emptor" (Let the buyer beware). Another, more modern phrase

springs to mind, that being "you are what you eat." Dietary issues become more complex as new products enter the market at an increasing rate. Will the chemical tinkering of both the food supply and our brain chemistry, either through intent or bureaucratic malfeasance, create a future inhabited by malnourished robots, incapable of realizing their own human potential? Or are we already there?•

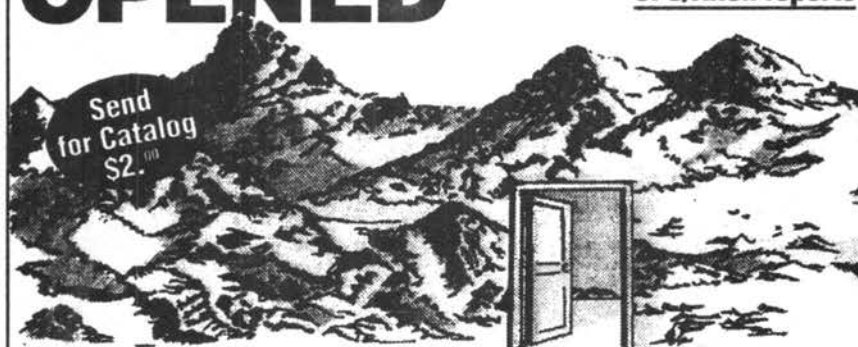

Star Trek

Sci-Fi or Psy-War?

Psy-war, or psychological warfare, is an admitted, if little understood by the public, component of the U.S. military. Other powers are also known to have so-called psy-weapons. Those powers are not limited to governments. Modern media advertising is clearly a form of psy-war, one waged against "targeted" demographics by major corporations and other institutions. Including religions...

In Victorian dramas, plays and novels, characters were often given significant names, names that described the character or had a special meaning in terms of the plot. Oscar Wilde's play, "The Importance of Being Earnest," is an example of this; with the title's double meaning. Likewise, the names of the characters in the original television series *Star Trek* are pregnant, as the Victorians would say, with multiple meanings. Are these meanings of no significance beyond the spinning of a tale, or do they reveal a hidden, subliminal psy-war attack on a targeted population? In this article I will attempt to show that *Star Trek* was a premeditated attack, one whose purpose was to subliminally indoctrinate America into obeying the Roman Catholic Church.

First, let us consider the primary character, the mover and shaker, the guy in charge, Captain James T. Kirk, Commanding Officer of the Federation Starship *U.S.S. Enterprise*. When we analyze his name, we first notice that James was the brother of Jesus. James took over the movement founded by Jesus after the crucifixion. The name means "the supplanter" and is a variant of Jacob, one of the Patriarchs of the Old testament. Kirk's middle name was Tiberius, a Roman General and Emperor. "Kirk" is the most common European language spelling of the word we know in English as "church." Put these all together: (brother of) Jesus, Roman (Emperor), Church, and what do you have? The Roman Catholic

Church! It was the Roman Catholic Church (RCC) that was, symbolically, in control of the *Enterprise*.

In the U.S. Air Force a Chaplain is referred to as a "sky pilot," here, in the person of Captain Kirk, we have a church (a kirk) flying through outer space, the abode of God. Just a pun, or a subliminal message?

Who ran Kirk? He took orders from Starfleet Command. If Kirk represents the RCC, then Starfleet has to be God. "Fleet" can refer to a number of ships, it can also mean "swift." Is it not "God" who commands the "stars" in their "swift" passage through the heavens?

Under Kirk were two primary characters. The Medical Officer, Leonard McCoy, and the Science Officer, Mr. Spock. Let's take up McCoy first. Leonard is Teutonic and it is "-nard," meaning "brave or strong," plus "Leo," the lion. Together they mean "strong in the Lord," or "strong in Faith." No less than thirteen Popes have taken the name Leo. The Lion has been a symbol of Christianity nearly since its inception. Of course, the lion image tracks back to the Lion of Judah, the totem of the Jews.

"McCoy" has two referents to American culture. Recall, if you will, that Spock and McCoy, the emotionless and the emotional, were perpetually locked in a feud. As well as being the archetypal battle of emotion vs. logic, it is also an allusion to an event in American history. In the name and character of "McCoy" we have the power of an archetype welded to the image of the

bitter feud between the Hatfields and the McCoys. Dr. McCoy represents The McCoys and Spock stands in for the Hatfields -- who lost.

McCoy's second connection to American culture and consciousness is in the phrase: "the real McCoy." It means that the item referred to is the genuine article, not an imitation or fake. Is this an attempt to say that the RCC is the true religion while up-start science, championed by Spock, is the impostor? So, Doctor (healer) Leonard (of the faith/faithful) McCoy (true religion), is the emotional (be as the little children, faith is from the heart) winner.

Dualities being the easiest to deal with in a sixty minute format, we also have the equally archetypal battle of Good vs. Evil. If McCoy is on the (winning) side of true religion, then (the losing) Spock, and Science, must be of the Devil. Just so you don't miss which side McCoy is on, his assistant is Nurse Christine (a variant of Christ, Christian) Chapel (a small church). Likewise, to ensure that you saw Spock as the Devil they gave him pointy ears!

Spock has no other names (pronounceable by humans, that is). Demons, you may know, have names that humans can summon them by, as well as ones that cannot be uttered by the human tongue. Spock is a miscegenation (a Biblical sin), a half-breed: part human, part Vulcan. "Vulcan" was the Roman god of fire and craftsmanship who lived in the underworld -- again, an image of both science and the Devil.

The only name "Spock" could refer to, in contemporary American culture, would be that of Dr. Benjamin Spock, the baby doctor. Perhaps this was intended to subliminally cause the viewer to associate science (only a little over a century old) with infants (in its infancy, as a baby) as a further denigration. Dr. Spock was a secular humanist, a progressive, and an outspoken opponent of the Vietnam War, which was just becoming a major shooting war at the time that *Star Trek* hit the air.

Mr. Spock, as a half-human demon, associated with Benjamin Spock, the

anti-traditionalist, the secularist, the authoritative anti-authoritarian, would have been the very antithesis of what the RCC stood for. Of course McCoy was the "Real Thing." The Christian Church, and particularly the RCC, has always been an opponent of rational, free thinking; and a proponent of emotional belief and blind faith. That is what the Inquisition was all about, wasn't it? Mr. Spock, the free thinker, the Faustian Devil, would have been burned at the stake!

In *Star Trek* the RCC has won, for both Spock and McCoy were completely under the command of Kirk (church). Capt. Kirk represents a face of the RCC that they would like us to believe is its true nature. Kirk is kind, and almost indulgent of the "feud" between his juniors. Like a loving father, he is firm and forceful when necessary -- yet, never too forceful. There are no Inquisitions on the *Enterprise*. (Except for the one episode where...)

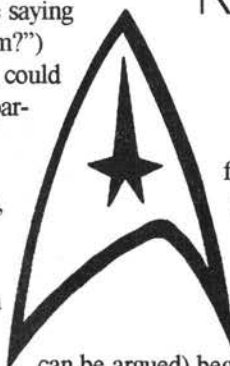
There were two other principal officers on the *Enterprise*: Uhura and Scott. Uhura is a variant of "Uhuru," Swahili for "freedom." Uhura is the Communications Officer, so she could represent "freedom of speech" -- but she doesn't speak for herself. She is the go-between for Kirk and the universe outside of the *Enterprise*; in particular his link with Starfleet (God).

Perhaps she represents religious freedom. Her "freedom," however, is closer to slavery. She cannot send or receive communications on her own, but only as directed by her superiors (in Orwell's *1984*, one of Big Brother's three great truths was "Freedom is Slavery," could this be saying "slavery is freedom?") The message here could be that freedom, particularly religious freedom, is the ceive, and receive, mindset; that the personal starship

Revolution (it can be argued) began in Scotland. Mr. Scott's name is a perfect Victorian novel name that exactly described his personality and his function: the simple mechanic. Mr. Scott would then appear to embody all the elements of the Industrial Revolution that the RCC is willing to accept (useful gadgets without any challenging ideas), while Spock represents those elements that the RCC wishes to crush.

tion: Just Cause" and "Operation: Restore Hope." This practice is not entirely new. The Spanish Armada was code-named "The Enterprise."

What was the failed attempt to invade England by Spain all about? England was then ruled by Queen Elizabeth I. During her reign, she encouraged a cult of personality to grow up around her. She, and her inner circle, got into some pretty strange things -- like Goddess worship, demon conjuring, and all manner of un-Catholic activities. As an example of this, Sir Walter Raleigh's customary court clothing was all black with magical symbols woven in silver thread. The Spanish "Enterprise" was an attempt to dethrone the neo-pagan Queen and retake England for Catholicism.

The U.S.S. portion of the ship's name was defined on *Star Trek* as meaning United Star Ship -- a transparent play on United States Ship, the designator for all U.S. Navy craft. As for the designator number, today all aircraft are required to display "N" numbers as a form of identification. This number could refer to the year 1701, which was the

date of the beginning of the War of Spanish Succession. This was a war to determine who would ascend to the Spanish throne. It eventually embroiled all of Europe, becoming a precursor of the World Wars to follow centuries later. I believe that, in this context, that date/number symbolized that, with the airing of *Star Trek*, a new war of neo-Spanish, i.e. Catholic, succession (to the "throne" of Earth) had begun.

What about the latter generations of *Star Trek*; the seven movies and two TV shows that followed? Did they follow in this "conspiracy?" I think not. One can find some inter-

esting meanings in some of the names, and one can arrive at some intriguing interpretations of some of the stories aired; but I don't see this system of hidden messages about the RCC continued.

However, there is the possibility that, with the death of Gene Roddenberry, *Star Trek's* creator, and the changing of personnel over the years, one or more other conspiratorial voices have begun to speak through this format. One episode of *Star Trek: The Next Generation* involved the Federation, in violation of its vaunted Prime Directive, sending undercover agents to a planet to shift them from a multi-national political system to a one-world government. The object was to get them to have a single voice so that the planet could then be asked to join the Federation. This could well be a message from the New World Order crowd (which the RCC seems to have joined). There is a growing movement to consolidate all the nations of Earth under a single authority, such as the United Nations.

While the RCC may have taken a back seat, television programming continues to appear to be population programming; in this case, a "plot" to move the Earth's population towards accepting a real "United Federation of Earth" at some point in the near future.

So, was *Star Trek* originally an attempt to subliminally convert America to Catholicism? Did it become a vehicle for creating acceptance for the creation of a United Federation of Earth? Was it actually a psy-war operation perpetrated by the Vatican or the New World Order to convert or subvert the U.S. Or, have I just found an series of amazing "coincidences?" birthplace of the AIDS virus (HIV). Of interest to conspiracy buffs is that David Ferrie, one of the key players in the assassination of President Kennedy, had documented links to the lab. In fact, some of the cancerous animals were housed in his apartment. Fans of Oliver Stone's *JFK* will remember Joe Pesci's over-the-top portrayal of Ferrie, who met an untimely death in the film when he was force-fed a lethal dose of prescription drugs by government agents. 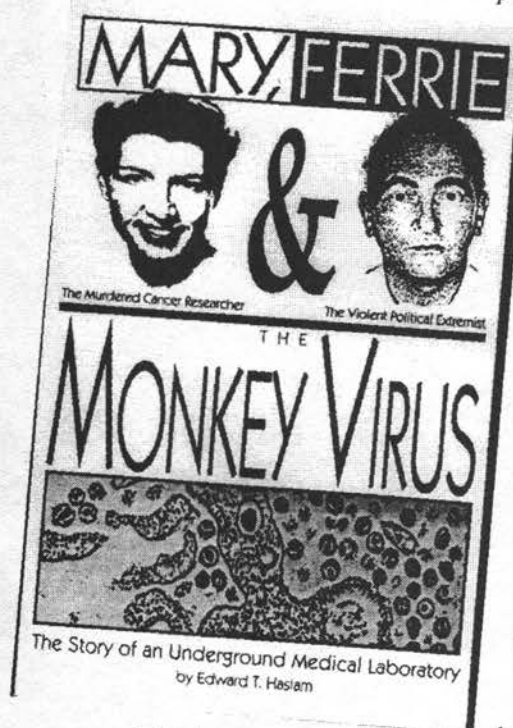

Nasa Mooned America! Rene, self published in Passaic, NJ, 176 pgs., \$24.95

Apollo 13 is a science fiction movie.

The first steps toward what was to be the third biggest deception in history were taken in 1961 when the Defense Intelligence Agency began its Apollo Simulation Project. This massive conspiracy is chronicled in words and pictures in R. Rene's book *Nasa Mooned America!*. A sample of the irrefutable evidence is provided in the three large official NASA color photographs printed in Rene's book. There are 27 "smoking guns" contained in these three images. The "noble adventure" of the Apollo "astro-nots" took

As Rene explains, the Apollo 16 mission purportedly spent 13 days outside of the Van Allen radiation shield protecting the earth. There was an average of 14.47 flares per day as found on NOAA solar flare records for the years from 1967 through 1991. This totals 188 flares and we will assume that not a single heavy flare happened on any of the 85 days that the Apollo missions were past the Van Allen shield. Their ships' hulls were paper thin, he explains. "In general, 5 rem is considered acceptable for a nuclear-plant employee in a year, with 25 rem (the total countenanced for Chernobyl cleanup workers) an allowable once-in-a-lifetime dose."

Rene figures the astro-nots are as radiation resistant as cockroaches, by the following analysis of radiation exposure they should have received on the Apollo missions: "Twenty percent of the solar flares had to be of intermediate activity and each gave the crew 25 rem. This represents 37.6 flares which gives astro-nots John Young, Ken Mattingly and Charles Duke a grand total of 940 rem apiece. Three astro-nots went to the moon twice and for the following calculations we shall consider only the intermediate flares. Astro-not Dick Lovell was allegedly present on Apollo 8 for six days and on Apollo 13 for six days. This is 12 days for a total exposure of 870 rem. Astro-not Gene Cernan supposedly was on Apollo 10 for eight days and on Apollo 17 for twelve days for a total of 20 days. this amounts to a total of 58 flares for a total dose of 1445 rem. However, astro-not John Young seemingly flew on Apollo 10 for eight days and Apollo 16 for thirteen days for a grand total of 21 days. this gives him 61 flares and a 1525 rem exposure. At this exposure they all should have died in space."

Why would the elitist managers of our shadow government wish to fake the Moon landings? Very big money. If it required one percent of the 39 billion

Dead Ringers

The JFK-Tippit Connection

On November 22, 1963, Lee Harvey Oswald was arrested in a Texas theater for the murder of police officer J.D. Tippit, who was shot on a Dallas street some four miles away within 45 minutes of the shooting of the President. Officer Tippit looked remarkably like John F. Kennedy. Eyewitness reports of the dead president after autopsy, including Jackie's, indicate that Kennedy did not "look like himself." Based on some unusual discrepancies between photos and x-rays, common sense dictates a probable connection in this amazing synchronicity. It is well known that the President's body was transported in two different caskets, but was one of them empty? Or did it contain the body of J.D. Tippit, a "dead ringer" for JFK?

In June 1992, I was invited by Mr. Douglas Carlson to address a closed session of JFK researchers at The Third Decade JFK Symposium in Chicago. While preparing for the Chicago lecture, one of my research associates asked me, "Robert, where was Officer Tippit shot?" I replied "In the left eye, I believe," for that was the story I had read in the *New York Times* many years before, "but...let me make sure." I found a copy of Jim Bishop's *The Day Kennedy Was Shot* and read the section on the death of Officer Tippit.

To my amazement, Bishop described Tippit as having been shot in the right temple, the right temporal area, the very same region of the head where the death blow struck the President at Z-313. Immediately, my mind boggled at the probabilities that this might be a chance coincidence. That the man accused of killing both Tippit and JFK could shoot two people within 45 minutes of each other, within 4 miles of each other, one with a rifle and one with a handgun, producing exactly the same type of wound, was beyond the laws of chance and beyond belief. I made up my mind to inquire about this in Chicago. I had read of some unusual discrepancies between photos and x-rays in several books including Harrison Edward Livingstone's *High Treason II* and David Lifton's *Best Evidence*. Common sense dictated a probable connection in this amazing synchronicity.

The True Nature of Tippit's Wound

At The Third Decade Press Conference in Chicago, a panel of the country's foremost experts on the Kennedy assassination discussed the X-Ray/Photo Paradox. I inquired whether anyone there had ever considered the possibility that we might be seeing rear view photos and x-rays of Tippit substituted for those of JFK. I told the audience that I had discovered the amazing synchronicity of the temporal head wound in both victims. From the podium, George Michael Evica, author of *And We Are All Mortal*, responded with a most unusual answer:

It's interesting that you should ask this question because... I've studied Tippit and when I went down to Dallas I found that Tippit bore a remarkable resemblance to President Kennedy, so much so that his friends in the Dallas Police Department used to rib him and call him 'Jack' and 'JFK'.

I then asked whether or not anyone had ever seen any pictures of Tippit other than the one I had dubbed "The Elvis Picture," which showed him in a cowboy shirt, head slightly tilted, hair slicked back, appearing to be about 26-30 years of age. To my knowledge it was the only one published since the day of his death. I inquired whether anyone had ever seen Tippit's autopsy report. Few people could answer my questions.

"Windowman": A Second Assassin

On the following afternoon, I attended a presentation by Robert J. Groden, co-author of *High Treason*, on the photographic evidence in the JFK Assassination. It was there that I identified the face of a second JFK assassin found in a Tom Dillard photograph in 1978 by Groden. The face of a possible second assassin was discovered by Mr. Groden in an old negative of a photograph taken by press photographer Tom Dillard six seconds after the

assassination of President Kennedy. The photograph shows the entire front of the Texas Schoolbook Depository including all the windows on the sixth floor. Groden had found the negative in a neglected pile of pictures and negatives in the National Archives while working as photographic consultant to the HSCA (House Select Committee on Assassinations) in 1978.

Groden noticed that unlike the published versions of the photograph which had been cropped to exclude the last row of windows, the negative showed all the windows. Furthermore, Groden learned that the negative had been treated with a radioactive emulsion ten years earlier in the hope that inducing a small radioactive reaction in the emulsion might enhance or highlight dimly illuminated details in the negative. Groden also noticed that the last window on the sixth floor of the depository opposite Oswald's presumed position was also open, the southwest window. Taking the negative, he put it under a microscope and looked into the last window. There, peering back at him, was the luminescent head of a man, hiding in the last window. Groden then made a slide of the 'Head in the Window.'

Sitting in the 10th row center of Thome Hall Auditorium I was stunned. As the face coalesced into a soft focus, I noticed the sharply angular features of the nose, brow, cheeks, chin and jaw, as well as the distinct shape of the left ear. "It would be easy to identify that face with such distinctive features," I thought. Later, however, as I reflected on my first feelings and reactions upon seeing the face, I recalled that I had also had a very strong somatic and visceral reaction to seeing the face. A deep recollection had welled up within me and I knew with certainty that I had seen that face before.

With a background in computer graphics, I visualized reversing the image into a positive photograph and enhancing the features of the eyes, brows, nose, cheeks, chin, jaw line and ears with enhancement techniques. In a flash I had a clear picture in my mind not only of the features of the face but even its cold and malific expression. At that moment I thought, "It is the expression of one so proud and entranced by the evil he has done that he could not resist taking one more peek at the chaos he had unleashed upon the world; one last glance that would turn out to be his own undoing by revealing his face to the world so many years later."

Later that afternoon, as I browsed through materials on display, my attention was drawn to a rare, self-published book by reporter Penn Jones Jr. of the Midloathian Mirror entitled *Forgive My Grief III*. As I passed over a series of rare photographs of "the Three Tramps" or "Hoboes" arrested in the railroad yards by the Dallas Police Department, I was shocked to realize that there at the head of the line in photos of the tramps being led off to the Sheriff's office was the face I had just analyzed in Groden's presentation: the Tramp called "Frenchy."

Identification of Frenchy

I recognized the face in the window as the Tramp who has come to be called "Frenchy" by JFK researchers, known to others as "Carlos," with such certainty that I had to wonder why Robert Groden hadn't realized it himself. I also wondered how we could submit it to computer scanning and enhancement as Gary Mack and Jack White had



done with Mary Mooreman's polaroid when they discovered "Badgeman," in order to confirm what I felt with such certainty: Frenchy was one of the shooters who fired from the Southwest window. I then took the photos of Frenchy which I had found and using advanced scanning and computer graphic techniques attempted to replicate a facsimile of Mr. Groden's slide, which I sent to him in the hope that we might work together in making a conclusive identification of the face in the Southwest window. Although Mr. Groden did not answer my letter, Mr. Groden did publish a greatly reduced version of the photo in his book, *The Killing of a President*, over a year later. I have enlarged Mr. Groden's version and with the Tramp photos for comparison. The most salient characteristics are the unique shape of the ear, the distinctive receding triangular hairline and the geometric proportions of the brow, cheeks, nose and chin.

When I discussed my identification of Frenchy as the man in the Southwest window with Mr. Dan Dupont, he brought to my attention that when one compared the Tramp photos and the photo of Lee Oswald handing out pro-Cuba pamphlets in New Orleans on August 16, 1963, it is clearly Frenchy present in both photographs standing in close proximity to two of the victims of November 22-24th, 1963. The unique posture of

hunched shoulders, head lowered, ear line and body language captured in both sets of photos attest to his identity.

Tracking the Tramps

Although Mr. Groden and I missed the opportunity to discuss the identification of Frenchy as the Face in Tom Dillard's photograph, I continued my investigation independently. With a personal certainty that Frenchy, one of the Tramps, had been present on the 6th floor of the Texas Schoolbook Depository, I began seeking out all photos taken of their arrest. During that period, I scruti-

nized photos taken by Jack Beers, William Allen and George Smith gleaned from several books, concentrating on conducting physiognomy studies of "Frenchy." Many of these photos were published in *Coup d'Etat in America* by A.J. Webberman and Michael Canfield.

In September of 1992, a research associate, Mr. Kevin McCrary, had presented me with a book called *The Man on the Grassy Knoll*, by John R. Craig and Philip A. Rogers. To my great satisfaction, I found that the authors, while following a totally independent line of thought and investigation, had arrived at the same conclusion, i.e., that the Tramps, and "Frenchy" in particular, had been actively involved in the murder of the President. They identified Frenchy as Charles Rogers of Houston, Texas. Included in *The Man on the Grassy Knoll* was a photograph taken by William Allen of the Dallas Times Herald. The photo showed the Tramps being led single file past the Texas Schoolbook

Depository. My interest was drawn to the photo by the presence of the arresting officers in the photo. I noted that although I had been familiar with the faces of the Tramps since the late 1960's, I had never seen the faces of the Dallas Police officers who had arrested them. The officers were almost always cropped out completely, or shown with parts of their faces cut off at the edges of the page or the TV screen, in photos which emphasized the faces of the Tramps or "Hoboes".

While studying William Allen's photo my attention was drawn to one particular person. I noted the exceptional posture and gait of one of the arresting officers who had a very square jaw and bore a strong resemblance to President Kennedy. Knowing already that Tippit had looked like President Kennedy, I jokingly wondered to myself whether or not the Dallas Police Department had been recruiting "Kennedy Clones" in 1963. However, being intent on identifying Frenchy, or "Window Man" as I now called him, I put the thought aside and pursued this line of investigation.

The Real Secret of the Tippit Murder

In late July of 1992, I received a distinguished piece of detective work and scholarship by Gary Murr entitled *The Death of Officer J.D. Tippit*. It contained the report of FBI Special Agent Arthur Carter on the autopsy of Tippit conducted by the Texas Coroner, Dr. Earl Rose. As soon as I saw the entry wound diagrams by Dr. Rose I realized that the lateral x-ray purported to be that of the late President was in fact that of Officer Tippit.

When I read Dr. Rose's report of the path taken by the bullet through Tippit's brain, I realized that it described precisely the same trajectory described by the official Warren Commission report of the bullet's path through the President's brain, but in reverse. It should be pointed out that an autopsist can with certainty only describe the path of a missile through brain tissue, not its direction. I then compared Dr. Rose's autopsy of Tippit with Humes' and Boswell's autopsy report on the President's brain. It was odd that both autopsies described the lacerations severing the same organs, the "cerebral peduncles," a part of the midbrain, which could not have remained intact and recognizable in President Kennedy considering what is depicted in Frame Z-313 and the testimonies of Dr. Kemp Clark and others at Parkland Hospital.

The only differences found between Rose's report and that of Humes and Boswell are the presence of a "parasagittal laceration from the optic lobe" to just behind the orbit of the right eye, and the severing of the "corpus callosum," which cannot be explained as the result of the passage of a bullet. However, both these lacerations can be explained as autopsy incisions: one, the parasagittal laceration, used to determine the

trajectory of the bullet and to retrieve it from Tippit's brain, the second, severing of the corpus callosum, was a consequence of the removal the brain from the cranial cavity. The damage to the skull of J.D. Tippit described by Dr. Rose matches the lateral x-ray of JFK exactly.

The JFK hoax-Rays

I decided to compare these purported x-rays of JFK with photos of both the President and Tippit. I searched for over a year to procure other pictures of Tippit but with little success. I sought the aid of researchers in the Dallas area for photos and information on J.D. Tippit. No other pictures were available until September 1992 when *U.S. News and World Report* published a rare right three-quarter profile of Tippit in police uniform. By properly sizing transparencies of the two men and comparing them, it became evident that Tippit and JFK, from the cheeks down to the jaw, appeared to be almost fraternal twins. When viewed from the side, the correspondence between their features was as George Michael Evica had stated in Chicago "a remarkable resemblance." I compared the x-rays with photos of both men and found that the x-ray overlays which I had made fit J.D. Tippit and did not fit the skull contours of JFK. I found the difference between the contours of the skull x-ray and the photo of JFK to be equal to the difference between contours of photos of Tippit and JFK. It is a case of simple algebra to figure out that if A minus B equals C, and A minus D also equals C, then B and D are equal to each other.

In August of 1993, I began to share my information with Professor James Fetzer of the University of Minnesota Philosophy Department to insure its safekeeping. His encouragement spurred me to continue my research. Professor Fetzer provided me with a piece of invaluable information. Having seen the original print, Professor Fetzer informed me that the Tippit-Elvis picture had been reversed right to left in previous publications. This was to become a significant insight. While I was conducting the skull contour studies, I realized that I had within my grasp the ability to recreate an "undamaged" analog of the skull x-ray by using a mirror technique to reflect the undamaged half of the skull in the x-ray. I also mirrored the damaged half.

I reproduced transparencies of the x-rays, bisected them, and by aligning them along the nasal septum, produced a "Reconstructed Skull X-Ray of

President John F. Kennedy." Clearly, it is not the skull of the President. Although JFK and Tippit bore a close facial resemblance, the differences between them can be compared in terms of the differences between the skulls of a Cro-Magnon (JFK) and a Neanderthal (Tippit). In the right three-quarter profile comparison of JFK and Tippit wearing the police cap, it is obvious that President Kennedy had a much larger cranium. Thus, the discrepancy between x-ray contour and photo. The x-rays seem to be of Tippit after removal of the fractured bones of the frontal and temporal area.

Discovery of Tippit Alive in the Tramp Photos

While conducting the Tippit-JFK facial studies in September of 1993, working with the photos on a daily basis, I became intimately familiar with the unique facial structure and characteristics of J.D. Tippit. With the photo from *U.S. News* and the "Elvis" photo, I was able to

discern a wide variety of unique features. It was while conducting this comparison that my memory was jogged and I decided to look at the Tramp Photos once again. I went back to *The Man on the Grassy Knoll* by Fuller and Johnson, containing the "Kennedy Clone," as I had come to call him.

There, in the photo taken by William Allen, was the same man, "The Kennedy-Clone," whom I had noticed a year before. I took a jeweler's loop to study the face more closely and as I scrutinized his features, I exclaimed in shock, "My God! This is Tippit!" Tippit was shown carrying a pump-action shotgun marching to the Sheriff's office with Frenchy, known to me to have been on the 6th floor of the TSBD through the Dillard photo. How could this be? How could Tippit, supposedly slain by Oswald at 1:15 p.m. and for whose murder Oswald was arrested at 1:46 p.m., be arresting this known assassination squad?

The Identification of Badgeman

As I looked at the photo again, I saw the pump-action rifle carried by Tippit and I had a gut-wrenching realization that I was looking at the weapon that might have killed JFK with a shot from the Grassy Knoll. It was exactly the type of weapon that would cause the type of damage seen in Z-313. It followed then that this officer, Tippit or The Kennedy Clone, might indeed be the killer known as "Badgeman," discovered by Jack White and Gary Mack and extracted from the Mary Mooreman photo through advanced computer graphics



analysis in the mid-1980's. The Mooreman photo was taken within a half second of the precise moment of the fatal head wound corresponding to the moment at Z-313 of the Zapruder Film. White and Mack isolated the precise position of the suspected shooter on the grassy knoll reported by several witnesses.

Through computer enhancement they were able to extract what appears to be the image of a man in a Dallas Police uniform. An apparent muzzle blast obscures the jaw and lower right quarter of the face. A policeman's badge appears to shine in the bright sunlight below the shooter's shoulder brandishing what can clearly be read as a "Dallas Police" shoulder patch. The contour of the shooter's forehead, eyes, brow, left ear and a distinctive receding

hairline are discernible. Sunlight is reflected by the shooter's forehead and shines more brightly around his right brow and forehead. The degree of convexity in the shape of the shooter's frontal bones is measurable and indicates a rounded forehead with a very distinct receding hairline exactly like that of J.D. Tippit.

I succeeded in making a video capture of "Badgeman" from the series *The Men Who Killed Kennedy* and began extensive studies with further enhancements comparing the now well-known features of J.D. Tippit with those of Badgeman. The new enhancements further revealed more distinctive contours of the left cheek and upper jaw. I discovered a distinctive wrinkle between the eyebrows produced by the shooter's squinting while taking aim at the President. This was followed by the discovery of a dark, distinctive furrowing of the cheeks along the left jawline.

It is clear now that Tippit, "Badgeman," and "The Kennedy Clone" are all one and the same man for the following reasons: (1) The contours of the hairlines of both Tippit and Badgeman are identical; (2) The shape of the left ears match in all three; (3) The convexity of the forehead as revealed by the reflected light on Badgeman's right forehead corresponds to the convexity of Tippit's forehead in the "Rogue-Cop" photo; (4) The shades and shadows of distinct furrows of the brow, as well as cheek and jaw correspond precisely with each other in all three photos; (5) The arc of the eyebrow and the angles formed between the ear and the nose, the ear and the lips, and the ear and chin all correspond; (6) The speckle of light reflected by a wrinkle on Badgeman's shirt corresponds exactly with the photo of the wrinkle on the shirt of the Kennedy clone; (7) The angle formed by the base of the square jaw and the left jawline is exactly 140 degrees in Tippit & the Kennedy Clone in the Tramp photos. Badgeman's chin is not visible.

The "Loss" of Tippit's Body

Professor Jerry Rose of State University of NY at Fredonia has informed this researcher that the Dallas P.D. "lost" Tippit's body for over an hour. How was that possible? Another strange and suspect fact is that Officer Tippit seems to have had bullets removed at two different locations; first at Methodist General Hospital where bullets were removed, then at Parkland under Texas Coroner Dr. Earl Rose who describes removing the same bullets removed at Methodist General where he had been pronounced DOA. Why was Tippit then moved to Parkland Hospital?

Dr. Earl Rose was arguing with the Secret Service over custody of the President's body until 2:08 p.m. when the Presidential party departed Parkland absconding with the body(ies). Despite this, Dr. Rose reports completing Tippit's autopsy at 3:15 p.m. (FBI Tippit Autopsy Report by SA Arthur Carter). I thought this was quick until I read of his boast that "We can have him (The President) out of here in 45 minutes," reported by Dr. Charles Crenshaw in *Conspiracy of Silence*. It appears that Dr. Rose was working under time pressure. This writer

believes Dr. Rose finished Tippit's autopsy before 2 p.m. when the JFK-Tippit Body Swap occurred.

The Fake JFK "Stare-of-Death Photos"

As I became more familiar with Tippit's features I began to see many distinguishing characteristics. There is one in particular which I believe makes the identification conclusive. In *High Treason II*, Livingstone, makes the following astute observation regarding the features of the person in the "Stare-of-Death Photos":

Note that the face appears pasty and white, yet this was taken before the autopsy began. Although the sharpness of the nose may be due to the camera angle, the nose nevertheless does not appear to be Kennedy's. The moles highly visible on his face in photographs taken in the morning are not seen here, nor are the pores and whiskers.

Tippit's Nose not JFK's

Regarding the Groden Right Superior Profile photo (G1), H.E. Livingstone stated: "Although the sharpness of the nose may be due to the camera angle, the nose nevertheless does not appear to be Kennedy's." This writer agrees with Livingstone's assessment. Furthermore, I find that the nose ridges and shadows in Fox photos F1, F4, F6 and F7 also demonstrate that it is Officer Tippit when compared to the Tippit-Elvis and the Allan "Kennedy Clone" Photo. The "Left Profile Photo" (F4) when compared to Kennedy's real profile shows clear distinctions in structure.

Divergent Eyes

Another consistent observation made by several witnesses who viewed earlier versions of the Stare-of-Death Photos, including Mr. Livingstone, is that of the divergence of the eyes in some these photos. Discussing the Fox photo (F1) in *High Treason II*, Livingstone writes:

Note how wide the eyes are, yet the eyes are not divergent, nor is the right eye popped from the head as it was described by medical witnesses. Tom Wilson's computer studies say the right eye has been painted in and is flat black on the gray scale study. It certainly does not look like it is the half popped out eye described by all the medical witnesses, and the eyes are not divergent as in the original Groden Stare-of-Death photograph I viewed in 1979, which he claims not to have at this time but which has been seen elsewhere since then.

This feature seen by eyewitnesses again indicates that the individual in the pictures which they saw was Tippit. The eyewitness account of Domingo Benevides who saw the Tippit murder supports this theory:

That is when I got out of the truck and walked over to the policeman, and he was lying there and he

had, looked like a big clot of blood coming out of his head, and his eyes were sunk back in his head, and just kind of made me feel real funny.

The Black Mole

What Mr. Livingstone did not notice is that, in addition, a mole which was not on JFK's neck that morning appears where JFK had none in "Superior Right Profile" (G1). The proof of Tippit's identity came when I noticed the unique black mole in the color version in Groden's *The Killing of a President*. The presence of the mole was not as salient a feature in the black and white versions published in several books in recent years. Due to the darkness and graininess of the B&W photos the true nature of the black mole was easy to overlook. However, in the color version published by Mr. Groden, this black mole's nature is clearly revealed. It lies on the right side of the neck, almost parallel to the base of the hyoid bone or "Adam's Apple."

Though I had studied photos of JFK for years, I could not ever remember seeing such a dark and salient blemish on his neck. Tippit demonstrates the pattern plainly. Furthermore, I discovered another unique ear mole pattern on Tippit's left ear which obviously matches the left ear mole pattern of the man in Fox Photo F4 (The Left Profile Photo). I began another search of photos of JFK. I did not find the pattern in them. I had discovered the reason for the right-left switch noted by Professor Fetzer.

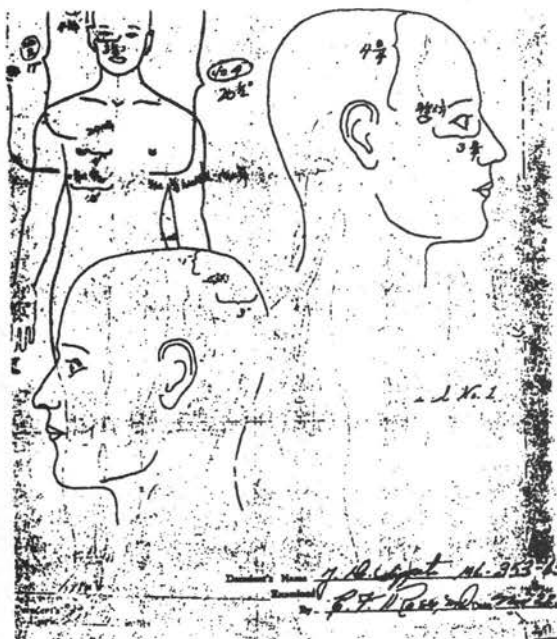
The two Tippit photos showing Tippit in casual attire: the Tippit-Elvis Photo and what I now call the Tippit-Rogue Cop Photo published by the *Dallas Morning News* in "The Day Kennedy Died," both show the black mole visible and in the same relationship to the hyoid bone as seen in the Superior Right Profile Photo (G1) as well as those photos attributed to James K. Fox (F1). I am grateful to Professor David Porter who pointed out the photo, for I had long suspected that the Tippit-Elvis picture showed a man much too young to be the 39 year-old man killed on November 22, 1963. The photo discovered by Professor Porter is the conclusive evidence needed to

identify Tippit as "Badgeman." I later confirmed that the "Tippit/Elvis" photo was taken in 1952, when Tippit was 28 years old.

Reason for the Reference Black Triangle

Following this discovery, the purpose and the need for the Reference Black Triangle became obvious in the scheme. Although President Kennedy and Tippit bore a great likeness to

each other in the bone structure of the jaw, brow, nose and cheeks, there were distinct differences above the browline. Tippit's cranium was rounder and smaller. In contrast to the President's red brown hair, Tippit's was black and had a distinctive receding hairline. In order to create the appearance of the same hairline as that of the President in an

area that had no hairline, it became necessary to fake one of the same contour by geometrically flaying an area of scalp. This flap was then sectioned and reflected as needed to fake aspects of the hairline from several angles. The reflected scalp and the underlying surface area were thus made to appear to be both hairline and the consequence of an actual wound.

In view of this, the accuracy of the Siebert and O'Niell FBI report becomes evident. Assuming that Dr. Humes was telling the truth about the brain he observed in his report, someone must have tampered with the President's head wound somewhere between Dallas and Bethesda. David Lifton's research led him, in the late 1960's, to the discovery of the mysterious Siebert and O'Niell FBI report. Siebert and O'Niell stated that "it was also apparent that a tracheotomy had been performed and surgery of the head area, namely, in the top of the skull." Why would surgery have been necessary on the body of a dead man? Perhaps to put something back together or to cover something up. Or both.

The Devil's Ear

The reader may recall that in addition to "The Black Reference Triangle" another artifact in the Stare-of-Death photos which has confounded medical researchers is the one called "The Devil's Ear." It is an unusual flap seen on the right temporal area

of the victim's head in both the Fox and Groden photos.

It is now possible to assess the purpose of "The Devil's Ear." Dr. Rose's autopsy report describes the entry of Tippit's head wound occurring in the area of the right middle cranial fossa. The so-called "JFK Lateral X-ray" shows what appears to be a semicircular fracture at a point where the temporal bone joins the zygomatic process. It is interesting to compare this characteristic of the JFK Lateral X-Ray with Dr. Rose's description of Tippit's wound. Dr. Rose describes it as "wound No. 1." It was actually the fourth wound placed with surgical precision by Tippit's killer: "No. 1 is 4 3/4 inches from the top of the head and 3 3/4 inches to the right of the midline. This measures 3/8 x 1/4 inch and is surrounded by a contusion ring."

The missile entered there and proceeded "slightly upwards, backwards and to the left." It caused extensive fractures around the temporal bone and surrounding areas. The bullet went on to strike the inner surface of the occipitoparietal bone also fracturing it extensively "but it did not exit." It was recovered by Rose in the area of the calcarine gyrus where it exited the brain tissue. This path when reversed coincides with the Warren Commission's description of President Kennedy's head wound more closely than the eyewitness reports at Parkland Hospital, all of which describe a larger temporal entry wound and an explosive large defect exit wound in the right rear occipital area.

The HSCA's "High Head Wound" photographs are most likely those of J.D. Tippit. One of the objections of experts to the High Head Wound Photos is the presence of clearly visible hair inside the entry wound. This would be nearly impossible in a real puncture wound. The path of the bullet which caused Tippit's head wound ended precisely where these photos purport to show the entry point of JFK's high head wound. Since the bullet struck the inner surface of Tippit's occipitoparietal bone "but did not exit," it is logical to assume that the point of impact would demonstrate signs of depression on the external surface of the skull with the scalp sinking into the area of the cavity and beveling on the inner surface. Thus, hair would appear intact within the depressed area, as is clearly seen in the High Head Wound photos.

The true nature and purpose of "The Devil's Ear" now reveals itself. While the head wound of J.D. Tippit may be described as a simple circular puncture type of entry wound, that of the President was clearly of a different nature. The President's head wound was an explosive one more characteristic of a wound caused by a shot gun blast or exploding bullet. In order to pass off Tippit's wound for JFK's, it was made to appear similar using the same technique used to create "The Black Reference Triangle." An area of scalp was flayed and reflected upward and backward to create a facsimile of the head wound of President Kennedy, attempting to approximate an area equal to that of the President's mortal wound. However, when compared to the catastrophic damage done to the President's head depicted at Z-313 of the Zapruder Film, one quickly realizes that the area of "The Devil's Ear" is too small to be the real consequence of the explosive wound seen at Z-313. Tippit's real wound was altered and disguised to appear to be JFK's mortal head wound.

Tippit's Wounds

As we study the Fox Photos F6 and F7, published as "Top of the Head Photos" in Livingstone's *High Treason II*, one can see clearly that, despite the overhead angle of the photo, the wounds on the torso are those of Officer Tippit. In the F6 (camera in a higher position) photo the wound on the right side of the chest perfectly coincides with Dr. Rose's description of Tippit's chest wound. Dr. Rose states referring to this as Wound No. 2:

Wound No. 2 is 17 inches from the top of the head on the right chest. It is 4 inches to the right of the midline, above and slightly medial to the right nipple. It is 3/8 by 1/4 inch and is surrounded by a contusion ring. No powder tattooing is noticed.

The wound seen in F6 and F7 is precisely situated and exhibits the same dimensions and characteristics of Tippit's wound. It is important to note that this wound is cropped out of "Right Superior Profile (G1)" photos. This wound is situated below the area where an incision for the insertion of chest tubes attached to the President should appear in the real President Kennedy. It is in the wrong position to be the point of insertion for the right chest tube. Dr. Charles Crenshaw, in *Conspiracy of Silence*, states: "The doctors inserted the chest tubes into the President's body by making incisions between the ribs on both sides of his chest in the mid-clavicular lines."

The chest tube incisions, which were linear, were then further opened and stretched by the insertion of trocars which preceded the insertion of rubber tubing. No such incision appears in these photos. The wound on the chest of this victim is too low and does not correspond with the position of the 2-cm. incision

drawn by Dr. Boswell on the official autopsy face sheet. The wound appears in uncropped Fox photo F1.

Note an amazing coincidence regarding the position of the shallow back wound in photo F5; a shallow wound from which no bullet was retrieved, and which was no deeper than the length of a finger when examined in Bethesda by Humes and Boswell. This wound perplexed them because it could not be followed very deeply into the body. The autopsist must have thought it strange to find no bullet where a bullet should have been. This supposed wound was seized upon by Arlen Specter and the Magic Bullet theorists as the point of entry at which to begin the fatuous physics of the Magic Bullet's path. This wound was described by Dr. Burkley in the official death certificate as follows: "A second wound occurred in the posterior back at about the level of the third thoracic vertebra." When we study this photo alongside Dr. Earl Rose's description of the path followed by the bullet which caused Tippit Wound No. 2, we find an amazing "coincidence." Dr. Earl Rose states:

THE COURSES OF THE MISSILES ARE FOLLOWED. The wound described as No. 2 is found to go between the second and third rib. The missile is found to penetrate the anterior edge of the right upper lobe. The bullet is found to go into the pericardial sac, there is extensive hemorrhage in the pericardial sac, approximately 4 ounces. Passes through the superior vena cava. It exits into the mediastinum, strikes the fourth thoracic vertebra to the left of the midline, courses in the substance of the vertebra and is recovered slightly to the left of the vertebra approximately 16 inches from the top of the head, having pursued a course very slightly upward, to the left and backwards.

Is it not remarkable that the bullet which caused wound No. 2 in Tippit should end its flight at the fourth (4th) thoracic vertebra, the one directly adjoining

the point of "entry" of Arlen Specter's Magic Bullet in Kennedy's body at "about the level of the third thoracic vertebra"? Is it not more likely that what we are really seeing is the point of entry of the course followed by Dr. Rose's forceps in the recovery of the bullets which caused wounds No. 2 and No. 3 from Tippit's body? Consider this remarkable statement by Dr. Rose:

"It wasn't Jack. It was like something you would see at Madame Toussaud's."

16 and 1/2 inches from the top of the head, 3/4 of an inch to the right of the midline of the back in the subcutaneous tissue a missile is recovered from this region. This is associated with Wound No. 3.

One can see now that it was Arlen Specter who forced his Magic Bullet into JFK's back through sheer will power and mass deception. In addition to Rose's description, some evidence to support this writer's conclusion is contained in the Siebert and O'Neill FBI report quoted by Mr. Livingstone on page 162 of *High Treason II*:

During the later stages of the autopsy, Dr. Humes located an opening which appeared to be a bullet hole which was below the shoulders and two inches to the right of the middle line of the spinal column. This opening was probed by Dr. Humes with the finger, at which time it was determined that the trajectory of the missile entering at this point had entered at a downward position of 45 to 60 degrees. Further probing determined that the distance travelled by this missile was a short distance inasmuch as "the end of the opening could be felt with the finger."

The mystery of the two angles in one wound is thus resolved when we realize that Dr. Rose may have used a single entry point to retrieve two bullets, corresponding to Wounds No. 2 and No. 3; one removed from the 4th thoracic vertebra and the other from subcutaneous tissue of the back. However, if he did not do so, it would necessitate a second entry point to retrieve the missile from the 4th thoracic vertebra which is precisely what is visible in Fox Photo F8 (The Back). There has previously been no satisfactory explanation given for the second wound seen in F8.

It is obvious that a "downward position of 45 to 60 degrees" indicates a path in the direction of the 4th thoracic vertebra, not the neck region as in Arlen Specter's imagination. In this context, the befuddlement of the autopsists is quite easily understandable when the

FBI report continues:

Inasmuch as no complete bullet of any size could be located in the back or any other area of the body as determined by total body X-rays and inspection revealing there was no point of exit, the individuals performing the autopsy were at a loss to explain why they could find no bullets.

It was because Dr. Earl Rose had them.

Tippit's Chest Wound

Another proof of the identity of J.D. Tippit as the victim in the Fox photo F6 (camera in a higher position) is the visible presence of a wound described in the Rose autopsy report as wound No. 2. (See photo F6 and Rose autopsy diagrams from FBI SA Arthur Carter's Report). Rose states: Wound No. 2 is 17 inches from the top of the head on the right chest. It is 4 inches to the right of the midline, above and slightly medial to the right nipple. It measures 3/8 x 1/4 of an inch, surrounded by bruising. There is also a contusion ring.

This wound has gone unnoticed before due to its close proximity to the right nipple with which it could easily be confused. However, when one looks closely at it one can see that it is a puncture wound. It is too low and lies in a position too close to the midline to be the right nipple. It may also have been mistaken for the chest tube insertion incisions but it is too low to be the incision described by the Parkland team. There is also a deep fold of flesh, lower and to the left of the center line, which fits the description and the position of wound No. 4 which struck a button on Tippit's police uniform driving it into his body.

Jim Bishop, whose description of Tippit's death in *The Day Kennedy Was Shot* was the key to this investigation, states: "He had hit Tippit in the temple, in the middle of the forehead, drilled two shots into the chest, and missed with the fifth shot. One hit a uniform button and carried it inside the body." Disinformation regarding Tippit's wounds had begun early. As previously mentioned, this writer had read a New York Times report stating that Tippit had been shot in the left eye Bishop's "middle of the forehead" shot is also clearly disinformation as evidenced by the Rose autopsy report and diagrams.

It is this writer's contention that the wounds in Officer Tippit were placed with "surgical precision." In *The Killing of a President*, Groden's description of the same event bears this out:

Three shots were fired across the hood of the car; the assailant then came around to where Tippit lay and fired a fourth shot into his head. One bullet struck a button on Tippit's uniform and stuck there; it fell off in the ambulance en route to the hospital.

This evidence was never recovered.

I've dubbed it the "Button/Bullet." Earl Rose writes: Wound No: 4 on the left chest is 20 1/2 inches from the top of the head, 1 1/4 inches to the left of the midline. The wound measures 3/4 by 3/8 of an inch, is transverse and surrounding this is a 1/4 x 3/4 inch abrasion. (The Rose Diagram shows "1 1/4 inch abrasion." Typo? or Disinfo?)

The involution of the fold of flesh visible to the left of the midline just above the victim's nose in the overhead Fox Photo F6 (camera in higher position) clearly fits this description. As we study the Stare-of-Death Photo (F1) we must note the two strange "bruises" visible near the left armpit and deltoid muscle. Could either of these "bruises" be what Dr. Rose is referring to when he wrote: "Poorly defined 1/4 inch inoculation type of scar on the left deltoid region." There are two marks on the deltoid region, one in front and another wraps around the side.

Disguising Tippit's Left Side Receding Hairline

As mentioned above, this writer believes that the "surgery of the head area, namely top of the skull" described in the Siebert and O'Niell report refers to the Reference Black Triangle which was used to hide Tippit's receding hairline. However, the hairline's recession was nearly symmetrical and so necessitated camouflaging on the left side also. In Fox F4, "The Left Profile," we can see that this was achieved by combing the hair forward and down from the area around the region of the coronal suture which resulted in an artificial whorl of hair or "cowlick" in that region. If one looks closely, one can actually see Tippit's bald pate beneath two of the combed hair locks. Also note that the angle of the sideburn is identical with that of the arresting officer in the Tramp photos. Studying the profile, one can note two very distinctive nose ridges, one above the nose bridge and another "notch" below the nasal septum which President Kennedy did not possess. These produced the "nose ridge shadows" discrediting the authenticity of Fox Photo F1 or Stare-of-Death Photo and are readily discernible in the Tippit-Elvis photo.

Alteration Of The Throat Wound

One of the repeated challenges to the authenticity of the "Stare-of-Death Photos" and "Superior Right Profile (G)" is the question of the alteration of the throat wound. The Malcolm Perry tracheotomy described by the Parkland team is quite at odds with the long gash across the throat of the victim in these photos. Eyewitness after eyewitness has attested to the alteration of the throat wound. Why was it necessary? If we compare a close-up of the face of the arresting officer in the William Allen photo with the President's official photo

published on the cover of the *New York Times* on November 22, 1963 their similarity in jaw structure and other facial features is clear. But Tippit's "laugh lines" and the furrow formed by a "scowl line," which leads from the right nostril to the corner of the lips in a stretched "S", to the middle edge of the lower jaw, are what distinguish him from the President.

In the G1 photo, acne scars are visible on Tippit's face on the right cheek and two distinct ones along the scowl lines about 1/2 inch below and 3/4 of an inch behind the corner of the right lips. Tippit also bears two distinct moles below the right sideburn, one level with the middle ear and the other level with base of the opening of the auditory canal. The lower one lies parallel to the one previously described on the right front cheek. This pattern is also visible in the "Tippit-in-Police Uniform" photo used to compare JFK-Tippit facial structure above. When joined in a geometric pattern its geometry is uniform in the Allen Tramp photo, the right 3/4 profile of Tippit-in-Uniform and on the face of the victim in "Superior Right Profile."

All of the above distinguishes the right side of the face of J.D. Tippit from that of President Kennedy. They also distinguish the face of the President from the face of the victim in the Fox Photos and "Superior Right Profile (G1)." They also confirm that the victim in the Stare of Death photos is the police officer in the Allen photo.

The question of the alteration of the throat wound is no longer in doubt when we realize that the victim in the "Stare of Death Photos" is not John F. Kennedy. So, we have "double-speak": when the government says the wounds of the President were not altered, it is probably telling the truth, however the photos it presented to prove it so were falsified by altering the wounds of another victim. The Throat Slash can no longer be called a "tracheotomy," it was plastic and psychological surgery. The surgery had three purposes: One was to produce a wound in the throat where none had been because it was already known that the President had been wounded in the throat. Secondly, it was a plastic surgical procedure to diminish the distinct jowliness of Tippit's double chin. The incision across the throat was designed to cause the flesh of the jowls to sag. This tightening of the flesh closer to the jawline camouflaged the differences described above by softening the "laugh lines" and the furrow of Tippit's scowl-line, making him look like a much younger JFK.

The third purpose of the Throat Slash is the psychological aspect. The sheer horror and ghastliness of the wounds depicted have served several purposes. The first two purposes were physical deception. Psychologically, the third purpose of the wound is to create a distraction

designed to induce an oversight of obvious facts which would expose the fraud. The shock induced at such a gruesome sight mesmerizes the viewer, freezes reason and falters one's logic. Finally, few people can look at these photos for any extended period of time without feeling fear and dread at the thought that these atrocities could have been visited upon the President of the United States. These photos are meant to instill fear into every citizen and into every President. They have been designed using Gestalt psychology, reverse-engineered to terrorize one into silence. The message is an implied threat: if "they" could do that to the President of the United States then what can they do to you, little man! A slit throat means silencing. "Ask no questions!" is the psychological message behind these photos. However, some Americans as yet cannot be silenced.

Who Altered the Bodies and the Medical Evidence?

Who could have perpetrated such an atrocity? Only one who knew what the President's actual wounds looked like and was in close proximity to both bodies. Proximity, opportunity and authority are the prerequisites which would have been required to participate in such an operation. Along with authority to view and touch the President's body, we also have to posit the skill to execute it. Who had the opportunity and the authority to view the President's wounds and those of Officer Tippit? Given the official time frame of the Warren Commission, we have to conclude that only two known men fulfill the requirements: Texas Coroner Earl Rose and Admiral George Burkley.

It is possible that an unknown third physician, very likely a plastic surgeon, who saw both bodies in Dallas, made the trip from Dallas to Washington either with the new President's entourage or flying there an hour later on AF-2 or on MA-1 (Military Airlift One), which was carrying both the President's and VP's limousines and their evidence back to Washington. Evidence which was later expunged on Johnson's orders.

According to the time frame confirmed by the presence of Tippit in the Tramp photos taken between 1 and 1:15 p.m., it is possible that Admiral Burkley was in close proximity to Tippit at Parkland during the Earl Rose vs. Secret Service Altercation. It now seems very probable that someone had autopsied Tippit by 1:45 and that, using the theatrics of Rose's argument with the SS over the body as a distraction and diversionary tactic, Tippit's body was surreptitiously placed inside the same coffin, designated "Coffin X," which already held the body of John F. Kennedy. Both bodies were transported to Walter Reed Army Hospital, where the JFK facsimile, using Tippit's body, was composed. They were later moved to Bethesda Naval Hospital, where they were shuttled from one operating room to another according

to the needs of the medical director, Dr. George Burkley.

There is evidence in the Air Force One tapes of an urgently patched telephone conversation between Admiral Burkley aboard the President's plane and Chief Surgeon of the United States Army, identified on the tape as Surgeon General Leonard Heaton at Walter Reed Army Hospital. The conversation itself has been deleted from the tapes though one can hear the petulance in Admiral Burkley's voice and his impatience with Andrews AFB Command Center at their inability to locate General Heaton. One can hear a frustrated Burkley spelling out Heaton's name for the operator letter by letter and demanding to speak to the Deputy Surgeon General at Walter Reed Hospital if Heaton could not be found. The contents of the Burkley-Heaton Conversation are deleted, the audio tape jumps abruptly to other topics.

One of the most cryptic messages in the Air Force One audio tapes is a series of messages from "Trinity" to "Watchman" and "Tiger," one of which is that "Slugger is still in Dallas." Who was "Slugger"? I have requested the pertinent files and tapes from the U.S. Army and the U.S. Air Force under the FOIA. After more than a year, no reply has been forthcoming.

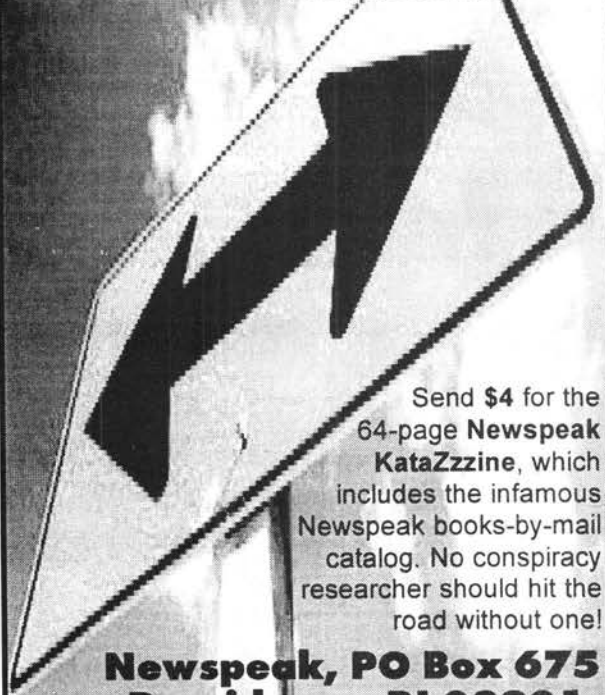
Who Is Buried in Arlington?

Walton looked as long as he could, with a growing sense of outrage. He said to Bob, 'You mustn't keep it open. It has no resemblance to the President. It's a wax dummy.... Don't do it.'" In detailing Jacqueline Kennedy's impressions, Manchester states: "Her impressions of Sunday morning, when she next saw him, are chronologically out of place here. Yet one of them is pertinent: 'It wasn't Jack. It was like something you would see at Madame Toussaud's.'"

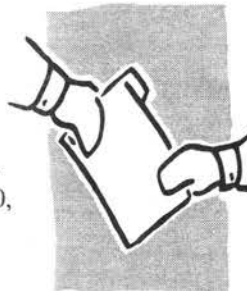

The Great American Holocaust

Rush Limbaugh was in high spirits. His daily radio and television shows had developed a unique market composed of genuine conservatives as well as millions of non-aligned but angry or frustrated Americans who recognized an establishment unresponsive to their needs. But Rush had a problem. The more he destroyed the establishment media taboos, the more he increased expectations that he would begin championing the very big, very deadly taboos which even he dared not touch. The drug medicine conspiracy and suppression of workable cures for

cancer were high on the list of subjects which Rush instinctively knew he better avoid.

Rush had a lot to protect. His new wealth, his private jet, and most important, his influence with the conservative revolutionaries who were determined to eradicate a liberal social vision which they sincerely believed was the cause of America's woes. Rush's wonderfully entertaining combination of ridicule, "Big Daddy" sincerity (defense of unashamedly patriarchal values) and emotional showmanship had fueled an enormous personal popularity. Unfor-

tunately, it had released those terrible expectations from millions who had hoped the airwaves might soon carry long-suppressed facts concerning the political establishment's greatest crimes and most carefully guarded secrets.

Medical Politics: The Great Taboo

The suppression of therapies which cured cancer was one of the biggest, most dangerous topics. It had to be kept from the American people and public debate. So Rush was careful to "deflect" the topic whenever someone managed to slip it past his talk show screeners. Rush was an experienced professional and easily dismissed the concerns of anyone who did "snake through" the cancer therapy taboo. Rush never investigated the subject, held essentially rigid and trusting views about medical politics, and admired the success of the private drug companies.

Unfortunately, Rush was just as naive as most Americans. In the matter of cancer, he'd been taken for a ride. But so had the establishment media which Rush excoriated daily for its supposed liberal bias. If any American institution deserved thorough condemnation for its failure to inform the American people about a matter which personally affected their lives, it was America's major newspapers and television networks. They had sold out the American people, refusing to put the continuous, scrutinizing spotlight on a dark network of public and private interests that benefited from an ongoing, lucrative "war on cancer" which always failed because it was structured NOT to cure cancer. Nor even examine original therapies which did cure cancer.

Here was an American Holocaust which could be laid directly at the door of the media establishment. But the monumental horror of that simple truth could not be broadcast. Millions of innocent Americans had suffered

and died horribly. Almost everyone past the age of thirty had a friend or family member who was an unsuspecting victim. The crime cut across all political, economic, social, racial and age group conflicts.

To keep a medical-scientific-financial-government bureaucracy cartel or "good-old-boy" network in power. How could such a crime occur in America and remain essentially invisible? There were lots of reasons, including most prominently the denial factor. People simply were afraid to look at the hard, factual evidence and alter the status quo. Even the "health practitioners" (usually small businessmen and business women themselves) sought compromises, acceptance and "new therapies," avoiding the hard political work and realities. The "professional" medical and scientific "experts" squirmed, bit their tongues, protected their turfs and medical licenses or scientific credentials by simply turning their backs on the human carnage. And the "big media" ignored the issue absolutely because powerful financial forces were deeply involved in the cancer conspiracy, right up to their guilty necks in a monstrous crime against the people of America and indeed the world.

Rush Limbaugh, 1995

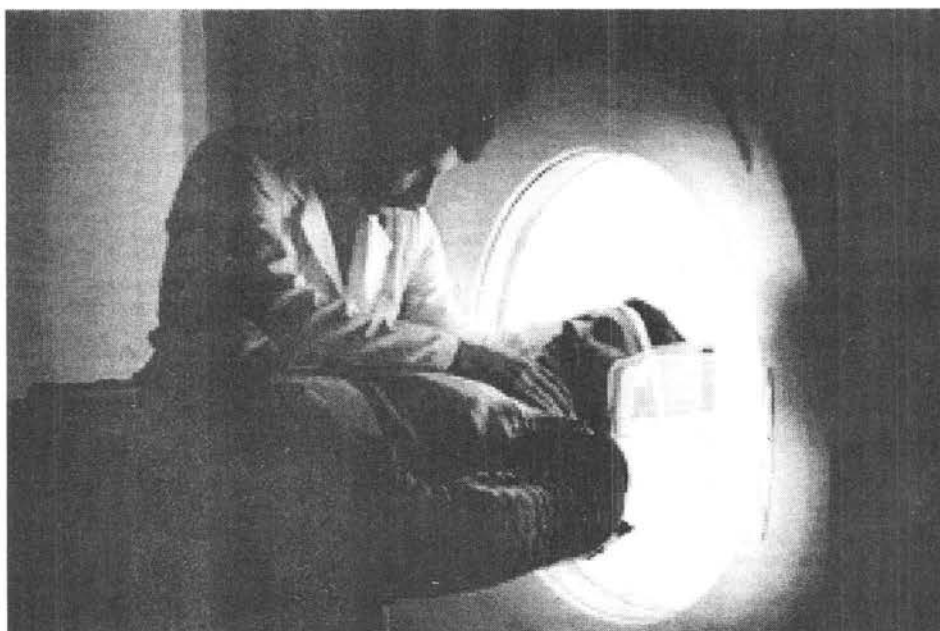
Rush Limbaugh couldn't be blamed if he chose to storm at less dangerous targets. He couldn't be blamed if he averted his eyes at the ongoing horror and joked about the "conspiracy crowd" while praising the entrepreneurial daring-do of the drug companies. Rush played it very, very cautious on this big and truly

revolutionary issue. Besides, Rush was really just a talker and entertainer, not really a true revolutionary. He had, to his credit, kicked a hell of a hole in the traditional, brain dead, gumption-lacking establishment media. Williams grasped the fundamental rot and core intellectual error of permitting a crowd of self-interested, cautious, scientific (sort of) bureaucrats at the Food and Drug Administration (FDA) and the National Cancer Institute (NCI) to have the authority but not the accountability for denying desperate patients the access to therapies which actually cured cancer. Williams didn't have the big picture and the nasty details, but he grasped the public policy error which

caused the slaughter.

The faceless, paper-shuffling, unaccountable "civil servants" playing it safe, just "following regulations" and insisting on years of rat studies or worthless lab procedures costing millions of dollars before "approving" a therapy which had actually cured cancer were, in fact, the hired, front-line gatekeepers of a system which murdered piteously countless innocent Americans. Murder was the word. It was a word which couldn't be said in polite society without causing people to turn away. Of course it was "politically incorrect" to use the word murder in such a context. Nevertheless, that's exactly what it was. Murder. And America had sheepishly, against all the traditions and courage of its shining history, sinned against its own.

The issue was political. Period. It was not a medical issue and

tuted itself for so long, so consistently, so habitually that no one in the newspaper and television network "health sections" even bothered to sneak a peak into the cancer world's dark corners. As for Rush's "New Media," well, he guarded that gate. Even Rush Limbaugh, the "fearless mouth," wouldn't tackle the big cancer taboo. Opening that door could unleash forces of furious change which might devour even him. But then, there was always the possibility of Rush finally getting up his courage and like one of the original Founding Fathers, boldly going where no one had ventured to go.

Benjamin Rush And The Lady No One Saw

Rush Limbaugh was kind of smart in a foxy way. If he ever figured out that the public wouldn't put up with his dissembling, excusing, and deceiving on the cancer issue, he'd move quickly and with his political instincts, grab it as his own. Such a late move would be, of course, a "big lie," but Rush frequently exposed himself as a posturer. He'd shift his position to suit his political biases, pushing blame where it didn't belong, deliberately fudging a core issue, using a hastily invented sideroad to hide or deflect a political principle or fact which might make one from his own political camp look bad or crooked.

Thus he was quite capable of doing the same with the cancer issue. At worst, he'd admit he was wrong previously, hadn't investigated it properly, just dismissed as conspiracy nuts those who called in seeking to address the cancer issue, and so forth. Then Rush would storm on emotionally for awhile until a new topic caught his attention and perhaps struck a chord with the folks who took his opinions as gospel "truth." Meanwhile, 10,000 more Americans would die every week because the treatments which actually cured cancer were kept from them by the "cancer authorities" who ran the whole rotten show. But they, of course, didn't dare admit what they had done out of ignorance, arrogance and greed.

They had murdered millions of Americans who trusted the "cancer experts" with their lives.

The politicians in charge of the health committees in Congress who had the oversight responsibility for the FDA and NCI follies were equally guilty. They, of course, carried the direct charge and authority from the voting public. Not only had they "fumbled the ball," so to speak, they had clearly ducked their Constitutional and moral responsibilities. The Constitution and the separation of powers had failed monstrously to protect the people. The money interests behind the cancer conspiracy had destroyed effortlessly the public interest. Members of both political parties were guilty beyond excuses. A hideous crime had occurred "on their watch" and beneath their very noses; their committee hearings and staff investigations had been public charades. They were part of a "see-no-evil" power elite keeping their positions secure rather than risking ridicule or worse to save millions of American lives. Their guilt will be embedded in the history books of America for a long, long time.

Year after year the politicians equivocated, deceived and dissembled. Decade after decade new generations of politicians carried on the pretense. Chemotherapy dripped into the veins of countless cancer patients, accomplishing nothing of significance as every objective study showed. But chemotherapy was the mindset within the National Cancer Institute, the FDA, the Congress, and with the big financial investors.

The fundamental issue had almost been won at the dawn of the American nation's experiment with freedom. Dr. Benjamin Rush, perhaps Rush Limbaugh's namesake, had sought to establish a constitutional principle protecting the American citizen against what Dr. Rush perceived as the inevitable clutches of a

medical monopoly. He recognized that the doctors were as dangerous as any religious monopoly, perhaps more so. If freedom of religion could be locked into the Constitution, why not the citizen's freedom to choose their own medicine, safe from medical authorities "permitting" only their monopolistic schemes and snake oils?

Dr. Benjamin Rush (1745-1813) failed to alert enough of the Founding Fathers to the danger he clearly understood. His prophetic words haunt America today as 10,000 innocent citizens are murdered every week invisibly. Dr. Benjamin Rush, a delegate to the Constitutional Convention of the United States of America in 1787, warned way back then of an "undercover dictatorship." He was absolutely right. It existed with a vengeance by the 1990s. Dr. Rush said:

Unless we put Medical Freedom into the Constitution, the time will come when medicine will organize into an undercover dictatorship. To restrict the art of healing to one class of men and deny equal privileges to others will constitute the Bastille of medical science. All such laws are un-American and despotic. They are fragments of monarchy and have no place in a republic. The Constitution of this Republic should make special provisions for Medical Freedom as well as Religious Freedom.

Actually the Supreme Court eventually did. It occurred slowly, filtering through various rulings, the events and tragedies of history, combining with a growing perception that the individual citizen could not trust the government, the doctors, the scientists, the business interests, the media or even the so-called alternative health practitioners with their glib talk, fancy

devices and expensive fees. The individual citizen had to exercise his or her own rights relating to Medical Freedom. But even with Constitutional Rights guaranteed to each citizen in the medical area, the cancer bosses basically just ignored the law and the public interest. They practiced suppression and fine-tuned their "undercover dictatorship."

Therefore, these are words which



no American citizen should forget:

"... (no) right is held more sacred, or is more carefully guarded, by the common law, than the right of every individual to the possession and control of his own person... Medical Association, state medical boards, hospitals and drug companies conveniently ignore such stated principles and legal rulings by the highest court in America. To honor the

Medical Freedom right would mean the destruction, within months!, of a heinous, criminal system which benefits a grab-bag of "cancer experts" hell bent on protecting their turf, their monopoly, their "undercover dictatorship." So the holocaust is sanctioned. The critics are silenced. Those providing alternative therapies which work are harassed, hit with incredibly expensive, debilitating lawsuits, often jailed, and sometimes quietly murdered.

Cancer: An American Holocaust

In general the people within the media do not comprehend the degree to which they are accomplices in a crime which has grown to such monstrous proportions. It is not just that they are naive and trusting of the medical professionals. It is not just that they share a societal "blind spot." It is more the nature of journalism combined with an historic failure. It is difficult for the media people to see beyond or step outside the system and the times.

For example, it is common for media people to jump from story to story. Their training and their personal career interests encourage them to pursue a story, do it, and move on to the next one. Rarely do they stop, consider, and pause, staying on an issue. Politicians know all too well that if caught in a bad policy or a personal error, they can usually "lie low" and soon the media will move on. Rush Limbaugh may remain focused on a political agenda but he's not a journalist; he is a media personality with political goals.

The average or even exceptional reporter employed by a major newspaper or television network sees himself or herself as essentially

an exception here and there, it has been primarily a tool of its owners, or larger political forces. It may be part of American folklore or an ongoing cultural hope to portray or wish for a "courageous free press." But that is essentially hokum. The illusion of a muscular, independent and critically thinking press as a societal safeguard is simply not true.

People make up the press. Mediocre people in large institutions who stifle the courageous few as the committees and processes grind down any truly profound expose which might challenge existing

which are their truest, life-and-death concern. History clearly, stunningly, makes that awful truth a recognized fact. The American people thus wallow in ignorance and triviality because the media is so consistently irresponsible and gutless. Yet Americans do sense it. And that is why they despise the media and what they receive from it. The cancer murders are just part of a larger societal sickness directly attributable to how people receive information.

A vigilant press and television information spotlight would never have allowed the murderous cancer system to have reached its present stage.

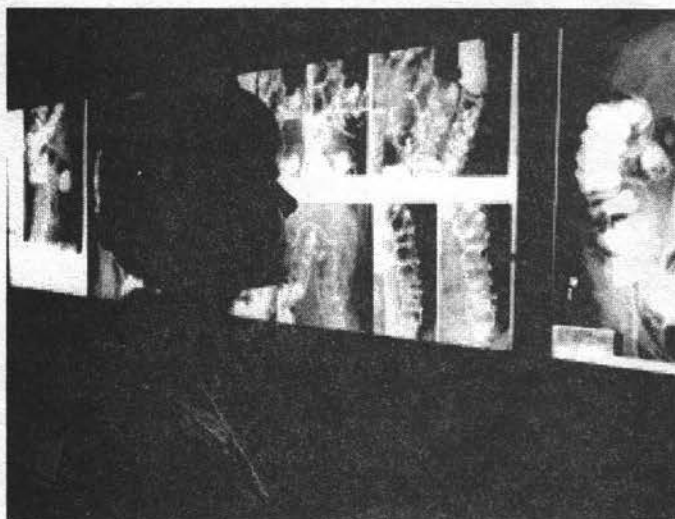
The cancer murders cannot be seen except through pinpointing the fact they rest on two essentials. It is a political issue, not a

scientific or a medical issue. And the media is the cancer conspirators' monstrous accomplice. It is for this reason that Rush Limbaugh, as a symbol of a supposedly media-busting force, is spotlighted here. Obviously he is not personally responsible for the cancer murders any more than are various cautious, career-focused doctors and scientists within the murdering system. But nevertheless they benefit by not challenging this heinous situation.

Betsy Lehman and the Boston Globe

objective. To cross the line and become an advocate requires a mindset change, plus a great risk because a career can be sacrificed out of such idealism. In play-it-safe historic times such as those in which we live and with a media dominated by self-centered, risk-averting, educated Yuppies, there are few who would dare to challenge the great cancer-killing machine with its high paid, big ego "experts" and "clinical trial," pseudo-science assumptions.

powers. The historic reality of the 20th century American press is one of a pathetic acquiescence to financial and political power. It ain't so. It doesn't happen. The historical examples are countless.

America's major press outlets and television networks have rarely informed citizens of the great principles, policies and corrupting forces

Globe, died of cancer at the Dana-Farber Cancer Center in Boston. Lehman was the personal health columnist for the *Globe*. She was in constant contact with the health experts. She supposedly had a reporter's skepticism and the best institutional sources. She supposedly knew her way around in the cancer world. She "informed" millions of *Boston Globe* readers.

Unfortunately, Betsy Lehman was ill-informed about the world of cancer which was her "beat." And tragically, for her, her failure to see resulted in her own murder. A few months after her death it was discovered that she was given a fatal drug overdose "through error" at the prestigious Dana-Farber Cancer Center. The story became page one in the *Boston Globe*. Investigations began. Outside experts were called in. The network of "prestigious" cancer centers around the country supposedly began examining their procedures. A chain reaction ripped through the entire system.

Why? Because the media had put a temporary spotlight on the cancer experts who in their cozy, back-scratching world kept the cancer machine operating. Sure, the media was still unable to penetrate beneath the surface and truly explore the rot of the decades-old cancer conspiracy, but just the accidental effect of killing the "personal health" reporter of the *Boston Globe* sent the entire "old boy network" (it includes women doctors, scientists and health officials also) into paroxysms of fear and concern.

Even little pieces of information which came forth were embarrassing to those who ran the system. Intelligent readers might ask questions which the bosses didn't want answered. Politicians might probe. And horror of horrors, suppose a radio show talk host got hot on the topic and the public got interested? So the "cancer experts" squirmed. They squirmed when the *Boston Globe* reported on the three hundred plus doctors and the three hundred fifty plus Ph.D.s linked to the Dana Farber Cancer Center, and the \$167 million annual budget. Isn't it odd that all that brain power and money is spent, year after year, and yet there are no breakthroughs in curing cancer?

The *Globe* reported that Dr. Vincent T. DeVita was being brought in to head an "external panel" to investigate the accident. But it did not report that Dr. Vincent T. DeVita was not only the former director of the National Cancer Institute (NCI) just outside Washington, D.C., but also was the man who pushed "high dose chemother-

apy" as a national policy year after year. Nor was the *Boston Globe* about to report that "high dose chemotherapy," Dr. DeVita's specialty, had been shown as far back as the 1960s to destroy the human immune system and be essentially worthless as a cure for cancer, especially the breast cancer.

Nevertheless, he was brought in to "objectively" assess the damage. It was a coverup, a cynical coverup, and the *Boston Globe*, mourning one of its own, couldn't even see the smoke and mirrors. Chris Walsh, the Chief Executive Officer of the Dana Farber Cancer Center was quoted in the *Globe* of March 23, 1995 as saying, "It's just so discouraging... There's nothing we want to hold back... Do we and other places continue to do high-dose chemotherapy trials for breast cancer? We think these trials should continue..."

Didn't he know the sordid history of high dose chemotherapy? Didn't he read the international studies about chemotherapy trials in the most advanced countries of the Western World, and their utter failure? Was he unaware of the studies from the 1960s which suggest the National Cancer Institute maintained high dose chemotherapy for political purposes, even when the scientific evidence screamed it should be stopped? Did he not understand Dr. DeVita's role on the national stage? How could such a person be truly objective? Was Chris Walsh accountable to anyone? Or was he just an innocent Yuppie trying to keep his own career on track?

Boston, after all, was the site of the Boston Tea Party, Paul Revere's ride, Bunker Hill, and the beginning of the American Revolution. The Constitutional Convention of 1787, with Dr. Rush's denouncement of the "undercover dictatorship," even emerged from the hills of nearby Western Massachusetts.

Perhaps another American revolution is beginning to smolder in Massachusetts.

666 and then some...

With only four more years left in the Millennium, the Number of the Beast (666) seems to be popping up everywhere. In the British film *Naked* (1994), the main character discusses the Apocalypse with a night watchman and reveals that the UPC symbol (Bar Code) is actually six-hundred and sixty-six. More recently, the alternative film *Doom Generation* (1995) features two young men and a woman on a violent murder spree who see the Number of the Beast everywhere they go (cash registers, license plates, etc).

Glimpses of 666 can also be seen in *Pulp Fiction* (1994) and *Leaving Las Vegas* (1995). In *Pulp Fiction* you'll notice that when John Travolta retrieves and unlocks the briefcase of his boss, the three-digit combination on the lock is 666. Likewise when Nicolas Cage, in *Leaving Las Vegas*, is confronted by Elizabeth Shue in front of a taxicab, you can clearly see the number 666 on

the rear panel in the background.

Some believe that searching for the Number of the Beast may in fact be a trap for the unwary. Self-styled messiah J.R. "Bob" Dobbs notes:

"The Con [conspiracy] has yet another group of people looking for the number 666 in every license plate, every price tag, every computer-sytem prefix, every government office employee's badge, every Non-Profit Corporation W-2 form, every lottery ticket, every underwear tag, in the center of metric rulers...and it IS on half the rock-and-roll album jackets. The thing is, THE NUMBER IS THERE...but it's a red herring for



simple minds. Half of those companies use it as a joke, much like the SubGenii [good guys] do. Sometimes the Con does deliberately place it to increase the paranoia of the Religion Dupes." *The Book of the SubGenius*

The publishing companies of New York also seem to have a fetish for six hundred and sixty-six. The national monthly *Harper's Magazine* resides at 666 Broadway,

New York, while the international publisher Bantam Books is located at 666 Fifth Avenue, New York. Most intriguing is the fact that the official insignia of the Trilateral Commission looks exactly like three sixes, twirling to the left.

The Number of the Beast also makes several appearances in the Holy Bible. Listing them in chronological order helps to reveal the connections between them:

"Now the weight of gold that came to Solomon in one year was Six Hundred Threescore and Six talents of gold....And the LORD was angry with Solomon, because his heart was turned from the LORD God of Israel, which had appeared to him twice. And had commanded him, concerning this thing, that he should not go after other gods: but he kept not

that which the LORD commanded." (*I Kings* 10:14 and 11:9-10)

"Now these are the children of the province that went up out of captivity... whom Nebuchadnezzar the king of Babylon had carried away unto Babylon, and came unto Jerusalem and Judah, every one unto his city; ... The children of Adonikam, Six Hundred Sixty Six." (*Ezra* 2:1-13)

"And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name. Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is
